# **GREEKS BEAT MCCOY**



By an overwhelming majority the voters of The Dalles have decided to set aside 40 acres belonging to the city, for a public park, The new park site lies immediately south of the city on an eminence overlooking the town and surrounding country. It is said to be an ideal location for a public park, and with very little improvement can be made a most delightful place. It is sparsely wooded with oak and pine trees, just sufficlent to afford shade. It is near the city water works, and water can be forced upon the tract with a hy draulic ram at light expense. The setting aside of this new park is the result of the efforts of the women's club, the Sorosis, which some three years ago began the agitation. At the recent election they had an initiative presented to the voters dedicating the land for park purposes and providing for its im-


