NEW ORDINANCE ON WATER IS PASSED

An ordinance providing for strict conservation of the city water was passed at the council meeting this week. This ordinance provides that the hours for irrigation, sprinkling, etc., be limited as follows: Property on the north side of the street, including one-half the block, may irrigate between the hours of 7 and 9 p. m.; property on the south side of the street, including one-half the block, may be irrigated between the hours of six and eight a. m. Councilman Staten moved an amendment permitting property owners in that section lying south of Montello Avenue to irrigate between the hours of six and nine p. m. and between five and eight a. m., the divisions between north and south sides of the streets being the same. The ordinance is a comprehensive one, providing that nobody shall sprinkle nor irrigate without a permit.

EXPERT TO ADDRESS THE CHILDREN HERE

C. H. Lane, first assistant in educational work of the department of agriculture, has been secured by State Superintendent Alderman to devote two weeks to lecturing on the children's agricultural and industrial work in this state. He will arrive in Hood River at 10:33 a. m. May 10 and depart on the same hour May 11. He will be accompanied by Calvin C. Thompson of Salem, field contest manager for the statewide contest along these lines.

Soon after the boys' and girls' contest was launched last winter Superintendent Alderman requested that the department send a man to Oregon. The same "crew" has since "worked" Kansas and Nebraska and is now in Arkansas, as witness the following telegram:

Roosevelt managers are using money under the guise of paying wages to workers, another name for bribery.

In Pennsylvania, instead of standing at the polls and handing each Roosevelt voter a five dollar bill, "due bills" were issued calling for this amount which were collected at headquarters when countersigned by the district leaders. It is estimated that \$100,000 was expended in this manner. This would "reach" 20,000 voters.

In New York county the Roosevelt managers expended a quarter of a million dollars. One district leader paid \$10,000 out of his own pocket in his own district on promise of reimbursement besides what headquarters sent him.

In Chicago two men contributed \$7,000 for use in one district on primary day, and \$200 was offered eight precinct captains to desert Taft.
