Each gathering of cream should be cooled in cold water before setting it away or adding it to the general lot of cream. A good way is never to mix a fresh batch of cream with older cream, however, but keep each lot in the different separators by itself in gallon crocks.

To obtain a full production of milk water is absolutely essential, and it should always be fresh, if possible, and where the cows can get it at any time during the day or night.

The thorough cultivation of tracts in which fruit bearing bushes or trees grow is to be commended for two reasons chiefly—first, it conserves moisture needed by the growing trunks, and, secondly, it reduces to a minimum the number of insects and worms which in some stages of their development find a harbor in the surface soil.

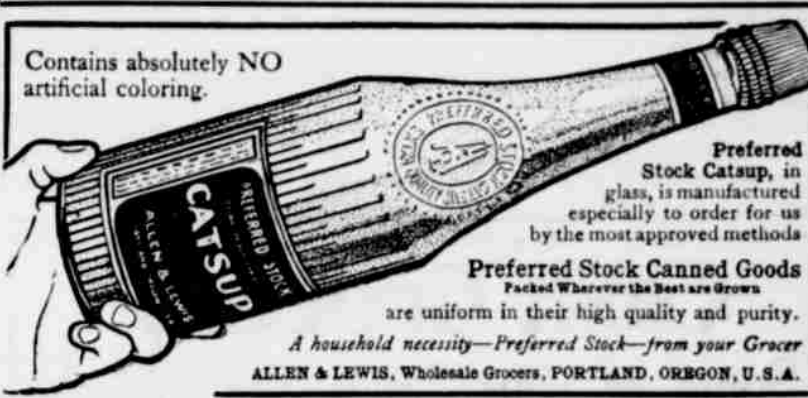

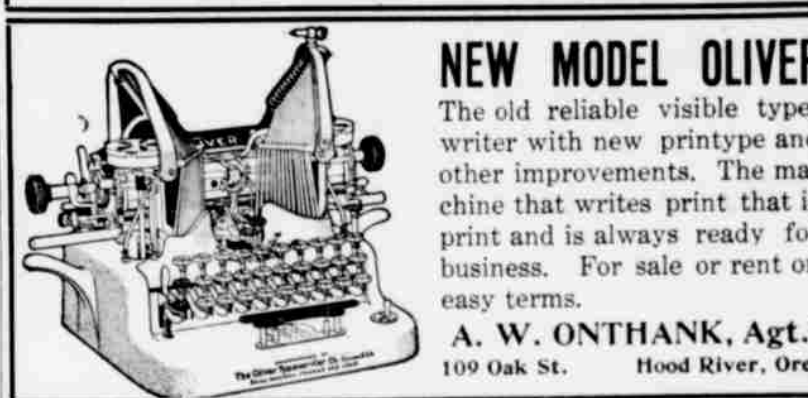
