This advertised list of delinquent taxes for the year 1911 is in pursuance of an act of the State Legislature which is embodied in Chapter 255 of the:

60th Session of the Law of the 1911 Session. The taxes on the following advertised property became delinquent on April 1, 1912, and are subject to a penalty of 10 per cent and interest of 6 per cent per annum per annum until they shall have been paid.

Any day after the expiration of six months after the taxes charged against the following real property were assessed, the tax collector is authorized, upon demand of any person making application, to issue to them a certificate of delinquency upon payment of the taxes, penalty, interest and cost of advertising.

Certificates of delinquency shall bear interest from the date of issuance until redeemed at the rate of 10 per cent per annum.
