





Into winter quarters, opring spray-ing is effective if done at the time the bud scales have opened enough so that the young leaves are just begin-ning to show their tips. It is very evident that it is more difficult to reach the pest at this time since they are more or less protected. In mak-ing the application all infested branches should be thoroughly drenched. The remainder of the tree need uot be sprayed. Lime-sulphur of winter strength or Black Leaf 40 (1 1000) with 2 pounds of soap to each 50 gallons of the tobacco solu-tion may be used. 


