LACK OF ENTHUSIASM.

Bryan Suffered From a Cold, and His Audience Was Chilly.

EUGENE, Or., April 5.—Colonel W. J. Bryan spoke to about 3000 people for two hours today, beginning at 11 o'clock. There was less enthusiasm than has ever been displayed in honor of a speaker of National reputation. Mr. Bryan was suffering from a cold, and it was quite an effort for him to speak, and it required considerable effort to attract his audience. The meeting was held in the open air in the school grounds.

Hon. R. M. Veatch acted as presiding officer and introduced the speaker. After the meeting had adjourned, Mr. Bryan came to lunch, and then took the 2 o'clock train for the south. His speech was the same as has been published recently. The lack of demonstration here was somewhat disappointing to Bryan's admirers.

Larger Crowd at Roseburg.

ROSEBURG, Or., April 5.—This morning's train brought a large number of people from the south. During the day many came from the surrounding country. The evening train brought Mr. Bryan and many people from the north. Those in town met Colonel Bryan at the depot and escorted him to the McClure home. At 7:30 Mr. Bryan was escorted by R. S. Sheridan, chairman of the Democratic state central committee, and other prominent unionists, to the platform south of the Odd Fellows Temple, and introduced by Rev. M. Howell, commander of Reno Post, G. A. R., to an audience of probably 4000 people, who listened for two hours. The speaker did not spare the Republicans, many of whom were present. The audience was not enthusiastic.

BRISK LAND-OFFICE BUSINESS.

Many Applicants and Much Money Recently Received at The Dalles.

THE DALLES, April 5.—The quarter ending March 31 was a very busy one for the United States land office at The Dalles. During the period there were 17 cash entries, 36 homestead entries, 4 desert land entries, and 5 state school selections, making a total of 15,539.55 acres of land entered during the month. Final proof was made on 32 homesteads and two timber culture entries.

Total receipts from sales were \$238,737; from fees and commissions, \$112,412, making a total of \$351,149. To this can be added \$100 deposited in the unreserved fund, awaiting settlements of filings on land held up for various reasons.

Twenty-one homesteads were filed on in one day during March, which is the largest record ever known here.

Large numbers of applications are received for land covered by abandoned claims and under contract, which are rejected.

The O. R. & N. Co. is securing lists of the large number of applicants for information about this country and furnishing them with descriptive matter touching Eastern Oregon.

Work for the Game Warden.

TILLAMOOK, Or., April 5.—W. S. Come has just come out of the timber in the Nehalem country, where he has been cruising. In coming out he passed a band of 14 elk cows, and some young men, knowing their whereabouts, started out to kill them. The elk were very tame, and had evidently been feeding in that vicinity all winter.

Fred Newton had a hearing today before Justice T. H. Goyns, charged with being armed with a dangerous weapon and assaulting another therewith. The case grew out of a row in a saloon early Sunday morning, when Newton stabbed J. Mitchell with a pocket-knife, inflicting a triangular wound in the left side. Newton was bound over to the Circuit Court, which will meet next week.

Martha L. Henderson, of Salem.

Martha L. Henderson, wife of J. Harvey Henderson, of Salem, died at her former home in McMinnville, last Sunday, of pneumonia. Deceased was the daughter of Mr. and Mrs. W. J. Loughery. She was born in Indiana August 30, 1855, and was married in 1873. She left a husband and two children—Mrs. Myrtle Barnhart and Robert S. Henderson. Mrs. Henderson was a member of the Baptist Church for 20 years. She was also a prominent member of the Rebekah Lodge of McMinnville, and a charter member of Home Circle, Women of Woodcraft.

Whitman Tax Collections.

COLFAX, April 5.—County Treasurer Windus reports tax collections for the month of March, 1900, to be \$39,672.92, of which \$7,028.64 was paid on the tax-roll for 1899. The total income of the county for the month, including fees of officers and miscellaneous receipts, was \$31,419.37. The total income of the county since January 1, 1900, has been \$173,185.66. Disbursements for March were \$28,928.66, of which nearly \$15,000 was for the common schools. The total expenditures of the county since January 1, 1900, are \$48,822.78.

Russian Rector for Seattle.

SAN FRANCISCO, April 5.—The Rev. V. V. Alexander, who was ordained a priest of the Russian Orthodox Church in the Russian Cathedral of this city Sunday last, has been named rector of the Seattle Mission, which includes the States of Montana, Oregon and Washington, British Columbia and the Northwest Territory of Canada, with a membership of about 700.

Northern Pacific Pays Its Taxes.

NORTH YAKIMA, April 5.—The County Commissioners today effected a settlement of Northern Pacific right-of-way taxes for 1899. The total amount due the county was a little over \$60,000. The railroad company refused to pay on the ground that the assessment was unreasonable. By the terms of the compromise, the county receives nearly \$7,000.

Methodists at Sheridan.

SHERIDAN, Or., April 5.—The Salem District Ministerial Association of the Methodist Church closed a two days' session at the M. E. Church here today. The reports from the charges showed nearly all to be in a healthy condition, the financial condition of all being much improved, and a number of excellent reports were made. About 25 ministers were in attendance.

In Linn County, the registration so far is but little more than 3000.

A man from Independence, Iowa, is to start a baking powder factory at Eugene.

Fishermen at Eugene were happy last Sunday. One of the papers says the trout were hungry enough to bite at any old bait.

Pendleton citizens are annoyed by flower thieves. One man offers \$10 reward for the arrest of the person who stole his hyacinth blooms.

Monday evening Grant's Pass celebrated the success of its "bonding proposition" with music and fireworks. A saloon joined in and gave out "free beer." The consequence was that many young men became drunk, and many citizens were put to shame.

A London paper states it has been discovered that Fayne Strahan Moore is a member of a London chorus in "The Messenger Boy." Mrs. Moore was offered inducements to go on the stage in New York immediately after the trial of her husband, and the Albany Democrat doubts very much that it is a chorus girl in London. But she is satisfied she is with her mother in Atlanta, Ga.

TAKES MORE MONEY NOW

COSTS MORE TO LIVE AND HANDS MUST GET MORE PAY.

Advance of Ten to Fifteen Per Cent at Oregon City Woolen Mill—Furper Mill Men Also Ask More.

OREGON CITY, April 5.—The woolen mill hands express satisfaction at the increase of wages granted by the management, although the pay that they are now receiving is less than it was before the panic. Before the period of "hard times," that struck the country a few years ago, the weavers in this mill were making an average of \$45 to \$50 per month, but their pay was cut down until the average compensation was about \$22 per month. Under the new schedule of wages the weavers were given an advance of about 15 per cent, while workmen in other departments received average advances of 10 per cent. Unskilled workmen have set in from the East, only being receiving about \$1 per day.

The recent dissatisfaction among the hands was caused by the increase of the cost of living, some of the men with families stating that on this account it was impossible to keep their grocery bills paid up with the wages that they were receiving. Many of the hands employed in the mills were glad that for the first time since the panic they were receiving more pay, and submitted to a reduction of wages when prices were low without murmuring, but say that the present condition of high prices for manufactured goods, without any corresponding increase in the cost of living, is a hardship. The weavers asked for increase of pay and it was granted without any haggling. The girls in the spinning-room, who walked out to protest their dissatisfaction, and when a new foreman shut down on the loose way of measuring that had been practiced for some time the girls found out that they could not regulate their accustomed wages. The management, however, adjusted the matter satisfactorily, and the strikers returned to work within an hour.

Yesterday 15 men employed in one department in the Furper Mills gave notice that they would ask for an increase of pay. These men are unskilled laborers, and ask that their pay be increased from \$1.25 to \$1.50 per day.

Difference Over Streets.

Two ordinances passed by the City Council last night—one providing for the purchase of 600 yards of crushed rock to be placed on the main streets, and the other providing an ordinance providing for the use of a portion of the city funds to be used in constructing a roadway from Third street up the bluff to Center street. While these ordinances were being passed, some lively talk took place between Councilmen Charman and Schuebel. The former opposed the proposed appropriation of at least \$600 for the improvement of Molalla avenue, stating that it would use up all the money in the road fund. Charman was personally interested in the proposed building of a roadway from Third to Center street, and fought the repeal of that ordinance, but without avail. The two councilmen discussed this ordinance until a late hour, making charges and counter-charges of a not complimentary nature. The attempt of Councilman Koerner to make peace, nor the passage of the motions, had the effect of restoring harmony. On motion of Charman the Council adjourned until next Monday evening, when the irrigation or system in the bluff district will be considered.

Councilman Schuebel announces his intention of residing at the adjourned meeting, on account of changing his residence to another ward.

Collins JUMPED FROM TRAIN.

Out the Hellpore First—Said to Have Had a Confederate.

ROSEBURG, Or., April 5.—John Collins, the Seattle knacker, in charge of Deputy Sheriffs McKelvey and Frank Brown, on train No. 21, which was en route to Union Creek, last night. A confederate opened another door at the rear end, and Collins cut the bell cord and jumped off the train. The train stopped at Union Creek, and the guards could start to search for the returned and captured Collins under the section-house at Union Creek, Cow Creek Canyon, and took the next train for Portland.

Deputies Said to Have Slept.

J. C. Collins, who is being taken to Seattle from San Francisco, to answer to the charge of bank robbery, arrived in Portland last evening, and was lodged in the City Jail over night. Collins, who is in charge of Deputy Sheriffs J. W. McLeod and Frank Brown, of King County, Washington, escaped from his guards Wednesday night near Roseburg. According to a man on the train at Union Creek, Collins noticed that the guards were both taking a light sleep, so he stood up, pulled the bell cord once, the signal to stop, and then broke the door open, and gave out signals to the engineer to stop. Collins, who is a tourist car—opened the door for the robber and he jumped off the train, which had by this time stopped at Union Creek. He afterward found that his right hand first touched the ground and was painfully bruised.

Acting upon Collins' signal, the engineer stopped the train at the station. The cars traveled on three miles before coming to a standstill. It was then too dark to make much of a search, but the officers left the train, and early yesterday morning went back to the place where Collins had jumped. A thorough search of the country was made, and Collins was at last found in the section-house, actively engaged in removing the track ties from his feet with a hammer and chisel. Collins says if he had three minutes more he would have been free and eluded pursuit. The officers retraced their man, and came through on the following train, and the "incident" they went to sleep one at a time.

INDIANS HELD FOR MURDER.

Admit the Killing of Hortons, and Waive Examination.

VICTORIA, B. C., April 5.—Jim Hanson, Kitchikoo, Mark Claret, Dave Claret, Jack Klam, Ka Tak, Jim Williams, Josh Keck, Qu Ni Leb, Paddy Uss, Hoock, Goo's Alas, George White, Day Kan Tut and Martha Hanson have all been held for trial at Skegway, April 29, for the murder of the Hortons. The Indians admit the killing, and have waived the preliminary examination.

CREDITORS TOO NUMEROUS.

Dallas Attorney's Wife Declares Her Signature to Mortgage Forged.

DALLAS, April 5.—J. J. Daly, a prominent attorney of this place, disappeared from here about four weeks ago. He was considerably in debt at the time. After he left Mr. Uglow, one of his creditors, to whom Mrs. Daly was surety on a note

and mortgage, called on Mrs. Daly to consult her with reference to the payment of the debt. But to Mr. Uglow's surprise, she declares her signature a forgery. There are several persons here said to be in a like predicament. Daly has been in Los Angeles, Cal., since leaving here, but at present his whereabouts is not known here.

Grant's Pass Hotel Sold.

GRANT'S PASS, Or., April 5.—A contract has just been signed for the sale of the Hotel Josephine to George E. Good, of Roseburg, formerly manager of the Bellevue, of Portland. J. O. Booth, the present owner, will remain in charge until May 1.

Sailed for Cape Weme.

VANCOUVER, B. C., April 5.—After a delay of two days the steamer Alpa sailed this evening for Nome with 224 passengers, and a full cargo of freight. As Nome is not a United States port of entry, the steamer cleared for St. Michael.

Broke Into the Jail.

TACOMA, Wash., April 5.—The jail at Puyallup, Wash., was broken into last night by outsiders, and three prisoners, all men, escaped.

R. K. Ennis, of Hillsboro.

R. K. Ennis, a prominent citizen and a pioneer of 183, died at his home in this city at 5:40 this evening.

Washington Notes.

The Fairhaven council has decided to collect the poll tax from all male residents.

The Big Bend Empire reports the death of Edward Clark, one of the pioneer settlers of Douglas County.

The Everett & Monte Christo Railroad Company is about to build a depot and make other improvements at Everett.

It is given out that the Mohr transportation line has been let on the Inland Empire to the sea will be in operation by June 15.

The Palouse country is catching its full share of the big tide of immigration that has set in from the East, says the Pullman Herald.

At the Everett postoffice the business handled in March, 1899, amounted to \$84,148 and in the March just past, \$93,994.

Republicans are making arrangements for constructing a wigwam in which to receive President McKinley when he shall visit the city.

J. B. Coyle, who resides a few miles east of Walla Walla, sold four head of cattle in Walla Walla. The animals were 20 months old and average 1475 pounds each. They sold for 4 cents, netting Mr. Coyle the neat sum of \$20, or \$3 per head. The stock had been fed on alfalfa hay and were of Durham breed.

Papers in the largest foreclosure suit ever begun in Jefferson County were filed Tuesday by Sidney V. Smith, trustee, and the Bank of British Columbia against the Moore & Smith Lumber Company, at Port Townsend, for the recovery of \$43,108.75. The mortgage covers the entire holdings of the Fort Discovery mill, which has been running for 30 years.

A contract between the City of Walla Walla and the Blalock Fruit Company for the reception and care of the sewage of the city for 35 years, and giving a lien on \$20,000 and in the sum of \$10,000 to secure the city from damages which may arise from any negligence on the part of the fruit company, has been entered into. The fruit company will use the sewage for irrigation and fertilizing.

AMBUSHED BY OUTLAWS.

Thrilling Experience of Two New Mexico Officers.

PHOENIX, Ariz., April 5.—The following details of the ambushing of Officers Scarborough, of Deming, N. M., and Birchfield, by outlaws in the Chiricua Mountains, have been received here.

The outlaws discovered that they were being followed, and laid a trap for the officers, who walked into it. As soon as they came within rifle range, the party of three bandits opened fire. The first wounded Scarborough and Birchfield. One shot striking in the left field, badly shattering the bone; another struck Birchfield in the left arm. Both men were disabled. The wounded officers held the outlaws at bay, although harassed, several times. A continuous firing was kept up until dark.

In the meantime, Birchfield managed to hold a ruck rifle in which he placed Scarborough, and in so doing he prevented his movements from being observed by the bandits, he slipped away, secured a horse and went for assistance. Returning to the fort, he was by Scarborough still alive and holding the fort, but suffering intense pain from his wound and exposure, it having rained and snowed all through the night. The party arrived at San Simon at 2 o'clock yesterday afternoon with Scarborough, and he was sent to his home in Deming. His wound will probably prove fatal.

The chase has started in pursuit of the outlaws, who have evidently gone further back in the mountains, where it will be almost impossible to dislodge them.

Crime of a Drunken Man.

CHICAGO, April 5.—A special to the Record from Wagoner, T. S. says: Tom Gaylor, while intoxicated, shot Night Watchman Humphrys, Dick Ketcher, and a man named Brown and Humphrys is not expected to live. Gaylor is still at large.

NEWS FROM HAWAII.

Two Fresh Plague Cases Reported March 25.

HONOLULU, March 25.—Via San Francisco, April 5.—Two cases of plague were reported March 25. One was a Japanese fisherman, the other a white man named John S. Since that date no cases have appeared.

Word has reached here that the disabled steamer Cleveland reached Hilo safely March 25. The distance of 400 miles was made under sail in 10 days.

Three hundred or more steamer passengers will probably sail from here on the next steamer for San Francisco. Dr. J. C. Keene, in view of the recognition now given the prophylactic as a preventative remedy, effective for from 30 to 40 days, he will give permits for the passage to persons who take the prophylactic and are in good health, have their baggage disinfected and are otherwise under sanitary conditions.

A riot occurred at Pahuau plantation March 11. The captain of police and four officers arrested eight Japanese for gambling.

About 200 Japanese, armed with cane knives and clubs, surrounded the officers and forced them to release their prisoners.

A disastrous cane fire swept over 530 acres on the Hawaiian Commercial & Sugar Company's plantation March 20.

Catholic Circles Divided.

DUBUQUE, Ia., April 5.—A serious division in Catholic circles seems likely over the naming of a successor to the late Archbishop Hennessy. Dr. in view of Dubuque Archbishop Keene, of Washington, and Father McLaughlin, of Clinton, were nominated by the convocation of priests on March 15. Some days later the bishops nominated Bishop O'Gorman, of Sioux Falls, and Bishop Scanlan, of Salt Lake. Today the German priests of the diocese forwarded to Rome a protest against the appointment of Archbishop Keene.

Capital City Notes.

In the Supreme Court today, I. W. Bennett was admitted to the bar for nine months, on certificate from the Superior Court of Washington, and on motion of S. T. Richardson and L. H. McMahan.
