SHOT A PREACHER.

Kentuckian Objected to His Visits to His Wife.

HOPKINSVILLE, Ky., June 20.—Ex-Congressman J. W. Ware shot Rev. W. F. Hiner, pastor of the Methodist church, while the latter was making a pastoral call on Mrs. Ware at the residence of the former. Ware entered the parlor and fired at the minister without warning. Dr. Hiner threw him to the floor and disarmed him. Ware was arrested and released on \$1000 bonds. Had the ball passed a fraction of an inch lower, the pastor would have been instantly killed.

ANOTHER DAY OF IT

No Nominations Yesterday by Philadelphia Convention.

GIVEN UP TO ROUTINE MATTERS

A Permanent Organization Was Effected, and the Platform Was Unanimously Adopted.

PHILADELPHIA, June 20.—President McKinley was not nominated at the session of the Republican National Convention today. But tomorrow will witness, in all probability, the unparalleled scene of both Presidential and Vice-Presidential candidates being nominated by acclamation. Senator Hanna threw up the sponge today. He found he could not stem the tide of the popular favor which was the direct influence of the Administration at Washington, and this he could not get. Possibly even with it he might have failed. But without it the task was hopeless. The President would have no hand in an effort to control the convention. He made known directly to Mr. Hanna his wish that the will of the convention should not be thwarted, and when that ungrateful word came, Mr. Hanna reluctantly abandoned the fight. With this retirement from the contest of the Empire State Governor, nominations could have been made before the convention adjourned today.

The original programme was to renominate President McKinley today and to nominate the candidate for Vice-President tomorrow. But the National Republican Committee had made a compact with the local Philadelphia committee to keep the convention here for three days, and it was feared that if the nomination for President was made today, the convention might take the bit in its teeth and wind up the business before dark.

All the preparations for the President's nomination at this session had been perfected. Hanna's red, white and blue plumes, attached to long staffs, had been taken down into the delegates' pit before the convention met and there stood away for the inevitable moment when the climax should be reached. As they were carried into the pit by the ushers while the convention was assembled they recalled the magnificent scene at St. Louis four years ago, when similar plumes were carried into the hall with delight during the famous McKinley nomination.

Hanna Would Take No Risks.

Considering the temper of the delegates and the crowd, Mr. Hanna decided to take no risks. And consequently the immense throng which backed the vast amphitheatre today was content to content themselves with the routine incidents connected with the permanent organization, an oration by Senator Lodge, the permanent chairman, and the platform which attended the unanimous adoption of the platform. Then they returned to the city to wait another 24 hours for the nomination which they had traveled, some hundreds, some thousands, of miles to witness. It was a great disappointment to most of them. The business of the convention moved so smoothly that the session did not afford them an opportunity to let off steam. They were not the slightest jar. The wheels moved as noiselessly as a Corlies engine. The hand of Hanna was at the helm. He was an experienced and accomplished manager. Not an eccentric slipped.

At one point, when the convention scaped on a sand bar over a proposition advanced by ex-Senator Quay, of Pennsylvania, to cut down the nomination of the Southern States in future conventions to a basis of polled votes for the Republican candidate, the lever was reversed, and the convention promptly backed off, thus avoiding the possibility of postponing a decision on the subject until tomorrow. The Southern delegates, without regard to color, race or previous condition, are very much incensed over what they regard as a blow at their power in National conventions, and the growl they emitted today indicates that they promise to fight in their effort to avert it.

Aggravated today Governor Roosevelt carried off his honors. His entrance was the signal for the most pronounced demonstration of the session. It was dramatic as a scene of yesterday, and was practically a repetition of his experience there. He still wore his Rough Rider hat. Some of his austerity had departed. With the relaxation of Mr. Hanna's opposition, the Governor exerted a certain amount of influence to the inevitable. And he appeared resigned to his fate. Only once did he seem to resent the popular acclamations. That was when Senator Wolcott, who is one of his ardent supporters, gave the crowd opportunity to cheer him by naming him on the committee to escort Henry Cabot Lodge, the permanent chairman, to the platform. He made no effort to conceal the annoyance he felt at being thus dragged into view.

Chairman Lodge's Oration.

Senator Lodge, young, brilliant, already famous as a scholar, statesman and historian, made a fine figure as he delivered his address at the beginning of the session. He was finely poised, head, close-cropped, iron-gray beard, delicately chiseled features and slender, athletic frame were clearly outlined as he spoke. He spoke in a voice, though somewhat hoarse, with a down-East raspiness, but his delivery was pleasing and forceful, and his speech was the scholarly, clear-cut effort expected of him. But it covered the same general ground Senator Wolcott went over yesterday, and, though some of the fine periods elicited applause, as a whole it did not stir up any great enthusiasm. Neither did the reading of the platform, a very strong document, by Senator Fairbanks, and for the same reason.

HAS NO OPPOSITION

All Candidates Withdraw in Roosevelt's Favor.

HANNA MAKES THE ANNOUNCEMENT

New York's Governor Will Today Be Nominated Unanimously for Vice-President.

PHILADELPHIA, June 20.—Senator Hanna tonight issued this statement: "The Administration has had no candidate for Vice-President. It has not been for or against any candidate. It has been deemed that the convention should make

himself makes the motion, on behalf of New York State, to suspend the rules and make Roosevelt's nomination unanimous. That is the probable way that New York will relieve itself. It may be said that the Governor Roosevelt knows this and with equal positiveness it may be declared that he will accept the nomination.

Woodruff Makes the Best of It.

Most significant is the attitude of the Woodruff element. Mr. Woodruff himself was not even ruffled. He smiled as he said: "I told Senator Hanna this morning that I believe nothing could beat Mr. Roosevelt for the nomination. I further told him that I had always believed that there would be a great sentiment for him and I never believed that I stood any chance to be nominated if he was taken up by the convention. I do believe that it is not a combination that will nominate him, but a genuine demand by the people."

NOT FOR TOM PLATT

But to Demand of the People Roosevelt at Last Yields.

HE HAS WON IN THE GAME

The Administration Fell In With the Popular Feeling and Accepted the New York Governor.

PHILADELPHIA, June 20.—It marked contrast with the rapid attention accorded yesterday were the indifference and discourtesy against which both Lodge and Fairbanks struggled today. The galleries were simply tumultuous, and the delegates conversed in ordinary tones or read newspapers. A sport and trimmer with winning ways is the ideal of this convention, if his lungs are broad and his social mellifluous, to the discredit of a thinker like Lodge or an honest man like Fairbanks.

The determination upon Roosevelt for Vice-President is due to two things. One is Roosevelt's triumph last night in the New York election. Then it is believed the scepter of power passed from Platt and passed to the ambitious Governor. After the session Roosevelt gave the impression that he was at last willing to accept the nomination. Another way of putting it is to say that Roosevelt is willing to be the nominee of the West and the people, though not to be the victim of Platt's purpose to unseat him. The other reason for the determination of Roosevelt is furnished in our shrewd President.

The desire of Hanna to serve the great corporate interests which dread the possibility of Roosevelt's accession to the Presidency through accident to McKinley, has been overborne by the man at the White House, whose ear always attuned to popular feeling, has caught the wares of enthusiasm for the New York Governor, and wishes to profit by it. It is in reality a victory for the people, and the corporations must console themselves with the reflection that this disposition of Roosevelt may sidetrack him for 1904.
