DOGS NOT TAUGHT TO RETRIEVE.—A California sportsman visiting this city noticed a considerable number of fine-bred sporting dogs—pointers, setters, water spaniels, etc.—some of which he considered the best-bred dogs of these varieties he had ever seen. He determined to purchase one to take back to California with him, but was astonished to find that none of the really fine dogs had been taught to retrieve. On inquiry he found that dogkeepers no longer employ dogs to retrieve the ducks, except in unusual cases, the ducks shot being allowed to drift ashore, and at the end of the shooting picked up, or, if out of reach, collected by a man in a boat. Hunters of upland birds do not train their pointers to retrieve, as they shoot Mongolian pheasants principally, and train their dogs to stand firm on a point, never allow them to go after the pheasant, no difference how long they have to stand. The reason for this is that if the dogs break from their point and dash at a pheasant they are liable to get out of the altogether. When a hunter goes into a field his dogs quarter over it very rapidly, and may point a bird away on the far side of the field. He is expected to stand like a rock till his master comes up and tells him to go on, no odds how long it takes. If the dog should break, he might be across the field before his master had reached the place where he made the point. As the shooting in California is chiefly at quail, the dogs are required to retrieve the birds. For this reason the California sportsman did not find any dogs of the kind he wanted which came up to his ideas.

NECESSITY OF GIRLS' REFORM SCHOOL.—Chief of Police McLaughlin says one of the burning needs of the city at the present time is a reform school for girls. There is a place of this kind where boys can be sent when necessary, and there is no place where girls who have broken away from restraint can be cared for. No one, unless in some position as Chief of Police McLaughlin, can have any idea how many young girls are leading the narrow strip which divides respectability from degradation, nor how many of them who might be rescued if it were not for the time to go to destruction for lack of such a place as a well-conducted reform school. If this matter were taken in hand by the proper persons and placed before the approaching Legislature in the proper light, there would be no trouble in having a reform school for girls established.

TOOK BACK A PRISONER.—Chief of Police William Mackler, of Tacoma, spent Christmas in the city, the Chief of Police McLaughlin. He came over after one L. D. Fuller, a colored man formerly a barber in the Hotel Tacoma, and who last September was found with a diamond jewelry valued at about \$100. Fuller was captured here by Detectives Ford and Cordano, and a sunburst diamond brooch, the most valuable piece of the stolen jewelry, was found in his possession. The other stolen diamonds were also located, some having been pawned and some being in the keeping of female friends of Fuller. Chief Mackler left for home at 11:30 last night with the prisoner. This was his first visit to Portland in the day time, and he took advantage of the occasion to take in the city under the guidance of the police.

TURKEY AT THE COUNTY JAIL.—The prisoners at the County Jail enjoyed a very pleasant Christmas. They had a turkey dinner, including mashed potatoes, fruit, cake, jelly, and mince pie, with cream, and cigars. Jailor George Mitchell and his wife furnished the cigars and coffee and cream. The Seventh Day Adventists donated some things, as did also a society of non-members. The Salvation Army Corps called at 4 o'clock and held services in the various corridors. There were a large number of visitors throughout the day, and many of whom brought gifts to friends inside. Frank E. McDaniel was remembered by numerous women callers, and a few others of the inmates were equally remembered. There are 64 persons confined in the jail, of whom five are women. Two of the women are Chinese.

NOT TO AFFECT PARENTS' OFFICES.—The proposed change in the organization of the county offices suggested by the taxpayers' league to the Multnomah County legislative delegation would not, it is asserted, be carried into immediate effect, as they have been surprised. The officers of the league state that the consolidation of the offices of County Clerk, County Recorder and Clerk of the Circuit Court, if decided upon, would not be carried into effect until the term of office of the present holders had expired. The league's measures have been prepared in accordance with this intention.
