

MAY END UPRISING

Snake River Indians Suffer Capture of Leader.

DUE TO BOLD DASH OF OFFICERS

Marshal and Troops Will Now Move East to Take Other Chiefs—Road Asks Government to Protect Property.

ST. LOUIS, Jan. 27.—A special to the Republic from Henrietta, T. T., says Deputy United States Marshal Bennett has just arrived here at 7:45 P. M. with Chitto Harjo, "Crazy Snake," whom he captured at Eufaula. This, it is believed, will end the insurrection.

RESULT OF INDIANS' COUNCIL.

Post Notices That Old Creek Laws Are to Be Revived. MUSKOGEE, I. T., Jan. 27.—United States Marshal Bennett, with six deputies, and Constable Hubbard, United States Commissioner Saxon and T. W. Gulick left today for Henrietta, 40 miles distant, where they will join troops sent to quell the Creeks. They will go overland, and take a commissary, 20 Winchester and plenty of cartridges. Just before the start was made a telephone message was received from Chocotah saying that the following notices had been posted there after the Snake council adjourned at Hickory Town, yesterday.

"Notice, read to all present: White citizens and friendly Creeks should be dealt with according to the old Creek laws, and according to the Creeks and Chief Forter. (Signed.) "LATA MEKKO." "Attest: Edward Harjo, Second Chief." The Dawes commission yesterday ordered a dissection of the survey in the disturbed district. Mose Lyon, in charge of a party that arrived here today, states that a number of light horsemen are still riding the country. They are heavily armed, but are not doing any damage, confining their efforts to protecting the members of the Snake band going to and from the meetings at Hickory Town. It is believed that the worst is over, but Marshal Bennett has his best deputies with him, and if he encounters trouble will put up a strong fight. It is his purpose to join the troops at Hickory town and work with them in making arrests of the leaders of the uprising.

REFUSED POSSE ADMITTANCE.

Indians Declined to Confer with Major Little's Force.

BRISTOW, I. T., Jan. 27.—Major G. W. Little (Pawnee Bill), with a posse, including Captain Edmond Harry, of the Creek Light Horsemen, and four Indian police, visited the hostile Creek stamping-ground, six miles south of this place, at noon today. The Indians, who were holding a big feast, refused the posse admittance and declined to confer with them in any manner. Many of the full-bloods who have been in the habit of wearing white man's apparel are now in the country, and are regarded as more bitter in their denunciation of the Marshals for the arrest yesterday of Tom Tiger, Captain of the insurgent light horsemen. Feeling that an attempt would be made to release Tiger, he was taken to Muskogee. Last night the citizens of Bristow guarded the town. At 6 o'clock this morning the full-blooded Indians, and the beat of the tom-tom was plainly heard by the guards on the south side of the town. A telegram from Marshal Bennett authorizes the Mayor and citizens here to arm and swear in all able-bodied men to protect their property until soldiers can be sent here from Henrietta.

ASK FOR MILITARY AID.

Railroad Calls on Government to Protect Property.

NEW YORK, Jan. 27.—Officials of the Missouri, Kansas & Texas Railway, in this city, today received advice from Vice-President General Manager Alden, whose headquarters are at the seat of the Indian troubles in Indian Territory, stating that he had advice from United States Marshal Bennett at Henrietta, mediating danger of the full-blooded Indians attempting to destroy tracks and bridges of the railroad at that locality. Mr. Alden says the protection offered by the United States Marshal is not sufficient, and suggests that the officers of the company ask for military aid. Henry House, president of Missouri, Kansas & Texas Railway, at St. Louis, Mo., in a dispatch, telegraphed to President McKinley, asking that immediate Government military aid be sent to protect the tracks of the company in the troubled district. A similar dispatch was sent to General Miles.

Indians Obstructed Railway.

KANSAS CITY, Jan. 27.—A special to the Times from Muskogee says: "Just before leaving for Henrietta today, Marshal Bennett received a telegram from Holdenville saying that members of the Snake band had thrown an obstruction across the railway track about nine miles south of that place, but that it was discovered and removed before a train arrived. The Deputy Marshal at Holdenville was instructed to make a thorough investigation. A message also received by Marshal Bennett from Okmulgee, the capital of the Creek Nation, stated that light horsemen of the Snake band passed a night on the postoffice door there yesterday saying the town was the property of the Indians, and all the white people would be driven out.

Settler's Home Burned.

GUTHRIE, O. T., Jan. 27.—Reports received here at the United States Marshal's office say that the home of John Bartram, a ranchman, living 18 miles west of Bristow, I. T., was burned by hellfire. Snake Indians last night. A band of 30 Indians, all drunk, made a demonstration. Bartram ordered the reds away. This morning the woman of the house and Bartram, feeling violence, moved his family to Bristow. Later his home and all the buildings on the premises were in flames. The report cannot be confirmed. It is the first overt act committed by the Creeks.

Choctaw Uprising Spreading.

WASHINGTON, Jan. 27.—Indian Commissioner Jones has received the following dispatch from the Choctaw Agency, Agent Schoenfeldt, at Muskogee, I. T., in regard to the Indian troubles: "Marshal Bennett will leave tomorrow

with force of deputies and Indian police. Will meet troops at Henrietta. Later dispatches indicate uprising in Choctaw nation spreading. Disaffected Indians have sworn to 40 light horsemen, and are attempting to carry out their laws and threaten to destroy property. Chase just sent a squad of policemen to Bristow to assist the civil authorities in maintaining order and prevent the selling of whisky to the Indians, where a large band of Snake Indians are now camped, threatening to burn the town." In a communication received here from Green McVittin, formerly chief of the Choctaws, he says the Snake party excitement is exaggerated.

Third Request for Militia.

GUTHRIE, O. T., Jan. 27.—Governor Bard today received a third request from Sheriff Thomas of Lincoln County, for two militia companies. In his request, Tighman, who is a noted United States Deputy Marshal, says the people on the Creek boundary are alarmed and that a band of Creeks is roaming over the entire country, drunk and shooting promiscuously.

PROGRAMME IN CONGRESS

SENATE WILL TAKE UP A VARIETY OF SUBJECTS THIS WEEK.

FIRE IN WASHINGTON HOTEL

Guests Were Badly Frightened, but All Escaped Uninjured.

WASHINGTON, Jan. 27.—Fire broke out at about 2:30 o'clock this morning, in a room on the first floor of the old portion of the building occupied by Willard's Hotel, and which adjoins the new structure, now in course of construction. The flames immediately adjoining, and the property loss will not exceed \$500. Half a hundred guests, including several Congressmen and their wives, were badly frightened. WU ON CONFUCIANISM

CHINESE MINISTER REPLIED TO HIS CRITICS IN SPEECH.

Said That They Who Attack Other Creeds Should Not Resent Comparisons With Christianity.

PHILADELPHIA, Jan. 27.—Wu Ting Fang, China's Minister Plenipotentiary to the United States, replied to his critics today in the course of a lecture on "Confucius and Mencius" delivered before the Society on Ethical Culture at Horticultural Hall. Every available inch of both seating and standing room was occupied. The audience, attracted by the protest and criticism raised by Minister Wu's recent utterances in New York City on the subject of Christianity, the Chinese Minister's statements were, however, extremely conservative. Justice Weston, director of the society, introduced Minister Wu, who said: "Twenty-four centuries have rolled by since Confucius walked this earth. His

THE COST OF TAMMANY.

Increase of 30 per cent Since Wigwam Returned to Power.

A long compilation of figures, designed to show the increase in the cost of the municipal government in recent years, was published recently in the New York Evening Post, with the statement that it was based upon a full investigation of departmental expenditures, both before and after consolidation. It is declared that "in the three years since Tammany returned to power the cost of municipal government has increased at least 30 per cent," and that "this enormous increase is due chiefly to extravagance of Tammany officials, but partly to expenditures forced upon the city by Republican machine politicians at Albany." It is stated that the estimates given are based upon reports of experts employed by Controller Coker to examine the books of the corporation forming the present city, and upon appropriations named in the budgets, as affected in numerous items by transfers between departments. These estimates show increases amounting to \$2,572,823 in five of the departments of the municipal government since consolidation, as follows: In the schools, \$1,923,329; in the Police Department, \$2,422,126; in the Fire Department, \$59,951; in the Health Department, \$176,951; in the Building Department, \$136,602.

Ch. Housheer, it is said, point to three general conclusions: "First—That the actual cost of government has increased at least 30 per cent since consolidation. This estimate is based on actual outlay by departments whose total appropriations aggregate 82 per cent of budget allowances for 1898, 1899 and 1900, excluding disbursements for the city's general obligations and county expenditures. These departments show nearly 35 per cent increase over the Strong administration, the old figures being based upon the basis for comparison. Since the investigation has not yet reached certain centers of suspected corruption, it is believed that the actual increase will be all departments is an altogether conservative estimate. And Tammany has yet another 12 months to serve, with budget appropriations \$4,530,331 in excess of any previous year.

Second—That a considerable part of the increase in departments showing the most striking gains has resulted from mandatory legislation, and is therefore, not directly attributable to the Van Wyck administration. But the disclosures indicate plainly that most of the departments have been run "for revenue only," with little regard for the public good. Third—The investigation confirms all the Controller has said respecting unbusinesslike methods of reporting expenditures, and shows the necessity for the immediate adoption of some comprehensive system for classifying departmental accounts and segregating elements of cost. It is believed that the present method of apportionment has no way of judging the real needs of a department, and votes away millions of the city's money with less scrupling than would be shown men would give a \$100 expenditure.

FORERUNNER OF STRIKE.

Proposed Miners' Conference in Pennsylvania So Considered. IN THE HOUSE.

Appropriation Bills Will Likely Monopolize the Week. WASHINGTON, Jan. 27.—The week in the House is likely to be monopolized by appropriation bills. Several of the 14 appropriation bills have already passed the House, namely, the executive, legislative and judiciary, pension, military academy, Indian, naval, river and harbor, and District of Columbia bills. Three others, the postoffice, agricultural and fortifications bills, have been reported to the House, and the remaining four, the army, consular and diplomatic, which is practically completed, will probably be disposed of during the week. Whatever time remains will be occupied with the bill to promote the efficiency of the revenue cutter service, which has been made a continuing special order, not, however, to interfere with appropriation bills.

ARRESTED FOR OLD MURDER

California Man Must Return to Texas for Trial—Confesses Crime. SACRAMENTO, Cal., Jan. 27.—Frank Hyatt was arrested here tonight for the murder of Steve Presley, committed in Elkhorn County, Texas, July 7, 1887. Hyatt made a full confession, claiming self-defense. He had been residing in this city for the past nine years, and was employed in the railroad shops under the name of Charles Eaves. He has a wife and stepson. In his signed confession, he claims that it was his intention to return to Texas next year and stand trial for the killing. He says the quarrel between himself and Presley, who was the stepfather of his former wife, occurred over some building material. Presley picked up a large stone to throw at him. He struck at Presley's arm with a club, to make him drop the stone, and the latter, in dodging, was struck on the head and died. Hyatt claims that he feared he would not get a fair trial, as all the witnesses were relatives of Presley, so he fled.

FINE POINT RAISED.

Right of Towne to Continue as Senator Questioned.
