BUTTE RACE TRACK QUARREL.

Clash Expected Today Over the Betting Question. BUTTE, Mont., June 30.—The city and county authorities are likely to clash tomorrow over the betting question at the race track. The police authorities are in favor of making Butte a wide open city in spite of the law against gambling. The county attorney has instructed all officers under his jurisdiction to enforce rigidly the gambling laws. He has even gone to the extent of raiding places where cards were being played for the drinks. Supposedly at the instigation of the gamblers, the police authorities have threatened to stop all betting at the race track, and to arrest the managers of the track, if it is persisted in. The races began Saturday night, and the police are expected to make a raid on the sports that something of the kind might be done, and their money tied up, that the betting was very light. The race track authorities are expected to be unfriendly, made all the police officials pay to get in. This, of course, has intensified the trouble. While no attempt was made to stop the betting Saturday, it is said the police will assume to exercise jurisdiction Monday. The County Attorney claims the police has no authority at the race track, which is outside city limits, and that the state law licenses pool-selling, and the gambling law contains no prohibition of it. He has told the race track people to stand on their rights, and that their special deputy sheriffs are to arrest the policemen, and put them in the county jail. Unless the police recede from its position, it is likely to be a lively time at the track tomorrow.

PENNSYLVANIANS SHOULD WIN.

Bob Cook's Opinion of the Oarsmen at Henley. HENLEY-ON-THAMES, June 30.—The Pennsylvania crew took advantage of Sunday to enjoy a thorough rest, the only exercise indulged in being a three-mile walk in the morning. All are in first-class condition. Bob Cook, Yale's coach, arrived last night. To a representative of the Associated Press he said: "The Pennsylvania crew to be in better physical condition than any other American crew that ever entered for the Henley races. They are better fitted to bring about a victory for the American stroke than any lot of men I have seen. Their broad blades and style of stroke involve greater force and shock to the muscles and system than the long, thin blades of the British, but I think they can stand the strain and should have a fair chance with the Lenders, supposing they meet them in the finals. The Pennsylvanians also have the great advantage of having rowed together, I believe, for nearly four years. They have improved greatly since they have been here, and perhaps instinctively they have adopted some of the best points of the British stroke." After the Killarney trip the Pennsylvanians will scatter, some visiting the Continent and others returning to the United States on the Victorian. They will leave for Dublin July 5. They are very enthusiastic over the victories of Kraenzlein, Duffy, Cox and Baxter at the Stamford Bridge athletic meeting, and they will be greatly disappointed if they fail to maintain their record.
