MOUNTAIN CLIMBERS' SUPPLIES.—The outings of the Mazamas have resulted in the development of an extensive business here in the way of furnishing camping and mountain-climbing outfits. For some time dealers in such outfits have been doing a thriving business. To say nothing of sweaters and bloomers for the women, and sunbonnets, gloves and thick socks and spiked shoes, and spikes for ordinary shoes, creepers and portable spike heels to be attached to footwear, there are also, for hatching and picking, canyons, cooking utensils and many other things which all have to purchase. Many very ingenious things and sets of things in tin and sheet iron are found in the camping outfit—kettles and pans and cups which fit under each other and occupy small space; Dutch ovens, tin reflectors, portable ranges, tin stoves and flasks, and many other conveniences charm the money out of excursionists' pockets. A small haversack is provided containing a large flask or canteen, folded around which is a sausage for making coffee or boiling anything in a frying pan, a plate, and, and knives and forks in a side pocket, all in a space of about six inches.

JOHN CARP'S FENCED LANDS.—Some curiosity has been manifested by several persons here to know how it is that the suit against John Carp for enclosing Government lands by fencing them has been dismissed by the United States Court here about a dozen years ago, has cropped up again. One of the parties interested in the case suggested that this probably came from the fact that some Government official whose term of office is about to expire wants a permanent job. He explained by saying that suit was brought against Carp by the United States Court in California some 12 years ago and a decision was obtained against him. A United States Marshal or deputy was sent to tear down the offending fence, and to take down some of the panels, and reported. Not long after the fence was made whole and the official was made foreman of Carp's rather extensive ranch, and for of that report to the contrary has charge of it yet. As Carp offered no testimony in the case, it is supposed that he has an idea that he can "beat" the government on the execution. It is about time that Carp owned the lands now, as he has had them enclosed so long.

THOSE BLESSED BELLS.—The police are arresting people who have no bells on their bicycles, and the Municipal judges fine them. In order to escape or defeat the provision of the law requiring bells on bicycles a number of messenger boys and others have procured cow bells, which they strap to some part of their bicycles, and with which they keep up a disgusting and unnecessary racket continually. There will soon be a loud demand for the abatement of this nuisance. The law should call for suitable bells on bicycles, and every one who goes careering around the streets keeping up a constant din with a cow bell or a church bell should be stopped. Certainly the law should be complied with in a proper and reasonable manner, and people should not be defeated with the eternal jangling of bells that annoy and give much trouble at times. Better to take some chance of being run over occasionally than to be permanently deafened or distracted by the bells, bells, bells.

TO ESTABLISH GERMAN HEADQUARTERS.—The German Aid Society, at its last meeting, selected a committee of four to confer with similar committees from the other German societies of the city with a view to raising funds for the building of a hall and the establishment of permanent German headquarters and clubrooms. The German Aid Society's committee is composed of John Reischer, C. H. Mendelsohn, Paul Weisinger and C. J. Schabel. It is expected that all the committees will be chosen within a fortnight, and the conference will be held about that time.

FINED FOR KILLING A ROBIN.—Game Warden Quimby yesterday caused the arrest of Sidney Legard, of Mount Tabor, who pleaded guilty to the charge of killing a robin and was fined. CARL ALBERT REUPPEL.

ENTITLED TO SUPPORT

CHILDREN, IF ADULT MUST AID POOR PARENTS.

Neglect of Father to Provide for Offspring During Tender Years Is No Defense.

A child, if able, must support his father who is poor and unable to earn a livelihood, notwithstanding such father may have neglected to provide for the child during its tender years. This was the effect of a decision rendered by Judge Cake yesterday in the matter of the petition of Marie Labovitch against her sons, A. L. and L. Labovitch, asking for a monthly allowance.

They set forth in their answer that he owed their mother for a divorce in 1871, and that she, instead, was granted the decree of matrimonial dissolution, and awarded the custody of the children. They alleged that she was compelled to defend the divorce and that she subsequently reared and educated them, and the father did nothing whatever for them. Not having acted the part of a father when he ought to have done so, the sons contended that he is not now entitled to consideration at their hands, and also that he cannot support himself, and has all along and also recently done so.

The matter came before the court on a motion by the District Attorney and Otto Kraemer, acting as counsel for the petitioners, that the part of the answer be stricken out. The court allowed the motion, holding that the statute is intended as much to guard the interest of the county as it is for the good of the indigent poor.

The statute referred to is as follows: "Every poor person who shall be unable to earn a livelihood in consequence of bodily infirmity, idleness, lunacy or other cause, shall be supported by the father, mother, children, brothers or sisters of such poor person, if they or either of them be of sufficient ability to do so. Provided, that when any person becomes a pauper from intemperance or other bad conduct, he shall not be entitled to any support from any relation except parent and child."

Edward Mendenhall, attorney for the defense, opposed the motion. He argued that the statute was subject to a liberal construction by the court, and submitted authorities on the point. He asserted that it was absurd to suppose that this law must be construed to cover every case, irrespective of the facts and circumstances surrounding it. He asked if this law meant that a father who deserted his child in his infancy, to be brought up by a public institution, such as the Children's Home, and turned up 20 years or so afterwards and claimed relationship, was entitled to have that child support him. He said the present was almost a parallel case.

Judge Cake could only find in the law that a child must support his father who is poor and unable to earn a livelihood. What may previously have occurred. The present decision is only preliminary to the main issue, and the case will be tried out later on, on its merits, and the question of the ability of the children to pay \$20 or \$30 per month to their father, whether he can support himself, and other facts will be gone into fully.

MISSIONS IN CHINA.

Dr. Eliza Leonard Writes to Friends From the Late Seat of War.

Dr. Eliza E. Leonard, who is stationed at Peking, China, has written, under date of May 25, to friends in Portland. After telling of the departure of the American troops, Dr. Leonard says:

"I wonder what the Chinese court will do when Peking is practically vacated. I don't believe they will be in any hurry to return. Three more of our school boys have come in. One was last shot and killed. He has had a hard year; died 200 miles, then found things quiet, got work and stuck at it until recently, when he felt he must get back in Peking and who was left. The other two boys and sons of Mr. Chung, our head school teacher. We learned that they had been taken by army officials, who were pleased with them, and finally Mr. Chung got back of them. He went down to Chinanfu for them. The officials were very loath to give them up. One wanted 2000 taels (about \$1000 gold), but finally gave up his boy without more trouble than the pay for school teachers. One lad (9 years) had two teachers and 500 soldiers at his beck and call. He also is quite a traveled gentleman, having been to 251-anfu, where the court is at present."

"Mr. Kilke and Mr. Cunningham went to Pao-tung-fu last week, so that in company with Mr. Lewis they might meet the Chinese officials, when they turned over the deeds to the property just outside the city. This is a voluntary gift of the citizens of Pao-tung-fu. The deeds were not the Chinese, but were signed by local officials, on red paper. The site is a beautiful one. We trust before long we may be able to build there and re-establish our work. Our old property there will probably be leased to a Tien Tain floral firm."

"The spot in front of the Simcox house, where there are nine graves, will be carefully looked after. We will put out trees, and the floral firm will put in some walks. The lease will run 10 years, when the property will revert to the mission. This we have no doubt, feasible scheme for having the place cleaned up, guarded and looked after. At present we could not, with full safety, put a Christian family on the property. The country about Pao-tung-fu is quite an unsettled state. What is to be we do not know."

It may not be generally known that doors of Oregon fir are finding great favor in the East. They are stronger and more durable and hold screws and fittings much better than the soft cedar. Any necessary width of this lumber can be obtained, and when it has been sawed all up or pitch is driven over the top, it is a fully white. Suitable lumber for doors is not to be found in the East. An agent has been inquiring into the probabilities of the saw and door business here, and talks of an order from a single house for 300,000 doors.

It is to use electric motors capable of pulling loaded cars, one at a time, from the Jefferson-street depot down some street railway to the terminal grounds.
