

STRIKERS UNABLE TO AGREE CONFERENCE ON STEEL STRIKE WILL MEET AGAIN TODAY.

Three of Principal Leaders Were Absent Yesterday, But Where They Went No One Knows.

PITTSBURG, July 31.—Hope deferred maketh the heart sick. This is expressive of the feelings of the majority of Pittsburghers tonight outside the inner circle of the Amalgamated Association executive board, which has been considering the proposals for a settlement of the strike for two days without agreement. How the members of the board feel is known to no man on the outside.

The second day of the executive board's deliberation was unproductive of any change in circulation, and for the conspicuous death of results. The absence of three of the principal members of the board from the session today gave rise to the story that the members were divided in their ideas of the peace proposals, and that in order to satisfy all, Secretary Williams had sent to New York to make modifications in the proposals.

It was after 11 o'clock this forenoon when the conference met. Chief Executive Secretary John Williams, Assistant Secretary M. F. Tighe and National Trustee John Morgan were not present. It was subsequently learned that the three absentees were out of the city, and had taken their departure on early trains. It was said later that they were expected to be present when the board shall be called together tomorrow morning. Where they had gone and what their mission was could not be learned.

MORE LAND CLAIMS DRAWN WHEELS IN OKLAHOMA RELIEVED OF 4200 NAMES.

Commissioner Richards Rules That Negotiable Paper Will Be Taken for Town Lots.

EL RENO, O. T., July 31.—Two thousand and one hundred names were drawn from each wheel in the great United States land lottery today, making a grand total of 5000. Tomorrow the list of prize-winners will be completed. The drawing of numbers will continue on the platform north of the Irving School building until about 10,000 names for each land district have been drawn from the wheels, making a total of 20,000 names. As there are only about 13,000 claims in the new country, the drawing of 10,000 names will go beyond the point where persons above 13,500 can get land. The remaining envelopes will draw blanks, but as the Commission desires to impress the country with the fairness and honesty of the drawing, every one of the 10,000 envelopes

He is a Fiery Anarchist.

NEW YORK, July 31.—It developed tonight that Gallotti's name was connected with the story which was circulated months ago in Paterson that King Humbert was sought by anarchists. At that time Garenno Fieschi, a workman in a dye works at Paterson, was shot and killed by Giuseppe Speranza. The latter was connected with the anarchist movement in Paterson, and was known as the "Red" of Paterson. A letter found on him told of the plot to kill Humbert. It called on Speranza to act as one of 37 men to leave this country to take vengeance on the crowned heads of Europe. Two weeks afterwards King Humbert was assassinated. It is not said that the letter found on Speranza was signed by Gallotti. It has always been asserted that Speranza's killing of the forerunner was to make up for his refusal to be one of those to go to Europe.

WAS TO KILL THE CZAR.

Gallotti Left the United States for This Purpose.

PATERSON, N. J., July 31.—Inquiry among the members of the anarchist group in this city, which has been arrested at Zurich reveals the fact that a man named Amiel Garriott was formerly connected with the anarchists here, and was well known among them. He was employed as a weaver in the Paragon Silk Mill, in this city. It was stated today by a member of the group that Gallotti sailed away with Breard, Lanni and Quantavillo, who they departed on their mission of assassination. Gallotti had been selected by the anarchists to kill Nicholas, Czar of Russia, and had accepted the mission. He was known as a determined man, and one that would be likely to take desperate chances in accomplishing his purpose.

American Woman Fined.

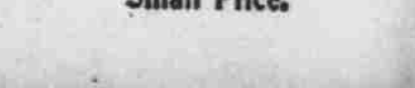
