

CITY NEWS IN BRIEF

EXTENSIVE SEWER WORK.—Two rather extensive sewers are now in course of construction on the East Side. One is in the East Oak street sewer extension district, and is 13 blocks in length, extending in a zigzag direction from the intersection of East Oak and East Sixteenth away out into the Ladd farm. A considerable section of it passes across a slough, south four blocks of this, between East Sixteenth and East Twentieth streets, being elevated on a pile trestle, and another section of about two blocks, being elevated in timber bents. It is supposed that this low ground will be filled in some time in the future, so as to cover the sewer to a proper depth. The sewer is of 24-inch, double-strength vitrified pipe, and is completed will cost about \$18,000. The other is the Beech-street sewer, which is completed from the county road, near the O. R. & N. car shops, D. J. Just east of Maryland avenue. A large force of men is employed on the job, and it is progressing rapidly. The water in the Willamette is falling fast, and in a few days the work of constructing the sewer to the flat to the river will be commenced.

STRIKE MAY AFFECT CANNERIES.—The cessation of ocean freight traffic between Portland and San Francisco, on account of the strike, is likely to cause some trouble in the canneries along the Columbia. A great deal of muretic acid is used in soldering cans, say 20 or more carloads of muretic acid, and some probably 40 or 50 carboys during a season. The supply of this acid is rapidly becoming exhausted on the river, owing to the large pack and canneries who are waiting for ocean traffic to be resumed are liable to exhaust their supply. Of course acid can be procured by rail, but as the expense is greater this will not be tried except as a last resort. An enormous quantity of block tin and lead is also used to manufacture the solder used in salmon canneries, and tin is likely to run short if the general strike comes in. In case a sympathetic strike should be ordered in Oregon, and the can factory in Astoria should be shut down, the consequences to canners on the Columbia would be very serious.

BECAUSE HE CAME FROM MISSOURI.—The recent disturbance near Twenty-first and Wilson streets, when C. J. Harford and George W. McMahon forcibly entered two houses and assaulted Motorman J. C. Marks, was inquired into at the Municipal Court yesterday. Marks testified that the defendants started a disturbance on the car on which he was motorman, because the conductor could not give them transfers to St. Johns. The defendants, who appeared to be under the influence of liquor, beat the witness, and when he sought refuge in a restaurant, they locked the doors after him, the defendants broke down the doors and assaulted him. One defendant found fault with the witness because he came from Missouri. The defendants said they did not know what happened, as they had been drinking. The case was continued.

JANITORS MAKE SPECIAL POLICE.—Janitors of the public schools of the city are to be made special policemen, in order that they may have power to protect school property during vacation. Complaints have reached the Board of Education in regard to unruly boys running windows in several of the suburban buildings, while more or less trespassing has been going on in various portions of town. Janitors who are called by Police Cohen, chairman of the Police Commission, can obtain an order on Chief McLaughlin, who will administer the oath and confer a star. Then hobos and hoodlums who refuse to "move the hell out of here," says so, may be collared, and the patrol wagon sent for.

REPLACING MORRISON-STREET BRIDGE.—Bids for supplying the lumber for re-laying the roadway of the Morrison street bridge were opened by the Board of County Commissioners yesterday and the contract was awarded to the East Side Lumber Company, of 210 1/2 East Second street. The work of re-laying the bridge will be commenced as soon as practicable. The bids submitted were as follows: North Pacific Lumber Company, \$147 75, exclusive of barge cost; East Side Lumber Company, \$152 00, with barge rental \$5 a day; East Side Lumber Company, \$191 50.

COMPLAINTS OF INCIVILITY.—Frank Hornstrom, an old and respected citizen, who broke into a burning house a short time ago and found a lighted candle in the mattress of a bed, was very indignant yesterday. He called on Police Cohen, who found in the possession of the police authorities, and yesterday when he went to police quarters he was not treated with common civility or respect. Some body evidently made a mistake, and Mr. Hornstrom should call on Chief McLaughlin when he has any business with the police department.

UNION TEAMSTERS CALLED OUT.—At a meeting of the Teamsters' Union last night it was decided to call out all union teamsters working for the Banfield-Vesey Company. The teamsters say that about two weeks ago they entered into an agreement with Mr. Banfield by which he promised to take back the union men within 48 hours, and that this arrangement has not been kept. The union men say that the fight is on worse than ever.

SALOON-KEEPERS IN TROUBLE.—The cases against Robert W. Patterson, saloon-keeper, and his bartender, C. Feldman, and Fred Lovy, saloon-keeper, in connection with the robbery of \$80, on the complaint of Frank Johnson, a recent arrival from Minnesota, will be heard at 9:30 o'clock this morning in the Municipal Court. Patterson, Feldman and Lovy have engaged three lawyers to defend them.

THOUGHT GUN WAS NOT LOADED.—Charles Kuschitzki, of Elma, Wash., was taken to the Good Samaritan Hospital yesterday, suffering from a gunshot wound in the right leg. He recently had occasion to examine a gun which he thought was not loaded, when the charge suddenly exploded and he was struck in the right knee. The surgeons hope to avoid the necessity of amputation.

INCORPORATION.—Articles of incorporation were filed yesterday in the office of the County Clerk by A. Lindley, F. B. Holbrook and William A. Munty, for the Oregon Land & Water Company. The purpose of the corporation is to conduct a general land and irrigation business. The capital stock is \$100,000, divided into 500 shares.

ONLY ONE GIRL, ETC.—Talk about a girl! They mutually admired caused unpleasantness last night between John Swanson and C. F. Johnson, as they argued the question at Second and Washington streets, and they got into a lively fight. Policeman Kitzmiller arrested both fighters and took them to the police station.

WEATHER TRYING ON BRIDGES.—The exceptionally dry weather is very trying on the planks in the decking of the various bridges about the city, causing the worn ones to twist up and break, and the city bridge crew is kept busy repainting the substructure of bridges all over the city.

PRINEVILLE OIL EXCITEMENT.—Will Wurtzweiler, the leading merchant and a capitalist of Prineville, is at the Imperial, asked about the reported oil strikes at Prineville. Mr. Wurtzweiler was non-committal. He hopes they have struck oil in paying quantities, but as no development work has been done, he says it is impossible to know what they have. He acknowledged, under high pressure, that there is a great deal of excitement over the prospects out there, but no amount of persuasion would make him divulge the slightest excitement himself. Asked if it were not true that the whole Prineville country is staked off in oil claims, Mr. Wurtzweiler blushed (the first time in his life), and admitted that a great many claims have been taken. From other sources it is learned that every indication points to a speedy development of the oil resources of the country immediately surrounding Prineville.

PELICANS IN THE MUSEUM.—Handsome mounted specimens of a number of species of birds have lately been added to the Free Museum in the City Hall. Among them are two fine, large pelicans, which attract much attention from the large pouches under their long bills, in which they carry home fish to feed their young. They are sometimes called the pelican of the wilderness, and are popularly supposed to feed their young with their own blood, when, by the sweat of their brows, they can procure no other food for them. There can be no question as to the truthfulness of this statement, as it is on record in one of the books of Captain Marston that while a boy in a menagerie was listening to the showman descanting on the filial tenderness of the pelican one of these birds thrust its bill into his hand and secured by the sweat of their brows, they can procure no other food for them.

AUTOS TO GREENHAM.—Fred Merrill will start an automobile line to the 12-mile hour and Greenham some time in the present month. He said in an interview that two autos were on the way to Portland and would arrive next week, when trips would be started by the way of experiment. He said that the matter had been considered for some time, but that regular trips would not be made at the start. It would first be ascertained how it would pan out before starting trips on schedule time, but Mr. Merrill intimates that it might be a permanent enterprise, should things turn out favorable. The object, he said, is eventually to operate an automobile line to Mount Hood, as this will not be done this season, as it is too late for that.

TROLLEY CAR VICTIM DIES.—Henry Averill, 65 years old, of East Harrison and East Sixth streets, who was injured by being run over by a trolley car on July 29, at Grand and Hawthorne avenues, died last night at St. Vincent's Hospital. He had tried to get on the Mount Tabor car, while it was in motion, as he slipped and fell. His right arm was so severely crushed that amputation was necessary.

SUES FOR \$2500 DAMAGES. Boy Who Was Accused of Theft and Arrested by Police.

John Wells, a 15-year-old boy, through his guardian, Mrs. S. T. Wells, has filed a \$2500 damage suit against Henry Melster. In the complaint Melster is charged with having on June 18 seized and rudely and violently assaulted the boy, as well as publicly and unprovokedly having accused him of the heinous crime of having attempted to break into a building for the purpose of theft. It is alleged that the boy was dragged and forced against his will into a room and there held by Melster and his servants until the police patrol wagon was summoned and the lad taken to the police station. It was found that he had committed no crime and violated no law, and he was accordingly released from custody. Yesterday on application his mother was appointed his guardian for the purpose of filing and prosecuting the suit for damages. For injuring the boy's character and reputation and his ability to secure employment, damage to the extent of \$1000 is asked. For the shame, ridicule and humiliation and the nervous agony and physical pain that the boy suffered, damages of \$1500 are prayed for, making the total of the suit \$2500.

Melster, against whom the suit has been filed, keeps a saloon at Seventh and Thurston streets. The incidents leading up to the boy's arrest, according to the Melster side of the case, were as follows: On the evening of June 18 Melster was informed by a neighbor of boys who were trying to break off the lock of his cold-storage house, near his saloon. Proceeding there, he found them in the act of hammering away at the lock. He asked the boys what they were doing, and young Wells asked him in a jocular fashion what business it was of his. Melster then seized Wells and dragged him to the office of the police. The police patrol wagon was called and the boy was taken to the police station. He was there released on his own recognizance. When the case came up in the Municipal Court Melster did not prosecute the charge of trespass, as his desire was to scare the boys so that they would make no further pretensions on his cold-storage house. "No case" was marked in the docket.

William Hall has brought a suit for divorce against his wife, Minnie Hall, to whom he was married in Vancouver, December 25, 1892. The grounds alleged for the divorce are willful desertion at Baker City, in March, 1897.

Gita Brown has filed a suit in the State Circuit Court, praying for a decree of divorce from her husband, R. A. Brown. For two years the latter, she alleges, has neglected and refused to provide for her support. There are three boys, ranging from 3 to 7 years, dependent upon the mother, and she prays for alimony of \$50 monthly.

In the United States Court yesterday in the case of Philomene Smith et al. vs. Martha Bonifaz et al. Judge Bellinger made an order allowing plaintiffs to sue in forma pauperis. The suit is to recover possession of an allotment of land on the Umatilla reservation. Mrs. Philomene Smith is a member of the Walla Walla tribe of Indians, and her husband was a white man. The other parties to the suit are of mixed blood, and the whole business is mixed up so that it would take a Philadelphia lawyer to understand it.
