British Policy in South Africa. NEW YORK, Aug. 16.—Concerning the effect of the discussion in the House of Commons of the latest South African situation, the London correspondent of the Tribune cables: Mr. Chamberlain carried the House of Commons with his defense of Lord Kitchener's banishment proclamation. It seems clear that the British Government is determined that September 15 shall mark the beginning of the re-organization of something like civil authority in South Africa.

BRITISH FORCE OF FIFTY RENDERED TO THERON.

Kitchener Reports That French's Cape Colony Column Is Gradually Driving Boers Northward.

LONDON, Aug. 16.—The War Office has received the following dispatch from Lord Kitchener, dated Pretoria, August 15: "While a party of 50 of French's scouts were proceeding to join a column near Bethesda, they were surrounded in the hills by a superior force under Theron, and surrendered. One was killed and 40 were taken prisoner, including 1,500,000 marks' worth of chartered securities, the property of the Garbart Terinien Company, of Dulsburg, of which he was manager. Embassier Captured in Milwaukee by Detectives.

CHICAGO, Aug. 16.—Garhart Terinien, of Dulsburg, Germany, accused of forgery and embezzlement by the German Government, was captured in Milwaukee by Chicago Pinkertons and brought to this city for safe keeping. The prisoner is wanted by the German authorities for having forged and hypothecated 1,500,000 marks' worth of chartered securities, the property of the Garbart Terinien Company, of Dulsburg, of which he was manager.

Outlaws Hiding in Wyoming.

CHEYENNE, Wyo., Aug. 16.—James G. Rhea, ex-Sheriff of Carbon County, is of the opinion that the Great Northern train robbers are in Wyoming. Costly Molinex Case.

NEW YORK, Aug. 16.—Edward R. Carroll, Clerk of the Court of General Sessions, has sent to Controller Cole a bill for \$383,000 for printing a volume of testimony taken at the trial of Roland B. Molinex for the killing of Mrs. Kate J. Adams. The bill for stenographic work and other expenses connected with the trial far exceed the expense of this mere printing of the records of the case.

PAN-AMERICAN NEWS.

The Asphalt Case.

NEW YORK, Aug. 16.—A dispatch to the Herald from Caracas, Venezuela, says: The Federal Court has declared inadmissible the recent formal exception to the composition of the court by the New York & Bermuda Company on the ground of partiality. The court has dismissed all exceptions filed by the New York & Bermuda Company and imposed upon the company the costs. This decision affirms the moving order of the court of the court dissolved. The decision does not affect the main question in the suit brought by the Warner-Quinn syndicate for the possession of the Felicidad asphalt mines.

Rockhill Will Remain.

Until the Protocol is Finally Signed. WASHINGTON, Aug. 16.—The State Department has received a cablegram from Mr. Rockhill, stating that he will remain in a few days, and that he will remain in Pekin, in view of this prospect, instead of leaving at once, as he contemplated. The report of the resignation of Mr. Rockhill's cablegram is construed to mean that the signing here refers to his with the Chinese plenipotentiaries.

Foreign Troops Still in Pekin.

PEKIN, Aug. 16.—The troops of the powers have not yet evacuated the public buildings. The British and American propose to occupy the Temple of Heaven and the Temple of Agriculture until their barracks are ready. Sir Ernest Satow, the British Minister, thinks it would not be wise to withdraw before the protocol has been signed in conjunction with the Chinese plenipotentiaries, as withdrawal would remove the chief instrument of the Chinese sign. The Japanese still hold the northern section of the city. It is considered significant of their relations with the Chinese that a Japanese Colonel has been elected to command and to receive the Chinese police. The opinion is growing that the court will refuse to return so long as the powers maintain such large forces in the province of Chi Li. The protocol does not provide for the destruction of the forts, the Ministers of the powers having failed to agree on this point.

Death of a Fugitive Cashier.

NASHUA, N. H., Aug. 16.—A letter received today from Assension, Paraguay, announced the death of Frank A. McKean, ex-Mayor of Nashua, and ex-chancellor of the Indian Head National Bank of this city. The cause of death was a heart attack. McKean had been in Paraguay since 1883, because of shortage of about \$100,000 in the finances of the bank. He had resided in South America since that time.

Brazilian Presidential Candidates.

NEW YORK, Aug. 16.—The Brazilian National Convention is divided on the question of Presidential candidates, says the Rio de Janeiro correspondent of the Herald. The members have decided to support Governor Rodrigues Alves of San Paulo, who is backed by President Campos Salles, while others favor Governor Quintino Bocayuva, of Rio de Janeiro.

Great Mortality in Lima.

LIMA, Peru, Aug. 16.—The great mortality in Lima is again attracting attention. There has been an alarming number of deaths, and the health authorities have just been held here by the German and British colonies in memory of the late Dowager Empress Frederick, of Germany.

Trouble Is Feared in Brazil.

MONTEVIDEO, Uruguay, Aug. 16.—The British cruiser Cambrian and the gunboats Nymph and Basilek have sailed for the Brazilian coast. It is believed that the departure of the British vessels has a connection with the troubles feared in Rio Grande du Sul.

The Mosquito Problem.

NEW YORK, Aug. 16.—The Board of Health of Montclair, N. J., has given the authorities power to purchase oil to begin the work of exterminating mosquitoes. The stagnant pools and swamp lands will be attacked first. The plan adopted by Professor Howard in South Orange of pouring the oil on the surface of the water will be adopted. This is the first time in this section that municipal action has been taken on the mosquito problem. Experimenting with the method has been carried on by private subscriptions, or by state officials.

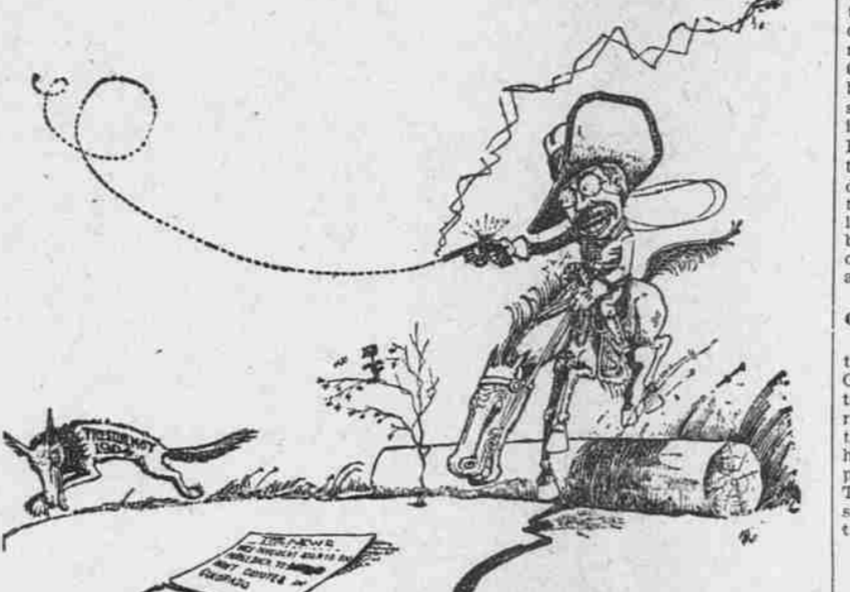
Lost the Wager and His Life.

All the men arrested were held in jail of various amounts.

NEW YORK, Aug. 16.—All doubt as to Walter Travis' appearance in the National golf championship at Atlantic City September 9 has been brushed aside by the news that the amateur champion will arrive from England August 21. The meetings where he met amateurs and professionals have probably sharpened his game, so that two weeks' practice here will put him in the pink of condition for his meeting with Douglas Zeely and the others who are awaiting to try to take his title away from him.
