

DE-WINDT WILL TRY AGAIN

OVERLAND JOURNEY FROM PARIS TO NEW YORK.

He Will Travel Over Siberia, Cross Behring Straits and Come Down the American Side.

LONDON, Sept. 22.—Harry De Windt, the explorer, is about to make a third attempt to accomplish an overland journey via Behring Strait between Europe and America. On the first occasion, starting from New York, he managed to reach the Asiatic Coast of the Straits, but owing to his capture and subsequent ill treatment by the natives, he was obliged to return. Last year he again attempted the journey in the reverse direction, but owing to the political situation in China and on the Amur, Count Lamsdorf refused to allow him to cross Siberia. Mr. De Windt is receiving assistance from the Russian and American authorities, including Commodore Melville, in Washington, as a result of which he intends to start on his journey forthwith.

Early in November, George Harding, who accompanied Mr. De Windt on all his previous travels, will proceed from Paris to Yakutsk, where he will get together dog and reindeer teams and will await Mr. De Windt's arrival. December 20, Mr. De Windt will leave Paris and travel by the trans-Siberian Railway direct to the terminus at Irkutsk, which place will be reached December 20. Thence the traveler will proceed to Yakutsk, a distance of 1200 miles, involving a three-weeks' sleigh journey. Arriving at Yakutsk early in January, Mr. De Windt will join Mr. Harding, who will then have in readiness the implements for the long journey to Behring Straits. A fortnight will be spent at Yakutsk, and in the third week in January the two travelers will proceed unknown to the natives and practically unknown country to Nijni Kolyma, the most remote north-easterly settlement of Russia, on the Arctic Ocean. This region has never been visited, except by an occasional Siberian trader, although one portion of it was traversed by an American traveler when searching for the survivors of the Jeannette. Between Yakutsk and Nijni Kolyma, a distance of 1200 miles, transport will be by means of reindeer teams. Beyond rough government shanties, known as postoi, erected every 100 versts, to enable a stray traveler to light a fire, there are no habitations, and the travelers will have to sleep in the open. This portion of the journey, and especially that over the Verkhayn Mountains, will be attended with considerable difficulty.

It is expected that the settlement of Nijni Kolyma, which has a population of 2000, will be reached in February, and there Mr. De Windt hopes to fall in with Teukuchil fur or ivory caravans returning to one of the small settlements on the shores of Behring Straits. It is of course, Mr. De Windt's intention carefully to avoid Oumudlik, the settlement where he nearly lost his life, and to make for East Cape, 120 miles to the north and 100 miles from Nijni Kolyma, reaching there in the middle of April. Mr. De Windt will then cross on the ice to Cape Prince of Wales, the most westerly point of Alaska, where the Behring Straits are only about the same width as the English Channel at Dover. Should the ice conditions not be favorable, the expedition will be postponed. Mr. De Windt will be accompanied by the Washington Navy Department, call for Mr. De Windt and convey him across the Straits, whence he will sail down the coast by the Yukon or Mackenzie Rivers to San Francisco, Winnipeg and New York, which it is hoped will be reached in June next.

Mr. De Windt's chief object is to survey the country to the northeast of Yakutsk, to which point the Russian Government is projecting a railway next year from Yakutsk. Yakutsk is situated on the junction of the Manchurian and Siberian sections. The country from Yakutsk to Behring Straits, which, with the exception of one mountain range, is all level, also is surveyed, in view of a possible extension of railways, on the American side, surveys already working on the northern extension of the Klondike railway to the American coast.

Although comparatively narrow, the straits are not without difficulties, and the possibility of a bridge connecting the two continents, which the American engineers have under consideration the construction of a tunnel.

RUSHED BY BOERS

Commander of Lovatt's Scouts Killed on the Orange River.

LONDON, Sept. 22.—The War Office has received the following dispatch from Lord Kitchener, dated Pretoria, September 22: "Kritzing, while endeavoring to force a passage of the Orange River, near Hushenel, at 1 o'clock Friday morning, rushed the camp of a party of Lovatt's scouts, who failed to cross the river, but the scouts lost heavily. Lieutenant-Colonel Murray and Captain Murray, his Adjutant, were killed. Deep regret at the loss of Colonel Murray, who throughout the war led Lovatt's Scouts with great gallantry. Under cover of darkness, the Boers managed to carry off a gun. They were promptly followed up and the gun was recovered in a smart engagement in which Kritzing lost two killed and 20 taken prisoners."

Lord Kitchener also reports that the British captured by the Boers in the bush near Scheepers Nek, September 11, have been released, and that the British casualties in the recent Vlakfontein engagement, when the Boers captured a company of mounted infantry and two guns, were one officer and five men killed, 23 men wounded and six officers and 35 men taken prisoners. He announced that these prisoners have been released. He further reports the capture of two commandos—one consisting of 55 men, under Commandant Koeke, who were taken together with their entire transport, west of Adenburgh, and the other, consisting of 54 men, including J. F. Botha, who were taken with 48 wagons and their belongings, 45 miles south-east of Colesburg.

Lord Kitchener's latest dispatches, although they contain good news as well as bad, have contained little to reassure the people concerning the state of affairs. The loss of Lieutenant-Colonel Murray, a brother of Lord Mansfield, is keenly felt. There is little doubt that further details will show it was a serious affair.

Lord Kitchener announces that the Buffalo River is flooded and that there is no change in the situation in that district. The latter fact shows that General Lytton has not yet succeeded in interfering with the movements of General Botha. P. J. Botha, whose capture Lord Kitchener reports, is a brother of the Boer commandant. According to the latest advice from Cape Colony the situation there is serious, owing to the sympathy and aid which the Dutch are giving the Boer commandos. The British find it difficult to obtain news of Boer movements. General French's task is described as the hardest of his career during the whole war. The strength of the Boers in the field is now estimated at 11,000. If these figures be correct, the Boers must be constantly gaining recruits. Their supply of arms and ammunition seems to be inexhaustible.

In Boer circles in Holland it is asserted that everything is prepared for a Dutch rising in both Cape Colony and Natal. A most alarming letter from Cape Town is published today by the Daily Express.

THE PRESIDENT'S SUNDAY

HOW MR. ROOSEVELT PASSED THE DAY.

Rebuked a Small Boy for Attempting to Snap-Shoot Him—Outing With General Wood.

WASHINGTON, Sept. 22.—President Roosevelt's first Sunday in Washington as Chief Executive was comparatively uneventful. In the morning he attended religious services with his brother-in-law, Douglas Robinson, and in the afternoon took a long stroll with General Wood. In the evening he dined with the family at the residence of Captain Cowley. Mr. Roosevelt probably will move into the White House Tuesday, his family joining him there a day or two later. The President's investigation committee, last week wrote to Major Erasmus L. Hawkins, who made the original charges against Colonel Helstead's conduct of certain affairs in the Philippines, asking him to submit to the committee a full, sworn statement of the charges he makes against Colonel Helstead. In reply, Major Hawkins addressed a letter to the President, saying: "I beg to say that I have preferred charges against Lieutenant-Colonel H. O. Helstead before the War Department, which charges are now presumably to be investigated by it. I do not desire to prefer charges before your committee against Lieutenant-Colonel Helstead, but stand ready to answer any summons to go before your committee and prepare to bring with me many documents shedding light on the subject-matter of the investigation with which you are charged."

"Others who have material knowledge of documents germane to your investigation, who should be called before you, are Colonel McIntyre, attorney-at-law, Washington; General W. W. Dudley, attorney-at-law, Washington; Major-General H. C. Corbin, U. S. A.; Governor Allen, late of

Idaho; Judge James E. Boyd, Greensboro, N. C.; Hon. G. D. McKeljohn, late Assistant Secretary of War, Captain W. E. Wharton, United States Census, and others.

"I presume the Secretary of War will furnish the committee a copy of the charges preferred against Colonel Helstead and his answer to said charges."

Killed Her Father-in-Law.
CHEYENNE, Wyo., Sept. 22.—Mrs. Lena Fair shot and killed her father-in-law, Michael Fair, at their home in South Cheyenne this evening. Mrs. Fair is a girl of 20 years. She says Fair, who is 62 years old, threatened to kill her, and when she fired he had one hand on her throat and with the other was reaching for his revolver. The police found a revolver in the hip pocket of the dead man. Mrs. Fair was arrested.

The officer, thereupon, turned back, and the President and Mr. Robinson continued their walk, going in a roundabout way to the Cowles residence. Quite a number of persons called during the afternoon to pay their respects, among them being Admiral and Mrs. Dewey. General Wood left here tonight for Havana, via Tampa. The expectation of General Wood is that he will be able to complete arrangements with the conduct of affairs in the islands can be handed over to the Cubans by the first of next May.
