FOR LIBRARY USE.—Mr. John S. Billings, director in charge of the New York City Library, devoted to publications relating to the development of the United States as a whole, has sent to The Oregonian for a copy of the pocket handbook, which he wants as an addition to the permanent collection of books in his department. For reference purposes the handbook will be found available for a long time in the future. It actually tells everything in a general way that any reader for information may desire to know about the Pacific Northwest. In a permanent binding the handbook will prove a valuable addition to any library. OWNERS OF A POLE.—Perry H. Blyth complains that there is an old rotten pole in the edge of the sidewalk in front of his property on Morrison street, between Seventeenth and Chapman, which he wants to have removed, but the owner of the pole is unable to find it. The pole is so decayed that, as Mr. Blyth says, one could drive a pickaxe through it, so it would not be a safe pole. The pole is raised up among a large number of telephone wires he does not desire to meddle with. He has applied to the electric light, telephone and telephone companies to remove this pole, but each says it is the property of one of the others and no one lays claim to it. Mr. Blyth has cast loose the wire which connected the pole with his telephone, and is likely to fall at any time, and may injure some one. The person or corporation who owns that pole will please come to the front and look after it. In the meantime Mr. Blyth might spike some artificial limbs to the pole and call it an ornamental shade tree.

SEWER WORK DELAYED.—The construction of the outlet for the Beech-street sewer system across the grounds of the O. R. & N. Co. has been a tedious job, and although the contractors, Smyth & Howard, have pushed the work as energetically as possible, some delay has occurred, and as the season is fast closing there are fears that the rains might set in and raise the river and prevent the completion of the sewer across the lowlands. A considerable portion of the sewer across the lowland has to rest on a concrete foundation laid on piles driven to a considerable depth, which requires time. City Engineer Chase and Chairman Branch of the sewer committee, who have been feeling nervous about the progress of the work, went over to inspect it yesterday. They say the job is being done in first-class style, and that the foundation for the sewer will all be completed and the work past any possibility of damage from a rise in the river before the rain set in.

GRASS FOR CHICKENS.—A box as big as a small house is being filled with Oregon grass and grasses at the rooms of the State Board of Horticulture, for the Fairington Exposition. The specimens were grown along the line of the Southern Pacific Company, and are well calculated to give the people of the South a good idea of the fertility of Willamette valley soil. The grasses are of many kinds, bearing full heads of plump grain, is represented in bound sheaves, as in the harvest field. Wheat, corn, oats, barley and speltz are put up in the same way, and there are varieties of strawberries and domesticated. Flax in full yield and flax straw broken, to show the strength of fiber, are also in the collection. Each specimen is marked "Grown along the line of the Southern Pacific Company in Oregon."

TOO FIRM WITH HIS REVOLVER.—F. L. Carson will have a hearing today before Municipal Judge Cameron charged with having threatened to shoot John Northcote with a revolver. Carson was in the Municipal Court Monday, charged with having a revolver in his possession, but he said that he was a sheepherder and required a revolver for his business out in the hills. On the understanding that he would leave town he was allowed to go, and his revolver was kept in the Municipal Court. Northcote says he met Carson in Whitechapel, when the assault took place.

DAVENPORT AT PENDLETON.—Next Saturday evening Davenport will speak at the Opera-House, Pendleton, on "American Caricature" and illustrate his talk with faces of well-known public men. Like his talk in Portland last Saturday night, this is a very good story without price, for a worthy cause—the library of the Pendleton Academy. The good people of Umatilla's metropolis may assure themselves of a very pleasant evening in a character of entertainment which is as rare as it is interesting.

PROPOSED PERMANENT EXHIBIT.—A San Francisco man has been around town several days, interviewing merchants on the proposition of maintaining a permanent exhibit at the Exposition on the plan of that just closed after a month's run. His idea is to draw nightly crowds throughout the year by the hand of a vaudeville troupe, whose personnel and programme will be constantly changed. What success he is meeting with he does not state.

TO EMPHASIZE NATURAL WILDERNESS.—L. L. Hawkins and Parkkeeper Myers, who have finished the construction of a trail into the heart of Macleay Park, are now engaged on a scheme for enhancing the natural wilderness of that picturesque tract. They are accumulating and storing away stuffed birds and animals, such as eagles, grouse, bears, cougars, owls, or anything of the kind which has become scarce and will not stand inspection from a near standpoint. These they propose next Spring to dispose artistically on the trees in the wilder parts of the park, so that they shall be mistaken for living animals. It is expected that persons visiting the park will be delighted to see a bear or a mountain lion evidently prepared to attack them and to see a bald eagle or a blue grouse perched on a tree-top far out of range of shotgun or rifle. As there are numerous bad boys in this city who would take great pleasure in shooting the stuff out of these birds and beasts, a band of stuffed Indians on a staff of war-path will be encamped by the trail in the park, each with scalping knife and tomahawk in hand, crying "Blood, blood, give me more blood." This is expected to deter all hoodlums from entering the park to molest the animals. If it does not their blood will be on their own heads.

OREGON AT THE BUFFALO FAIR.—In the Cleveland Review and Observer of October 18 is a four-column letter by Max G. Cohen on the Oregon exhibit at the Buffalo fair. It goes quite into detail in describing attractive industrial features and speaks in complimentary terms of the people having charge of the Oregon department. Speaking of the fruit the letter says "Oregon is displaying a fine collection of fruit, including apples, peaches, pears, plums and prunes on which the award was granted. The Wilder medals are the recognized standards of awards among the exhibitors of all North America, and they are valued above all others, not excepting the awards of the Pan-American Exposition, for in the many years they have been granted there has never been a question as to the fairness of the decision or the unbiased opinion of the judicial committee."

YOUNG MAN AT SPOKANE.—J. J. Powell made a vigorous defense in the Municipal Court yesterday, when he was accused of loitering on the streets after midnight and refusing to move on. "I'm a stranger in town, and did not know I was doing wrong," he explained. "I have walked around Spokane after midnight and the police did not bother me. Spokane is not Portland. I was walking around Judge Cameron's house and never saw a policeman. I've been a soldier and I've been in the army," went on Powell. "Which army?" asked the Judge caustically. "The Salvation Army," replied Powell. The police evidence was that Powell had been hanging around Whitechapel saloons. On promising to leave the city at once Powell was allowed to go.

HIS WAS ONLY A SAMPLE.—A young man who came here a short time ago from Chicago to be married to a Portland young woman, in strolling about town one day came across a florist's establishment, and looking for a bouquet for his affianced lady, he was attracted by the display of autumn foliage, and he bought a good large handful of sprays, paying therefor \$1. When he took the stuff around to the house he found that the florist had sent in a wagon load of maple boughs and gorgeous Virginia creepers, and the house was decorated with them from front to rear. He concluded that he had paid too much for his sprays.

RUNAWAY GIRL IN JAIL.—F. A. Johnson, a well-dressed, smooth-talking youth, and Ida Knapp, 17 years old, of Bancroft street, were arrested by Policeman Jamieson last night in a saloon on First street near Madison. The complainant was John Knapp, the girl's father. The girl ran away from home a week ago, and the police had been searching for her. Johnson, who said that he is employed by a portrait concern, has been in similar escapades before, but he has always managed to get out of the net of the law. The girl was detained in the city jail last night until Municipal Judge Cameron makes an examination into the case.

NOT READY FOR OCCUPANCY.—The new Central School building, which it was expected would have been ready for occupation two or three weeks after the schools opened, is not nearly completed yet. The children occupy the old building, but in several of the rooms are very much crowded. It is hoped that three or four of the rooms in the new building will be occupied next week, but it will be ready for occupancy. It is not remembered that any new school building was finished as soon as was expected.

RUMOR SALE.—Two loads of new goods were received yesterday at the rummage sale at the corner of Sixth and Alder streets. For a small sum of money many desirable bargains may be had. The street-car companies repaired their portion of the thoroughfare, between Madison and Burnside, the past Summer, but the property-owners are only attending to their portion, and each feels the need of private improvement.

Certain persons, who saw the display of art needlework there, affirm that Miss Oberg's was by far the best of any exhibited and should have been awarded first prize. This has been written Mr. Dosh and Mrs. Weathered. The banquet piece referred to will be remembered as containing remarkably skilled work in portulacae, about a dozen prominent American Presidents and National heroes being embroidered on it in pure white, without the aid of color. All who have seen it consider it one of the most beautiful and remarkable pieces of needlework ever exhibited in America.

POLYSCOPE PICTURES POSTPONED.—The parade of the Fire Department to get polyoscope pictures taken by Photographer Shields took place yesterday afternoon from Sixth and Pine streets, but at the critical moment, just as the horses were rushing past, the photographic apparatus broke, and the event was declared off for the present. There were 30 pieces of fire apparatus in position, led by Chief Campbell, and the horses ran steadily and well. One of the horses attached to truck 5 fell on the slippery asphalt near Stark street, but he was not seriously hurt. It is possible that another attempt will be made to take a series of pictures in about a week or so. The photographer was vexed at the failure of his apparatus, and said he had had no interruption in his work for two years.
