

ABDUL HAMID IS ALARMED

ORDERS THE COMPLETION WITH ALL SPEED OF DEFENSES.

The French Squadron, It is Now Said, Did Not Return to Toulon.

PARIS, Nov. 2.—The Sultan has ordered the completion with all speed of the defenses at Smyrna and the entrance to the Dardanelles, says the Constantinople correspondent of the Echo de Paris. "Submarine mines will be placed and troops mobilized at points where disembarkations are likely. A violent anti-French feeling prevails, and fears are felt for the safety of French residents in Turkish cities, Constantinople excepted. The officials of the Foreign Office today informed the Associated Press that the information set forth in the dispatches yesterday was correct. The incorrect announcement from Toulon of the return of Admiral Gailard's division, which created a great sensation, emanated from the correspondent of a well-known news agency. The announcement was that Admiral Malmgren, commander of the Mediterranean fleet, returned to Toulon at 10 o'clock, with all his vessels, including those belonging to Admiral Gailard's division. The correspondent of the news agency referred to the confusion of the dispatches. A correct list of Admiral Gailard's ships is now published as follows:

Two battle-ships Gaulois and Charlemagne, two cruisers Admiral Potin, Chanzy and Gallie, and two torpedo-boat destroyers of the Hellandier type.

FRANCE IS OFFENDED.

Found It Necessary to Call Down the Ottoman Government.

NEW YORK, Nov. 1.—The Paris correspondent of the London Times and the New York Times declares that the palace of Constantinople has been humiliated and exhausted. He says it is the general belief that Turkey will now abandon her procrastinating tactics and fulfill her engagements.

The correspondent adds that things cannot go on as they have done. The Government is faced with a debate on the foreign situation in the Chamber of Deputies, and it is imperative that a situation both embarrassing and ridiculous shall be ended. When the trouble with Turkey began, the dispatch goes on to say, it seemed difficult for France to take a coercive naval demonstration in regard to the three matters at stake. The question of the Constantinople quays concerned a private enterprise, having divergent interpretations of a concession. The Lirondo and Tubin debts were even less of the sort for which a power mobilizes a fleet. The Porte, however, has acted toward France in a way calculated to wound and offend, and a demonstration is needed or the dignity of France will be compromised.

According to the Herald's Berlin correspondent, the Lokal Anzeiger, in discussing the proposed movement of a French fleet to the Levant, expresses the opinion that the establishment of a French naval station at Smyrna would be a standing menace to England's position on the Bosphorus.

ENGLAND'S FOREIGN POLICY.

Necessity of a Good Understanding With Russia.

NEW YORK, Nov. 1.—The Berlin correspondent of the London Times and the New York Times quotes an article in the National Zeitung on the discussion of the question of Great Britain's foreign policy, which has been going on in the London Times and the National Review. The National Zeitung, in its discussion, suggests an anti-Russian attitude, and accuses the London Times of sowing the seeds of dissension between Great Britain and Germany.

The correspondent urges on the contrary that a good understanding between Great Britain and Russia would be the best thing for Anglo-German relations, as it would remove the grounds for the accusations that Great Britain tries to use Germany as a cat's paw. Great Britain and Russia, says the correspondent, have more in common than have Great Britain and Germany. Englishmen desiring the friendship of Russia have no wish to quarrel with Germany, but only wish a second string to their bow, as Germany herself does.

It is true, remarks the correspondent, that the German Government deprecates the excesses of the press in its invectives against Great Britain. But if similar attacks were made in Germany against the German Emperor and German institutions a protest would forthwith be made by the German Embassy in London. An indication of German national feeling, these attacks deserve to be taken into consideration.

O'Rell Warns the Press.

NEW YORK, Nov. 1.—"Max O'Rell" leads the column of the Figure with an article which warns the French and English press against indulging in periodic outbursts of empty, says the Paris correspondent of the Herald. He points out that the press has long fulfilled the duties formerly monopolized by diplomacy, and he says, has lost its influence and its prestige, owing to the advance of democracy.

"It is the American press alone," he says, "which four years ago was the cause of the war between Spain and America. It is the press which three years ago all but succeeded in provoking war between France and England, by mutual bombardment, lies, prejudice and insult. It is the press which one of these days will succeed in causing this war."

Since the press has been styled the great luminary of the universe, its first duty," concludes Mr. O'Rell, "is to enlighten, and how can journalists enlighten others when they themselves are in darkness?"

He therefore urges his colleagues of the press to refrain from writing on any subject with which they have not at least an elementary acquaintance. Let them at least visit England before discussing questions relating to England or Germany or America. If every country worked on this plan, Mr. O'Rell guarantees that 20 years hence the peace of the world would be assured.

Another English Amalgamation.

NEW YORK, Nov. 1.—A proposal for the amalgamation of Kodak Limited, with a number of other well-known kindred undertakings in England and America is under consideration of the directors, says the London correspondent of the Times. Two-thirds of the Kodak shares are already owned in America. And if the scheme is carried out the American corporation will acquire a business with a capital of over \$3,000,000. One result of the transfer of the property to an American Company will be the removal of income tax, a trouble, which it is understood has given rise to great dissatisfaction among American shareholders.

Invaded Portuguese Territory.

NEW YORK, Nov. 1.—The Berlin journals, says the correspondent of the London Times and the New York Times, have the angry complaints in the Portuguese press to the effect that troops from German Southwest Africa have crossed the frontier of Angola and established themselves at Quhanam, holding the German The Portuguese demand a delimitation of German-Portuguese frontier. The Berlin newspapers seem to think the demand reasonable, but make light of the reported invasion.

Lloyd Griscom to Marry.

NEW YORK, Nov. 1.—The wedding of Lloyd Griscom, United States Minister to Peru, and Elizabeth Duer Bronson,

of New York, has been unfortunately timed for Saturday, when it will be difficult for carriages to drive through the West End on account of military procession, says the London representative. The American Embassy will be fully represented, and Henry White's daughter will be among the bridesmaids. The ceremony will be at St. Mark's, Westminster, and will be followed by a reception at the Coburg Hotel. The wedding journey will be prolonged from Paris to Toulon.

Anti-American Agitation.

LONDON, Nov. 1.—The Spectator, discussing the continued agitation in Central Europe against the United States, will say tomorrow that there is in fact a real danger. If the conservative parties on the Continent, which include the Agrarians, Clericals and Absolutists and the vast mass of the peasantry, should achieve a temporary triumph, a grand effort will be made to boycott the United States and the Argentine Republic as a protection for "false interests." Although the movement will pass and probably the hatred with it, the common enemies of England and America will tend to drive all who speak English and sell any buy good freely into a single defensive group.

Expulsion of an American.

BERLIN, Nov. 1.—With reference to the expulsion from Prussia of Joseph Herrings, the American newspaper correspondent, the Berlin representative of the Koenigsberg Hartungzeitung says: "The expulsion greatly surprised Berlin officials who act in the police precincts communicate to the newspapers evidence that the police are too zealous for the letter of the law. The higher authorities, however, are of the opinion that the intended expulsion, the closing sentence of the communiqué is interpreted to mean that Count von Bulow has expressed displeasure at the action of the police and is willing to give redress."

The whereabouts of Mr. Herrings is not known in Berlin.

Nationality Fend in Austria. NEW YORK, Nov. 1.—The Czech declaration of war on the cabinet, says the Vienna correspondent of the London Times and the New York Times, has caused fresh confusion in the domestic situation in Austria.

The elements interested in maintaining the antagonism between the Czechs and Germans never abandon their subterranean efforts to stir up trouble. The Czechs are busy behind the scenes. There is every reason to believe that the Ministry will stand its ground and will work for the maintenance of the status quo. Industrial interests unless hampered by a domestic crisis.

Distress Throughout Germany.

NEW YORK, Nov. 1.—The Berlin correspondent of the London Times and the New York Times says that while the Agrarians continue to demand even higher protective duties than those proposed by the government, the distress throughout Germany is becoming intense. It is estimated that there are 80,000 unemployed persons in Berlin. In the suburb of Charlottenburg particularly the conditions of labor, both skilled and unskilled, is distressing. A mass meeting of the unemployed has been called there.

Consultation on Voyron Letters.

NEW YORK, Nov. 1.—The Rheinische Westfälische Zeitung states that Count von Bulow's interview with the Kaiser at Liebenberg Castle was in regard to General Voyron's correspondence with Field Marshal von Waldersee, says the Herald's Berlin correspondent. In official circles the possibility that this is a correct statement is admitted, but the German Government, it is declared, will not take any action in the matter.

Policy of the New Ameer.

SIMLA, Nov. 1.—The Ameer of Afghanistan, Habibullah Khan, has caused to be spread abroad a proclamation informing all Afghans who have fled from their country because of extortion, oppression or fear of arrest on false charges, that they can return safely and that lands confiscated from them will be restored; that funds will be advanced for improvements and that a year's taxes will be remitted.

King Victor Will Arbitrate.

NEW YORK, Nov. 1.—The Rome correspondent of the London Times and the New York Times says King Victor Emanuel has accepted the invitation to act as arbitrator between Brazil and Great Britain in regard to the Guiana frontier question. The King is said to be gratified at the tribute paid to his mental qualities by the invitation, as well as by the compliment paid, through him, to the Italian Nation.

Lipton on American Trade.

LONDON, Nov. 2.—The Daily Chronicle publishes this morning an interview with Sir Thomas Lipton regarding trade and commerce in the United States. He describes both as a highly flourishing condition, and expresses the opinion that the Americans are "sure to become formidable competitors in the future, owing to their promptitude in executing orders and their modern methods."

A Scandalous Duke.

NEW YORK, Nov. 1.—A dispatch from Paris to the London Times and New York Times says the Duchess de Tarente has obtained divorce from the Duke on the ground of a letter he wrote approving a scandalous newspaper article. He preferred the letter as follows: "I prefer the letter in your name as a woman and a wife."

Ceel Rhodes' Affidavit.

CAPE TOWN, Nov. 1.—The affidavit of Cecil Rhodes, repudiating bills aggregating £25,000, drawn in favor of the Princess Radwill, of the German branch of the Radwill family, and purporting to have been signed by Mr. Rhodes, have arrived here. The Emperor's Court has issued a writ of imprisonment for the Princess on account of minor debts of £113.

Russian Battle-Ship Ashore.

COPENHAGEN, Nov. 1.—A dispatch from Newburg on the Island of Funen announces that the Russian battle-ship Isler is ashore today on the north end of the island of Langland, between Funen and the Island of Lolland. A salvage steamer has gone to her assistance.

German East Asiatic Society.

BERLIN, Nov. 1.—An organization to be known as the German East Asiatic Society, has been formed in Berlin to maintain closer relations between Germany and Germany now in Asia and to promote German scientific and commercial undertakings in Asia.

Rejected Vote of No Confidence.

MELBOURNE, Nov. 2.—After a continuous sitting of 24 hours the Federal House of Representatives rejected, by a vote of 15 to 12, a resolution of no confidence in the government introduced by Mr. Reed, the opposition leader, in connection with the tariff bill.

Captain Neliske Acquitted.

BERLIN, Nov. 1.—Captain Neliske, of the German cruiser Gazelle, who was tried for not reporting the insubordination that occurred on the cruiser while she was engaged in the maneuvers at Dahle, in Kassel, was captured and five soldiers were murdered, roasted and eaten.

Carnegie Nominated.

LONDON, Nov. 1.—Andrew Carnegie today was formally nominated for the lord rectorship of St. Andrew's University. Mr. Carnegie's election will be declared by the Vice-Chancellor November 5.

No Free Silver in Spain.

MADRID, Nov. 1.—The Chamber of Deputies has passed the bill prohibiting the free coinage of silver.

HOMECOMING OF THE DUKE

NAVAL PAGEANT IN PORTSMOUTH HARBOR.

The Ophir Escorted Into Port by the Victoria and Albert, With the King on Board.

PORTSMOUTH, Nov. 1.—Today's naval pageant, in honor of the return of the Duke and Duchess of Cornwall and York, was almost a reproduction of the ceremonial attending their departure. The town and harbor were astir early. Immense crowds assembled along the sea front and rounds of cheers mingled with the national anthem and strains from the harbor ships and land batteries as the royal yacht, Victoria and Albert, entered the harbor. On board the royal yacht the King, in the uniform of an Admiral, stood on the after bridge at the salute, while the Queen and the children of the Duke and Duchess paraded the hurricane deck.

The roads were a striking spectacle, owing to the gathering of ships, dressed from stem to stern, and with their yards manned and the sides lined with crews. Nelson's old ship, the Victory, started the salute to their Majesties, and each ship in turn took it up as the Victoria and Albert moved down the Solent, escorted by a fleet of all the royal yachts.

On Yarmouth, Isle of Wight, the Victoria and Albert and Ophir met and exchanged signals of greeting.

About 2 o'clock the booming of distant guns announced the approach of the royal vessels. The track will be formed in the harbor in eight, with the Trinity House yacht Irene acting as pilot. She was followed by the Victoria and Albert, the Ophir and the royal yachts. The Victoria and Albert were fired, bands played and crowds cheered as the vessels passed down the lines of the fleet.

Royalty was in created enthusiasm for the crown and in emphasizing the unity of interests wherever the flag flies. The loyalty of the colonies demonstrated in Australia, South Africa and Canada by their unexampled reception of the heir to the throne has imposed an obligation on the mother country to welcome him with the same unique honors. But to the colonies will be accorded the imperial nature of the function. Their official representatives, headed by J. S. Colgate, Lord Strathcona's deputy for Canada, will be at Victoria Station and present addresses of congratulation and welcome and receive a reply from the King.

The King will be introduced by Mr. Chamberlain to the Duke and Duchess of Cornwall. The colonies will place in this way their final seal upon their country because of extortion, oppression or fear of arrest on false charges, that they can return safely and that lands confiscated from them will be restored; that funds will be advanced for improvements and that a year's taxes will be remitted.

ANOTHER CASE OF PLAGUE

REPORTED TO THE HEALTH AUTHORITIES OF GLASGOW.

The Situation at Liverpool Is Unchanged—Extra Precautions to Be Taken by American Liners.

GLASGOW, Nov. 1.—Another case of bubonic plague has been certified to here. Large numbers of people who have been in contact with plague cases or suspects at the outbreak in India today are refusing to grant clean bills of health. A barmoid who was recently transferred from the Central Station Hotel (which belongs to the Caledonian Railway) to the Central Station Hotel, who was suffering from the plague, had been officially reported up to a late hour tonight. Two hundred employees of the Central Station Hotel are confined to the hotel precincts for observation.

Regulations at New York.

NEW YORK, Nov. 1.—Health Officer Doan said today, in regard to the report of the appearance of plague at Glasgow and Liverpool:

"The same regulations will be carried out in regard to the port of Glasgow as when the disease recently appeared in that city. As regards Liverpool, all steamers and their crews and passengers will be carefully inspected on arrival at the city. The health authorities will carefully inspect all passengers before embarking for this port. I do not apprehend any danger to the public health from the appearance of the case of plague at Glasgow and Liverpool."

No New Cases at Liverpool.

LIVERPOOL, Nov. 1.—The three cases of bubonic plague in the hospitals here when the disease recently appeared in that city, have been officially reported. James Boyle, United States Consul, conferred today with representatives of the American liners regarding extra precautions, particularly in connection with emigration. He has also asked the railway companies to have emigrant cars disinfected.

Texas Establishes a Quarantine.

AUSTIN, Tex., Nov. 1.—Health Officer Tabor, after having been officially advised by the United States Marine Hospital Service that bubonic plague exists at Liverpool and Glasgow, has established a quarantine against those ports.

Consul Boyle's Report.

WASHINGTON, Nov. 1.—A cablegram received at the State Department today from United States Consul Boyle at Liverpool said no new cases of bubonic plague had been reported up to 12 o'clock noon there in that port.

Plague at Batoum.

ST. PETERSBURG, Nov. 1.—Ships leaving or entering the port of Batoum, on the Black Sea, have been ordered to be closely inspected, owing to a death from the plague in the town.

POPULATION OF SEATTLE.

Some Examination of Recent Preposterous Claims.

The Tacoma News publishes an interesting editorial essay on the population of Seattle, which we reproduce below. It shows how absurd is the multiplier of 2½ applied to the names of the directory of city whose population, as returned by the census of the United States was 16,521 males to 23,150 females. Again, it is obvious from the excessive number of males, that the names of thousands of persons in transit for Alaska were taken at Seattle. The examination by the Tacoma News is thorough, and the results convincing, beyond cavil or appeal. It will repay the reader to look the article through:

The new directory of Seattle, issued by R. L. Polk & Co., publishers of directories in many cities, contains the names of 41,712 residents of Seattle and its environs. In the introduction the publishers say that the multiple 2½ is the lowest one they employ in estimating population upon the basis of the counts of names in any city directory, and that by employing this multiple they estimate the population of Seattle and its suburbs at 117,385. They add that 10,000 ought to be deducted as the probable population of the suburbs, leaving 107,385 as the probable population of Seattle in 1901. If this estimate is reliable, Seattle is enjoying a remarkable growth, for the Federal census of last year,
