PLANTS UNKIND.—General F. A. Boutelle was in town yesterday looking into the apple market along Front street. Although this is a good year to market apples, the General has no use to sell, although he has for several years owned one of the largest apple orchards northeast of Vancouver. The elements were unkind there last spring, and a hail storm destroyed the bulk of General Boutelle's crop. With otherwise would be worth bringing him a few thousand dollars. This was a particularly unkind stroke, in view of the fact that the General is a veteran who took a very active part in making the history of the Pacific Northwest. He takes his loss with the philosophy of a patient veteran, and looks for better luck next season.

ALL ABOUT A HAT.—Bert Adams, who was arrested last Saturday, charged with the larceny of a hat from a Third-street store, was before Municipal Judge Cameron yesterday. John Sullivan testified that he and Adams were walking near the store where the larceny took place, and that witness went to get a shave, asking that Adams would wait outside. "Adams is an honest fellow," said Adams, "and I am a hat." "I am a hat," insisted the witness. "I am a hat in a hotel here, and spend my money in Portland. I've been here one month." The Judge asked that good Adams had bought in Portland. "Well," replied Sullivan, after some anxious thought, "I bought a necktie from a drunken man last week for 30 cents." The Judge decided that there was no evidence against Adams, and he was discharged.

ORDERED TO LEAVE THE CITY.—A long, lanky man, who said that his name is John McLaughlin, was before Judge Cameron yesterday. The police testimony was that the defendant had been seen going through Jack Hurley's pockets when Hurley was on the sidewalk drunk. "If the man had any other money on him," said McLaughlin, "I ought to have been charged with larceny from the person. Hurley has often been before this court, however, and he rarely has any money on those occasions," remarked the Judge. The defendant, who denied that he had tried to rob Hurley, was sentenced to 30 days in jail, and the sentence was suspended on condition that he left the city within one hour.

HIS FRIEND IN NEED.—"Peter Fisher, you are charged with vagrancy. What do you have to say about it?" asked Municipal Judge Cameron yesterday. The young man addressed was wearing a clean, neatly pressed suit, and he had a friend who had money enough to take the two out of town. "Let me go, please," said the man, who was looking at the audience and said: "I'm Pete's friend, Pete was kind to me last winter when I was sick, and I ain't goin' back on Pete now. I've got 50 left, and I can get Pete out of town this afternoon." Fisher, who is an intelligent-looking man, was allowed to go.

HOME SCIENCE SCHOOL.—The new Domestic Science School, on Washington and Exposition streets, in the Exposition building, will be open every day from now on from 9 A. M. to 1 P. M., and from 2 till 4 P. M., and again from 7 till 9 P. M. It is hoped that the school girls will come forward to help with the work. From 5 to 7 P. M., on Saturday both morning and afternoon. Tuition must be paid for each course in advance. All wishing to take these courses will register as soon as possible, in order to facilitate the commencement of the work.

IS YOUR DOG LICENSE PAID?—Licenses on dogs were due and payable September 1, and they are still due, being paid in. So far 137 dog licenses have been paid. The dog-catchers have been at work intermittently, and have scooped in a couple of extra dogs of unlicensed canines, and there are more of the same sort ready to be taken. In addition to 1400 cubic yards of garbage burned at the garbage crematory during October, 12 dogs, 20 horses and 4 cows were cremated, 55 loads of sawdust and 37 loads of sludge being consumed in the operation.

MAJOR DUBBIN COMING.—Tonight at the Salvation Army hall, on First street, near Washington, there will be a gathering of unusually large proportions. The program will include all the officers, soldiers, recruits and converts of the army in this city, as well as some visitors from near-by towns. They will be tendered a public reception by the command of the Northern Pacific Coast division.

As regards music, Mrs. Mark Levy will be the soloist.

A NEW BOULEVARD.—A party of surveyors is at work on the hills south of the city, laying out a boulevard some four miles in length between E. Main and E. 4th streets, and the boulevard will be called Rathburn avenue, and winds along the summit of the hills, from which a fine view of the city and surrounding country is obtainable. The owners of the property along the route are laying out this boulevard.

TO EXAMINE THE WIRES.—The County Commissioners have engaged experts to examine the cable wires of the Portland General Electric Company on the bridges across the river and report whether the presence of these wires endangers the bridges in any manner. This action was the result of a recent discussion on this subject, in which the Commissioners and City Engineer Chase took part.

LECTURE TONIGHT.—Professor A. C. Newell, principal of Bishop Scott Academy, will deliver a lecture on "The Classics" at St. Helen's Hall at 8 o'clock this evening. There is no admission fee, and the public is welcome.

DREDGE TURT SATISFACTORY.—The new section dredge just completed by the Northern Pacific Lumber Company was moved across to the east side of the river, just above the Burnside street bridge, yesterday, for a working trial. The test was highly satisfactory in every respect. The suction pipe of the new dredge is only 14 inches while the pipe of the Port of Portland dredge is 30 inches; yet persons who witnessed the working of the new dredge yesterday are of opinion that she can do as much work as the larger dredge of the Port of Portland. Instead of a revolving cutter on the end of the suction pipe to stir up the sand to be pumped, the new dredge has three jets of water under pressure. Just what is the benefit of the change, if any there be, has not yet been ascertained; but the company is so well pleased with the working of the dredge that they say they are ready to maintain their offer to the Port of Portland Commission to do all the dredging required in the river for a sum not greater than the working expenses of their dredge, thus enabling the city to avoid the necessity of investing a large sum in a new dredge. The Northern Pacific Lumber Company believes it more practical and economical to operate two small dredges than one large one, as it is improbable that the two dredges would be broken down at the same time, while when the large dredge is in need of repairs all operations must be stopped. It was generally supposed that the object of the company in building the dredge was to deepen the water in front of its property, but Mr. E. Williams, vice-president of the company, says this is only a trifling part of the work they will have to do. Nearly every property-owner along the river front wants some dredging done, for there is hardly a place where deeper water is needed, as larger and larger ships keep coming here. "It is not known exactly where the dredge will be put at work first, as this depends somewhat upon what the Port of Portland Commission decides to undertake with its dredge."

MR. STEEL DOES NOT WANT IT.—George A. Steel, chairman of the Republican State Central Committee, disclaims any aspiration to be the successor of Collector J. W. Iver. Yesterday Mr. Steel said: "I notice in this morning's Oregonian an item reporting me as an applicant for the Alaska collectorship. TO END RECEIVERSHIP.—Receiver Nixon, of the Portland Savings Bank, will cease paying dividends to depositors in that concern at the end of the week. Next week he will leave the concern, and to secure his discharge as receiver. Just what disposition will be made of the uncalled-for dividends has not yet been decided by the court. Some \$2000 will remain on hand, representing a large number of small claims. Every effort has been made to have creditors of the bank call for their dividends, but a considerable number appear not to care whether they get the money or not.

ALL UNDER ROOF.—The new portion of the Y. M. C. A. building is all under roof, and the workmen can now put in full time on the interior, regardless of the weather. When the building has been finished and the windows placed in position the present contract will be fulfilled. By December 1 all the rooms except the auditorium are expected to be ready for occupancy. The contractors have had a very favorable fall for outdoor work, and were it not for delay in obtaining material consequent on the strike, they would have finished the building ere this.

NO STRIKE.—The Waiters' Union is a new organization which is seeking to adjust the matter of wages and hours on an equitable basis in connection with the different restaurants and hotels. The union is having the assistance of a committee of the Federated Trades Assembly, and looks forward to a fair arrangement all around. There is no strike on, and all waiters are at work as usual.

TWO CASES OF SHALPOX.—The first arrival of smallpox cases of the season, in the persons of William Dobie and James Raymond, landed here on the steamer Hassler last Saturday. Having come on board at Oak Point, Wash. They were placed in detention until the disease developed sufficiently to insure that there was no mistake in regard to it, and they were then taken to the pesthouse. On the return of the steamer here Monday night she was thoroughly fumigated, and City Physician Zan vaccinated all on board, about 40 persons. Dr. Zan and an assistant will go down to Oak Point today to fumigate Benson's logging camp, where the men came from, and to vaccinate all the men employed there. Dobie and Raymond came from some point in Washington, and have no idea where they contracted the disease. They halted at Benson's logging camp on their way here, but it is doubtful whether the disease was far enough developed at that time to be contagious. Mr. Benson has, however, arranged for the fumigation of the camp and the vaccination of all his employees as a precaution for their safety, and it is hoped that there will be no spread of the disease there.

SEWER BIDS TOO HIGH.—The Board of Public Works yesterday rejected all bids for the construction of the Hamilton-avenue sewer, and ordered the City Auditor to advertise the work again. The lowest bid, that of J. H. Steimmons, \$465, was about 800 above the Engineer's estimate, and the board thought there was too much discrepancy. Mr. Steimmons was on hand to explain that such work cannot be done as cheaply in the winter as in summer, as much interference with the bidders and create a tendency toward carrying in the bidders being excavated. Mr. Chase said there was considerable logic in his argument, and that his office had cut figures very close in making the estimate, but still the difference between the contractor's figures and the City Engineer's was too great to be reconciled. The property-owners of Hamilton-avenue desire to have the sewer constructed at an early date, as it will drain a large district in South Portland. HIS SPLINTER THROUGH HIS LEG.—John Danely, a lawyer in the employ of the Portland Lumbering Manufacturing Company, is laid up at his home in Fulton Park from the effects of a peculiar accident. He was engaged in running an edger, when a long, slender strip of fir struck him in the right thigh, and passing through the leg. The "splinter" was eight feet in length and about an inch square at the end. A fellow-workman pulled the stick out, but it was so hot that a good exercise of strength to do so. The wound was ragged and painful, and will keep Danely from work for several weeks. He had been in the habit of wearing a splinter-proof suit, but this stick struck on one side of the apron.

TO ENLARGE MEMBERSHIP

CHAMBER OF COMMERCE DECIDES TO MAKE THIS OFFER.

One Thousand Members Would Make Possible Effective Advertising of City and State.

To enlarge the membership of the Chamber of Commerce to at least 1000, and then to take up systematically the advertising of the city and state as the program adopted at the meeting of the trustees yesterday. To accomplish this result an address is being drafted which sets forth in detail to the business men and professional men of the city the work the Chamber of Commerce is doing for the advancement of the city and state. All persons interested in the welfare of Portland are invited to join the association. With a largely increased membership, the trustees are confident that the influence and efficiency of the Chamber of Commerce will be greatly enhanced.

A ripple was created by the announcement by the assistant secretary of the receipt of a bill of \$15 from the New York Commercial for a year's subscription in advance. One of the members who has been in the past favorable to this publication, A. H. Devers, quickly arose and put in a protest against paying the bill. Since the first bill was paid some months ago, he said he had changed his mind. The property-owners of Hamilton-avenue desire to have the sewer constructed at an early date, as it will drain a large district in South Portland. The work may be let next Tuesday, after being duly advertised again, after which the board hopes to proceed with the work. The new sewer will have a length of 10 blocks, and considerable rock work to be figured on in the bid.

The unsightly condition of the city streets was brought up as a subject for discussion by Mr. Lombardi. Lombardi, Devers and Batchelder, was appointed to confer with the Park Commission on the question of providing a more suitable entrance to the City Park.

The communication of the Alaska Chamber of Commerce, of Juneau, requesting the endorsement of resolutions urging the building of a courthouse and jail at Juneau, for which the amount appropriated by Congress is now available, was on motion referred to the Park Commission, and Congress for action if the facts shall be found to be as stated in the resolution.

Upon the suggestion of Mr. Batchelder, the First Bank of Portland was asked to list of banks which the Chamber of Commerce has designated as sub-depositaries for the collection of the McKinley monument fund.

NEW OFFICERS ELECTED.

At the annual election of officers of the Manufacturers' Association last evening W. H. Morrow was chosen president; L. E. Scheiner, vice-president; H. E. McLean, secretary, and W. H. McMonie, treasurer. The executive committee selected is composed of R. J. Holmes, chairman; H. Metzger, A. H. Devers, George J. Jr., and B. B. Schwalbe.

The association has now over 90 members and is doing a great deal toward inducing outside capital to invest in Portland enterprises. Mr. McLean, the secretary, who was last evening unanimously re-elected, is tireless in his efforts to add to the membership and extend the usefulness of the organization. His salary was voted very materially last evening for the ensuing year, as an acknowledgment of his merit.

The association passed a resolution of thanks to Hon. M. C. George, for his able service in the Oregonian on the best methods of keeping a ship channel open from Portland to the sea, and the secretary was instructed to communicate with the Oregon Congressional delegation, informing the Senators and Representatives of the association's action.
