

JACK WADE OWNSUP

Makes Second Avowal of Guilt in Morrow Murder.

SHOT WAS ACCIDENTAL, HE SAYS

He Makes Public Confession to Give Dalton Chance for Life—Latter Hopes for Commutation of Sentence.

I have known all along that there was no chance for me, and have wanted to see Dalton punished, too, because he gave me both ways. But I have thought it over, and concluded it is right for me to tell the truth. I fired the shot, but I did it accidentally. I did not want to kill Morrow, nor anybody, and would not have done it intentionally, even to save myself. I hope this will save Dalton. I am doing this because it is right, and not because I am afraid to die. I can't see anything in it for me. All is true. JACK WADE.

Jack Wade has made a second and a public confession like the one not Dalton fired the shot that killed James B. Morrow. The first confession was made privately to Mrs. Ella Boltz, a religious worker in the County Jail, now in Sacramento, who gave Wade a copy of a paper which was printed in last Sunday's Oregonian, that Wade had confessed in her the details of the shooting, and that he was guilty. Yesterday Wade called Attorneys John

Logan and Clarence Vesie to his cell and re-told the story of his crime, stating that he desired to make a full and public avowal of his guilt. In the presence of the attorneys he then dictated and signed the foregoing statement. The effect of Wade's confession on Dalton was magical and his spirits immediately revived. It is almost certain that his attorney, Clarence Vesie, will ask Governor Geer to commute his sentence to life imprisonment.

"Shot Was Fired Accidentally." "The shot was fired accidentally," said Wade, in discussing the circumstances of the crime with an Oregonian reporter. "I had no intention of killing Morrow. When I called to him to stop, he said, 'All right, boys,' and then made a motion to put his hand in his pocket and walk around me. I had the pistol in my right hand, and was about to reach for him with my left when the gun went off."

"You know when this goes in the paper what I should like to see. I don't want anybody to get me or anything like that. I look at it this way, because a man done me a wrong is no reason for me to do him a wrong. There is no reason for me to let him go when there is he can escape. That is just the way I look at it. I am not going to do him an injury because I can. My heart is in the right place. I never carried a pistol before. I think I took a step backward."

"Dalton and I were walking close together when the shot was fired. I saw Dalton and the gun went off. I knew he was dead, and started to run. I did not intend to fire, but the gun went off so easily."

Confession Not Unexpected. John F. Logan, who has been previously aware that Wade would make a confession. Mr. Logan, in speaking of the matter said: "A week ago Wade sent for me and said he was going to make a confession. I never carried a pistol before, but I was told to tell the truth, but cautioned me not to say anything about it at that time. He said something about making a confession on the order. Corbett, at which the situation was gone over and Mr. Sherman assured Mr. Corbett of the hearty co-operation of his state in making the 1905 Exposition an overwhelming success.

Shortly before the close of the last Legislative session a resolution was passed endorsing the Lewis and Clark Centennial, and authorizing the Governor to appoint a committee of three to keep in touch with the plans being developed in Portland, and to make for a Utah exhibit. The committee appointed is composed of Hoyt Sherman, of Salt Lake, chairman; Judge L. W. Shurtleff, of Ogden, secretary; and H. W. Corbett, bishop of the Mormon church. The committee has met informally from time to time, and has noted the progress made in preparing the way for a successful culmination of plans under consideration.
