

OPPOSE RUSSIA'S GRAB

ALL NOT SERENE WITH MANCHURIAN TREATY. England, America and Japan Object to Secret Dealing with the Chinese.

PEKIN, Feb. 6.—The British, American and Japanese Ministers have renewed their opposition to the Manchurian arrangement between China and Russia.

The powers opposing the Manchurian treaty are now beginning to recognize the force of the proposition that China is making the best terms possible for herself and incidentally for the equal rights of the other nations in China, and are shifting their protest to the responsible party.

The Japanese have an expedition in South Formosa which is engaged in wiping out the bandit who have been ravaging those districts, and up to January 15th the Russian Minister here is endeavoring to maintain the transparent diplomatic action that the Manchurian treaty and the Russo-Chinese Bank agreement are not related.

Chang Chi Tung, the Viceroy of Hankow, and Liu Kun Yi, the Viceroy of Nanking, continue to oppose the treaty. They are co-operating with the Japanese Ministry. The correspondent of the Associated Press has seen a draft of the agreement. The Chinese will build all railroads and develop all mines in Manchuria.

ABANDONS THE BOER CAUSE.

Dutch Government Has Had Enough of the Negotiations.

LONDON, Feb. 7.—The Brussels correspondent of the Daily Telegraph declares it to be an absolute certainty that, owing to the attitude of the powers and the Boer leaders, the Dutch Government is now firmly determined to abandon the Boer cause and any idea of fresh intervention.

In the House of Commons Mr. Balfour, government leader, announced that copies of the correspondence exchanged between the Government and the Boer leaders and the Government of Great Britain on the subject of peace in South Africa had been mailed to Lord Milner, who would be instructed to act as a mediator to communicate the contents to the Boer leaders in the field.

Kruger and Kuyper.

LONDON, Feb. 6.—The Daily Mail this morning publishes an article devoted to showing that Dr. Kruger, the Dutch President, has for 20 years been the devoted friend of the Boer cause.

The result is that the opposition gains a majority in Parliament, the fruits of T. W. Russell's compulsory land purchase campaign against the government are Parliamentary Secretary of the local government board.

MAY BE ASKED TO RESIGN.

PROFESSOR CHARLES W. PEARSON.

CHICAGO, Feb. 6.—Professor Charles W. Pearson will be asked to resign from the faculty of Northwestern University, the Tribune says, if the report of the committee appointed to investigate his case is accepted by the executive committee of the board of trustees.

after a two hours' session behind closed doors last night, at which the communication written by the professor on Tuesday was read and the case reviewed. The members of the board of trustees, including the university, Dr. Robert P. Shepard, business agent, and M. H. Wilson, a trustee.

The report, in substance, will declare that Professor Pearson has transgressed the limits of propriety in openly declaring the fallibility of the title while occupying a chair in an institution supported by the Methodist Church; and that he should seek a chair in some liberal institution where he would be at liberty to preach any doctrine he might desire.

It thus means the conclusion is drawn that the university trustees should ask Professor Pearson to resign.

Professor Pearson, when informed of the verdict of the trial board, declined to discuss the matter. On previous occasions, however, the professor has declared that if he were asked to resign, he would not stay where he was not wanted.

Professor Pearson was not asked to attend the meeting, and did not know one had been held until the matter was made public last night. The Pearson report will be given to them at that time.

RESULT OF ITS STUDY

INDUSTRIAL COMMISSION SUBMITS ITS FINAL REPORT. Deals with the Nation's Progress in Agriculture, Mining and Transportation.

WASHINGTON, Feb. 6.—The Industrial Commission has submitted its final report to Congress. It is a document of more than 1000 printed pages.

The first part, which has been made public, deals with the subjects of agriculture, mining and transportation. Recommendations are made on the subjects of transportation and agriculture. The commission advises as to transportation:

"That the policy of Governmental supervision and control of railroads, as originally enacted in 1887, and embodied in the report of 1888, and embodied in the following year in the interstate commerce act, be revived and strengthened;

That the authority of the Interstate Commerce Commission, under the act of 1887, be extended to include the adequate protection of shippers and clearly intended by the framers of the laws, be restored; and that the powers and functions of the Interstate Commerce Commission be practically as contemplated in the so-called Cullom bill of 1900, except as to authority to prepare and enforce a uniform classification of freight rates.

"Such legislation should provide for more stringent regulation of the conditions under which freight and passenger tariffs are published and filed; no rate should be established without the consent of at least 60 days' notice to shippers, unless specifically authorized by the Interstate Commerce Commission;
