Huntington Money for Tuskegee.
TUSKEGEE, Ala., April 29.—At the annual industrial exercises of the Tuskegee Normal Institute, Booker T. Washington's school for negroes, a letter was read from Mrs. Collis P. Huntington, of New York, stating that Mrs. Huntington desired to give a contribution to erect a commodious brick building for the use of the academic department of the institute. This building Mrs. Huntington will give in memory of her late husband, and it is to be known as the Collis P. Huntington Memorial Building. Two years ago Mrs. Huntington gave the money to build Huntington Hall, the best dormitory for girls which the school has, and not long before his death, Mr. Huntington gave \$50,000 toward the school's endowment fund.

Recovered From Pittsburg Wreck.
CAIRO, Ill., April 29.—Forty-six bodies have been recovered from the City of Pittsburg wreck. Eight bodies were found today. Two were identified as those of Steward William Bollinger, of Cincinnati, and one of the Burke boys; another is supposed to be a girl of the Burke family; another that of Harlow Dove, Memphis, and four are not identifiable. The body of Millionaire L. L. Hunter, of Pennsylvania, has not been recovered.

Appomattox National Park.
WASHINGTON, April 29.—The Senate committee on military affairs today authorized an adverse report on the bill creating a National park at Appomattox, Va., where General Lee surrendered to General Grant.

IS FEARED BY HILL

President's Move on Trusts
Alarms Railway Magnate.

COMMENT OF WASHINGTON STAR

Beef-Sugar Men are Probably the President's Strongest Opponents, But They are Laboring Under a Misunderstanding.

President Roosevelt's firm stand against the trusts has sent J. P. Hill scurrying to Washington for the apparent purpose of drumming up opposition among Senate and House Republicans to Mr. Roosevelt's re-nomination. The effect so far seems to be to strengthen the President in quarters where trusts are not so favorably regarded as they are with promoters. The President made six Foster appointments yesterday, which is accepted as indicating the collapse of the Wilson-Turner combination's "pull."

WASHINGTON, April 29.—James J. Hill has been in Washington for a day or two, and it is said his visit has started the talk of opposition to President Roosevelt's re-nomination because of the President's position regarding the merger, the beef trust, and his probable action relating to some of the other trusts in the near future. The Washington Star, speaking of Mr. Hill's visit to this city, says: "Mr. Hill is said to have expressed to his friends in Congress, especially to his intimates in the Senate, a fear that a spirit of hostility to railway and financial interests may be engendered in Congress and become manifest in legislation reflecting the tone which some capitalists think exists in the executive branch. It is a part of the gospel current at the Capitol that Mr. Hill does not regard President Roosevelt's chances of re-nomination as flattering, if there is any such outcome."

It is not at all surprising that Hill should be here opposing Roosevelt, but it is doubtful if he has met the encouragement given him a few weeks ago. A great many Republicans were of the opinion that the suit against the merger might well have been postponed, so as not to offend the commercial interests, but the rise in the price of beef through the arbitrary action of the beef trust, and the President's determination to proceed legally against it, has raised him largely in the estimation of many people, and Western Senators and Representatives are much more pleased with him than before. Hill did not find any cause of complaint against him on that score.

Probably the bitterest opponents that the President now has in Congress are the men known as "beef-sugar" Republicans. By men of both House and Senate he is attacked quite strongly when this subject is under discussion, and some of the men, who, in addition to their opposition to granting any concessions to Cuba, have been refused the appointments they were seeking, are quite bitter in their attack. Possibly these beef-sugar men gave Hill some encouragement, but most of the men believe it would be a dangerous policy to encourage a cabal against the President on account of his attitude on the trusts. As a matter of fact, the President's position on Cuban reciprocity is not directed at the beef-sugar interests, for any plan which is formulated in Congress that will not seem a direct blow at the executive in the matter of dealing with Cuba will be perfectly satisfactory to Roosevelt.

Agree to Chemawa Appropriation.
The conferees on the Indian appropriation bill have agreed to accept the substance of Senator Mitchell's amendment, appropriating \$25,000 for a new brick dormitory at the Chemawa Indian school.

Declare for Washington Bill.
The Senate public lands committee today ordered a favorable report on Senator Foster's bill permitting county commissioners in different parts of Washington to select lands in lieu of school sections upon which settlers had made homes prior to their survey. The bill will undoubtedly pass.

Foster Controls Patronage.
The six Washington land office appointments made today indicate very clearly that the President expects to defer to the wishes of Senator Foster in naming Federal officers in his state. All of the appointments save Smith reside in the town where their office is located. Smith hails from Sedro-Woolley.

Report for Crater Lake Park.
The Senate public lands committee today favorably reported the House bill creating the Crater Lake National Park.

MORE FOR OREGON BUILDINGS.
Delegation in Congress Will Try to Amend House Omnibus Bill.

WASHINGTON, April 29.—It is expected that the omnibus public-building bill, which passed the House today, will be quite generally amended in the Senate, as many bills for buildings have passed the Senate which were not incorporated in the House bill. At the same time, the unanimity with which the House bill was passed will encourage that body to stand firmly for its bill in conference. It is understood, however, that the committee expects to yield to the Senate, in some instances, which will be made.

Senator Mitchell announces his intention of fighting for an increased appropriation for enlarging the Portland Post-office. He says the bill heretofore passed by the Senate committee appropriates \$250,000 for this purpose, while the omnibus bill carries \$100,000 less. He maintains that such an extension as is needed cannot be built for the amount provided in the general bill.

It is probable Senator Simon, a member of the committee, will also attempt to have his bills appropriating \$100,000 each

ACCIDENT ON THE FULTON

ACCUMULATED GAS EXPLODES ON SUBMARINE BOAT.
Half a Dozen Men Hurt—Trouble Occurs While the Vessel is Entering the Delaware.

LEWES, Del., April 29.—An explosion of much severity, which injured a half dozen persons, occurred on the submarine boat Fulton today as she was running into the harbor of the Delaware breakwater. The boat was bound from Brooklyn to Norfolk and was partly submerged when the accident occurred. The most seriously injured are:

LIEUTENANT OSCAR COHEN, of the Austrian Navy, severely bruised.
LIEUTENANT ARTHUR MARTHUR, U. S. N. (son of Major-General MacArthur), cut about the head.

HARRY MOORE, assistant engineer, injured about the head.
C. B. MINER, assistant engineer, nose split.

CHARLES BECHTOL, gunner, severely hurt on the head and body.
All the injured were sent to the United States Hospital and after their wounds were dressed they were discharged, with the exception of Bechtol. He will leave the hospital tomorrow morning.

The explosion was caused by the accumulation of gas which had been generated by the storage battery. Although the explosion was a violent one, the vessel was only slightly injured. She will be towed to the Holland Company's station at New Suffolk for repairs as soon as the weather moderates. It will take several days to put the battery in serviceable condition.

On account of the rough weather at sea it was decided by the commander of the Fulton to put into the Delaware breakwater, and it was while the boat, partly under water, was rounding the great stone breakwater that the explosion occurred. Nine men were in the hold and three men on deck at the time.

Much bravery was shown by Engineer Saunders. After the explosion the engine continued to work. Saunders wrapped his face and head in a wet towel and went below and stopped them.

Eight Killed in Texas Tornado.
Fifty-seven Persons Injured, Three Fatally, at Glenrose.

DALLAS, Tex., April 29.—A dispatch from Granbury, Tex., confirms the report of damage done at Glenrose by a tornado yesterday. One additional death—making a total of eight—is reported and three of the injured probably will die. The revised list of dead follows:

Fifty-seven persons were injured, but, with the exception of the three mentioned as fatally hurt, it is thought that all will recover. Thirty-three buildings were destroyed. More than 100 persons are homeless and are destitute of food and shelter. Relief parties have started from Granbury with merchandise and other supplies and accompanied by several physicians.

The tornado devastated farm property and crops for a distance of five miles north of Glenrose and seven miles south, but no fatalities or serious injuries are reported outside of the town of Glenrose. Glenrose is the county seat of Somers-

TO FIRE FIRST GUN

Active Republican Campaign to Be Opened May 1.

ASHLAND TO BE TAKEN BY STORM

W. J. Furnish, C. W. Fulton, J. H. Ackerman and A. M. Crawford Will Deliver Addresses—Governor Odell May Speak Here.

The first gun in the Republican state campaign will be fired at Ashland May 1. W. J. Furnish, C. W. Fulton, J. H. Ackerman and A. M. Crawford will deliver addresses. The other dates fixed for rallies by the Republican State Central Committee are as follows:
May 2—Medford, Astoria.
May 3—Grant's Pass, Heppner.
Governor Odell, of New York, has been invited to speak in Oregon during the campaign.

The Republican state campaign will be opened at Ashland Thursday evening, May 1, when W. J. Furnish, C. W. Fulton, J. H. Ackerman and A. M. Crawford will deliver addresses. These gentlemen will address the people of Medford on Friday evening, May 2, and will continue the campaign at Grants Pass on Saturday evening, May 3. The itinerary for the following week has not yet been determined.

The campaign will also be opened the latter part of this week in other parts of the state. On Friday evening, May 2, J. P. Cavanaugh, a well-known Portland attorney, will deliver an address before the Young Men's Republican Club of Astoria. Judge John F. Caplan, of this city, will fire the first gun of the Republican campaign in Eastern Oregon, at Heppner, Saturday evening, May 3. Harrison Allen, who has charge of the itinerary of the campaign, has nearly completed arrangements for addresses by prominent Republican speakers at other points in the state, and announcement of these will be made in a few days.

C. W. Fulton will make the principal address at the meetings at Ashland, Medford and Grant's Pass. W. J. Furnish, nominee for Governor, and J. H. Ackerman, nominee for Superintendent of Public Instruction, will make brief addresses, stating their views upon timely topics of state policy. Mr. Furnish makes a good, plain, business-like talk, and his auditors will find him ready to express his intentions as to the performance of his duties after he has been elected. While both Superintendent Ackerman and Mr. Crawford are fluent speakers they will leave most of the time to be occupied by Senator Fulton, who is an active candidate for the United States Senate. If Governor Odell should be nominated by petition, as now seems probable, he will also take an active part in the campaign.

It may be predicted that Senator Fulton will make an interesting day in Southern Oregon. He has served a number of terms in the State Senate—twice as president, and is quite familiar with state affairs. The Democratic candidates have been making some statements which lay them open to a good drubbing, and Mr. Fulton is likely to administer the punishment in good style.

Since arrangements are in progress for addresses by many speakers who are not candidates, and all the dates and places of these addresses have not been fixed, it is impossible for Secretary Allen to determine the entire itinerary of the candidates. As other matters assume definite shape, he will be able to settle that part of the programme.

It was learned today that Governor Odell, of the State of New York, will be on the coast next month. The managers of the state Republican campaign at once began corresponding with him, with view to securing his services in Oregon before June 2. Governor Odell is a possible candidate for President in 1904, and is an orator of rare ability. All people of the state are glad to hear him speak upon public issues.

MORROW COUNTY IN LINE.
Northeastern Oregon for Furnish, Says G. W. Phelps.

G. W. Phelps, Republican nominee for joint Senator in the district composed of Morrow and Umatilla Counties, was in Portland yesterday from Heppner. He says the outlook for the Republican state ticket in Northeastern Oregon is exceedingly bright, especially for Mr. Furnish, who is a resident of that section. The nomination of an Eastern Oregon man for Governor has been very pleasing to the bunch-grassers. Mr. Phelps says that with the exception of four or five men who have personal grievances, there are no Republicans in Morrow County who are opposing the election of Furnish. Continuing, he said that Mr. Furnish had the greatest strength on the day he was nominated, and Mr. Furnish had more opposition when the convention adjourned than he has ever had since. Chamberlain was nominated with a hurrah that made many people think he would give the Republican nominee a close race. The Democrats have a habit of electing their ticket the day of the convention, and their campaigns are of the all-come-over-way style. But the effect of that kind of a campaign is not lasting. People grow tired of a campaign by noise and flourish. In a rowing public meeting men will participate in the demonstration, but when they go home to think the whole matter over, they form their conclusions after weighing the issues carefully.

"At the present time, Mr. Furnish has a majority of the voters of Oregon with him. As the campaign progresses, and the facts develop, that majority will be steadily increased."

Mr. Phelps went to Pendleton last evening.

FURNISH IS SAFE.
