ACTION AGAINST PACKERS

BILL WILL BE FILED IN COURT AT CHICAGO NEXT MONDAY.

CHICAGO, April 29.—Tomorrow or next day the specific status of the proposed action of the Government against the big packers will be laid before Attorney-General Knox at Washington. While the actual drafting of the bill and the temporary injunction has not yet begun, the allegations which this bill will contain have been practically determined upon by District Attorney Betham, acting with Special Government Counsel Day. It is now known that the bill in its entirety will have to travel to Washington and back before Mr. Betham as a condition of its being submitted to the Attorney-General so that any suggestions he may desire to make will be made. It is said that the bill will be filed in the United States Circuit Court next Monday.

BILLION-DOLLAR BEEF TRUST.

Great Combination of Chicago Packers Said to Be Under Way.

CHICAGO, April 29.—A \$1,000,000,000 packing trust is among the possibilities if the United States Government should succeed in maintaining its contemplated injunction proceedings against the Tribune. "The prediction is made in La Salle-street financial circles that large packers who may be made defendants in the Federal Court will be forced formally to combine in the prosecution of the Sherman anti-trust law if successful. The combination would be along the lines followed by the United States Steel Corporation, and would be made to comprise practically all the beefpacking companies in the country. In the formation of such a combination all the powers now denied the packers, with rare exception, could be legally consolidated. The single exception, in the opinion of corporation lawyers, would be the adoption of an arbitrary and unreasonable schedule of prices. Many attempts have been made to form such a corporation, but all have been unsuccessful. During the lifetime of P. D. Armour the question of the promotion of a huge packing company, to include all the Chicago firms, was discussed, but Mr. Armour stood firm against all such proposals. It is estimated that at one time the project went so far as to be considered by the heads of all the large Chicago firms, but the question of the allotment of capital stock is understood to have been the rock on which the plan went to pieces. Representatives of Armour & Co., Swift & Co., and the other large packers at the stockyards today denied that there was any foundation for the report that adverse action of the Government might result in the packers forming a \$1,000,000,000 trust. Five hundred employees of the packing firm of Lybby, McNelly & Lybby have been released, owing to the "dull times." Superintendent Morrow said that the proposed Government investigation of the packing business had nothing to do with the letting out of the employees, and that the plant would by no means be closed. "It is not unusual for the meat business to grow comparatively dull at this season," he said.

CUBAN TOBACCO OUTPUT.

New Combination Aims at Its Control.

NEW YORK, April 29.—The World tomorrow will say: "An important movement in the battle for control of the tobacco market of the world has been organized. Wednesday, when the giant Continental Tobacco Company and the American Cigar Company will, through a new arrangement, become practically one. Control of the tobacco output of Cuba is aimed at. The new combination of the Continental Tobacco Company and the American Cigar Company is one by which the Continental buys the entire manufactured output of American Cigars, and manufactures and disposes of it through its own salesmen."

Roosevelt at Olympian Games.

WASHINGTON, April 29.—President Roosevelt will attend the opening of the international Olympian games, which are to be held at St. Louis, from September 8 to September 14, 1904. He gave his promise today to Henry J. Furber, Jr., the president, and Benjamin J. Rothman, secretary, of the Olympian Association, that he would attend the games. He is expected to leave for St. Louis on the 15th of the month.

Suit for an Injunction.

NEW YORK, April 29.—Hearing has been concluded in chancery chambers, Jersey City, in the case of Joseph Rubino and others against the Pressed Steel Power Company for an injunction preventing the leasing of the company's factory, which has been organized as a trust, to a plant, which had been valued at \$200,000, was started by English capitalists, but that the location was bad and no money was made there. A new company, he added, has been organized to take over the plant to take over the affairs of the company, but this is being opposed by the stockholders. Vice-Chancellor Stevenson announced that he would give a decision tomorrow.

Big Deal in Coal Property.

NEW YORK, April 29.—Formal announcement has been made that New York banking interests have purchased the entire stock of the Pocahontas Coal Company, the largest independent company operating in the Pocahontas coal fields, and was one of the first to be organized. It owns the City of Pocahontas and all its public works. The property has been turned over for operation to a New Jersey Company, lately organized with a capital of \$5,750,000.

Application to Vacate an Injunction.

HELENA, April 29.—The Supreme Court today heard the application of the Amalgamated Copper Company for a writ of supervisory control to have the court vacate the injunction issued by Judge Clancy, restraining the Boston & Montana from paying to the Amalgamated any accruing dividends. The injunction was issued by the Butte Judge November 19 last. The Amalgamated has sought to have it vacated in the lower court, but without success, and appeal has accordingly been made to the Supreme Court.

Annals Contempt Order.

HELENA, Mont., April 29.—The Supreme Court today heard arguments on the motion to set aside a contempt order made by Judge Harney last Saturday, adjudging Lawyers John A. Forbe and L. O. Evans, of Butte, guilty of contempt and fining them each \$500 and sending them to jail for 24 hours. The contempt order and order released the bondsmen. The contempt consisted in filing affidavits in a mining suit reflecting on the Judge.

Paris Salon Opened.

PARIS, April 29.—President Loubet today opened the old salon in the Grand Palais. There were 1850 exhibits, compared with 2002 last year, resulting in an improved aspect and a higher level of merit. Chartrain's portraits of Mrs. and Miss Roosevelt attracted a large share of attention, and received high praise from the critics. The American artists were represented by many meritorious works.

Minister Wu Feels Offended.

WASHINGTON, April 29.—Minister Wu Ting Fang has declined an invitation to deliver an address at a school commencement at Milledgeville, Ga., on account of the recent criticisms of himself in the Senate.

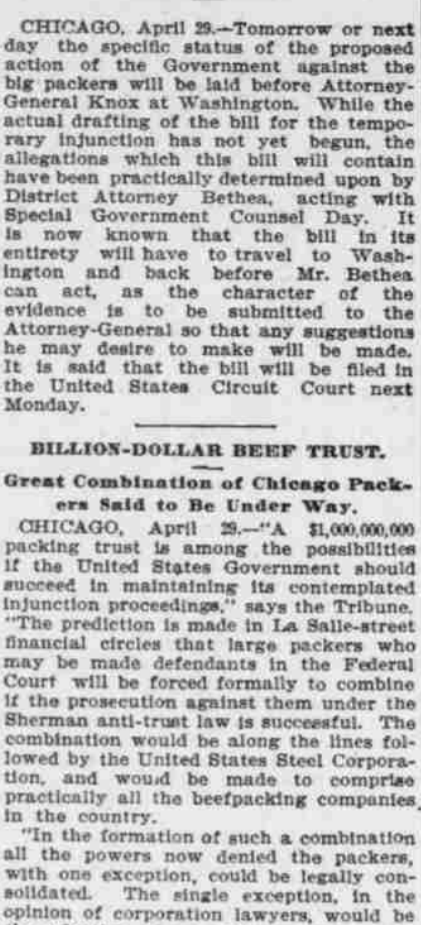
Men's Burns Prove Fatal.

FORESTERS BEGIN WORK

Triennial Meeting of Supreme Court of Independent Order. LOS ANGELES, Cal., April 29.—The opening session of the triennial meeting of the supreme court of the Independent Order of Foresters was held today. The first important business to come before the supreme court was the presentation of the triennial report of Dr. Oronhyatekha, supreme chief ranger, in which he advocated the correction of certain abuses and the institution of certain reforms in administration. It has been reported that the supreme court contemplated a rerating of the old members at the present session, but the officials deny the statement. Up to January 1, 1902, the supreme court disbursed in benefits to its members and their beneficiaries more than \$1,250,000. Since the last session of the supreme court, December 31, 1901, there had been instituted 1773 subordinate and companion courts. Among those in attendance were W. W. Hunter, a prominent barrister, of Toronto; A. E. Stevenson, general manager of the United States branch of the Foresters; R. Lee Bryce, head of the Australian branch of the order; C. H. E. Rea, president of the Actuaries Insurance Association of Great Britain; Dr. R. Kelly, Anglican bishop of Western Australia, and Supreme Secretary J. A. McGilivray. A committee of Royal Foresters from Saginaw, Mich., under the command of Major Harrison, is acting as guard of honor to the supreme officers. The company is composed of 29 Royal Foresters.

CURED MEATS GO UP.

Advance Is 1-2 Cent a Pound—Lard Also Takes Upward Jump. All kinds of cured meats have advanced 1/2 cent a pound. Lard is 1/2 cent a pound higher. These new prices are announced in the local market to meet the higher level of prices in the East. In the past month cured meats have all advanced about 1 cent in the East. Small receipts and higher cost of hogs are the causes of the advance. Receipts are between 25 and 35 per cent less than they were last year at this time. Stocks are not laid by as is commonly done at this season, to meet large summer and autumn consumption, and the result is short accumulation. A premium is paid for large hogs, and large hams now cost more per pound than do small. Usually large hogs are a little cheaper than small.
