CROCKER GOES EAST. Candidate for Collector Will Meet President Roosevelt.

FIREMEN OVERCOME BY SMOKE. Twenty-six Have Narrow Escapes to Seattle Hotel Fire.

SEATTLE, Wash., April 30.—At 2:30 o'clock this afternoon fire broke out in a sub-basement on First avenue, used for storage purposes by a retail furniture store.

Twenty-six firemen were overcome by the smoke and fumes general in the infernal material. The fire had gained considerable headway before it was discovered, and when the apparatus arrived the whole building, which is a six-story structure, occupied by the Bainier-Grand Hotel above, was enveloped in a dense smoke.

It became necessary to dig through four feet of solid masonry from an adjoining basement to reach the seat of the flames, which were finally quenched, with no damage to property other than the stock owned by Seater & Co., valued at \$900.

The overcome firemen were taken into the open air by a corps of physicians managed to revive them all.

LOVE FOR GIRL BRINGS HIM BACK.

Alleged Horse-Thief Is Promptly Taken in Charge by Sheriff.

COLFAX, Wash., April 30.—James Chamberlain, who has been wanted by the Sheriff for a month, on a charge of being a member of an organized gang of stock thieves, was arrested by Deputy Sheriff Davis at the home of J. Standford, in "The Rocks," in the town of Wrester part of the county, yesterday.

Chamberlain, who is a mere youth of 19 years, is charged with the theft of six head of horses from Hon. W. L. LaFollette, March 14. The horses were found in the pasture of I. W. James, who is now in jail awaiting trial on a charge of receiving stolen goods.

Chamberlain disappeared, but being in love with a farmer's daughter, returned and was captured. He was taken when the officers, collecting in the room, and made no resistance. The officers are looking for others who are alleged to be members of the same gang.

A controlling interest in the Guy Milling Company was sold today to Guy Lombard and associates, known as the Tekoa Company, of Tekoa, Wash. The Guy Milling Company has been capitalized at \$900, but this is to be increased to \$25,000, and the capacity of the mill increased from 50 to 120 barrels per day.

The Tekoa Company, owned by J. Russell, at 7 o'clock, and will increase its capacity to 200 barrels. This company now owns the electric light plant, mill, bank, harness store, creamery, grocery, hardware, furniture and general merchandise stores at Tekoa and will also handle grain.

BARBER OBJECTS TO BOYCOTT. Asks Court for an Injunction Against Union at Vancouver.

VANCOUVER, Wash., April 30.—P. P. Hunt, proprietor of a barber shop against which a boycott has been declared by the barbers of the town, has filed a petition in the Superior Court asking for an order of injunction against the members of the Vancouver Barbers' Union.

The plaintiff alleges damages in the sum of \$50, which he alleges he has sustained in loss of business by reason of the boycott last Sunday. The members of the union, he alleges, collected in the room, and used abusive and boisterous language, and circulated handbills, the purport of which was to prevent persons from patronizing his shop, all of which, it is alleged, conspired to the damage claimed.

The court is asked to issue an order restraining the members of the union or others from further circulating handbills referring to him in his business, or from further interfering in any manner with his business. Each member of the Barbers' Union was today served with a copy of the proceedings.

WAR ON BEER PRICES ENDS. Spokane Breweries Consolidate and Advance Prices.

SPOKANE, Wash., April 30.—A war in beer prices, which has been going on in Spokane for two years, ended today in the consolidation of the two big brewing concerns, the Spokane and the Galland-Burke.

As a result, prices have been advanced from 12 to 14 per barrel. The managers say their prices are now on a level with those of the Coast cities. The Spokane Company bought the Galland-Burke property, and will increase its capital stock from \$500,000 to \$750,000.

The consolidation of the two big brewing concerns, the Spokane and the Galland-Burke, as a result, prices have been advanced from 12 to 14 per barrel.
