

STRIKE IS ORDERED

Hard-Coal Miners Will Walk Out Monday.

OWNERS REFUSED TO ARBITRATE

Another Convention of Union Will Be Held Wednesday to Decide Whether Strike Shall Be Permanent.

SCRANTON, May 9.—A general strike of the miners of the anthracite region has been ordered for the afternoon, but the order has a reserve qualification attached. The question as to whether the strike is to be made permanent is left to the decision of a convention of delegates of all local organizations of miners, to be held at Hazleton next Wednesday.

The miners' executive committees of five districts met this morning, and had a three hours' session. At its conclusion President Mitchell gave out the following statement:

"Reply to our proposition to submit the question in dispute to an impartial board of arbitration have been received from President Baer, of the Philadelphia and Reading; Chairman Thomas, of the Erie Railway; President Truesdale, of the Lackawanna, and President Oliphant, of the Delaware and Hudson, all of whom refuse to join us in the adjustment of the differences between us by the methods we proposed. The executive committees are now considering the chances of success or possibilities of defeat should a strike be inaugurated. A decisive vote on the question will be taken this afternoon.

At 4:30 o'clock the committee again assembled and remained in session until 7:30 o'clock. When the session concluded President Mitchell prepared a statement, and assembling the newspaper men at the St. Charles Hotel, read to them as follows:

"The anthracite workers of Pennsylvania have elected a committee of the anthracite miners, who were delegates to the Shamokin convention to represent you in the negotiations with the mine operators for a three days' convention. It increased wages, shorter hours and better conditions of employment, have exhausted all peaceful, conciliatory and honorable means at their command, and have failed to secure any concessions of a tangible nature, and while under the resolutions adopted by the Shamokin convention authority was vested in the executive committee, should they fail in the negotiations, to inaugurate a strike at whatever time in their judgment held out the greatest promise of success, the committee, after three days' deliberation, are of the opinion that in justice to the anthracite miners, and those dependent upon them, before a general strike is inaugurated, the question should further be considered by a delegate convention, in which representatives of the various local unions shall be fully instructed by their constituents and prepared to vote in favor of or in opposition to complete cessation of work.

"In the meantime, all persons employed in or around the collieries, strip-pings, washeries and breakers are instructed to abstain temporarily from all work, beginning with Monday, May 12, and continuing thereafter until a final decision is reached by a delegate convention, which will convene Wednesday morning, May 14, at Hazleton, Pa.

"The basis of representation in this convention shall be one vote for each 100 members and one vote for each additional 100 member or majority fraction thereof. The executive committee recommend that special meetings of all local unions be held Monday afternoon, May 13, for the purpose of electing delegates, and considering the question involved, and it is especially requested that instructions be given delegates as to how they should vote on the question to inaugurate a strike or continue work.

"The instructions for all men to suspend work Monday do not include firemen, engineers, pumpmen and other labor necessary to preserve the property of the operators.

"The order is signed by all the district presidents and secretaries. There is a large crowd about the St. Charles when the order was given out, and the proverbial dropping of a pin would be audible at any time. President Mitchell, standing in the center of the crowd on a chair, read the statement.

Immediately upon the conclusion of the reading the crowd scattered, and in an indescribably short space of time persons had spread by word of mouth and message all through the valley. A thousand varying comments might be heard from the miners as they learned of the committee's action. The general sentiment could cover the general sentiment. There is not a particle of question that the miners will religiously obey the order and that Monday next not a single shovel of coal will be mined in the Lackawanna Valley.

While the committee meeting was on this afternoon, President Mitchell was summoned to the Missouri and a telephone message. He was gone over half an hour. Reports had it that he was in communication with Senator Hanna. He refused to say whether or not this was so.

No Appeal to Morgan.

NEW YORK, May 9.—At the office of J. P. Morgan & Co., the report that a direct appeal for a settlement of the differences between the miners and the operators had been made to Mr. Morgan was denied. It was asserted that no communication had been received from Mr. Mitchell.

AGAINST BEEF TRUST.

Proceedings Filed by Attorney-General of Missouri.

JEFFERSON CITY, Mo., May 9.—Attorney-General Crow tonight filed in the Supreme Court of this state proceedings against the Armour Packing Company, the Hammond Packing Company, the Cudahy Packing Company, Armour & Co. and the King Packing Company for violating the state anti-trust laws by combining to fix and maintain prices and control the supply of dressed, cured and smoked meats and lard in Missouri. An alternative writ was issued returnable to the court on June 20. The proceeding is the result of the inquiry this week before Judge Burgess, where evidence was secured from butchers and dealers. United States Attorney-General Knox telegraphed Attorney-General Crow today for a copy of the evidence, and he will furnish it at once.

HER SAFE WAS EMPTY.

Great Humbert-Crawford Lawsuit Ends in a Fiasco.

PARIS, May 9.—The interest in the great Humbert-Crawford lawsuit, which was supposed to involve the possession of 100,000,000 francs, and which had for years been before two continents, culminated in a fiasco today, when the police officials proceeded to the residence of Madame Humbert and found the safe, in which the alleged securities to the value of 100,000,000 francs were said to be locked up, was empty. All the parties to the suit are South Americans.

According to the story, R. H. Crawford died 20 years ago, and left 100,000,000 francs to Theresa d'Aurillac, now Madame Humbert. Just as the lady was about to obtain possession of the fortune, two nephews of Mr. Crawford appeared with a second will, bequeathing the property to them. A lawsuit was commenced for the possession of the money and securities, which, according to Madame Humbert, by mutual agreement had been locked up in a safe in her house, conditional on her not touching the money until the court's verdict was returned. Madame Humbert, in the meanwhile, borrowed millions on the strength of the supposed fortune.

CAUSE OF THE WAR.

Spanish Senate Is Again Threshing It Over.

MADRID, May 9.—For the last two days the Senate has been discussing the interpellation of Marañon Primo Rivera concerning the Spanish state of affairs in Spain and the United States. Senor Moret yesterday, in defending his conduct at that time, said the Spanish fleet quitted Santiago de Cuba on the advice of the Council of Admiralty, which had been convoked at Madrid. Senor Moret was Spanish Minister of the Colonies at the time of the war.

Spanish Mission at the Vatican.

ROME, May 9.—The pope today received in audience an extraordinary mission headed by the Marquis de Ajerbe, conveying the public acknowledgments of King Alfonso XIII. The state ceremonial was observed. The Marquis presented to the pope, in behalf of their Majesties, a superb carpet. His holiness returned the compliment by presenting the Queen Regent moccasins valued at \$10,000 manufactured at the Vatican.

The pope will receive ex-Queen Natalie of Serbia tomorrow. Her letter announcing her conversion to the Roman Catholic faith was signed, "a very devoted daughter of the Roman church."

Severe Weather in Italy.

ROME, May 9.—The weather in Italy is very severe. In the northern mountains furious cold winds with rain and snow are blowing. A violent tempest is raging over the Adriatic Sea. The waves have run ashore at Civita Vecchia and the lighthouse and a portion of the sea wall there have been washed away. The vineyards in the vicinity of Genoa have been ruined by the extreme weather.

Presents for Roosevelt.

PARIS, May 9.—The Rochambeau mission, which sails from Havre tomorrow, takes as presents to President Roosevelt for Mrs. Roosevelt, the table centerpiece of Sevres porcelain, which won the prize at the exposition of 1900, and for Miss Roosevelt, a Sevres tea set.

Wilhelmina Improves.

THE HAGUE, May 9.—Queen Wilhelmina had a quiet night, with no rise in temperature. She is making sufficient nourishment, and her condition really is satisfactory. Queen Wilhelmina was able to sign royal decrees this afternoon.

King Disapproves Ship Combine.

LONDON, May 9.—The Associated Press learns that King Edward has expressed to a friend his strong disapproval of the shipping combine on patriotic grounds.

Earthquakes in Southern Spain.

MADRID, May 9.—Earthquakes were felt at Alicante, Murcia and El Che, on the southern coast of Spain, last night. Panics followed, but there were no fatalities.

Kaiser Offers a Yacht Prize.

BERLIN, May 9.—Emperor William has offered a prize of \$90,000 to be competed for at the Heligoland-Dover yacht regatta, June 15.

German Vineyards Destroyed.

BERLIN, May 9.—Nearly all the Spring growth in the vineyards in the Saar region has been destroyed by frost.

STORMS IN THE EAST.

Heavy Snow in Minnesota.

IMPRESSIVE AND SOLEMN

FUNERAL OF THE LATE ARCHBISHOP CORRIGAN.

Requiem Mass Said by Cardinal Gibbons—Sermon Preached by Archbishop Ryan.

NEW YORK, May 9.—The body of Miguel Corrigan, Archbishop of New York, was interred today in the crypt of St. Patrick's cathedral. The funeral was conducted with all the impressive solemnity and ceremony of his church and was attended by a remarkable gathering of clergy. Almost with the break of day crowds began to assemble at the cathedral, and when the hour of funeral service arrived, a multitude had been assembled to pay last respects to the dead prelate. Ignite, on the gothic altar, six candles were burning, and the smoke of incense hung about it. Around the altar, where the dead archbishop lay, three burned on each side of him, with a double row in a candelabra above his head and another double row below his feet. These were the only lights except the blue and crimson bars of sunshine which filtered through the window of the sanctuary. Black cloth was hung about the fluted pillars; on the vacant archiepiscopal throne there were purple and black, and laurel tied with red silk. Opposite, on the episcopal side, a cardinal's throne had been prepared, all purple, with the cope on the pulpit, were all the signs of mourning.

The chimes played, and then the bells tolled from the spires; and after that the priests and bishops and archbishops and cardinals gathered in, following a boy with a cross and candle-bearers. There were bearded Franciscans in coarse brown cowls, with white rope girdles; swayer brethren in white lace surplices; Jesuits in tall black; Dominicans in black and white cowls; more priests in lace, bishops in purple; and after an interval the spare, bent figure of the cardinal in black and gold, with a black and gold half pace behind him on either side. Then there were National Guard officers in uniform; and in the south aisle came various officers of the city government, two rows of them, in black coats, bows of crepe on their sleeves. Within the altar rail, priests and bishops and archbishops were arranged in proper precedence. The cardinal presided, and the attending deacons placed over his red robe the white vestments of the mass, and on his head the white mitre, and the mass began.

The cathedral was crowded when the service began. At 10 o'clock the procession of priests, Bishops and Archbishops, with Cardinal Gibbons, entered the Cathedral. A Protestant Episcopal minister, Rev. F. M. Clendenning, rector of St. Ann's Protestant Episcopal Church, Westchester, walked in the procession with Dr. Brann, of St. Agnes' Roman Catholic Church.

After the reading of the gospel, Archbishop Ryan, of Philadelphia, preached the sermon, in the course of which he said:

"The three Archbishops of this great see were of different characteristic virtues. The Most Rev. John Hughes stands out as the most striking exemplification of courage when courage was much needed. His courage was distinguished for his marvelous prudence, by which he conquered without fighting. Archbishop Corrigan seemed to belong rather to the Cardinal McCloskey class of men, but when principle was involved, he was immovable as Archbishop Hughes. His motto—'Dominus petra mea'—(the Lord is my rock)—was first that of the monk, but later of the statesman. The Archbishop himself was a rock-mossy and yielding on the surface, but beneath, firm and immovable. He was brave with the courage of God, for whom alone he suffered. His humility seemed to make him timid.

"What, after all, is death to such a man as this? What but a liberation, an illumination, a unification, a liberation from most pressing duties and responsibilities, an illumination when the light of God's face shall shine upon him, and he will be the solutions of all the great problems of life, and the length of his breadth and height and depth of God's love, and a union with the divine original, after whom he was formed."

At the close of the service a death mask of the Archbishop was taken. The body was placed in a casket, which was taken to the crypt under the high altar and placed in a vault beside the bodies of Archbishop Hughes and Cardinal McCloskey.

Successor of Corrigan.

ROME, May 9.—The correspondent of the Associated Press is informed that it is not likely that the successor of Archbishop Corrigan will be named at the next consistory, which probably more than a month will elapse before action will be reached. It is therefore probable that a capitular vicar will be appointed to administer the archdiocese.

Memorial Service at Rome.

ROME, May 9.—There was a memorial service in honor of the late Archbishop Corrigan of New York, this morning, in the chapel of the American College here. Bishop McDonnell, of Brooklyn, N. Y., celebrated a requiem mass and Cardinal Satolli assisted.

Passenger Train Held Up.

MEMPHIS, Tenn., May 10.—Word has reached here from Bonnevill, Ark., that the Frisco passenger train which left Memphis at 3:25 last night was held up between Jonesboro and Bonnevill, Ark., at 2 o'clock this (Saturday) morning. There were four men in the attacking party. After stopping the train they detached the engine and the passenger car, pulled to a "blind siding" where they blew open the safe with dynamite. The explosion wrecked the car, and the men escaped in the darkness. A posse has been sent to the scene.

POLICE MAKE BIC RAID.

Arrested 240 Persons in "The" Alieu's Gambling-House, New York.

NEW YORK, May 9.—A sensational raid was made by the police today on an alleged gambling-house on Sixth avenue, known as the West Side Club, and of which "The" Alieu is the alleged proprietor. Inspector Brooks and Captain Chapman, with 40 policemen in plain clothes, planned the raid. Warrants had been secured for the alleged principals, and at a given signal the attacking party advanced to the house, battering in the doors with axes as they passed through the passages. Over 200 persons were completely trapped. Every point of escape was guarded by policemen, and as the rush for escape began, the arrests were rapidly made. The police say they found the various rooms fully equipped for betting on the races, and all sorts of gambling apparatus was seized. In all 240 persons were taken to the station-house.
