

TO PAY ONE-FOURTH

Lewis and Clark Directors
Levy Stock Assessment.

CALL MADE FOR 25 PER CENT

New Offer for City View Park Is Submitted—Investigation as to How Other Expositions Were Conducted.

The first assessment on the capital stock of the Lewis and Clark Corporation was levied by the board of directors at the regular meeting held yesterday afternoon. It is for 25 per cent on all subscriptions for one share or more. Of subscriptions for less than one share the whole sum is called. Steps were taken to ascertain definitely how other expositions have been conducted, and how those who were connected with their management think the methods might have been improved upon. This information is sought for the purpose of preparing a definite outline of the scope and plan of the Lewis and Clark exposition, which is deemed necessary to have before further progress can be made toward organizing the exposition, or even selecting a site for it. A more definite offer of the City View Park site was submitted.

The first matter to get the attention of the Lewis and Clark directors yesterday afternoon was an invitation of the Albina Sub-Board of Trade, by M. E. Thompson, for the directors to take an automobile excursion to the Albina & Knox tract, offered for an Exposition site, and more thoroughly inspect it. Eight of the directors present had already examined the tract, and the others said they would do so.

Benjamin J. Cohen, secretary and treasurer of the City View Land Company, submitted a more definite offer of the City View Park tract for the Exposition site, having talked with the sub-committee about the tender made Monday. He offered to lease the tract, 37.65 acres, for a period reaching from June 1, 1902, to January 1, 1906, for \$100 a year, the Lewis and Clark authorities also to pay the taxes on the property, which for the past three years have averaged \$550. The company would also donate to the city five acres of the tract for the permanent improvements it might desire to make. Though the land company desires to sell the tract in a body, it reluctantly offered the Lewis and Clark corporation an option on the entire area for \$100,000. Chairman Wessinger, of the sub-committee, in supplementing the offer of Mr. Cohen, said that in talking the matter over with the sub-committee Mr. Cohen had said that his company would sell for the Exposition about half the tract, selected where it would best suit the purposes of the celebration, at the same rate that was named for the whole. The offer to lease reserved the right of the land company to give one or more rights of way to steam or trolley railways, to be taken where they would not interfere with the Exposition. This offer was filed with the others.

The board declined to have read an anonymous letter signed "Citizen." A letter of Commissioner Deane recommending that the board take the Omaha Exposition, which was a success, as a pattern for the Lewis and Clark celebration, was read. Letters of Senators Mitchell and Simon, and Congressman Tongue and Moody, promising to comply with the request of President Corbett to favor the postponement of the St. Louis fair if application for it should be made, were submitted.

The letters of C. Harper Anderson, pertaining to the relics of his illustrious kinsman, Meriwether Lewis, which letters have already been read, and which were read to the directors, and Secretary Reed was instructed to reply, expressing the board's approval of the plan for exhibiting the relics at St. Louis and in Eugene. Mr. Anderson said that he and the Lewis and Clark fair, but to say that the board is not now in position to make an offer for them.

On application of A. A. Morse, president of the Oregon Sunday School Association, President Corbett was directed to send by Mr. Morse the invitation of this board for the International Sunday School Convention to hold its next triennial meeting in Portland in 1905.

Miss Edith L. Niles presented plates of halftone portraits of Lewis and Clark, with facsimiles of their signatures, free of charge, to the board, and the gift was accepted with thanks. Aune, the photographer, applied for the position of official photographer for the Exposition; W. B. Chase filed an application for a situation as engineer for the Exposition; J. J. Chamberlain wished to be auditor; George Ott desired to be employed to arrange the landscape for the Exposition. All these applications were considered filed, and the secretary was directed to keep an index of all applications for positions and to file them after making proper acknowledgment. It was also decided that the time of the board should not be consumed with the consideration of communications that could as well as not be attended to by the secretary alone or upon conference with the president, and that only the more important communications will be brought before the board.

J. M. Long, the representative of the board in the canvass of the state for subscriptions to the Lewis and Clark Exposition and Oriental Fair, reported that he had arranged for meetings at Baker City, La Grande and Pendleton; that the people of those towns manifest a healthy interest in the enterprise and he was sure they would do their share to support it. It was resolved to ask President Meares, of the Chamber of Commerce, and President Beach, of the Board of Trade, to attend those meetings with Mr. Long, and President Corbett was authorized to select other representatives of the board to attend as an evidence of good faith in the movement and of the interest Portland feels in it.

The following resolution declaring the levy of the first assessment on the capital stock of the corporation was offered by Director Fenton, chairman of the ways and means committee, and passed without dissent:

Resolved, by the Board of Directors of the Lewis and Clark Exposition and Oriental Fair: That an assessment of 25 per cent on the capital stock of the company, and on all donations of money made to the company, be hereby declared and made, and be hereby made due and payable to the First National Bank, treasurer of this company, on the 1st day of July, 1902; provided, that all subscriptions to the capital stock which are for less than one share shall be paid in full to the treasurer on the date above mentioned.

Resolved, further, That the secretary shall proceed in the manner provided by law to protect the interest of the company in the estates of subscribers in the capital stock who have died since November 26, 1901.

Resolved, further, That notice of this assessment shall be given to subscribers in a newspaper of general circulation in the City of Portland once a week for four weeks prior to July 1, 1902; and the secretary is further instructed to mail to each shareholder a statement of the number of shares held by him and the value thereof, together with a statement of the amount due from him under this assessment.

STUDENT'S GIVE A PLAY.

St. Helen's Hall Girls Put on Clever Comedy.

A tragedy-comedy, entitled "Faith and Qe; or How a Little Faith Changed Many Faiths," presented by the students of St. Helen's Hall last evening, was one of the cleverest amateur performances ever given in the city.

Just as the fagots are being lighted Philip Fairfax, a friend of Randolph, arrives from the East, and the two young Virginians make short work of the vicious Puritans. Randolph, of course, gets the girl.

YOUNG THIEVES CAUGHT.

Two Boys Agreed for Robbing Telephone Boxes and Other Thefts.

Two boys who are supposed to be leaders of a gang of youngsters who have been robbing telephone boxes were arrested by Detective Kerrigan and Snow yesterday afternoon. The boys, who gave the names of Charles Burton and Charles Clark, admitted that they had committed several robberies, but declined to name their associates. The officers also arrested Robert Matthews as an accomplice, but upon examination by the Chief of Police he was released, as there was no evidence against him.

The two boys held are accused of having robbed the telephone boxes in the Good enough and Burkhard buildings, the Grand Central station and Charles Lohmre's blacksmith shop. The boys effected an entrance into Lohmre's place by breaking a window.

When arrested the boys had a number of wrenches and bicycle tools in their pockets, and they admitted that they had stolen money from the telephone boxes, they said, in opening the boxes. Asked by Detective Kerrigan as to what they did with the money stolen, they said that they "matched" with other boys and lost it, or most of it. They also offered about a dozen nickels and two telephone "slugs" to the officers, and they were placed in the safe as evidence. Both boys will have an examination today.

HUNTING A LOCATION.

Wholesale Grocery Firm May Come to Portland.

A large firm of wholesale grocers, of a town in Illinois, is looking over the Pacific Coast for a new location. The firm, which has been in business for many years, has a big grocery business. The company has ample capital, and with the connection it has in the East, desires the very best of trade obtainable. "We have several locations in consideration," said the representative of the company, "and among them yours. We expect to make our decision in the next 60 days, after personal inspection of the coast, and we should be glad to hear from you in regard to the location of your business, to build and complete a structure of our own by October. We are in possession now of much data and very general information, but would be pleased to hear from you in regard to any building you might have that might meet our requirements and be desirably located for shipping facilities. We want a site with at least 150 by 150 feet, three or more stories high, and with ground adjoining that would allow enlargement of the structure."

A number of new buildings are contemplated in this city. Should any of these be desired to correspond with the company in regard to putting up a building, he can obtain the address of the firm at the Chamber of Commerce.

RADEMAKERS MUST GO BACK

County Court Orders Incurables to Return to Chehalis.

The Rademaker children, who are afflicted with leprosy, or some other incurable disease, will be sent back to Chehalis, where they came from. Judge Calk and County Commissioner Showers talked the matter over yesterday. Judge Calk said they were not residents of this state, and the taxpayers of Multnomah County were not going to be burdened with the responsibility of keeping them. They had arrived in Portland ostensibly en route to the School for Defective Youth at Vancouver, but had been dumped off the train here, and turned over to the authorities. Mr. Showers argued that the community is not responsible for their keeping.

Judge Calk remarked, "I telephoned to Lewis County, and ascertained that the County Court does not meet there until Monday. I think we had better order County Physician Mackay to send them back." Mr. Showers assented, and word was sent to that effect to Superintendent Hansen, of the Poor Farm. The children, since their arrival have been kept in a building at that place.

FRUIT MEN ADOPT PLANS

ASSOCIATION WILL BE FORMED TO UNITE GROWERS.

Prices Will Be Regulated by Committee—Sales Before 5:30 A. M. Are Forbidden.

At well-attended meeting of the Fruitgrowers' Association held yesterday afternoon in Odd Fellows' Hall, Grand avenue and East Pine street, a plan of action for the coming season was adopted, after full discussion. C. H. Welch presided. After reading the minutes of the previous meeting the report of the committee appointed at a former meeting was read by G. T. Hunt, chairman. Mr. Hunt, the committee signing the report were H. J. Mickelson, A. J. Henniman, A. V. Folkman and W. M. Gates. The report was read by sections, discussed and adopted. As amended it is as follows:

Your committee on permanent organization beg leave to submit the following report and recommendations for future operations, and in making this report we have divided our work under five different headings: First, organization; second, general contracts and general marketing; third, boxes and crates; fourth, market place; fifth, pickles and other specialties.

Under recommendations we recommend that we incorporate under the general laws of the State of Oregon, for the purpose of dividing into 100 shares of the par value of \$1 each; and that the name of the corporation shall be that of the Fruitgrowers Market Association; that so far as possible the shares shall be issued to each grower, and this corporation is intended to be temporary only; and for the purpose of giving us a thorough organization and to enable us to secure the enactment of a state law providing for the incorporation, operation and management of a co-operative association.

To reach an agreement among ourselves and with the canneries as to the amount of fruit that we shall contract, and how it shall be contracted, we recommend that a general grower contract this season on his own behalf and at such prices as he may secure, but he must contract and deliver at least 500 pounds of strawberries for each and every acre he has in berries; 1250 pounds each of raspberries and blackberries for each and every acre; and that he must file with the secretary of this corporation a memorandum of his acreage, pounds of fruit contracted and canneries contracted with, prices not to be given. This memorandum will be for the use of the directors of the corporation only, and is intended to insure the fulfillment of each and every contract, and in general marketing no member of this association shall offer or cause to be offered for sale any of his fruits prior to 5:30 o'clock each morning, and that the board of directors shall meet daily and estimate the probable yield of the same and estimate what amount shall be contracted for at the canneries from such acre.

As regards boxes and crates, we recommend that no boxes or crates be used more than once, under any consideration, except tin-tops used for canneries purposes only; that where crates are sold with the understanding that they shall be returned, full value of each and every crate shall be deposited with the seller at the time of selling, said deposit to be returned only when the crates are returned in good condition, this to apply to all classes of buyers, equally; and we further recommend under this heading that it would be proper for our association to endeavor to secure the enactment of a city ordinance prohibiting the sale or offering for sale of any fruit prior to 5:30 o'clock each morning, with proper penalty attached for each and every offense, and that we invite the co-operation of the Retail Grocers' Association and the Produce Merchants' Association to secure the enactment of such a law. That we endeavor to establish schedules of wages for pickers during the season.

Appended to the report was an obligation to abide by the rules of the association as set forth in the above report. There was much discussion over the proposition to contract so much fruit to the canneries, but it was decided to let it stand as a good thing, for the reason that it would prevent overloading the market at any time. There was no hasty action on any of the propositions.

The committee on boxes brought in samples for examination of the growers. No action was taken, and will not be taken until it shall be ascertained if 75 per cent of the growers will be willing to accept of the plan. The following committee was appointed to make a canvass of the different localities for names of growers: A. J. Henniman, B. Vall, J. W. Gragson, H. Haeger, A. V. Folkman, M. J. Maclean, and J. F. Jaeger. This is a special committee, but all the present members of the association are expected to act in the work of this committee. The district to be covered is mainly in Multnomah County and some portions of Clackamas County. In this district 75 per cent of the fruit-growers an effort also will be made to ascertain the number of acres there are in berries. If 75 per cent of the growers cannot be obtained, it is understood that the organization will not be pressed any further, for it is felt that any smaller membership would not be effective.

The next meeting will be held in the Odd Fellows' Hall, Grand avenue and East Pine street, next Monday evening, May 12, when it will be known whether this association will be a success or not.

MASS MEETING AT WOODLAWN.

Will Be Held This Evening to Discuss the New School-House Site.

A mass-meeting of citizens of Woodlawn and vicinity will be held tomorrow evening at 8 o'clock at Buxton's building, on the corner of Alameda and Union avenues, to consider the question of another site for the proposed new school-house, and also to discuss the widening of Union avenue to 80 feet, from Alberta street to Dekum avenue.

At a meeting held last winter in Woodlawn it was decided to leave the matter of selecting a site for the new building to the Board of Education, but it is understood that it is proposed to put the new building on the ground occupied by the present structure. To this objection is made that the new building should be on higher ground, somewhere in the vicinity of Alameda street, where it would be central to that part of the district. Much interest has been worked up over the matter. The meeting will be held under the auspices of the local Board of Trade.

ALBINA FAIR SITE OFFER.

Local Board of Trade Will Advocate Abraham & Knox Tract.

Now that the Ladd tract has dropped out as a possible site, with the Hawthorne Park, for the 1906 fair, the Abraham & Knox tract, near the city limits, is being urged strongly as a site for the Exposition. The Central Albina Board of Trade has taken the matter in hand and is pressing the advantages of the location on the attention of the board of directors.

This tract itself comprises 52 acres of well-located land. It has over one mile of river frontage overlooking the Willamette River, and the terminal grounds of the O. R. & N. It is on elevated grounds, standing on the same bench that extends along the Willamette River to St. Johns, and is certainly very light, commanding a comprehensive view of the Portland Harbor. Considerable adjacent land is said to be available, to the amount of 100 acres.

The main portion of the land is cleared. On the edge fronting the river there is a considerable fringe of natural growth of maple, laurel, dogwood and other shrubbery, with a considerable sprinkling of fir trees of small and large growth. At one point there are three or four acres of fir grove overlooking the river. Much of the land has been cleared and put under cultivation, while a portion still contains the stumps of massive trees. The

side overlooking the Willamette River bends in and outward, and there are several deep ravines descending from the higher ground down to the county road which follows the contour and windings of the bluff above high water mark. From the higher points, which project well out toward the river, nearly all of Portland may be seen. On a clear morning the scene is entrancing. The harbor is spread out, and the business portion of Portland is in full view. Perhaps the view is almost as complete as can be had from Council Crest, on the West Side of the City Park. The St. Johns spur extends along part of the tract. On the east side is the Willamette boulevard, Fremont street, it extended, bounds the land on the south side.

The offer is that the tract shall be used for a fair site, and that the citizens will donate a 10-acre tract for permanent buildings. Owners of the land have agreed to donate two acres. President Thompson and other members of the Central Albina Board of Trade say they are confident they will be in position to offer 15 acres in all for permanent purposes.

FINE SCHOOL ENTERTAINMENT.

Given to a Crowded Assembly at Clinton Kelly School Yesterday.

The assembly hall of the Clinton Kelly School, East Twenty-sixth and Powell streets, was crowded with a delighted audience yesterday afternoon at the entertainment given by the pupils for the benefit of the library. No gains had been spared in the preparation and drills. The main portion of this work was in the charge of Miss E. M. Wells, aided by the other teachers in the building. The parents supplemented all the efforts by providing the many different picturesque costumes required in the performance. It was a "May day festival," and the flowers of the season were represented. The east end of the assembly hall had been decorated as a fairy grotto, and was very beautiful.
