Albina Club Greets Judge
George H. Williams.

JUDGE CAPLES PAY HIM TRIBUTE

Enunciation of Republican Principles and Policies by Two Speakers Received With Enthusiasm
—Party Candidates Cheered.

Judge George H. Williams and Judge John P. Caples were the speakers at a Republican rally held in the Albina Club last evening. Judge Williams was received with enthusiasm, and was assured by the applause with which his address was interrupted that the people approve his views upon public questions now in issue. Judge Caples' address was an eloquent and logical presentation of the reasons which support the principles upon which the Republican party has entered this campaign. Judge Williams' address dealt chiefly with local issues, his contention being that the Republican ticket was made for a fair and honest primary election, that there is no good reason why it should not be elected, and that no Republican who is a Republican from principle should vote for a Democrat for office. Judge Caples gave an instructive review of the history of American expansion, showing that every drop of earth that was acquired by the United States prior to the recent acquisitions was brought under American sovereignty by Democratic administrations, and that the Democratic party has been a party of expansion until recent years. Both addresses were heartily applauded and made very favorable impressions upon the audience.

The meeting was held in Gomez Hall, under the auspices of the Albina Republican Club. The attendance was light, but was considerably better than was had at the fusion meeting in the same hall a week ago. T. W. Vreeland, president of the club, introduced the speakers in a few appropriate remarks. Judge Caples was the first speaker.

Judge Caples' Address.
When the applause following his introduction had subsided, Judge Caples commenced his address by referring to the great pleasure this opportunity afforded him of again looking into so many familiar faces, and renewing his acquaintance with old-time friends after an absence of more than four years. He said that more than 30 years ago he had had what he then esteemed as a high honor, the privilege of appearing upon the same political platform with the late President Grant. He said that he had justly honored friend, Judge George H. Williams. "I repeat," he said, "I felt highly honored then. I feel more highly honored now."

Then the Republican party of the Pacific Coast was a mere speck upon the political horizon, scarcely larger than a man's hand. I congratulate you, Judge Williams, I congratulate myself; I congratulate you all that we have lived to see that Republican party recognized and acknowledged as the political savior of this great Republic. Its influence extends all over this broad land; its praises are chanted from Maine to the Arctic Ocean, while its bugle notes of victory are sounded from the Pacific to the Atlantic, and from the Great Lakes to the north to the Southern Gulf.

Prosperity and Expansion.
Judge Caples compared the two party platforms and considered it a matter for congratulation that after fighting the Republican party for 30 years, the Democrats were unable to defeat it. He said that in this campaign, they have admitted, he contended, that the Republicans have been right on all other matters. The two issues are the prosperity and retention of the Philippines. The Democratic party stands opposed to those Governmental policies by which Republican administrations have made possible the present prosperity of the country. The Democratic platform contains a plain declaration in favor of giving up the Philippines.

The speaker called forth a storm of applause by an eloquent plea against hauling down the flag in the islands, and charged that the Democratic party has repudiated the principles of all of the great Democratic presidents by adopting a policy against expansion.

The following are brief excerpts from his remarks on that subject:
"Suppose the American Government had adopted an anti-expansion policy from the first, what would be the extent of our territory, and what would be our position among the nations of the world today?"

"When the Louisiana purchase was made, 'Was the Revolution fought for the benefit of the wild men of that far western country? But the party of expansion prevailed, and when that vast productive region became an American territory no emissary of the Government went out to ask the consent of the natives."

On the course of his address Judge Caples stated a historical date incorrectly, and Judge Williams whispered a correction, whereupon the speaker took occasion to refer to the statement that Judge Williams is getting old, and declared in an impressive manner that such men as Judge Williams never get old.

At another point in his speech he closed a resume of the advantages gained by the acquisition of the Philippines by asking, "Shall we turn the islands back to those people?" A Democrat in the audience answered in a low voice, but loud enough to be heard by those near by, "Yes."

The mention of the name of W. J. Furnish was greeted with long continued applause, as was also a brief tribute to J. N. Williamson, a member of the United States in this district. He referred to Judge Williams as the man who for more than two score years had walked before the American people a tower of strength, and who would preside over the city's affairs as its chief magistrate and the Gladstone of the West.

Work of Republican Party.

"A brief retrospect of even a tithe of what the Republican party has already been able to accomplish," said he, "ought, it seems to me, to furnish an assurance of what it would most likely be able to accomplish in the future."

"The party, the administration of which for considerably less than one-half a century, has accomplished more in the interests of liberty and humanity, for the happiness and prosperity of the whole people of the United States, and by its prestige and example, it may said, for the liberty-loving people of the entire world, than has been accomplished by any other political party or organization in congress since the dawn of time."

"It found the National credit a jeering byword, but by a wise financial system it filled, by overhauling the vaults of our erstwhile empty Treasury, and re-established our National credit throughout the commercial countries of the world."

"In the red rain of war its gallant men, as with the beams of destruction, hurled from existence the black burden of African slavery, which, like a funeral pall, had tarnished the brightness of our National reputation for nearly 100 years."

"It found the laboring element of the country deep down in the slough of adversity and despair, but by a wise protective system it elevated both the people and their labor to a high plane of permanent

prosperity, and transformed them into the very highest types of living humanity, loyal, courageous and hopeful American citizens."

By his wise aggressive and defensive policy it has enlarged our territorial limits until we can now proudly boast that the sun never sets upon our broad free dominion."

Judge Williams' Address.
Judge Williams' address was many respects similar to those he has delivered before other Republican clubs in this city. He said, regarding his own candidacy, that he did not seek the nomination, but that he accepted it as the earnest solicitation of men of both factions of the Republican party, upon the plea that his acceptance would help preserve the party unity. He said that his friends had also urged him to accept because his long years of experience as a lawyer and a judge would enable him to conduct city affairs when the new charter is put into effect, without involving the city in costly litigation. Having accepted the nomination, he would feel very much humiliated by defeat.

Referring to the use of the word "citizens," employed to designate the fusion ticket, Judge Williams said it might imply that the candidates on the Republican ticket are not also citizens of the city. He said he is a citizen of Portland about 40 years, and considers himself as much of a citizen as any candidate on the opposition ticket.

He described the proceedings by which a few Democrats and a few Republicans traded with each other for places on a mongrel ticket, and said that every Democrat who is a Democrat from principle is a Democrat with a whole heart. He said, referring to the factional fight in Multnomah County, that he is neither a Simon nor an anti-Simon man, that he is a plain Republican. He has voted for Joseph Simon every time Simon has been a candidate in Multnomah County, and he deemed that a privilege which he had a right to exercise without being criticized by anybody. He expressed the opinion that those men who are called Simon Republicans are true Republicans, and inquired whether they are going to permit themselves to be sold out to the Democrats for a few offices distributed to office-seekers. For himself, he would rather vote for a Democrat who stood upon a Democratic platform and advocated Democratic principles than a Democrat who permitted his name to be placed on a fusion ticket.

Speaking of State politics, Judge Williams said, among other things, that he could not see how any man who is a Republican from principle can vote for the Democratic candidate for Governor, for Chamberlain represents the principles of the Democratic party. "Chamberlain," he continued, "for he knows that he cannot be elected without Republican votes. But let me tell you that he is a Democrat, and if he is elected, he will give you a Democratic administration that will make the Penneyer administration look like 90 cents."

He said that the Democrats all over the United States are anxiously waiting for the Oregon election. They hope to receive news that Chamberlain has been elected, so that they can march it through the East as a Democratic victory and a repudiation of the policies of Roosevelt. He commended the President's action in proceeding against the trusts, and hoped that Oregon would leave no uncertainty as to her endorsement of that policy.

In speaking of some of the cruelties which have been practiced by American capitalists, who were enraged by the treacherous slaughter of their comrades, Judge Williams said that a war is conducted for the purpose of killing people, and some cities cannot be exterminated. While he would not defend any kind of torture, it must be remembered that soldiers are not sent to war to play mumble-bee or ping pong.

On the labor question, he said that he is not an employer of men, and that he has no personal interest on either side of the contest that is going on between employers and employees. Being disinterested, he can see in any matter relating to labor difficulties as the justice of the case may require, and this is all that any one can reasonably ask. He could see no reason why the laboring people should be unfriendly to him, for he has been a laborer himself, and pays good wages to the few he now has occasion to employ. He said that his Newport speech to show that at a time when no political campaign was on, and when he had no thought of being a candidate for office, he had expressed opinions favorable to organized labor.

WHAT GEER'S FRIENDS WILL DO.
They Will Vote for Furnish—No Mistake About It.
Dr. T. C. Smith, of Salem, is in Portland for a few days. He says that Marion County will go Republican this year, as usual, and by about the usual majority. He has been some time in the habit of voting for Mr. Chamberlain, but Dr. Smith thinks that not many will scratch their tickets, and the number of Republican votes Chamberlain receives will make no material difference. Squire Farrar, nominee for State Senator in Marion County, says that the talk of Republicans voting for Chamberlain is rapidly fading in Salem, and that he openly talked of scratching the Republican ticket are now wearing Furnish buttons and are taking an active interest in the campaign. When the votes are counted it will be seen that the Republicans have voted right.

Another Marion County Republican who was in Portland yesterday, and who declines to let his name mentioned in this connection, said:

"You can count on all of Governor Geer's friends voting for W. J. Furnish for Governor. These are the men who talk about the close friends scratching their tickets, and are doing it for a purpose, and do not understand the situation. Early in the campaign many of Geer's friends were sore and talked of voting for Chamberlain. They know that the members of the Legislature will seek a reason not to vote for Geer for Senator, and that a very ready reason would be that his friends had never voted for him. Now, if Furnish should run behind heavily in Marion County, he would be charged against Geer's friends, and members of the Legislature would hold Geer responsible for it. But Furnish will not run behind to any great extent in Marion County. Geer's friends will be lined up when election day comes and will vote solidly for Furnish. Then when the Legislature convenes they will demand to know why Geer should not be elected Senator, since he has been shown to be the choice of the people. Those who want to vote for some other man will have to find some other excuse besides the disloyalty of Geer's friends."

NO MONEY ON CHAMBERLAIN.
Democrats Want Odds, and Long Odds at That.
The Democrats still continue to be in a hurry not to put their money up. They are putting up all kinds of talk, but their confidence in the election of Chamberlain is not of a very substantial kind. The five bets of \$1000 each on Furnish victories are still hanging at Sig Sichel's cigar store, and with them hang \$300 on Williams. There are no takers. Early in the campaign a number of bets, aggregating \$5, were made on the result of the mayoralty fight, but the human men seem to be weakening.

Some Democrats say they are willing to put up money on the proposition that the Furnish majority will be less than 5000, and more are willing to bet that it won't reach 7000. The Republicans think their opponents should either "put up or shut up," and until they stop talking of

electing Chamberlain, it is probable no bets will be made other than on straight results. Rather than miss a chance to take in some good Democratic coin, wagers may be laid on majorities late in the campaign.

A rather significant incident occurred in a hotel lobby a few days ago. An up-country politician, and something of a sporting man, was in town and was gathering information from one of his Democratic brethren in Portland. The Portland political leader painted the certainties of Chamberlain's success in glowing colors—had for all denials but counting the votes. With satisfaction spread all over his face, the Valley politician remarked:

"Well, I'm glad to know things are looking so well; I have a few hundred dollars lying loose and I—"

"Hold on here now! Hold on! Don't you tell me that you're not thinking of betting on Chamberlain? You were talking politics. You keep your money in your pocket!"

The story was started yesterday that a well-known Portland Republican is putting up money on Chamberlain. This turned out to be one of the brilliant campaign arguments of the Democrats, however, for inquiry developed the fact that the man mentioned had tried in vain to find some one willing to bet on Chamberlain, and, having failed, is on a vigorous hunt for some one ready to put up money on him.

Chamberlain at St. Helena.
ST. HELENA, May 15.—(To the Editor.)—The article in this morning's Oregonian headed "Up Against It at St. Helena" is a fabrication manufactured for

campaign purposes. Messrs. Chamberlain and Wann were not met at the depot with a band of cheering men, as the article stated. But a delegation of Democrats boarded the train at Scappoose and accompanied Messrs. Chamberlain and Wann to Houlton, and from there to St. Helena. At St. Helena they were met by the chairman of the Democratic Central Committee, who had arranged for the gentlemen's entertainment. Mr. Chamberlain dined at the business houses in our little city and was introduced to both Republicans and Democrats, and he was treated as royally as any one could have desired. Mr. Chamberlain did not enter the Collector's office, as the article stated. Nor did he meet your informant, T. C. Watts. Now as to Mr. Watts being in Portland, there is surely some mistake, for he is now in St. Helena, and has since Judge McBride was elected, engaged as court bailiff at \$3 per day, and as he could not attend to the duties of that office and be in Portland at the same time, it must have been some other gentleman who gave you that campaign lie. True, Mr. Watts has been in politics some time—so long that he thinks a "yaller dog" on his ticket is better than a square man on the Democratic ticket.

Now as to the meeting in the evening. It was presided over by W. B. Dillard, who introduced the speakers in a very cordial and spirited manner. Mr. Wann's speech was appreciated, and he will get many Republican votes. Mr. Chamberlain spoke for nearly two hours, and was frequently applauded. As to how many Republican votes he will get in this county, Mr. Watts nor no other man can tell; but one thing I do know—that if he should get all the votes of Republicans who said they will vote for him, he will receive at least 150 in the county.

BABY HOME'S MAY TEA.

Friends Will Be Entertained at the Institution Tomorrow.

The annual May tea of the Baby Home will be held at the Home tomorrow from 2 to 5 P. M. All the friends of the institution, old and new, are expected to be present. The institution will be open for inspection in every department. For the convenience of persons wishing to attend the "tea," the City & Suburban Railway Company will run special cars every 30 minutes Saturday afternoon, beginning at 1:30 o'clock.

The Baby Home is a worthy institution, and its object, the care and relief of helpless little ones, appeals to every kind of charitable heart. The directors are very anxious to get a hospital started in connection with the Home, as when contagious diseases appear among the inmates there is no other building to remove them to, and they have to be quarantined in one of the rooms of the Home, which is very undesirable and likely to cause the disease to spread among the inmates.

There are at present 18 babies in the Home, but the number of inmates averages nearly 25. The tea is free, but the managers hope to receive liberal donations from visitors to aid in securing the desired hospital, as well as to carry on the work they have on hand.

The Baby Home was incorporated in 1890. Babies are taken in for adoption and to aid parents in distress. Upwards of 50 babies have been put out with families who adopted them, and these have been kept track of as far as possible, and so far as the management knows there is only one of them whose condition needed to be bettered.
