

HOAR HAS HIS SAY

Denounces the Attitude of Government in Philippines.

HE DEMANDS OUR WITHDRAWAL

Sharply Arraigns General Funston for the Methods He Pursued in the Capture of Aguinaldo.

A notable contribution to the discussion of the Philippine question was made in the Senate yesterday by Hoar. He denounced the attitude of the Government in the Philippines as one of the most wicked and foolish chapters in American history.

WASHINGTON, May 22.—Soon after the Senate convened today a resolution offered by Hale was passed directing the Secretary of the Navy to furnish the Senate with detailed items under the head: "The Pay of the Navy."

OUR RIGHTS IN PHILIPPINES

Bishop Thoburn in Theological Argument With Senator Patterson.

WASHINGTON, May 22.—Bishop Thoburn, of the Methodist Episcopal church, stationed in India, was before the Senate yesterday to discuss the Philippine question.

"If a Filipino Government should be established and you had been asked whether you thought such establishment was the will of God, would you ask to defer your opinion?" "I would not say it was the act of God," he replied.

"No, I would not. I would say it was the act of American politicians." He added that he believed that with an independent Philippine Government, the Macabebes would be exterminated within 12 months.

Mr. Patterson asked the witness if he believed the subjugation of barbarous or semi-civilized people by the great powers to be the act of God.

"You volunteered to say that God had put us in the Philippines," said Senator Patterson, and he insisted on a reply.

that the steamship companies would see to it that the passengers could pass the test, if they knew they would have to carry them back unless they could. Shattuck and Kieberg (Dem. Tex.) opposed the amendment. The former sent to the desk an amendment to that of Underwood, which he said would get around treaty rights and at the same time make the rule applicable at the places it was desired to touch. It provides that all persons, whether able to read the English language or some other language, or not able to do so, who shall enter the United States except at the seaports thereof, or at Vancouver, Me., Newport or St. Albans, Vt.; Plattsburg, Niagara Falls or Buffalo, N. Y.; Detroit or Sault Ste. Marie, Mich.; Pembina, N. D.; Sumas, Wash.; Laredo, El Paso, or Eagle Pass, Tex.; or Nogales, Ariz., shall be adjudged to have entered the country unlawfully, and shall be deported as by law provided.

After a long discussion the Shattuck amendment was adopted, and the Underwood amendment, as amended, also was adopted. The bill was then laid aside until next week.

The Senate amendments to the omnibus public building bill were disagreed to and the bill went to conference.

An amendment to the rules was adopted, providing that before conference reports are considered in the House they shall first be printed in the Congressional Record. At 5:10 o'clock the House adjourned.
