

FIFTH DAY OF TRIAL

SHEVIE'S SISTER TESTIFIES IN CASE AGAINST HIM.

Her Affidavit as to His Whereabouts on Day of Murder Was Made After She Was Filled With Liquor.

ST. HELENS, Or., May 23.—An affidavit of Eva Zeller, sister of August Schevie, in the Schukowsky murder trial was introduced in evidence for the purpose of impeaching her testimony in court. The statements in the affidavit were corroborative evidence as to the time August Schevie was away from the house on the day after Christmas, the day of the murder. In rebuttal, Mrs. Zeller testified that she had been filled with liquor before making the affidavit; that she might have been forced to make her mark and sign the affidavit, but that she had no knowledge of having signed any such paper.

The statements supposed to have been made by the defendant while in the sweat box of the Multnomah County jail were not admitted as evidence.

The defense introduced an expert gunsmith from Portland, who testified that it would be an impossibility to determine by the indenture of the trigger as to whether a cartridge had been exploded by a rifle or by a revolver.

Twenty-two witnesses have been examined in this case, and after the defense closed their evidence the jury was taken out to the scene of the murder to look the ground over for themselves. The argument of counsel will probably be submitted to the jury tomorrow morning, which will be the fifth day of the trial.

In a Hurry to Be Hanged.

WHATCOMB, Wash., May 23.—Alfred Hamilton, also known as Alfred Hawkins, was hanged this morning at 6 o'clock for the murder of D. M. Woodbury. Hamilton was broken by the fall, and he was pronounced dead in 15 minutes and 5 seconds. Hamilton maintained his nerve to the last. Answering Sheriff Bridges' query if he had anything to say, "No, I am here to die." He cursed the Sheriff when he read the death warrant to him 10 minutes before the execution, and rushed up the scaffold stairs two steps at a time.

ROSEBURG, May 23.—Judge Hamilton today sentenced James Vivian Ware, alias Smith, to 10 years imprisonment for assault with intent to commit murder. Dan Saunders was sentenced to three years for stealing a rifle from Mose Ryan, at West Fork. Thomas O'Connor was sentenced to two months' imprisonment in the county jail.

SEVENTY-THREE IN LINE.

Democratic Colonels March With Chamberlain in Pendleton.

PENDLETON, May 23.—George E. Chamberlain, Democratic candidate for Governor, arrived here this morning, was received by a few friends at the railroad station, and proceeded to his hotel. He made a talk from Milton to West Freewater, two miles distant, and addressed a small gathering. Then he talked at Weston and Athena to good-sized meetings. He returned to Pendleton at 8 o'clock this evening, and was met at the station by two brass bands and a number of Democratic admirers. A procession was formed, and the marchers followed by Mr. Chamberlain on foot—the walking was good—supported by Colonel James H. Riley, Colonel E. D. Boyd and several other Democratic Colonels. In the procession there were, by actual count, 73 men, mostly candidates, or prospective candidates, and they made an imposing display as they marched up Main street. At 7:30 o'clock the Democrats, inspired by the melodies of the Helix and Athena bands, formed in procession again, and proceeded to the Courthouse, which was well filled by the house tonight. The enthusiastic admirers of Mr. Chamberlain, Mr. Chamberlain made his usual speech in favor of flat salaries and political reform, and was warmly applauded. Furnish buttons on the streets were about twice as numerous as Chamberlain buttons.

ROUSING MEETING AT MEDFORD.

County Candidates Attended, and H. V. Gates Spoke.

MEDFORD, May 23.—The largest audience reported during the campaign gathered in the opera-house tonight to listen to speeches by Gus Newbury, County Clerk, and Hon. H. V. Gates, of Hillsboro. The meeting was called to order by H. D. Jones, who was introduced by Mr. Newbury, who confined himself to a detailed record of the Republican officials for the past four years, and showed how the county debt was reduced over \$14,000 in the past year. Mr. Gates then addressed the audience on National and State subjects. He spoke of Tongue's record and services for the state, and made a strong argument in favor of the state ticket. He then paid his respects to the Democratic platform, dissecting it from top to bottom. His remarks were greeted with applause. All the Republican candidates for county offices were in attendance, and a large picture of Geer as candidate for United States Senator occupied a prominent position on the platform.

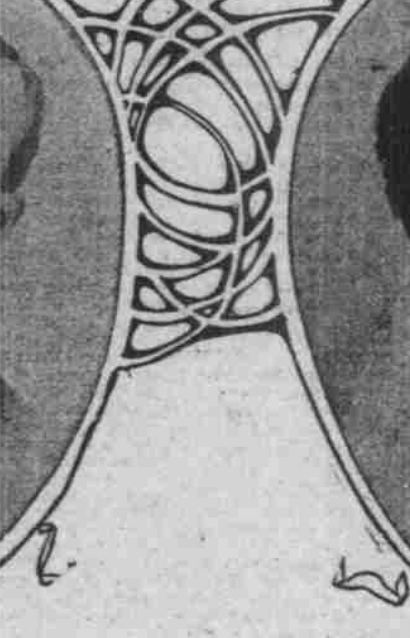

CHICAGO, May 23.—Speaking as a representative man of the colored race in Chicago, Ferdinand Barnett, one of the assistant State's Attorneys, stated that the time was not far distant when the 10,000,000 American negroes would forcibly revolt against Lynch law. He said: "There will be no other course left for us. Lynch law in the South has gradually made the negro feel he is an outlaw. In the last 15 years 500 negro men, women and children have been shot, hanged or burned at the stake without trial. The negro has consequently come to know that the law affords him no protection." Mr. Barnett uttered these words at an indignation meeting of the colored people held at the Bethelham Colored Church to protest against the wrongs done the colored race.
