

SECOND DISTRICT IS O. K.

CANDIDATE WILLIAMSON TELLS ABOUT HIS TOUR.

Meetings are Well Attended and Voters are Inclined to Support Republican Principles.

NO HOT AIR.

At the open-air meeting this evening at the corner of Sixth and Ankeny streets, where H. Williams and L. R. Webster will discuss the issues of the campaign in their usual forceful style. All voters are invited to attend and listen to the addresses of these ABLE SPEAKERS.

J. N. Williamson, Republican nominee for Congress, passed through Portland yesterday on his way to Rainier, where he and Judge J. E. Magers addressed a mass meeting of citizens last evening. When asked regarding the progress of his campaign, he said:

"I have visited every county in this district east of the Cascades, except Wheeler, and I find no reason to be discouraged. The Republican meetings have been attended by larger numbers of people than I have ever seen before on such occasions, and the enthusiasm is unlimited. It is a matter of no small gratification to me to see that the people of my section of the state, among whom I have lived and worked so many years, take so kindly to my candidacy. The campaign, however, is not a personal one, but so far as we are concerned, is being made a question of principle. The people of Eastern Oregon are prosperous, and are generally satisfied with the Republican National Administration. The Congressional campaign, of course, involves National issues only. The people are practically unanimous in favor of retaining the Philippines; they admire and applaud the noble fight President Roosevelt is making against the trusts, and the large majority seem to believe that Republicans who will support the Administration should be sent to Congress. I am inclined to believe that the big demonstrations made at every place we have held a meeting of citizens in favor of the Republican party continue to be the party of progress, prosperity and National honor, it will receive the endorsement of the people. The voters can see that the Republican party was right on the issue of the Philippines. They are wildly enthusiastic when any mention is made of the fight Roosevelt is making against the trusts. The people are with him, and will stay with him until the trusts are brought under control."

When asked regarding the gubernatorial campaign, Mr. Williamson's answer was short: "Furnish will be the next Governor of Oregon."

CHAMBERLAIN MONEY SLOW.

Sporting Men Offer Odds on Furnish in Multnomah County.

Men who have money to bet on the election of Furnish have found it necessary to offer some inducement to the Chamberlain men. There were five \$1000 bets offered, as follows: \$1000 that Furnish will carry Multnomah County; \$1000 that he will carry Eastern Oregon; \$1000 that he will carry Western Oregon; \$1000 that he will be elected Governor. The bets didn't start until yesterday, the Umatilla County, Eastern Oregon and state bets were taken down, and the others were changed to this proposition: \$1000 to \$500 that Furnish will carry Multnomah County, and \$1000 to \$500 that he will carry Western Oregon.

Taking down the three bets looked on the face of it as though the money was up the money had been taken down, but inquiry it was found that this was simply a scheme to lead the Chamberlain men on. The money has been up 10 days, with no one ready to take the bets. The bets were taken down in order to present the appearance of weakness, so as to encourage the Chamberlain men to put up their money, and then offer to take the bets. The two propositions were the same end in view. It has been expected that some odds would have to be given before any money would be put up on Chamberlain, and it is doubtful whether the bets now offered will be taken.

One Democrat almost bit the bait that was thrown in the way of odds on Furnish. When he offered to bet any sum up to \$5000 that Chamberlain would carry Marion County, a well-known Republican was informed of this, and in 10 minutes he pulled down \$5000 he jumped at the conclusion that the Furnish men were scared. He hunted up some of his friends and, after a consultation, went to the clear store and offered to take all of the five \$1000 bets. His bluff was promptly called and he was told to get his money. He went and returned, but had no money to put up the bets. He thought \$5000 had been taken down, it was up for any one who wanted to meet it.

Yesterday afternoon a card was hung up in a clear store offering to bet any sum up to \$5000 that Chamberlain would carry Marion County. A well-known Republican was informed of this, and in 10 minutes he pulled down \$5000 he jumped at the conclusion that the Furnish men were scared. He hunted up some of his friends and, after a consultation, went to the clear store and offered to take all of the five \$1000 bets. His bluff was promptly called and he was told to get his money. The story that \$500 had been offered on Chamberlain's carrying Marion County was diligently circulated by the Chamberlain men yesterday afternoon, and for a time it seemed to have the desired effect, but when it was learned that the offer had not been made good, the Chamberlain men doubt became convinced that Chamberlain has no chance in Marion.

An offer of \$250 on Williams still hangs out at Big Slick's cigar store, as also does the \$500 on Furnish.

COOS SAFELY REPUBLICAN.

J. D. Lee Reports Many Democrats Will endorse the Administration.

TALK ON KINDERGARTENS

FRIENDS OF SCHOOLS ADDRESS WOMAN'S CLUB.

Address by Mrs. Helen Ladd Corbett—New England Conservatory Club—Furnishes Musical Programme.

At the Woman's Club meeting yesterday afternoon the principal subject under discussion was the Portland free kindergarten, and the advisability of having them become a part of the public school system. A number of brief and instructive addresses on this question were made by Mrs. Helen Ladd Corbett, president of the Kindergarten Association, and Professor Rigler, superintendent of the city schools.

In the course of her address Mrs. Corbett earnestly urged the club women to exercise all their influence at the June election, at which it will be decided whether or not the kindergartens are to be continued.

"More than 200 cities in the United States," said Mrs. Corbett, "have combined the kindergartens with the public schools, and one only needs to inform himself of the work done in other cities to see how well the plan has worked."

Miss Pritchard gave some interesting

details of kindergarten work, also speaking of the necessity of earnest and ambitious effort which is essential to the life of a city.

Professor Rigler, when he was introduced, said:

"I think every intelligent person connected with education knows that the kindergarten helps children in their public school work. I would like to see the kindergarten connected with the public schools. In order to give children a well-rounded training we should have the kindergarten and the manual-training school. At the election on June 3 this question will be voted upon separately from all other questions, and I am inclined to think the people will accept the proposed combination."

It was resolved that the Woman's Club pledge to the Kindergarten Association their hearty interest and support, and appoint a committee to act in favor of the resolution. After a short but very interesting account of the visit to the biennial convention in Los Angeles, presided over by the president, Mrs. Marquam, there was an intermission, after which a most delightful musical programme was given by the members of the New England Conservatory Club.

The programme was opened by two numbers, (a) "The Water Lily," Franz Abt; (b) "The Only," vocal, sung by a double trio consisting of Mrs. Goddard, Mrs. Piper, Mrs. Linn, Miss Watt, Mrs. Shillock and Mrs. Shultz.

The Beethoven "Polonaise" was given with precision of attack and great delicacy of touch by Mrs. Shultz. Miss McGinn, Mrs. Goddard and Mrs. Hall.

Mrs. Hamilton, who has not been heard in Portland for some time, sang the "Chanson Provencale" of Dell Aquana, which is admirably adapted to her light, dainty style, and in the duet with Mrs. McGuire her voice was also heard to advantage.

Mrs. Berry played on the violin the "Second Mazurka" of Wieniawski, with good style, showing dainty bowing and careful phrasing.

Mrs. Shillock, with her usual pleasing manner, delighted the audience with Lillie's "Home Song," her lower notes being particularly rich and full. Miss McGinn played Chopin's "Ballade in G Minor" most effectively, giving to its rendition brilliant execution and delicate shading.

Mrs. Shultz, both in the duo and Saint-Saens' variation, in a theme by Beethoven, showed herself possessed of ample technique and delicate and sympathetic touch.

Mrs. Piper sang two numbers beautifully, Van der Stucker's "The Sweetest Flower," which brought out all the sympathy and pathos of her voice, and Cowen's "Snow Flakes" gave more expression to its power and brilliancy.

Roberts' "Forget-Me-Not" was sung by Miss Watt, Mrs. Linn and Mrs. Shultz, their voices blending beautifully, and the programme was closed by the double trio in Miller's "May Song," the solo part being taken by Mrs. Fletcher-Linn.

License Officer McEachern called on the man yesterday to inquire into his methods of doing business, and to ascertain whether he ought to pay license or not.

Schrader stated that he was born in Wisconsin, near Green Bay, and is about 40 years old. He has practiced divine healing ever since he was 12 years old, and has never done any work. He is not the kind of a man one would think of inviting to a small and select tea party.

His hair and beard do not match in color. He wears a mystical, dreamy look, and has a lot of patter in the way of Scriptural quotations at the end of his tongue.

He told Mr. McEachern that he made no charge for his services, but took what was given to him, and said that he could not be made to pay a license for praying for people and accepting gifts from them. There was no law against this.

It was pointed out that there is a law against obtaining money under false pretenses, which might fit his case. When asked how a suggestion that he cut off his hair and go to work at some useful occupation would be served the way bunco men and sure-thing men are in some towns, he said he could do no good to any one by his prayers, unless the person prayed for was a hypocrite.
