Chicago University Changes.
CHICAGO, May 28.—Dr. John Dewey, professor of philosophy at the University of Chicago, has been appointed to the office of director of the School of Education, an office recently made vacant by the death of Colonel Francis W. Parker. The department of education, which has been within the philosophy department, will be merged into the school of education, of which the Chicago Manual Training School and the South Side Academy will form parts.

Candy Factory Burned.
NEW YORK, May 28.—J. J. Matchett & Co.'s candy factory in Brooklyn was burned today. Loss \$175,000.

Damaging Storms in Texas.
FORT WORTH, Tex., May 28.—Severe storms causing floods in the Panhandle along the Red River have resulted in great damage to the Fort Worth & Denver City Road and also the Colorado & Southern. There are no through trains from Denver to Texas. Crops have been badly damaged. Railroad bridges at Parker Creek and over Red River are ruined.

VERY HARMONIOUS

Ohio Republicans Now Present a Solid Front.

A DEMONSTRATION FOR HANNA

State Convention Completes Work by Adopting a Strong Platform and Nominating a Ticket.

Secretary of State—Lewis C. Laylin, of Newark.
Judge of Supreme Court—William B. Crew, of McConsville.
Food and Dairy Commissioner—Horace Ankeney, of Xenia.
Member of Board of Public Works—William Kirtley, Jr., of Deane.

CLEVELAND, O., May 28.—The Republican Convention, which was held at the Hotel Hamilton, closed this evening with a great demonstration in his honor, to which he responded in a characteristic speech. The Senator, at former state conventions, has sounded keynotes that have been taken up by Republican Glee Clubs. He told them today to sing "Keep on letting well enough alone" in the campaign rallies this year.

The convention was distinguished by harmony in all that was done. One of the last reconciliations was that of Senator Hanna and ex-Governor Asa S. Bushnell, of Springfield. The latter had been here all week, but Bushnell and Hanna never spoke as they passed each other's quarters. They had not spoken since the memorable contest for the Senatorship in 1897. Before going to the convention today, they met in the most cordial manner. The delegates who "got them together" gave glowing reports around the convention hall of the way they were calling each other "Mark" and "Sam" again.

Senator Hanna and George B. Cox, of Cincinnati, also had a friendly farewell tonight after a contest during the day over nominations. What were called the Hanna men won all ballots, but Cox supported none of the winners. In making up the state ticket Hanna and Cox were on opposite sides today, the same as in former years. The organization of the Legislature last January, but good feeling prevailed after the convention was over.

While Senator Hanna was cheered as he entered the hall, as he announced the vote of his county delegation, of which he was chairman, as General Grosvener and other speakers referred to him and on other occasions the mention of the names of President Roosevelt, Senator Foraker, Governor Nash and others were also cheered. General Grosvener was heartily received as the permanent chairman, as was General Dick when he read the resolutions, which were adopted substantially as he had drafted them, with the exception of the Cuban resolution, on which there was a compromise.

United For Hanna.

In accepting renomination at the head of the state ticket, Secretary of State Lewis C. Laylin referred to the state convention at Zanesville in 1895, at which the so-called triple alliance was entered into that included Bushnell for Governor, Foraker for Senator and McKinley for President. Secretary Laylin said they were equally united now for Senator Hanna to succeed himself, although not so distinctly positive in expressing preference in advance for President and Governor. This reference to the Governorship was enjoyed by the delegates, who have during the week witnessed the dress parade here of a half dozen or more aspirants for the gubernatorial nomination next year.

Many ladies attended the convention today, among them being Mrs. Hanna, who occupied a front seat on the platform, but she and the ladies with her left the hall before the Senator was called out for the closing speech.

When the convention reassembled today, Governor Nash, as the temporary chairman, called for reports. The reports of the committees on credentials, rules and order of business were submitted and adopted. The report making General Charles H. Grosvener permanent chairman and continuing the remainder of the temporary organization was adopted. When Governor Nash presented Mr. Grosvener he received an ovation.

General Grosvener's Speech.
After a feeling reference to the death of President McKinley and a strong endorsement of the administration of President Roosevelt, the speaker turned to the Philippine question. Said he:
"The Philippines are ours. They are ours by the conquest of Dewey and the Army; they are ours by the terms of the treaty with Spain; they are ours by every principle of law, National and international; and the American people will never consent to the introduction into political power of a party that would pull the old practical game of 'scuttle' and run away from responsibility even as great as it is."

"In the fear of God and in the name of American civilization we will control and govern and benefit those islands and we will repeat in the Philippines, on a larger scale, what we have accomplished so brilliantly in the island of Porto Rico. The American flag has never been pulled down from any territory that it ever claimed jurisdiction of. It never will be pulled down while the Republican President is in the White House."

Mr. Grosvener declared that the Republican party does not wish the scheduled uses of the tariff as a fetish, but favors revision whenever the requirements of business demand it. He added:
"The tariff question for the Republicans at this particular time is the question of when and how and by whom any revision of the tariff which is deemed important shall be made. What is there in the ports of the times that indicates a necessity for any revision of the tariff schedules of the Dingley act? We have unbounded prosperity. Is that the time to commence a tariff agitation that shall unsettle values and disturb the peace of business and precipitate into commotion the business interests of the United States? That is the important question and a question which, in my opinion, can only be answered in this way. Until injurious results to business and prosperity are known to have been produced by the existence of tariff schedules, the time has not come to enter upon a revision of that document."

"Incidental to this subject is the question of wider markets. We cannot go on forever adding to the volume of our production and yet fail to gain new and wider markets. The problem of the day is the question of new markets for American production."

"Reciprocity must not be used to destroy home industries. Reciprocity must not be made use of to lessen the wages of the American laborers or to curtail the scope of their employment. But reciprocity may be used to open the markets of other countries to the production of our country and thereby and in that way make it possible to give more wages and more hours of labor to the American workman."

Referring to trusts, the speaker declared that Republican officials were the only ones that had ever made any practical efforts to meet this great question, and he declared that the country was going on in the courts for the disruption of the so-called beef trust.

The Platform.
At the conclusion of General Grosvener's address the platform was reported by General Dick, chairman of the committee on resolutions. The resolutions were adopted by acclamation. On General Dick's motion the resolutions were adopted. The platform is substantially as follows:

"We deeply lament the tragic death of President McKinley, and cherish his illustrious life and noble example as the highest inspiration to patriotic consecration and service. Enshrined forever in the hearts of his countrymen, their unceasing devotion guards his memory, and on their augmented content and gratitude under his sure guidance is raised his worthiest and most enduring monument. What he was in his great and gracious personality, and what he did in his lofty and lasting work remain a precious heritage for his people. Through his legislative and administrative accomplishments he is justly recognized as the chief architect of our later industrial growth, and as the pathfinder of our opening career of commercial expansion. His measures restored property, diffused confidence and security, promoted fraternal concord, pointed the way to reciprocal advantages in commercial exigencies, enlarged the Republic, advanced its prestige and influence among the nations, carried liberty to oppressed peoples, and placed our country in the van of the forces for civilization and humanity. While he lived his moral power and wisdom and patriotism were the pillar of public safety, and after his death his fixed and well-defined policies continued to be the hope and strength of the Nation."

"We cordially sustain President Roosevelt in his pledges to carry forward the great work which came to him as a sacred legacy. We recognize his earnest and conscientious efforts to advance the interests of the Nation."

TO PASS CUBAN BILL

Present Congress Is Soon to Dispose of It.

CANAL BILL WILL GO THROUGH

Demands of the People Cause the Majority to Be More Determined in Their Action—Means No Long Debate.

Congress will yield to the will of the people in three important matters—the Cuban reciprocity and Nicaragua Canal bills will be passed, and the measure for the leasing of the public ranges killed. The House committee on public lands has decided to report no bill to this end until the people demand it. The Lacey bill and other like measures are indefinitely postponed.

WASHINGTON, May 28.—It looks as if the opposition to two important matters before Congress was in the process of crumbling away. Those who thought they might be able to prevent the passage of a canal bill at this session of Congress are about discouraged, and the prospects now are that instead of extended debate on the canal bill it will be passed as soon as the strong majority in its favor is fully known. Of course, it is complicated to a certain extent with the Cuban reciprocity bill, and the opponents of Cuban reciprocity will try and keep the canal bill before the Senate. But as soon as it is ascertained that there are 45 Republican Senators who will vote for the Cuban bill, the Democratic opposition will probably give up, as it will simply mean delay to no purpose, and extended delay during the hot weather is not a part of the Senate programme.

The Republicans who are managing the fight for Cuban reciprocity have handled it in a way to compel the opposition to crumble, as the demands throughout the country for the passage of some bill granting concessions to Cuba seem to be more than they can stand. General Dick, a very popular Republican in Ohio, was overthrown in his effort to prevent the adoption of a resolution favoring Cuban reciprocity. Every Republican convention that has taken up the question at all favors Cuban concessions. Senator Burton, of Kansas, has been defeated by Representative Long, the latter being an earnest advocate of reciprocity. Republican Senators cannot hold out against these declarations. The evident sentiment is in favor of giving some recognition to the new republic, and consequently the prospects for the bill are brighter than ever before. There is not the least doubt but what factious opposition to both the Cuban and canal bills will cease, and they will go through without extended debate.

DEATH BLOW TO LEASING BILL.

House Committee Smothers All Measures Before This Congress.

WASHINGTON, May 28.—The House committee on public lands today set its stamp of disapproval on the Lacey bill for leasing the vacant public lands, by indefinitely postponing the measure. The bill will not again be considered at the present session, and probably not again in this Congress. There are several members of the committee who believe that a leasing bill on the lines proposed by Lacey would be of general benefit to settler and stockman alike, and at their suggestion it was agreed to have all hearings in leasing bills printed as a document for circulation, in the hope of "educating the people of the West up to the benefits of a leasing system." The committee decided to do nothing more with pending leasing bills until there was a general request for such legislation from the people themselves. Representative Bell, of Colorado, had a

hearing before the committee in opposition to the Lacey bill. He protested against the adoption of the bill because the small stockmen would be unable to fence, and it would therefore not benefit them. "With the provision in the bill that any homesteader may, at any time locate on the leasehold, and he, owners of stock not close herded would be prevented from leasing because they could not afford to fence, and without a fence a cattle owner could not keep his cattle on a leasehold, or keep his neighbor's cattle off. He said that no cattle owner would go to the expense of fencing his leasehold when at any time a part or all of the land might be taken up by settlers; improvements included."

Ide Case Will Go Over Again.

The Senate commerce committee will not meet tomorrow, as the Senate will convene at 11 o'clock. This means that the Ide case will again go over without action.

Rough Rider Gets Alaskan Job.

Melvin Grigsby, of South Dakota, was today nominated by the President for United States Attorney for Alaska. He was Colonel of the Third Rough Rider Regiment, and his selection was a personal matter with the President.

Indian Agent Removed.

Clinton T. Strachan, Indian Agent at the Nez Perce agency, was today removed by the Indian Office on account of defamatory interviews and criticisms made by him against Senators Heitfeld and Dubois. Strachan, in a public interview, declared that Dubois, as a member of the Indian committee, neglected to have the proper appropriation made for clerical service at the agency, and by reason of this neglect certain work would have to be abandoned, to the detriment of the agency and the neighboring settlers. Strachan persisted in these statements after being notified by the Indian Office of their incorrectness, and his removal followed.

NO FAVORS TO TERRITORIES.

Senate Committee Wants Each to Stand on Its Own Bottom.

WASHINGTON, May 28.—The decision of the Republican members of the Senate territory committee today not to take up the omnibus territorial bill was based upon the fact that no time could be given to the consideration of the bill at this session, and the further fact that the members of the committee think that each territory should stand on its own bottom, and not be carried along by a meritorious territory like Oklahoma. Probably a separate bill may be passed for Oklahoma, but there is still vigorous opposition to both Arizona and New Mexico, on the ground that they have not shown a sufficient increase in population. Even if the Oklahoma bill was reported it is doubtful if it could get consideration in the Senate under the present conditions.

Harriman Leaves for Buffalo.

CHICAGO, May 28.—E. H. Harriman, after spending several hours in Chicago, left tonight on a special train for Buffalo. From there he goes to his home, ending the long trip of inspection and observation which has extended from the Atlantic to the Pacific Coast, and as far south as Mexico.

HIS MANLY RECORD

Judge James A. Fee Pays Tribute to W. J. Furnish.

NO MORE ABLE OFFICIAL

Pendleton Jurist Punctures False Accusations Made for Political Effect Upon Character, and Integrity of His Friend.

EXTRACTS FROM JUDGE FEE'S ADDRESS.

From a poor boy, whose life was a constant struggle, he has become one of the leaders in the business, social and political affairs of the community in which he resides.
No man, however great his genius for political manipulation, could have arisen to the position now occupied by W. J. Furnish and have enjoyed the respect and confidence of the people to whom he is best known had he committed the offenses with which he is charged.
No man ever left behind him a clearer or a clearer record of the transactions and affairs of his office (than) than did W. J. Furnish, and were he the dishonest man that some of those who now malign and abuse him contend he is he would not have left a record by which his dishonesty could have been traced.

During his entire campaign I have been closely identified with him, and I know that not one illegal or unlawful purpose is attempting to control the primaries or the conventions of his party.

The false accusations which have been made against W. J. Furnish, the Republican nominee for Governor, were fully answered last evening by Judge James A. Fee, of Pendleton, who has known Mr. Furnish for 29 years and who is perfectly familiar with all the political events in Union County. The charges, which had their origin in baseless insinuations voiced by defeated candidates, were squarely met, after which Judge Fee reminded the people of Portland that Eastern Oregon has always stood by the Republican candidates in this section of the state, and appealed to the Republicans of Multnomah County to be equally loyal to the candidate nominated from Eastern Oregon. The hearty applause which was given this appeal was evidence that the people considered the claim of Eastern Oregon one of merit.

W. P. Little, president of the Young Men's Republican Club, of South Portland, called the meeting to order and introduced George H. Howell as the chairman of the evening. In a few pertinent remarks Mr. Howell introduced Judge George H. Williams, whom he announced as the next Mayor of Portland. As Judge Williams arose, the crowd of over 800 people broke forth in hearty welcoming applause.

As other speakers were present, Judge Williams said he would speak but briefly. He said that it has been charged that he is an old man, and he must admit that the charge is true. Yet he thought that it does not follow that an old man is incapacitated for holding an office of responsibility. "Judge R. P. Boise, of Salem, is several years my senior, yet he is occupying the circuit bench in the Third Judicial District, and is eminently satisfactory as a trial judge. He rides over the mountains to Tillamook to hold court. He renders opinions which are recognized as able discussions of the law involved in the cases tried by him. A short time ago I conducted one side of an important trial before Judge Boise which lasted several days, and if he is incapacitated by age I failed to discover it."

"Pope Leo XIII is several years older than I, yet he discharges the duties of his high position with an extraordinary ability, as everyone knows."

"It has also been charged against me that I am a member of a church, and this also is true. But I am neither a
