"Another matter which ought to engage your attention at once is the matter of getting other states to co-operate with you. Most of them will do it in one way or another if they are approached in the right way and at the right time. We did not begin soon enough, and so lost the chance in many instances because the Legislatures did not meet between the time of our promotion efforts and the time our fair began. You ought to keep track of the time the Legislatures meet in all the states, and if you can, get each Governor in his message to recommend some appropriation in your interest. This of itself will be a great advertisement. It makes the people of every state familiar with what you are doing, and it helps to get the Legislatures to act. And when two or three have made appropriations it helps mightily toward pulling in others. Of course, when Legislatures meet it will be necessary for you to have representatives on the spot to push your interests along. It is always better if the president or other high officials of your fair can do this work, but that is hardly possible in your situation. What you will have to do is to get some lawyer who has had experience in lobbying against Legislatures and one of your leading editors, for influence on the newspapers, and have them go up and work up legislative co-operation for you. Taken in time—and you have plenty of time—you ought to get a very large representation from the several states of the Union.

"Under any circumstances there are bound to be some losses due to deficiencies in administration, but there are likely to be still greater losses due to the skill with which concessionaires, especially Midway men, plan the game of shenanigans. It is almost an invariable rule that the Midway shows operate on the percentage basis, and there is, of course, a thousand devices by which the showmen try to avoid returning the share due upon their contracts to the exposition association. Properly managed, the Midway percentages due to the association ought to equal 50 per cent of the gate receipts. I say properly managed, for everything depends upon the way the thing is done. A weak man in charge of the department or a man not strictly honest may cost an exposition untold sums. Your man must be one who cannot be cajoled into yielding too much—who knows how to say no and keep on saying so—and he wants to be above suspicion on the score of personal integrity.

"There is always a temptation where money is needed—and nobody ever yet saw one of these affairs where money was not needed—to make arrangements with the concessionaires who deal in the large set problems. That is to say, it is a temptation to inexperience to accept the offer of the man who will promise to pay much for a special privilege rather than pay the offer of the man whose assurances are less sanguine. Of course, none of them ever has any money, or much money, to put up in advance. Our experience has been almost uniformly that the man who is most glib in making pledges is least ready when it comes to performing them. The character of the man is really the first consideration, and this is largely to be determined by what they have done elsewhere.

"But these are matters for the future—matters to be determined after your site has been chosen, your buildings up and your organization complete. The first thing before you is the selection of a site and the second is the organization and setting in motion of your department of promotion and publicity. There is enough here to occupy all your energies for the next year to come. You cannot get at the work too soon, and you can't push your promotion department too hard or be too liberal with it. Money spent in getting other states to assist you, in bringing your plans and your invitations to the attention of exhibitors, and in judicious advertising, is money well spent.
