Fund Wanted to Advertise the State.

PLAN ADOPTED TO RAISE \$2500

Citizens Agree to Help the Harriman Bureau of Immigration—New Literature Will Be Printed and Distributed.

Now is the time for all good citizens to help advertise the state of Oregon. A fund of \$2500 is to be raised for this purpose. The money will be spent on booklets and pamphlets to be distributed by the immigration bureau of the Harriman system of railroads. The literature will be descriptive of Oregon industries and resources.

A resolution to raise this money was unanimously adopted last night at a meeting of citizens called together by the Board of Trade. The plan of G. M. McKinney, immigration agent of the Harriman lines, was already set forth in these columns. The same approval had been given by the Chamber of Commerce in the afternoon. The last-named body adopted a resolution to have the Harriman immigration bureau join hands with the Board of Trade in the work of raising \$2500 and of issuing therefrom an edition of advertising matter. It is believed that this sum of money will secure about \$50,000 of the edition.

The advertising committee of the Chamber of Commerce is composed of Adolph Wolfe, A. H. Devers and H. C. Wortman. The committee named last night by the Board of Trade to co-operate with the chamber committee is made up of L. G. Davidson, W. M. Killingsworth and Ellis G. Hughes.

Bright and early this morning this joint committee will begin its work. It will meet at the Board of Trade headquarters at 10 o'clock to map out a course of procedure. Immediately thereafter it will go after the money, and will not stop until it gets the cash. It is expected that the money will be forthcoming at most in two or three days.

Discussing the Plans.
The meeting last night was well attended. Besides Mr. McKinney, his corps of assistants and high officials of the O. R. & N. and Southern Pacific lines in Oregon, there were present many prominent citizens, including Mayor Williams, Gov. Sprague, Chamberlain and two members of the advertising committee of the Chamber of Commerce. F. E. Beach, president of the Board of Trade, presided.

Mr. McKinney set forth the plan of the immigration bureau in a lucid and winning manner. Short addresses were made by Governor-elect Chamberlain, Mayor Williams and a number of other citizens. Everybody present was made to realize that a new era is dawning on Oregon; that hereafter the Southern Pacific and O. R. & N. will work for the development of the state with greater power than they have in the past. The Harriman system is the greatest ever attempted, said Mr. McKinney. "There has never been such a great work of the kind ever attempted. The purpose of the Harriman system is the development of Oregon," remarked Mr. McKinney. "And we have one of our own following from the Harriman system, Ben Campbell, back of that purpose."

Mr. Harriman's Interest.
The speaker introduced his subject by telling how Mr. Harriman took up the immigration project and how last June he himself was invited to undertake the greatest work of the kind ever attempted.

"The purpose of the Harriman system is the development of Oregon," remarked Mr. McKinney. "And we have one of our own following from the Harriman system, Ben Campbell, back of that purpose."

"The Union Pacific is taking the lead among transcontinental railroads. It has the only daily tourist through service from Chicago to Portland. It has taken the initiative in quoting a low rate to the Pacific Coast. We have the best district in America from which to draw home-seekers. In fact, we have the most intelligent in the United States. We can do more for Oregon than for any other state, owing to your vast area of available land. No state in the Union is so open as Oregon. And when I say that in the short space of 10 days in Texas we caused 185,000 acres to be taken up by newcomers, this means that we can do a great deal more for your state than for any other."

How Bureau Will Work.
Mr. McKinney explained how the bureau will circulate the advertising literature. Representatives will go into the communities of the Middle West and select farmers to whom to send literature. When interest is awakened among them, stereotyped lectures will be delivered to them about the new districts of the west, and then special matter will be distributed about places to which they are best adapted. All this work will be directed by the central bureau through its representatives in the Middle West.

"We ask you to welcome the home-seekers we send you and to guide them," said Mr. McKinney.

The speaker went on to eulogize the unmeasured mineral, timber and agricultural wealth of the state. "The region between the Deschutes and the John Day rivers will some day be the Palouse of Oregon," he declared. "There is enough timber in Oregon to make every man, woman and child in it rich beyond computation if its wealth were divided among them."

Chamberlain Lends Encouragement.
Governor-elect Chamberlain said the work just to begin had been needed many years. "It has been a subject of thought for me for a long time. While Oregon has been going ahead one pace at a time, Washington has been advancing at the rate of 10 paces." Mr. Chamberlain cited from memory a recent magazine article that in the year ending 1901, 242,000 immigrants passed over the Great Northern, 50,000 of them to Washington and 10,000 to Oregon. "The natural friend of Oregon is the Harriman system," said he, "and our people should stand in to help."

No Drouth or Cyclones.
Mayor Williams thought it well to advertise Oregon as a land free from drouth, floods, blizzards and cyclones. "Those storms in the Middle West," he remarked, "are doing as much for Oregon as anything. Our state has progressed slowly. If we can induce Eastern farmers, who know how to work, to come here, the country will progress and prosper immensely, and so will Portland. And I hope that as our city increases in wealth it will also do so in reputation, as a city whose citizens are a law-abiding, upright, moral people."

"I am glad," said Mr. Hughes, "to see the railroads getting around to a place where instead of our having to seek them, they are seeking us. In the past Portland has never failed to do its part in advertising work. In 1896 we raised \$30,000 for this object. Then the railroads wouldn't budge to help us."

Short speeches were also made by Seneca Smith, A. H. Devers, W. M. Killingsworth and Thomas Guinness.

Attorneys See Defunct Bank.
SALEM, Or., July 21.—(Special).—Brown & Wrightman, Salem attorneys,

today filed in the Circuit Court a claim against the defunct Gilbert Bros. Bank for \$500 for services rendered. A. Gilbert during the litigation in the United States Court and State Court prior to the appointment of Claud Gatch as receiver. They defended Gilbert in the suits brought against him to force him into bankruptcy.

WHERE IS F. M. JONES?
Drew Bogus Checks and Got Them Cashied.

A well-dressed, smooth-tongued man, who has been masquerading in this city for several days as F. M. Jones, a stockholder and officer in the Hutchinson Mill Company, of Seattle, is being sought for by the police, charged with passing bogus checks. His real name is not known. His plan was to call on a reputable business house, order goods to be shipped to some other address than that of the Hutchinson Mill Company, Seattle, under the pretense that the firm was to start a branch factory at the location he gave. In more than one instance he told the firm from whom he bought goods that he was short of cash and induced them to cash checks varying from \$20 to \$50, drawn on the Seattle Scandinavian Bank. Needless to say, he did not have an account at the bank.

Among those who regret that they have had alleged business dealings with the mythical Mr. Jones are the Povey Bros. Glass Company and the J. M. Arthur Co. It is believed that the check operator has worked his precious game in several cities in this state and Washington. He sported a liberal collection of business cards bearing the name and address of the company he said he represented. His scheme was to purchase mill machinery and supplies, offering a cash payment on account, and agreeing to send the balance in a stipulated time. The value of the purchases ranged from \$40 to \$150, but before the Povey Bros. Glass Company shipped the goods he ordered, they, as a wise precaution, communicated with the Hutchinson Mill Company, asking if the transaction was "right." A letter received in reply stated that the mythical Mr. Jones was a fraud, and had nothing to do with the business firm in question. It was also stated that the company has been put to a lot of trouble and expense by the swindler, and that detectives have been employed from Seattle to try to run him down.

In the meantime the mythical Mr. Jones had caught the alarm, knowing that the checks he had drawn on the Scandinavian Bank had not been honored. A diligent search by the Portland police has so far failed to find him, and the detectives are asking themselves this question: "What happened to Jones?"

THEY WILL LOSE NOTHING
How Creditors of a Savings Bank Are Made Whole.

Joseph E. Hedges, administrator of the estate of John Myers, deceased, petitioned the County Court yesterday for leave to pay 7.50 per cent on claims amounting to \$2500 owed by the Commercial & Savings Bank. Myers was one of the principal interests in the bank, and was responsible for its indebtedness. The bank failed, but was in fairly good condition, paying 32.44 per cent to its creditors. The administrator of John Myers' estate desires to pay the creditors the balance due, 7.50 per cent, and this makes those who hold claims against the bank whole.

Suit Over a Salmon Commission.
Suit has been begun in the United States Circuit Court by Charles W. Pike against the Alaska Fishermen's Packers' Association for the sum of \$4336.42. The complaint alleges that the parties entered into a contract for the delivery and sale of salmon, and that the plaintiff was to receive a commission of 5 per cent, the defendant reserving the right to sell the salmon in the open market of Portland and Astoria. The defendant, it is alleged, made outside sales to the extent of \$91,367, and the plaintiff asks as his percentage the commission of 5 per cent, agreed upon, which amounts in all to \$4336.42.

Court Notes.
Dr. Dav Rafferty yesterday petitioned the County Court to be appointed administrator of the estate of M. S. Johnson, deceased, valued at \$15,000.

The final report of Charles H. Rafferty, administrator of the estate of Wash F. Allen, deceased, was filed in the County Clerk's office yesterday, showing \$10,331 received and \$10,331 disbursed. The balance paid to heirs, 10 in number, \$1500, or \$150 each.

Articles of Incorporation of the Pacific States Trust Company were filed in the County Clerk's office yesterday.

BEAT A CHINAMAN.

Proud Achievement of Two High-Minded Young Men.

A Chinaman named Jim, and who resided at 22nd and Second and Oak streets, was brutally beaten by two unknown young men last night at the east end of Burnside-street bridge and robbed of \$10 and a bottle of whisky. The police have been called to the scene, but during the entire fracas a policeman could not be found. The Chinaman, who earns his living cleaning houses and "batches" in a shack back of the river bank, also has his home at the time, when he was attacked by two boys, who knocked him down and then threw his hat in the river. Placing his right hand behind him, as if about to draw a revolver, the Chinaman ran toward his tormentors, who cried out, "Don't shoot." Hearing the cry, two young men seized the Chinaman, threw him on the ground and found that he was grasping a bottle of whisky, which they took, but could not find a weapon in his possession. A wordy war ensued, and the robbers ran away, closely pursued by the victim, who yelled "Follee!" at the top of his voice.

"Stop that or we'll fix you," said one of the young men, threateningly, and they ran at the Chinaman, gave him a severe beating and escaped. The Chinaman's face was cut and bleeding, according to one eye-witness, and he complained that he had been robbed of \$10. The police are making an investigation into the matter.

FOUR BOYS FINED.

Bathed in River Without Suitable Costumes.

Because they bathed in the river without their wearing suitable costume, four boys, named Frank Reynolds, Charlie Boggers, Henry McCoy and Clifton Jordan, appeared before Municipal Judge Hogue, yesterday. "I have repeatedly warned these boys to keep out of the river, but they won't do it," testified Police-man Reising. "Last Saturday afternoon they were in the Portland Public Bath, but they had some sort of trouble there, and went outside to bathe. They did not have on proper bathing costume. 'We wore trunks,' broke in one boy. 'That's no excuse. You must, if you bathe in the river, be covered from neck to feet,' stated the prosecuting officer. 'It is strange how you boys persist in bathing in the river, when you have the public bath to go to,' said the Judge. 'What you have stated is no excuse. It is time that an example is made of this class of offenders. You are each fined \$5.'

NEW RURAL MAIL ROUTES

FREE DELIVERY SERVICE TO BE FURTHER EXTENDED.

Postoffices Will Probably Be Abolished—But Farmers Will Be Better Off.

OREGONIAN, Or., July 21.—(Special).—Applications for two more rural free delivery routes from this postoffice have been forwarded to the Post-office Department at Washington, and are awaiting their turn to be acted upon. It is highly probable that they will receive favorable consideration, as the success of the two existing rural routes will be an incentive for granting more, and their establishment will be in line with the department's policy of giving free delivery to as much of Eastern Multnomah as possible.

Route Inspector Fogarty, of San Francisco, was here last week, and made a thorough inspection of the two existing routes, and, incidentally, inspected proposed extensions of the service. He was very favorably impressed with all he saw and was well pleased with the workings of the system here up to this time. He allowed it to be inferred that he would recommend an extension of route No. 2, so as to embrace all the territory as far East as the top of the Sandy bluff on the Lutsford road to a point on the Powell Valley road, one-half mile beyond Pleasant Home. About 40 more families will get the service if the extension is granted. All the new roads to be traversed are in excellent condition. The annexed district will be about two miles square, and is thickly settled and highly prosperous.

Postmaster Hofer, of Cleone, has received notice that rural free delivery will be established from his office on September 1. He has also received all necessary supplies and full instructions, but the name of the carrier has not been announced yet. There were three applicants for the position, all of whom took the prescribed examination. They were James H. Schram, Wade Odum and H. H. Palmer. A selection will be made soon, and then the work of making a census of the route and putting up boxes will commence. All this must be done and everything will be in readiness for regular trips over the route before the day set for the beginning.

Persons who are posted in regard to the intentions of the Postoffice in this section have let it be inferred that the entire eastern portion of Multnomah County as far as Latourelle Falls and a portion of Clackamas County will be covered with rural delivery routes. There will be a route from Montaville, one from Lents, one from Cleone, four from Gresham, two from Troutdale, one from Orient, and one from Latourelle Falls—seven in all. Only two are now in operation, both from this place, but three more have been ordered—Lents, Cleone and one from Troutdale. The others will follow as rapidly as possible, and of them are expected to be in operation before next Spring.

With such an extensive network of rural delivery, it is obvious that some of the other existing postoffices will be unnecessary. They would be practically useless and their cost of maintenance would go far toward the support of the rural routes. These offices are five in number. They are Palestine, Roseburg, Rockwood, Terry and Powell Valley. Their patrons would all be served by carrier. By eliminating them, the Portland-Sandy stage route would probably be a better one in the past, also, thus making a large saving in that direction. Gresham will get its mail from Cleone after August 15, and there is a probability that all the other offices east of here on the Sandy route will be supplied from Troutdale. By that means they will get their mails about three hours earlier than at present, thus permitting the rural routes to be started on their regular trips at an earlier hour.

Palmer's tile mill, which has been in operation near Powell Valley for several years, will be moved to Deep Creek, about five miles south. It will be located in a new district of excellent timber, and will continue the cutting of railroad ties as before.

Construction of the new schoolhouse at Rockwood, near Deep Creek, Oreg., will be \$2628, one story high, and so arranged as to permit an addition thereto when needed. The contract price is \$260. John Brown, who built the Gresham schoolhouse, is the contractor.

Posters are up announcing the Grand Army reunion at Pleasant Home, August 11-15, inclusive. There will be new features this year, and several committees are working to make the affair a greater success than ever before. Sunday, August 17, will be devoted to religious exercises.

YOUNG MAN ARRESTED.

Charged With Assaulting Harry Vail, of South Mount Taber.

Edward Urfer, a young man, was placed under arrest yesterday by Constable Keenan, on a warrant issued by the East Side Justice Court, charging him with assault on Harry Vail, of South Mount Taber, Friday evening, July 18. He was placed under \$5 bonds to appear for trial before Justice Sutor on Monday.

It is alleged that Urfer is one of the gang who attacked and beat up Harry Vail while he was wheeling home on the cycle path on the Section Line road Friday night last. The charge is the mildest that could have been made. There were several implicated in the assault on Vail, and it is said that Urfer was identified as one; but this will come up at the trial tomorrow. He may then be able to show he was not there.

An attempt has been made to settle the trouble with A. Vail, father of Harry Vail. Mr. Vail was visited at his home, South Mount Taber, by the young man who had assaulted his boy, and he came to find out what he was going to do about it. Mr. Vail then asked him why he had assaulted his boy, and the reply was "To teach him a lesson," or something to that effect. Mr. Vail then declined to talk with him further. Urfer was beaten about the face severely. He says he gave no provocation whatever for the assault.

SALMON HATCHERY.

Some Fish Caught in Racks—Buildings Have Not Yet Been Put Up.

R. W. Parker, who came in from his ranch on Salmon River yesterday, says that at the new hatchery some salmon

are being taken, but there is yet a light run. It is expected shortly that there will be plenty of salmon running.

Work on the buildings for the hatchery has not yet been started, but will be shortly. There has been some delay in getting a right way to the ground, but Mr. Parker says he understands that this matter had been or soon will be settled. In that event the buildings would be put up at once. However, until late in the fall the hatchery can go ahead without the buildings. The location is considered all that could be desired for purposes of hatchery. Samuel Brown is superintendent.

AN EXCITING RUNAWAY.

J. D. Eaton and Child, South Mount Taber, Thrown Out of Wagon.

J. D. Eaton, of South Mount Taber, was severely injured, and his 3-year-old daughter narrowly escaped being killed in a runaway accident last evening. Mr. Eaton was driving homeward, and had reached the corner of Hawthorne avenue and East Twelfth street, when his horses took fright and, becoming unmanageable, ran through the Ladd tract on Ladd avenue. Reaching the center of the tract, where the road diverges right and left around the Park block, by the quick turn of the wagon, Mr. Eaton was thrown out on his head, leaving the screaming child still in the wagon.

The horses swept around the Park block, the vehicle part of the time being on two wheels, and dashed along the rough road to the intersection of Division and East Twenty-first streets. Here the wagon collided with the curb, and the little girl was thrown high up and then struck paralytically on her face and side. The horse ran on to East Twenty-sixth street, where they were caught.

The child was picked up partly stunned, but not seriously hurt. Presently Mr. Eaton came limping up to where his child was thrown out in a very excited frame of mind, as he thought she had been killed. His shoulder had been dislocated by his fall, and he sustained other bruises. He was greatly relieved to find his child alive and comparatively uninjured. After the damages to the harness had been repaired, Mr. Eaton again started homeward.

Sellwood Schoolhouse.

The contractor has started work on the Sellwood schoolhouse. Mrs. E. H. Hell purchased the small house in the back end of the building, and has moved it to a vacant lot. The main structure will be moved to the east side of the schoolground to a foundation that will be built at once. Four new rooms will be built on the west side, and connected with the old structure, an eight-room building being the result.
