PROSPERITY IN LOWER ALASKA.

Hammond has just returned from Ketchikan, Alaska, where he has spent the past three months. He installed and put to work a 30-stamp mill there. He says the outlook is good for the district, especially in copper. Most of the gold ore are low grade, but they exist in vast ledges. The ore is mostly free milling. High values are found usually in the smaller ledges. The district has a large development this year. Mr. Hammond says Portland capital is well represented, especially in the salmon-canning industry. The canneries have put on a good-sized pack, and when Mr. Hammond left the run of fish was good. A number of new companies, representing English and New York capital, are starting mining industries, and others are investigating with a view toward operating on gold and copper. A large timber syndicate has been formed for supplying Alaska with lumber from Ketchikan district. Hitherto lumber for Alaska has gone mostly from Puget Sound. The syndicate had obtained 15,000 acres of choice timber land when Mr. Hammond started home. The Ketchikan district is about 300 miles across. It takes in Prince of Wales Island, Annette Island and Metlakahla, the Indian mission. The natives are industrious and are employed mostly in the fisheries.

SUMMER IN PORTLAND.—A man of Waterloo, N. Y., has \$2500 which he would like to invest in a chair factory, and he asks the Manufacturers' Association of this city whether this field would be a good one for such an enterprise. Secretary MacLachlan has hastened to reply an emphatic yes. He tells the man that this is one of the best fields; that wood materials are abundant, and that there is a good market here for finished product. The man says that \$40,000 will be required for the enterprise, half the sum to be for machinery and the other half for working capital. He proposes to mortgage the plant and stock for the sum needed. He says he has plenty of brains to insure the venture. A citizen of Cudahy, Wis., asks the association to name a good place in the Northwest for the manufacture of mining machinery. The reply names Portland. A Philadelphia citizen wishes to know whether Portland would be a good place in which to manufacture stoves. The reply is that such an industry would pay if conducted on a basis warranting competition with Eastern manufacturers.

DEMAND FOR MINING MACHINERY.—Business is good in mining machinery. Shipments are steadily made out of Portland to Southern Oregon, British Columbia and Alaska. A 10-stamp mill, one with a tramway and a 20-horsepower power machinery have just been shipped by a local company to Arrow Lake, British Columbia, a place about 120 miles north of the line. Last Saturday a carload of boilers and a carload of machinery was sent to Bohemia for the Le Roi mine. An order was closed yesterday for a large air compressor, three drills and a 7-inch waterwheel, to be shipped to Murray, Idaho. A good demand is reported for hand power rock drills, and machinery for prospecting.

ROWBOAT UPSETS.—A middle-aged man and a boy about 15 years old engaged a boat at a beachhouse yesterday afternoon and started for a trip up the river. About 15 minutes afterward the boat was found upset in the river near the public baths, and the man was going to the street dripping wet. Nothing was seen of the boy. The matter was reported to the police, and Detectives Snow and Kerrigan were detailed on the case, but they were unable to find any trace of the lad or his companion. Whether or not the boy was drowned is not known, as he was not seen after he had left the beachhouse.

AN INDIAN PRIEST.

Death of Enemagbhow, Beloved of Bishop Whipple.

Boston Transcript.

In the death of the Chippewa Indian priest, Rev. J. J. Enemagbhow, at the White Earth Reservation, another link has dropped from the chain which binds the present to the days of heathenism and warfare, when Bishop Whipple began his work among the Indians. Ordained to the priesthood by Bishop Whipple, the life of this godly man, a full-blooded Chippewa, was intertwined with the life of his bishop, whose journeys throughout the wilderness, in sunshine and in storm, he often shared. His life has been full of pathos, bravery and self-sacrifice, and he goes to his rest respected and honored.

Rev. Mr. Enemagbhow had been a sufferer for a number of years from rheumatism, but was apparently in his usual health at the time of his death. Since his affliction prevented more active service he had been the rector emeritus of the church of St. Columba, at White Earth. (A thousand dollars toward the erection of this church building was given to Enemagbhow by Jennie Lind.) In a letter written a short time ago to a member of Bishop Whipple's family, Enemagbhow said:

"I have been ill, and my rheumatism still confines me to my room. Some one reported that I had died. I was astonished to see how powerful my people were. They said, 'Since our loved bishop has gone from us sorrow and deep heart-sickness have been always with us, troubling us from day to day. Our hearts are full of grief. If you leave us we shall be lost and lonely.' My people tell me I am growing thinner and thinner, though except for rheumatism I feel well and sleep well in the nights. But three times of late I have dreamed of my loved bishop. I dreamed that I sat under the oak tree in front of the Bishop Whipple Hospital, and suddenly I saw him coming toward me. He stood before me with shining face, and smiled, and then started away without saying a word."

"This dream happened twice. I dreamed a third time. I saw my bishop a great distance away, coming toward me. He again stood before me. He smiled and said, 'My dear Enemagbhow, we must take a journey together to all the reservations in the Indian country.' I hesitated a moment and glanced at my foot. He, too, glanced quickly down and said, 'I will not take you on this journey. Your foot is far too ugly. Very well, dear bishop,' I said, 'if that is the only objection, I think it is a small objection. My bishop, that ugly foot has traveled thousands of miles with you—thousands of miles in the Indian country. That ugly foot has carried a heavy birch-bark canoe over the long portages you have traveled, but it never impeded the travel. I have stood, dear bishop, on this ugly foot for 30 years while you were giving your great loving sermons to my people, and it never molested nor impeded your loving words.' He said—his face was shining with love—'When I see your heart's moved and troubled like the great water, for I think only of our bishop. You have been much with him.'"

"But the dream! I cannot get it from my mind. My heart tells me—the forest whispers (I—shall soon be with my bishop. My heart cries out for him. The Indian Indians above all are lonely. They will soon go in search of him."

"I see you in our land before I die, my people will rejoice greatly. Good-bye."

Rev. Enemagbhow's death occurred during the convocation at White Earth, during the morning and afternoon sessions the clergy went to the priest's house to pay their respects, finding him in his armchair apparently very well. After the evening service at the church, as the Indian deacon, Rev. Frederick Smith, was on his way to his home, accompanied by some of the visiting clergy, the bell suddenly tolled, and a few moments later it was found that Enemagbhow had entered into life eternal.
