LABOR COUNCIL MEETS. AMERICANS CALLED DOWN

WASHINGTON, Oct. 6.—The executive council of the American Federation of Labor began a week's session here today. The report of the secretary-treasurer showed the American Federation of Labor to be in excellent condition; that an increase of more than 200,000 members had been gained in the last four months; that the official magazine, the American Federationist, is on a sound basis, financially and otherwise; that there are now more than 900 volunteer organizers throughout the country, and 30 salaried organizers directly employed by the American Federation of Labor, and 240 organizers employed by affiliated National unions.

Stone Sends Full Militia to the Mines.

TAKE TO THE FIELD TODAY

Men Who Desire to Work Will be Protected.

NO DISORDER TO BE ALLOWED

Roosevelt is Still Hopeful—Labor Commissioner Wright Meets Mitchell and Sargent Starts on the Same Mission.

The strength of the National Guard of Pennsylvania is 11,000 men. It is composed of 14 regiments of infantry, four troops of cavalry and three batteries of artillery, one of the latter being armed with 3.2-inch field pieces, another with machine guns, and the third with automatic guns.

HARRISBURG, Pa., Oct. 6.—Governor Stone, late tonight, ordered out the coal strike militia today.

HARRISBURG, Pa., Oct. 6.—Governor Stone will neither affirm nor deny the report from Washington that he has been asked by President Roosevelt to call an extra session of the General Assembly to settle the coal strike. He still declines to discuss the situation or the prospects of an early settlement of the differences between the operators and the miners.

Miners Are Much Surprised.

WILKESBARRE, Pa., Oct. 6.—The news of the calling out of the entire State Guard caused a mild sensation among those gathered at strike headquarters, but apparently the least perturbed were President Mitchell and the three district presidents. There was a crowd in the lobby of the Hart Hotel, and as soon as the miners' chief came down the stairs with his traveling bag in hand, he was asked for an opinion on the action of Governor Stone. He at first declined, but a moment later, as he pushed his way through the throngs, he exclaimed: "If they call all the troops out in the United States, it won't make the men go to work."

NEW FAIR BOARD

Stockholders Elect Ten Directors

TO REPRESENT THE STATE

Twenty-five Men Now Head 1905 Exposition.

FIRST MEETING NEXT FRIDAY

Address Will Be Sent to Members of Legislature Regarding Appropriation—Legislative Committee of Five to Be Appointed.

- New directors of the Lewis and Clark Exposition of 1905: James H. Raley, of Pendleton. J. C. Cooper, of McMinnville. J. M. Church, of La Grande. G. L. Miller, of Baker City. B. Van Dusen, of Astoria. A. Bush, of Salem. Green W. Riddle, of Riddle. P. L. Willis, of Portland. J. C. Alsworth, of Portland. Samuel Connell, of Portland.

These men were chosen yesterday by the stockholders of the Fair corporation to complete the membership of the board of directors. The meeting had been adjourned from the regular annual session, which took place July 7. The number of shares of stock represented was 19,223 1/2. The total number of shares in the corporation is now 25,561. President H. W. Corbett presided.

The personnel of the board is now complete. It contains 25 members, 15 of whom have carried forward the Fair project to its present status. As now constituted, the board is made up of 18 residents of Portland and of seven residents of other towns of Oregon. It will meet Friday to effect complete organization. Twenty-one new committees are yet to be appointed, and as soon as they have entered upon their work the active promotion of the Exposition will be started.

Other Members of the Board.

The 15 other members of the board are: H. W. Corbett, president of the corporation; H. W. Scott, first vice-president; Adolph Wolfe, second vice-president and auditor; Leo Friede, third vice-president; Paul Wessinger, A. H. Devers, Rufus Malloy, John F. O'Shea, Charles E. Ladd, A. L. Mills, G. W. Bates, I. N. Fleischner, W. D. Wheelwright, F. Dresser and W. D. Fenton.

The new directors had been nominated by the committee on ways and means, and the election went off quickly and unanimously. The meeting devoted only a few minutes to discussion of the nominations. The plan of electing influential citizens of parts of the state outside of Multnomah County was looked upon as the best way of enlisting the aid of all Oregon in the Fair. Such representation on the legislative committee, which is yet to be appointed, was regarded as essential, inasmuch as that committee will have the preparation of bills that will go before the Legislature in behalf of the Fair.

Three of the new directors live in Eastern Oregon—James H. Raley in Umatilla County, J. M. Church in Union, and O. L. Miller in Baker. J. C. Cooper resides in Yamhill County, B. Van Dusen in Clatsop, A. Bush in Marion, and George W. Riddle in Douglas. Several of the stockholders desired to have Southeastern Oregon and more of the coast counties represented, but were satisfied with the election because the new men represent Oregon as much as is compatible with the active work of the board.

"I move that the secretary be instructed to cast the vote of this meeting for the 10 men nominated," said I. N. Fleischner. The motion carried.

"The ballot is cast. Mr. Chairman," said Secretary Reed, "for 19,223 1/2 shares of stock."

To Address Legislators.

After the meeting of the stockholders the directors held a short session. President Corbett read a letter which he proposed to address to the Legislature.

Water for Mau Plantations.

HONOLULU, Sept. 30, via San Francisco, Oct. 6.—The initial surveys for a proposed ditch to supply the plantations in the center of the island of Maui with water from Nahuku have been commenced. The new ditch will be 45 miles in length.
