CROWDS GREET REDMOND

Philadelphia Academy of Music Is Filled With Irish Sympathizers.

PHILADELPHIA, Oct. 27.—Advocates of Irish liberty filled the Academy of Music and Horticultural Hall tonight and extended a welcome to the Irish Parliamentary envoys, John E. Redmond, Edmund Blake, John Dillon and Michael Davitt. About 8000 in subscriptions was raised for the United Irish League defense fund. Governor Stone was chairman of the meeting, and in taking the chair, expressed deep sympathy with Ireland.

John E. Redmond said that not for a quarter of a century has the struggle between the Irish Nation and English Government been so acute in Ireland as it is at this moment. An overflow meeting was held in Horticultural Hall, at which the four envoys also spoke. They will leave for the West tomorrow.

JUDGES ON SAMOAN CASE

King Oscar, as Arbitrator, Called Noted Men to His Assistance.

STOCKHOLM, Oct. 27.—The official organ today announces that King Oscar's decision in the Samoan arbitration was arrived at in accordance with the views of three judges, Van Orstelt, formerly Swedish Minister of Justice, M. Hagerup, ex-Premier of Norway, and M. Odekrantz, who was Chief Justice of Samoa, all of whom were called to assist in the work of the arbitration.

Still No Agreement With Strikers.
PARIS, Oct. 27.—Another meeting between Premier Combes and the national committee of the striking miners was held here today, but no definite results were obtained. There was a slight disturbance today at Rochefort between strikers and non-strikers.

Democrats Now Concede His Election.

BETTING MEN GIVE ODDS

Hill's Attack on Governor Proves a Boomerang.

UP-STATE APATHY IS BROKEN

Coler Is Making Gains in Greater New York, but Even Pulitzer's Paper Acknowledges His Cause Is Hopeless.

OREGONIAN NEWS BUREAU, Washington, Oct. 27.—From now until the close of the campaign, New York will be the center of political interest. Today, it is conceded by Democrats generally, and asserted by the Republicans, that Odell will carry the state by 6000 to 20,000 plurality. The latter estimate is made by the New York Herald, while the lower figure is admitted by the World. Estimates placed today are made with odds of 10 to 7 on Odell. Senator Platt says Odell will come down to the New York City line with a larger majority than Roosevelt had four years ago—120,000.

The Herald poll shows, however, that Coler is gaining strength, and the trust issue, which has, in a measure, been injuring the Republicans, is causing many changes to the Democratic column. Even if Coler is not elected, he will smash all records in Greater New York since 1892, and will at least have a plurality over Odell of 8000.

It is apparent that Hill overreached himself in his attacks on Odell. His aspirations on the honor and integrity of the Governor have angered the Republicans, and have probably put an end to the threatened Republican apathy "up the state."

REPUBLICANS ARE AROUSED.

General Apathy Is Broken by Prospects of Democratic Gains.

OREGONIAN NEWS BUREAU, Washington, Oct. 27.—While present indications point to the election of a Republican House of Representatives, the feeling is quite general among party leaders that the campaign may be won or lost this week. It is variously estimated that there are between 20 and 40 districts in the Northern States apparently Republican which may, by reason of developments this week, swing into the Democratic column. Apathy has been most marked in Republican ranks in the East up to this time. The widespread publication of estimates in the leading papers yesterday and today, pointing out, without exception, general Democratic gains has had the effect of slightly arousing the voters. In the closing days of the campaign legal developments will have this effect quite frequently, but to what extent is problematical. The Republicans from the start have been unusually handicapped by a shortage of campaign funds, while in many states the Democrats have had more money than in any campaign in the past decade.

Chairman Babcock believes the New York Herald's poll of yesterday very conservative, and points out that, if the Republicans carry only the districts set down in that poll as surely Republican, they will still control the next House. On the other hand, Chairman George says:

"We shall not only get all the votes conceded to us by the Herald, but enough more to give us a good working majority in the next House."

ADDICKS SAYS HE WILL QUIT.

Washington, However, Is Still Skeptical of the Delaware Man.

OREGONIAN NEWS BUREAU, Washington, Oct. 27.—The report comes from Wilmington, Del., today that J. Edward Addicks contemplates dropping the campaign he has been making for Senator before election day. The report is based on a statement said to have been dictated by Addicks to this effect: "So far as I am concerned, the election of the Republican ticket in Delaware is now in the hands of friends of the President." This is taken to mean that if the state is carried by the Republicans, it must be done by the "regulars." Little credence is placed in the story in Washington, where rumors of this sort have been heard often before.

Red Break by La Follette.

OREGONIAN NEWS BUREAU, Washington, Oct. 27.—Governor La Follette's declaration on Saturday that Senator Spooner must declare in favor of the state Republican platform to get the administration support for re-election, will undoubtedly mean to administer a telling blow to the Senator, will cost the Governor many votes this Fall. It is said his majority will not be half of that polled two years ago.

Man Who Shot Striker Promoted.

SHENANDOAH, Pa., Oct. 27.—Upon the recommendation of Major-General Miller,

Colonel Rutledge tonight promoted Arthur Wadsworth from a private to a Sergeant. Wadsworth shot and killed William Durham on the night of October 8 while on guard duty. Durham not heeding the order to halt given by Wadsworth, the latter believing Durham was about to attack the home of a nonunion miner. The Major-General says he deprecates the killing of Durham, but the promotion of Wadsworth is a reward for the faithful performance of duty.

FINDS RUSSIAN SURVEYS

Monuments Located as Indicated by Anglo-Russian Treaty.

SEATTLE, Oct. 27.—Advices were received from Jansen on the steamer Dolphin, which arrived today, that the missing Russian boundary monuments, which have been so eagerly searched for by Lieutenant Emmons for the past two seasons, had been discovered by a prospector of the Porcupine district named James H. De Blondu. He is a native of Marseilles, France, but has been interested in the Porcupine district and the modus vivendi strip for several years. WILL SUCCEED MILES AS LIEUTENANT-GENERAL OF THE ARMY



WASHINGTON, Oct. 27.—"I do not think I am betraying any confidence when I say that Major-General S. B. M. Young will be the next Lieutenant-General of the Army," said Major-General Corbin today. Then he added: "And his promotion will be enjoyed by no one more than myself."

Lieutenant-General Miles will retire for age next August, and this declaration by General Corbin was inspired by some comment to the effect that the appointment of General Miles' name in the monthly Army list next after that of General Miles pointed out the probable successor.

SHOWERS OF ASHES.

Activity of Volcano Causes Consternation Among Mexicans.

CITY OF MEXICO, Oct. 27.—There is no little consternation felt by the inhabitants of many towns in the remote south country on account of showers of ashes falling in the extensive region from San Juan Bautista, capital of the State of Tabasco, as far north as Salina Cruz. It is believed that a hill near Palenque, where there is a great prehistoric city in ruins, has suddenly been transformed into an active volcano. The ashes falling at Palenque have hidden the sun at Comitán, and a great fear has come on the people. Palenque is the center of the disturbance, as the burning mountain is said to be near there. There is some anxiety felt for Chiapas, arriving at San Cristobal las Casas say a hill in the Guadalupe Sierras is vomiting fire and smoke. People in many towns have been running about in terror and offering prayers publicly for the safety of themselves and children. Scientific opinion is that all of this is part of the general awakening of volcanic forces in the West Indies and Central America.

BIRTHDAY OF ROOSEVELT

The President Celebrates His Forty-fourth Anniversary.

WASHINGTON, Oct. 27.—President Roosevelt today celebrated the 44th anniversary of his birthday. He was down in his office early, going over some matters with Secretary Cortelyou, who has just returned from Canton. Many messages of congratulation were received, and numerous remembrances arrived during the morning. Among the latter were many flowers. A committee representing the Hungarian Club, of New York, of which the President is an honorary member, in accordance with the custom, called to congratulate him upon his anniversary. Several members of the Cabinet also called to extend their congratulations.

Pope's Physician Ill.

ROME, Oct. 27.—Dr. Lapponi, the Pope's private physician, is suffering from appendicitis and the pontiff is much distressed. Dr. Manzoni, who operated on the Pope for a cyst about two years ago, is attending Dr. Lapponi, and may operate on him tonight.

Tennessee Railroad Promoted.

KNOXVILLE, Tenn., Oct. 27.—Cole J. Sanford died at his home in this city today, aged 79 years. He was president of the Knoxville & Ohio Railroad, and had extensive coal interests.

REBELS LOSE HEAVILY.

Urbe-Urbe Attacks La Cienega, to Be Defeated by Colombians.

COLON, Colombia, Oct. 27.—The revolutionary force under General Uribe-Urbe and General Castillo, which attacked La Cienega October 14, consisted of 1200 men and four pieces of artillery. The government forces lost Colonel Penalver among the killed, while General Alfredo Fernandez and many other officers were wounded. The losses of the revolutionists are reported to have been heavy. According to news received at Cartagena yesterday, forces of the government were then attacking General Uribe-Urbe and Castillo, who were holding a position on the river Frio, near Santa Marta. General Marmaduke has proceeded with all speed from La Cienega to the rebel position on the river Frio. His command consists of 2000 men. He is believed to have engaged the enemy, and it is rumored in Cartagena that the fight was most sanguinary, and that there were very heavy casualties on both sides. Details of the engagement are lacking, but further information is expected here tomorrow upon the arrival of a steamer from Cartagena.

The British cruiser Retribution is believed to be still at Santa Marta. News was received in Colon today that the town of Quibdo, on the Atrato River, Department of Cauca, which has been held by the revolutionists for several months past, has been attacked by the combined government forces from Cauca and Antioquia, with the result that the rebels were forced to retreat. Quibdo is in a gold mining district. Many families of the rebels expelled from Quibdo have arrived at the outskirts of Cartagena, where they are living unattended.

To Protect French Interests.

CARACAS, Venezuela, Oct. 27.—The French cruiser D'Estrees has arrived at La Guayra.

HILL TALKS TO FARMERS

He Says the Great Northern Will Cut More Rates Soon.

CROOKSTON, Minn., Oct. 27.—President James J. Hill, of the Great Northern Railway, made the principal address at the Farmers' convention here today. Despite the inclement weather, fully 15,000 farmers were in the audience.

He spoke for about an hour, dwelling particularly on the necessity for diversified farming and drainage. Coming to the question for the Great Northern Railroad, the Northwest, he declared that the supreme object of the road was to secure prosperity for the Northwest. He said the road was now paying 7 per cent dividends, and that he did not want it to pay more than that. He declared he had but a beginning in the matter of reduction of rates. So far from it being the object of the Great Northern to rob the people, Mr. Hill stated that in addition to the reduction of rates to the shippers, the road had during the year paid out an increase in wages amounting to \$300,000, and that without an increase in the number of men employed by it.

DELAY TO CANAL

Colombia Puts Up Price on Panama.

OFFICIAL NOTE TO HAND

United States Now Asked to Pay \$10,000,000.

\$7,000,000 THE OLD FIGURE

Yearly Payments to Begin at Once—Another New Demand—Negotiations Not Closed by Any Means, but Will Be Prolonged.

Colombia has set a greater value on the Panama Canal concession since it finds the United States is likely to buy it. It now asks \$10,000,000, instead of \$7,000,000, as proposed by the American treaty; that payments shall begin at once, instead of waiting 14 years; and claims to its contention that it cannot guarantee perpetual control. A 100-year lease is its proposition along this line.

WASHINGTON, Oct. 27.—The long-expected response of the Colombian Government to the proposition made by the State Department for the negotiation for a canal treaty on the lines of the Spooner act has reached Washington, and was presented to the State Department by Mr. Herran, Secretary of the Colombian Legation. It is difficult to learn the exact nature of this communication, but it is known that it is not altogether an unqualified acceptance of the State Department's proposition. It is, however, friendly and dignified in tone, and does not close the negotiations by any means, though it unquestionably sets back the date of final agreement by opening up new topics for argument.

For one thing, the Colombian Government is now entirely dissatisfied with the small amount of the payment to be made to it by the United States under the terms of the protocol, which it is proposed to use as the basis for the treaty. This sum is \$7,000,000. Colombia wants at least \$10,000,000. Moreover, the original proposal looked to await for 14 years before beginning the payment of annual rental, the amount of which was to be fixed by mutual agreement. Colombia now asks the United States to agree at once upon a lump yearly payment of \$600,000, which will largely increase the immediate cost of the enterprise. The Colombian Government clings to its contention that it has no constitutional authority to alienate any Colombian territory, and reiterates that the best it can do to meet the language of the Spooner act, which looks to perpetual control by the United States over the canal strip, is to make a 100-year lease, with a distinct stipulation that the same shall be renewable by the United States at the expiration of the first century.

PLEASED OVER KNOX'S DECISION.

France and Canal People See Success for Panama Route.

PARIS, Oct. 27.—The announcement of the decision of Attorney-General Knox that he found the title to the Panama Canal property valid and unencumbered has been received here with much satisfaction by the officials of the company and those who are government. M. Lamproy, secretary of the company, said today that the decision bore out his contention before the Morgan committee of the Senate. He expects the next step will be the conclusion of a treaty with Colombia. While the secretary foresees some delay in ratifying the treaty, he says Mr. Knox's opinion insures the carrying out of the Panama project.

Twenty Nine Remains to Be Settled.

NEW YORK, Oct. 27.—In discussing the report of Attorney-General Knox on the validity of the title to the Panama Canal, William N. Cromwell, of this city, counsel for the canal company, called attention to the fact that the question of title does not again come before Congress. That subject was by the Spooner law, left absolutely to the determination of the President.

"Only one matter remains to be settled," he said. "That is the conclusion of a treaty with Colombia. It will be recalled that the Hay-Concha treaty of May 18 last was approved by these Ministers. The form of the Spooner law, however, made certain amendments to the proposed treaty necessary in the interest of both governments, and these few points are the object of the pending discussion."

YOUNG AT WASHINGTON.

American General Interviewed on British Army.

CATSKILL, N. Y., Oct. 27.—Major-General S. B. M. Young is a guest of George McLanahan, of Washington, D. C., at Mr. McLanahan's country home here. General Young is a today that a published report relating to the coming to America of noncommissioned officers of the English army was misleading. It is possible, he said, that the Englishmen, who are trained athletes, may come over and give exhibitions at the military tournament at Madison-Square next Spring, and such exhibitions, he added, might prove interesting to Americans as showing the results of physical training in England. The English training, according to General Young, is not superior to the system at West Point, but it is much better than can be found at American military posts.

General Young left for Washington this evening.
