

NOT TO HANG FRIDAY

Certificate of Probable Cause
Granted in Belding Case.

SUPREME COURT WILL DECIDE

Chief Justice Moore Finds Debatable
Question for Consideration, Which
Necessitates a Stay of
Execution.

SALEM, Or., Oct. 27.—(Special.)—Chief Justice F. A. Moore today granted a certificate of probable cause in the Belding murder case. This means that the execution of Belding will not take place next Friday, as ordered by the court, but that execution will await the decision of the Supreme Court on the appeal.

The granting of the certificate of probable cause for appeal does not necessarily mean that Chief Justice Moore found in the transcript of the records of the case some ground for reversing the judgment of the lower court. It means only that the record shows that some debatable question is presented for the consideration of the Supreme Court, and that Belding should not be executed until this question has been presented. In capital cases the Supreme Court does not inspect the record so closely as to determine whether an error has probably been committed by the lower court, but only so closely as to see whether the appeal presents any question upon which there may be a difference of opinion.

The law in all criminal cases is that an appeal to the Supreme Court does not stay execution unless either the Circuit Judge or one of the Justices of the Supreme Court grants a certificate of probable cause for appeal. In cases punishable by imprisonment the convicted man usually begins serving his time immediately, even though an appeal be pending. But in capital cases the execution of the orders of the court would put an end to any necessity for an appeal, and a certificate of probable cause is always granted if asked for and a debatable question is shown to be involved.

SHERIFF GLAD OF DELAY.

May Arrange to Hang Other Murderers
on Same Day.

Sheriff Storey yesterday received a telephone message from Salem announcing that the Supreme Court had granted a stay of execution in the Belding murder case, pending the hearing on appeal. Belding would have been executed on Friday if the Supreme Court had not interfered. The scaffold has been built, and it is allowed to remain until it is needed. Sheriff Storey, in speaking about the matter, said:

"I am pleased that the hanging has been postponed. There are other murderers to be tried, and there is Smith, who stands convicted. I hope that arrangements can be made to hang them at the same time and have the agony over with at once."

Belding was informed of the reprieve by County Jailor Jackson. He smiled and remarked: "That is all right. I now have a chance to make arrangements for the care of my little boy." Belding has stated heretofore that he is aware that it is only a question of time when he will be executed. His attorney, Fred Nelson, who lost in the State Court they will appeal to the United States Supreme Court for a decision as to the constitutionality of the information law. There are two other charges against Belding, and if necessary, the District Attorney will cause him to be tried on one of them. These are based on the testimony of the grand jury, and Belding may be hanged while his attorneys are waiting for the decision in the first case.

WILL OIL PRESERVE?

Question to Be Investigated by Oregon
Good Roads Advocates.

Will oil help Oregon roads to shed water? This question will be investigated by the Oregon Good Roads Association, of which John H. Scott, County Judge of Marion, is President. "The essential to good roads," said Judge Scott yesterday, "is drainage. You must have a road bed of a road three, five or 10 feet deep and unless the highway has a 'roof' that will shed water, it will go to rapid ruin. Some people think they can improve a road permanently by throwing large rocks into the mud holes. They make a big mistake. The bed of the road must be compactly laid and its surface must have an envelope of water to run off the water."

The Judge will personally ascertain whether oil will make roads in Oregon more impervious to water. To this end he will gather information from Southern California. That district is very dry and roads there are sprinkled with oil with highly beneficial results. James W. Abbott, agent of the Southern California Oil Company, who was in Portland yesterday, was disposed to doubt that oil would accomplish in Oregon the results desired. He said that oil would improve roads in summer, but that in the winter the water would soften the road surface. "I shall look carefully into this matter," said Mr. Abbott, "for it is of importance to road improvement here if oil can be used to advantage."

The announcement of Colonial Secretary Chamberlain's decision to proceed to South Africa, in order to examine on the spot the problems presented by the termination of the war and the settlement of affairs in the new British colonies consequently caused the utmost surprise in political circles. It is tolerably certain, declares the correspondent, that the situation had not been one of peril the Colonial Secretary would have left the whole matter absolutely in the hands of Lord Milner.

The feeling between the British and Dutch people in Cape Colony just now is said to be more bitter than it was in the days before the war. The Transvaal and Free State colors are worn freely in the Dutch towns of the Cape. The loyalists are naturally alarmed at this state of things.

Ever since Mr. Chamberlain became Colonial Secretary he has disregarded precedent. One notable instance, which has a slight resemblance to a master stroke of policy, now initiated by him, was his visit last Autumn to Malta to inquire into the petition of the Maltese against compulsory adoption of the English language. When he returned to London, he consulted with his colleagues and soon afterwards came an intimation that the objectionable edict had been withdrawn. It is possible that it is this experience which has prompted him to study for himself the present position of affairs, not only at the Cape, but in England's two new colonies, so as to be able to initiate and carry out an imperial policy which will justify the sacrifices of the millions of the British South Africa.

NEW TRAIN ON SOUTHERN PACIFIC.
