Colombian Force Wins a Big Victory.

URIBE-URIBE IS CAPTURED

Gives Up Many Arms and Much Ammunition.

BOTH SIDES LOSE MANY MEN

Success of the Regulars is Largely Due to General Marjarras, and Causes Great Rejoicing at Panama and Colon.

PANAMA, Oct. 28.—The revolutionary leader, General Uribe-Uribe, with 10 cannon, 2000 rifles and 200,000 rounds of ammunition, has surrendered to General Marjarras at Rio Frio, near Santa Marta.

General Marjarras, with 2000 men, proceeded against the rebels, from La Cienega, and engaged the enemy two days ago.

The news of the victory was received here by General Fredon and Salazar this morning in a telegram from General Marjarras.

DEATH BLOW TO REVOLUTION.

American Legation is Now Confident Peace is at Hand.

WASHINGTON, Oct. 28.—Confirmation of the news of the surrender of General Uribe-Uribe was contained in a dispatch received at the Colombian legation here tonight.

The movements of General Uribe-Uribe have taken him into various portions of the interior of Colombia, his early operations being in the State of Jolima, later in the State of Magdalena, and finally in the State of Santander.

COLON AND PANAMA REJOICE.

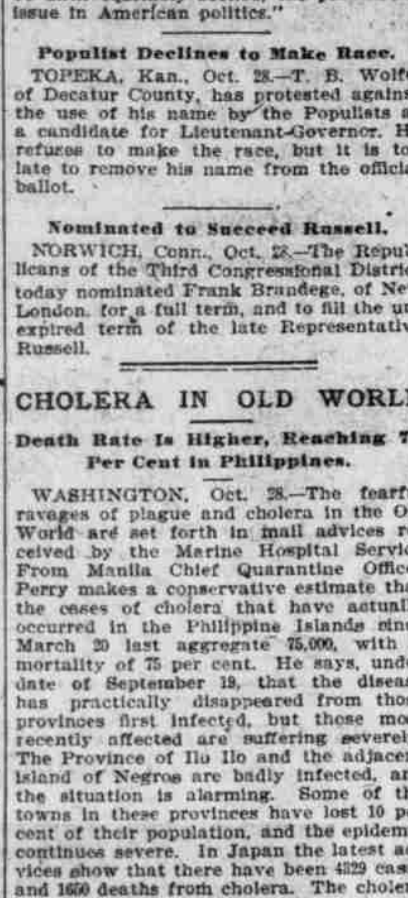
