

ONE BEAR SLAIN

But Roosevelt Did Not Kill It.

FINE SPORT IS ENJOYED

President Leaves His Stand and Then Bruin Shows Up.

EXECUTIVE OUT AT LATE HOUR

Some Fear Expressed That He Will Get So Far Away as to Be Compelled to Sleep on the Trail.

EMERSON, Miss., Nov. 14.—A lean black bear, which weighs 225 pounds, is hanging up at the President's camp on the Little Sunflower, but, to the regret of all the members of the party, the first trophy of the hunt did not fall to the President's rifle. The bear's trail was struck by the hounds soon after the party started this morning. The members of the party, except President Roosevelt, Mr. Foote, Mr. Parker and Hoke Collier, had been stationed at the various crossings, and as soon as the dogs gave tongue, the President and his guides plunged through the dense underbrush in pursuit. Within a few minutes, the dogs showed the direction the quarry was taking, and Hoke Collier, with the instinct of an old bear hunter, immediately made up his mind as to where the animal was to come out. To save the President a useless hard trip through the brush, he directed Mr. Foote to take the Bears along the trail to a certain cut-off. This was done, and the President and Mr. Foote rode to the assigned station.

On the way, several swamp deer were jumped, but no effort was made to get a shot at them. For several hours the President and Mr. Foote trailed the bear. The trail of the bear carried the yelling hounds out of hearing, and shortly after noon Mr. Foote abandoned hope that there was a quarry would come back their way, and he and the President returned to camp for lunch. Had they remained, the President would have had a shot, as the bear, with the pack at its heels, crossed almost the exact spot which Hoke had indicated. About a mile beyond this point the bear, exhausted by his long race, ran into a water hole and turned on the dogs, one of which he killed. Collier roped the bear and tied it to a tree, and the President, who was summoned, declined to shoot it, and Mr. Parker dispatched it with a knife.

On the way to camp with the dead bear, the dogs struck a fresh trail, and the President, Mr. Foote, Mr. Mangum, Secretary Cortelyou and Dr. Lang followed it. Mr. Fish and Mr. Parker returned to camp, but at dark when the Associated Press correspondents left, there was no sign of the President, and some anxiety was manifested lest the President, in his enthusiasm, would get too far away, and be forced to sleep on the trail.

None of the small army of newspaper men and photographers who followed the President here succeeded in reaching camp today. The only newspaper men allowed there were the three press association representatives who accompanied the party. All kinds of expedients were attempted by the others to get to camp, but without avail.

The weather conditions today were ideal. The sky was overcast at daybreak, and a few drops of rain fell, but toward 7 o'clock the clouds broke away and the sun came out. The air was soft and balmy, and old hunters said the dogs could work without distress. About midnight "Burr Ennold" reached the government headquarters at the Mississippi River with six bear dogs, and Mr. Mangum, despite his illness, started with them for camp before daylight.

HIDDEN TREASURES FOUND

Americans Discover Cavern Utilized by Some Prehistoric Race. HERMOSILLO, Mex., Nov. 14.—A remarkable story, duly authenticated, of the discovery of hidden Aztec treasures, has just been reported to the government authorities at Tepic by Rev. Pablo Martino, the parish priest of Yescu. The priest makes a statement, which is corroborated by several reliable witnesses, that a party of Americans, headed by an archaeological expert, who gave the name of Heverick, arrived at Yescu several weeks ago, and went from that place into the mountains accompanied by three Mexican guides. The archaeological expert obtained his bearings by means of a chart which he is said to have copied from an Aztec stone tablet in the National Museum in the City of Mexico. He located a vast cavern in a mountain near Yescu. Immense stone images stood about this cavern. In one end was a handsome altar, above which burned a bright flame, supplied by natural gas from a crevice in the wall. In a chamber adjoining this main temple was found a great store of ornaments and utensils belonging to the Aztecs or some other prehistoric race. Twelve burials were required to transport the articles to San Blas, where they were shipped to San Francisco, accompanied by the Americans.

BOUGHT VOTES RIGHT AND LEFT

New York District Captains Fell Into Trap Set for Them.

NEW YORK, Nov. 14.—Two District Captains in the Ninth Assembly District have been indicted for accepting bonds of \$500 each to answer charges of violating the election law. The evidence in the case was procured by six young collegians who volunteered their services to the State Department. McCullagh, one of the young men is said to be a millionaire. Another is a young physician, and the four remaining are medical students. They claim to have made themselves noticeable around West Twenty-sixth street just before election day. Disguised as tramps, they were accosted by workmen who, after becoming acquainted, disposed of them in various rooms. On election day they were provided with alms bearing the names of men who had registered in good faith but who had been called away. In this manner they say they voted many times apiece, and for each ballot allege they received \$1. Superintendent McCullagh's deputies at the polls were furnished with names, and the ballots are said to have been marked for identification.

REPUBLICANS MAKE BIG GAINS

Hawaiian Election Shows Complete Reversal of Sentiment.

HONOLULU, Nov. 8, via San Francisco, Nov. 14.—(Correspondence from the Associated Press.)—Complete election returns show that Prince Kuhio, the Republican candidate, has beaten Delegate Wilcox for Congress by a margin of 100 votes. The Republicans have 30 Representatives out of 30 and nine Senators out of 15. This is a complete reversal of the last election results, which elected Wilcox majority of the House and two-thirds home rule majority in the Senate. The new Legislature contains a large number of new members, and the result is generally attributed to dissatisfaction with the last Legislature and opposition to Delegate Wilcox's plan to make the Republic a Federal settlement for all American people.

GOOD WORK AT CARLSLE.

Superintendent Says Indian Students Have Made Good Showing.

WASHINGTON, Nov. 14.—The annual report of Lieutenant-Colonel R. C. Pratt, United States superintendent of the Carlisle Indian Industrial Institute, Carlisle, Pa., contains a very favorable statement during the year a maximum enrollment of 1073 was attained. The students earned during the year an aggregate of \$1,519. The report shows excellent results from the work of the students, and the superintendent shows increasingly satisfactory results, and the advance of the standard of scholarship and improvement in articulation and English. Colonel Pratt says that Nature-study has a special interest for the students and that this class of educational work was pressed with more system and larger results.

Italy Now Satisfied Composer Did Not Fare Badly in America.

ROME, Nov. 14.—The latest news which has been received from the composer Mascagni affair have convinced the Italian press that the American authorities did their utmost within the limits of the law to mitigate the composer's situation. The Italian Consul in Boston has telegraphed to the Foreign Minister that it was impossible to do more than they did for the composer.

ALIENS TELL ON SNUGLER

Baker on Ship Dressed Them So They Could Pass as His Helpers.

NEW YORK, Nov. 14.—Charged with smuggling aliens into the United States by a method unique and ingenious, Auguste Mellere, chief baker on the steamship Roma, has been arrested by the Immigration officers, and Federal officers are searching for other immigrants who are alleged to have landed illegally. The Roma arrived from Naples last week. According to Cappa, the baker offered for \$25 lire to dress him in a white cap and apron, the regulation baker's garb, so that he could land without having to undergo official inspection. Cappa says he and four other aliens took the offer. The Immigration officers passed them as members of the crew. In searching for the Italian Colony, Cappa got lost and began to ask questions. Going back toward the ship, he innocently told his tale to a customs inspector and was immediately detained. In his affidavit the French baker was arrested.

VOLCANO MORE VIOLENT

Eruption of Stromboli is Increasing—Ashes Out at Sea.

ROME, Nov. 14.—The eruption of the volcano Stromboli is increasing in violence and is accompanied by shocks of earthquake and alarming detonations. Ashes thrown out by the volcano are falling on boats out at sea.

REMAINS OF 1776 WAR LEADER MOVED

FOREIGN LEADERS OF REVOLUTION

NEW YORK, Nov. 14.—The remains of General Nathaniel Greene, one of the foremost military leaders of the Revolution, were reinterred this afternoon, being placed under the Greene monument in the National Soldiers' Cemetery. The interment was performed by the National Society of the Sons of the American Revolution, and was presided over by the Rev. Dr. John H. Houghton.

IRISH EDITOR SENTENCED TO PRISON

LIMERICK, Ireland, Nov. 14.—(Special.)—James Limerick, proprietor of the Limerick Leader, was sentenced here today to four months' imprisonment at hard labor, for inciting to intimidation and conspiracy, although he had been acquitted of the same within the law. Mr. Buckley gave notice of an appeal, and was released on bail.

Lieutenant Jordan Weds.

DENVER, Nov. 14.—Lieutenant William Jordan, United States Army, now stationed at Fort Logan, and Miss May Beal were married today at St. Mark's Church in this city. The ceremony was performed by the Rev. Dr. John H. Houghton.

Earthquake Shock in Kansas

MPHERSON, Kan., Nov. 14.—What is believed to have been an earthquake shock was felt here last night, but no damage was done. As far as is known, the shock was not felt in any other portion of the state.

Doukhobors Azita a Titone

WINNIPEG, Man., Nov. 14.—J. S. Creer, of Yorkton, has wired the Dominion Immigration Department that the Doukhobors were making satisfactory progress on the prairie. The majority are back in their homes.
