

## WON A GREAT RACE

Glory for Protected Cruiser  
Cincinnati.

## ALABAMA FASTEST BATTLESHIP

Five-Day Ocean Race Ended in the  
Harbor of San Juan, Porto Rico—  
Several Surprises Were Devel-  
oped by the Experiment.

NEW YORK, Nov. 21.—Carrying a great white bow in her teeth and with phosphorescent spray dashing high upon her sharp bows, the cruiser Cincinnati forged abreast of Cuba light at midnight last night, a winner in the greatest ocean race of warships ever run on the North Atlantic seaboard, says a Herald dispatch from San Juan, Porto Rico.

Barely two miles astern of the cruiser flashed the white searchlight of the great battle-ship Alabama. She had distanced all her rivals of the heavy-weight class and had shown her quality by putting up a hammer-and-tongs struggle all the way from Hampton Roads, Va., with the fleet-footed cruiser. One by one she had left behind the little gunboat Machias, the Indiana, the new battle-ship Kearsarge, her own particular rival, and last of all the plucky Massachusetts, sister ship of the Oregon.

That the comparatively old Massachusetts was a stronger competitor than the Kearsarge is one of the surprises of the race. That the Alabama came in so close a second to the fast commerce destroyer Cincinnati, even though the cruiser had been handicapped 25 miles at the start, is a superb performance for a first-class battle-ship heavily armed.

This is the first time in its history that the ships of the North Atlantic squadron have engaged in such a long-distance speed contest in the open sea. As a component part of the great fleet of warships now assembling for the winter naval maneuvers under command of Admiral Dewey, the North Atlantic Squadron was ordered, after assembling at Hampton Roads, to proceed to the naval rendezvous off Cuba light, the beacon that gleams from the pinnacle of a rocky little island off San Juan Point, Porto Rico. Here was a superb opportunity to test the actual relative speed of the ships of the fleet in competition, and under thoroughly practical conditions.

## The Start on Saturday.

Five of the ships lined up for the start at noon on Saturday—the Alabama, the Kearsarge, the Massachusetts, the Indiana and the Machias, baby of the fleet. The last-named is a gunboat, only 190 feet long and of 1000 tons displacement. The other four are battle-ships. The Massachusetts and Indiana are sister vessels launched in 1883, and with the Oregon, not entered in this contest, they mark the earlier type of first-class battle-ships of the new Navy. The Kearsarge and the Alabama represented later types of sea-fighters.

Thirty-five miles behind the line-of-battle-ships came the protected cruiser Cincinnati. By reason of her speed and light type, this was regarded as a fair handicap for the greyhound of the fleet, which, to do her destined work, should easily outclass them all in cruising qualities.

At the flash of the gun the levitators were off to sea, with full head of steam, and in 10 minutes all were plowing through the ocean headed for Cuba, with widening mainmasts of white spume boiling under their pounding screws. Almost from the start the Alabama began to forge ahead of her rivals. She gained visibly on the Indiana and the little Machias. The Kearsarge was regarded as her most dangerous adversary, and the race between these two ships has always existed between officers and crews of these two ships.

No device was neglected on either of the giants of the fleet to speed them to their limit. Smoke from the funnels and huge stacks and their decks quivered above the throbbing engines. Four hours from the start, just before twilight, the Alabama left the Kearsarge hull down astern with only her masts and funnels visible. With the older Massachusetts it was a harder struggle. But, newer lines and greater power were told to tell. Before night the old ship, despite her most gallant efforts, was astern and gradually, even her gleaming lights faded out of sight.

Barring accidents, it was the Alabama's race, so far as the battle-ship work concerned, but at sundown Monday the look-out at the stern of the leader sighted the Cincinnati coming up like a race horse held in check for the finish. She had made up her handicap, passed the Kearsarge and was now speeding in the wake of her sole competitor. It seemed a hopeless task for the battle-ship to try to hold the cruiser, but she made a brave fight of it all day Monday, and on Tuesday and Wednesday. She checked her rival as the latter slowly forged ahead and then ahead of her, almost within sight of the goal.

When Cuba light was picked up the Alabama was within 10 miles of the goal, going at a terrific clip, but she could not close up the gap. Barely two miles astern of the cruiser at midnight she hove to. The Kearsarge, Massachusetts, Indiana and Machias were not in sight at the finish.

## WILL REBUILD AT MEACHAM.

## "Frisco" Branching Out.

## Advance in Michigan.

DETROIT, Mich., Nov. 21.—General Superintendent L. Hommedieu this afternoon announced an increase of from 1 to 4 cents an hour in the pay of switchmen on the Michigan Central Railroad in the big yards between Detroit and Chicago and at junction points in Michigan, from December 1. The new scale affects about 500 men, and means an increase to the company's pay roll of about \$6000 a month. The increase was given voluntarily to make the scale commensurate with that paid by Chicago railroads.

## Road Between Guayaquil and Quito.

SAN FRANCISCO, Nov. 21.—A. R. C. Moore, secretary of the Guayaquil & Quito Railroad, has arrived here from Ecuador. He reports that rapid progress is being made in constructing the railroad. Starting at Guayaquil, the railroad, a 42-inch gauge, mounts to an altitude of 11,200 feet on the Palmyra Pass before descending to Quito, which has an altitude of 8000 feet. The line is now at Alausi, 3000 feet above sea level.

## Railroad Men Go Hunting.

## END OF A BOLD, BAD MAN

HANGED FOR ONE, BUT HAD SLAIN  
—A SCORE.

Was One of the Most Desperate Outlaws That Ever Trod Arizona's Cactus Plains and Canyons.

SOLOMONVILLE, Ariz., Nov. 21.—Augustin Chacon, the Mexican outlaw, was hanged here at 1:30 o'clock today before four officials and those spectators having cards to the jail enclosure. Chacon was game to the last. He passed a quiet night, sleeping soundly and seemed in good spirits all morning. At 9 o'clock he was shaved and later a priest was with him for an hour. He requested that Sheriff Parks have Charvarria and Molono, two local Mexicans present, and asked for an hour to speak before the execution. After drinking a cup of coffee and still smoking a cigarette, he ascended the gallows shortly before 1 o'clock and spoke for 30 minutes, but he incriminated no one. His remarks were disconnected and made through an interpreter. He commended the officials who tried him and have had him in charge since his sentence. As the cap was being adjusted he said loudly, "Adios, amigos," and straightened up for the drop, giving the Sheriff the signal to spring the trap. His neck was broken and the attending physicians pronounced him dead in 16 minutes after the fall.

The crime for which Chacon was executed today was committed on Christmas day, 1895. The night before he and a band of outlaws, of which he was the leader, broke into the store of Mrs. McCormick at Morenci. Paul Becker, manager of the store, came upon the robbers in the act of looting the place. They captured him and ordered him to open the safe. Upon his refusing to do so, he was stabbed to death. The following morning Constable Alexander Davis trailed the robbers to a Mexican house, from which the entire band emerged, shooting at everybody in sight. Two of the robbers were killed.

Chacon shot and killed Pablo Salcedo, who was going up the mountain side to persuade him to surrender. For this crime he was convicted in 1897 and sentenced to be hanged at Solomonville on June 18 of that year. On the night of the 9th of June, 1897, he dug his way out of the stone jail at Solomonville and escaped. He was at large until September of that year, when he was captured near Naco by Captain Burton Moorman, of the Arizona Rangers. Moorman, together with Sheriff Parks, of Graham County, had arranged with William Stiles and Burt Alvord, the latter of whom has since surrendered, to entice Chacon across the Mexican line into Arizona on a horse-stealing expedition. The officers, Stiles and Alvord, lay in wait for Chacon in the night and played the part of associate, and at daylight arrested him. At the last term of court he was sentenced to be hanged on this date.

During his recent period of liberty Chacon is known to have committed many crimes, and is credited with having taken more than one life.

## GAME OF NEW YORK SWINDLERS.

Sold an Italian Contract Which They Did Not Own.

NEW YORK, Nov. 21.—Three men, charged technically with the larceny of \$250, but who are alleged to have been the means through which the complainant lost a much larger amount, have been assigned to the county court here. They are Daniel W. Leese, alias George Rivers; George W. Palmer, whose card says he is a commissioner of the United States Court of Claims, and Philip F. Rhoades, a clerk connected with the Business Improvement Company.

The arrests were made on a warrant secured some months ago, the complainant being Joseph Marrore, an Italian contractor. Marrore alleges that in answer to an advertisement, he called at Palmer's office and was taken by Palmer to the office of the Halter Investment Company. There Leese told him he had a contract to get out a quantity of granite blocks in Connecticut and wanted 500 men to work in the quarry. Rhoades alleged to have told Marrore that he had a contract for a reservoir at Providence, R. I., and wanted 1000 men.

Taking both contracts Marrore says he paid Leese \$500 and Rhoades \$700; that he put out men and worked for four weeks, but that Leese and Rhoades did not have the contracts, as they had asserted. Eventually, he was compelled to pay his men \$4250.

At police headquarters it was said that Leese's picture is in the Rogues' Gallery as a "commercial swindler."

## LOGAN FOUND GUILTY.

Conviction on Ten Counts—Penalty, 30 to 90 Years.

KNOXVILLE, Tenn., Nov. 21.—Harvey Logan, alias Kid Curry, the Montana train-robber and outlaw, was found guilty on 10 counts of a 13-count indictment in the Federal Court this afternoon. Sentence was not passed on the prisoners by Judge Clark, but court was adjourned to Saturday, November 22, at which time a motion for a new trial will be argued, and if the motion be overruled, sentence will be pronounced.

Logan, by at verdict, has been found guilty of forging the names of bank officials to the Montana bank notes in six instances, passing illegal money, and in his possession. Three counts, in which he was charged with concealing bank notes to the amount of \$500, were thrown out, at the suggestion of the prosecution. The lowest punishment on any of the 10 counts is five years and the maximum 15 years. Some of the counts being virtually the same, Logan stands to receive a sentence of 30 to 90 years.

Logan was taken into custody on July 4, 1901, at Great Falls, Mont., where he was held by Wagner, Mont., opened the express safe by dynamite and secured \$4000 in bank notes of the National Bank of Montana, which he carried off to the city of this city on December 11, 1901, after shooting two policemen.

## LOSSES \$26,000 NECKLACE.

Forfeited Because It Was Not Declared to Customs Officer.

NEW YORK, Nov. 21.—Judge Adams, in the United States District Court today directed the jury to find for the Government in the case of Mrs. Ida Harrison Dulles, from whom a \$25,000 pearl necklace was taken on her arrival from Europe some months ago. Judge Adams said Mrs. Dulles had failed to comply with the requirements of the customs service, and therefore the pearls should be forfeited. Mrs. Dulles, in her defense, said she intended to declare the necklace, but that she desired to consult her husband on the matter before doing so. While she was talking to her husband, the Treasury agent stepped up and asked her to hand him the necklace which she was wearing.

## DENVER CONTENT CASE.

Jury Trial Refused to Defendant, Who Took Appeal.

DENVER, Colo., Nov. 21.—District Judge Johnson today refused a jury trial to Julius Alchele, Clerk of Arapahoe County, on the charge of contempt in certifying names on the registration lists prior to the late election after he had been enjoined from doing so. Judge Johnson held that the amendment to the code allowing jury trials in contempt cases was unconstitutional.

The Supreme Court today heard arguments on Alchele's appeal for a writ of prohibition to restrain Judge Johnson from proceeding with the contempt cases, and took the question under advisement. Attorney Harvey Riddle, who appeared

for Alchele, contended that the District Court had no jurisdiction in the case in which the injunction was made, and that Judge Johnson had erred in refusing to allow a trial before a jury.

## ANOTHER TRAIN WAS ROBBED.

Got Money, But It Is Not Known How Much.

DAVENPORT, Ia., Nov. 21.—A west-bound passenger and express train on the Rock Island track No. 11 was held up by 12 masked robbers soon after midnight this morning at a point three miles west of Davenport. The robbers uncoupled the express car and ran it two miles further west to Gale siding, where the safe was blown open with dynamite. The explosion was heard in Davenport.

The train which was robbed left Chicago at 6:58 last night. It was the fastest train that runs through to Fort Worth, via St. Joseph and Kansas City.

Ten men of the local police department have hurried to the scene of the robbery. It is not known how much booty the robbers secured.

At 3:15 A. M. it was definitely learned that the robbers were successful in removing the contents of the safe from the express car. No person was injured. It was nearly two hours after the hold-up before the train could proceed.

The robbers succeeded in stopping the train by placing a red lantern on the track, and when the engineer saw the danger signal he brought the train to a stop. Five masked men boarded the train.

Detached the mail and express cars, and forcing the engineer to accompany them, took these cars westward, leaving the rest of the train standing on the main track.

## Wounded Girl and Killed Himself.

ANN ARBOR, Mich., Nov. 21.—Because Bertha Sheldon had allowed another man to court her, she shot him dead in a store where she is employed, G. A. Darlington, a packer for an organ company and a student in the University School of Music, today shot her in the arm and then fired a bullet into his own head, dying almost instantly.

Darlington came here from Strathcona, Ontario. He served with the Canadian soldiers in the South African War. He was about 24 years of age.

## Fatal Shooting at a Prizefight.

GUTHRIE, O. T., Nov. 21.—Trouble arose at a prizefight at Oklahoma City tonight, and in a few seconds 25 shots were fired. Goldie Wilson fell dead with five bullets in his head, his brother is fatally injured with a shot through the neck, and two unknown men were shot, one through the shoulder and the other through a leg. The prizefight had reached its fourth round when the melee started.

## SHOT AND KILLED A MAN

DEED OF SON OF OUR MINISTER TO GUATEMALA.

Slayer Seeks Protection of United States Legation—International Aspect of the Case.

WASHINGTON, Nov. 21.—The State Department has been informed that Godfrey Hunter, Jr., son of the United States Minister at Guatemala City, today shot and killed William Fitzgerald, of Grand Rapids, Mich. Hunter has taken refuge in the Legation, and an interesting question has arisen as to his exemption from arrest.

Important details are lacking in the report of the affair, which has come to the State Department, and the officials are in doubt as to what should be done. They have no notion of surrendering without protest an American citizen to the local courts of Guatemala unless satisfied that the man is a proper subject for punishment. Even then, it is not at all certain that the department itself has the right to waive any legal exemption that the man might have. International law lays down the precept that an Ambassador or Minister may not of his own accord surrender any such exemption in his own case.

The only name by which the dead man was known was Fitzgerald. He was shot four times. Another fact developed is that young Hunter was accompanied at the time of the shooting by the secretary of the Legation. This official is set down in the register as being James G. Bailey, of Kentucky, who went to his post in June, 1901. The cablegram, also, rather by suggestion than by direct statement, gave ground for the inference that the killing was provoked.

It is known of the personality of Godfrey Hunter, Jr., and it is impossible to learn definitely whether or not he was actually connected officially with the United States Legation at Guatemala City at the time of the killing. That he had been a clerk or typewriter in the Legation is established, but in some quarters it is said that this connection had been terminated some time ago.

Important point in settling the question of exemption of young Hunter from arrest, for a legation attaché or employee engaged in a large degree the exemption conferred by international law on an Ambassador or Minister. Another point that may operate in Hunter's favor is his kinship to the Minister. He was certainly a member of the Minister's family, and that fact might be regarded as sufficient to base a claim of exemption.

The excitement in the neighborhood of the Legation in Guatemala City has made it difficult for the State Department to obtain any information from any unbiased person connected with the legation and not involved in the affair. Therefore, it is probable that it will await some application from the Guatemalan authorities for surrender of young Hunter and decide Hunter's claim to exemption from arrest on the basis of all the points presented.

It is supposed here that the shooting affair may mean the relief of Dr. Hunter from his post as Minister. The doctor had been steadily embroiled with members of the Guatemalan government since he assumed office in 1897, and lately, owing to his connection with a government railroad and other matters not supposed to be proper for a Minister to meddle with, the pressure became so acute that the department was obliged to relieve him from office. It may be that Fitzgerald was connected in some way with the charges against the Minister.

his father's private secretary at the Legation in Guatemala for some time. Young Hunter figured in a social affair in Louisville which was extensively recounted about a year ago. Dr. Hunter and his son came to Louisville last winter. Young Hunter was taken seriously ill while here, and for a time his life was despaired of.

Dr. Hunter's eldest son, William, is a resident of Louisville. He has had no information on the tragedy except that contained in the Associated Press dispatches. Fitzgerald, whom young Hunter shot and killed today, made charges about a year ago against Dr. Hunter. He criticized sharply the way in which Dr. Hunter conducted his office, and made some serious reflections on the Minister. Fitzgerald, while on a trip to this country, gave out an interview at New Orleans in which he scored Dr. Hunter and young Godfrey severely. He announced that he would prefer charges against Dr. Hunter at Washington, but the matter was never taken up by the State Department.

Fitzgerald in Guatemalan Employ.

GRAND RAPIDS, Mich., Nov. 21.—William Fitzgerald, father of ex-United States Consul William A. Fitzgerald, at Champerico, Guatemala, reported shot and killed today, has received no advice and the only information he has of the shooting is contained in the Associated Press dispatch. Mr. Fitzgerald was crushed by the first news and entertained little hope, but the later dispatch, indicating that the victim may be some other Fitzgerald, gave him hope that his son was still safe. Young Fitzgerald was appointed Consul at Champerico about six years ago, served about a year and resigned, entering the service of the Guatemalan government, which position he still holds.

## HIGH LICENSE FOR VERMONT

Legislature Passes Bill With Referendum Attached.

MONTPELIER, Vt., Nov. 21.—Both branches of the Legislature today passed a local option high license bill with referendum attached, and the bill will be submitted to a vote of the people on the first Tuesday in January. Should a majority then declare in favor of the bill, the law will go into effect on the first Tuesday in March next. An amendment to allow women to vote on the referendum was defeated, 128 to 51.

## Chamberlain at Windsor.

LONDON, Nov. 21.—Colonial Secretary and Mrs. Chamberlain went to Windsor tonight on a farewell visit to King Edward prior to their departure for South Africa.
