St. Louis ex-Speaker Is Back From Europe.

CAME BECAUSE SON DIED

His Bereavement Renders Him Careless of What Happens—Placed Under Arrest at Philadelphia.

PHILADELPHIA, Nov. 28.—After eluding arrest for several months, Charles F. Kelly, ex-Speaker of the St. Louis House of Delegates, who is wanted in the West in connection with the bribery cases, was arrested in this city at 1:30 o'clock this afternoon.

Kelly arrived at New York on the steamer Celtic this morning from Liverpool, and had just stepped from the Western Express in the Broad-street station on the Pennsylvania coast when he was taken into custody by a detective of this city. He admitted his identity, and is now locked up in the central police station. He will be given a hearing tomorrow morning by Judge Conover, who will be held to await requisition papers from the State of Missouri. The labels on Kelly's baggage indicated that he had been in Naples, Paris, London, Berlin, Dublin and Killarney.

ARRIVAL AT NEW YORK CITY.

Came Back Because of His Son's Death.

NEW YORK, Nov. 28.—Charles F. Kelly, ex-Speaker of the House of Delegates, of St. Louis, arrived here today on the steamer Celtic. On the same ship were William Rattigan, a St. Louis contractor, and William J. Sullivan, of St. Louis. Kelly's name was not on the passenger list, but Sullivan's and Rattigan's were. At the dock when the Celtic arrived, was Congressman-elect James J. Butler, of St. Louis.

Kelly's face looked white and wrinkled. He was recognized as he stepped down the gangway by G. Carroll, correspondent of the St. Louis Post-Dispatch, and when he was called by name he started back as though he had been struck. Congressman Butler, who was the correspondent away, but Kelly held out his hand and said:

"For God's sake, let me alone for today. I have nothing to say. I have been received word that my son is dead, and I am going right back to St. Louis. "Where have I been? Everywhere. The trip has been no rest for me. I will be glad to get back to my home in St. Louis, who is broken-hearted over our boy's death. I can't tell you what is ahead of me. I don't care, now that the boy is dead."

MOST WANTED OF ALL.

Kelly Alone Can Convict Boodlers, but May Be Too Late.

ST. LOUIS, Nov. 28.—Charles F. Kelly, ex-Speaker of the City Council, known as the House of Delegates, was the most badly wanted of all the members of the caucus known as the "Cotton Club" on charges of bribery in connection with the passage of the municipal lighting bill. Kelly was wanted because he, it was charged, had been the "cotton club" which, according to evidence, had been distributed among the 19 members of the caucus. Where did this money come from? Kelly was the only member of the grand jury who wanted to answer, and, believing that Kelly could furnish the answer, indicted him on September 8. He was at the four courts when the indictment was made against him. A Deputy Sheriff told him he was wanted. Kelly asked permission to run over to the Council chamber to attend to an important matter, saying: "If you need me before I get back, telephone me at the House of Delegates."

"For God's sake, let me alone for today. I have nothing to say. I have been received word that my son is dead, and I am going right back to St. Louis. "Where have I been? Everywhere. The trip has been no rest for me. I will be glad to get back to my home in St. Louis, who is broken-hearted over our boy's death. I can't tell you what is ahead of me. I don't care, now that the boy is dead."

UP DESCHUTES VALLEY

RAILROAD SURVEY TO BEAD IS COMPLETED.

Everything Now Ready for Construction of Columbia Southern Extension—May Begin in Spring.

The board of directors of the Columbia Southern Extension Railroad Company yesterday approved the maps of the last section of the proposed extension from Shanko to Bend, a distance of a trifle more than 27 miles. The maps will now go to the United States Land Office at The Dalles for filing, in order that the company may have right of way across the main line above the divide, however, that the southernmost 27 miles of the route will cross very little Government land. Prospects of irrigation in that country, together with the promise of a trifle more than 27 miles of putting most of the Government land into private hands.

Everything is now ready for the financing of this project and for construction. President Lytle expects to have all arrangements made for putting construction crews on the line early in the Spring. The grades are very light, and the curvature is not great. For most of the distance the line does not vary perceptibly from dead level. From Shanko it bears southeasterly to Trout Creek, from which it runs north to the divide between Hay Creek and Willow Basin, crossing Agency Plains and going through the Haystack country. The crossing of the divide is at a distance of about 10 miles from Trout Creek. From that point to Bend there is a little curvature or grade in the line.

With this line completed to Bend, Central Oregon will belong to Portland's trade. If it is completed to Bend next year, as it is now hoped to do, it will beat the Nevada, California and Oregon line up from Reno. If construction is started on the line between Bend and California trade will dominate half of Oregon.

MAY FIGHT FOR IMMIGRANTS.

Rock Island Demands Share Which Other Roads Refuse.

CHICAGO, Nov. 28.—Present indications point to a war among the Western lines over the control of the traffic of the passenger department of the Western lines met here today with Commissioner Wadleigh and Chairman McLeod, of the Western Passenger Association, in an effort to reach a settlement. REOPEN ST. LOUIS CASE.

Commerce Commission Will Consider Coast Rates.

WASHINGTON, Nov. 28.—The Interstate Commerce Commission today announced its decision to reopen the case of the Business Men's League of St. Louis against the Atchafalaya, Topeka & Santa Fe Railroad Company and other lines. A further hearing will be held at St. Louis, February 19 next.

The commission holds that a showing of less distance and former grade rates does not warrant an order requiring lower rates from St. Louis to Chicago and other points than from New York on traffic carried by rail to Pacific Coast destinations. While the commission does not condemn the tariff as a whole, many of its details will be ordered to be changed. A differential as between carloads and less than carloads, which is at once more than 50 per cent of the carload rate, is prima-facie excessive.

The complainants in the case are granted leave to proceed in that branch of the case involving the question whether on traffic from the Middle West the present rates to intermediate points which are beyond the line to Pacific Coast terminals are lawful.

PENSIONS ON UNION PACIFIC.

Old Employees to Get More Than \$300,000 a Year.

OMAHA, Nov. 28.—Rules and regulations for a pension system, which will go into effect January 1, 1903, have been completed by the officials of the Union Pacific Railroad by which its old employees will be retired on pensions. The details of the system will not be made public until later, but it is officially stated that they have been worked out and the regulations printed. It is also stated that it will involve the annual distribution of over \$300,000.

BIG FOUR RAISES WAGES.
