

STAFF BILL PASSED

House Approves Reorganization of Army.

AFTER HOT FIRE OF CRITICISM

President to Be in Supreme Command, Name of Secretary of War Being Cut Out—More Pension for Dead Veterans.

The House yesterday passed finally the general staff bill, which places the active command of the Army in charge of a general staff of officers, under direction of the President.

Several members freely criticized the bill, while declaring they would vote for it.

Six members denied a charge that they pooled their committee work.

A bill was passed raising the monthly pension for total deafness from \$30 to \$40 a month.

WASHINGTON, Jan. 6.—The House today passed the bill for the creation of a general staff for the Army by a vote of 155 to 52. By the terms of the bill it becomes the duty of the general staff to prepare plans for the National defense and for the mobilization of the Army in time of war, to investigate and report on all questions affecting the efficiency of the Army, and to advise the President on all matters relating to the Army, to general officers and other superior commanders.

The general staff corps is to consist of one chief of staff and two general officers, all to be detailed by the President from officers of the Army at large, not below the grade of Brigadier-General, four Colonels, six Lieutenants-Colonel, and 12 Majors, 30 Captains, to be detailed from officers of the grade of Captain or First Lieutenant, who, while so serving, shall have the rank, pay and allowances of Captains. All officers of the general staff shall be detailed therefor for periods of four years.

While serving in the general staff corps officers may be assigned temporarily to duty with any branch of the Army in which they hold permanent commission, and no officer, except a general officer, shall be eligible to a further detail in the general corps, unless he shall have served two years with the branch of the Army in which commission he holds, except in case of emergency in the time of war.

The bill also provides that the chief of staff, under the direction of the President, shall have supervision of all troops of the line and of the Adjutant-General's, Inspector-General's, Judge-Advocate's, Quartermaster, Subsistence, Medical, Pay and Ordnance Departments, the Corps of Engineers and the Signal Corps, and shall perform such other duties as may be assigned to him by the President.

The vote yesterday having shown that the bill to create a general staff in the Army did not command the support of the necessary two-thirds to pass it under suspension of the rules, a special order was brought in from the committee on rules at the opening of the session of the House today, which provides for its consideration. The rule allowed an hour for general debate. It was not anticipated, and upon its adoption the House proceeded to the discussion of the bill.

McClellan (N. Y.), who is a member of the House, supported the bill, although expressing doubt whether the best results could be obtained from a general staff, composed of officers detailed for short terms without previous technical training. He remarked, ironically that perhaps this could not be helped, as long as Senators had sons and Representatives had relatives willing to serve their country. Adams (Pa.) warmly commended the bill.

Kluttz (S. C.) believed that one General in the field was better able to command the Army than a board of strategy. He said that the strategy during the Spanish War was ridiculous, and that it was only after Dewey had cut the cable that he had the free hand that gave an opportunity to win the victory in Manila Bay.

Warner (Ill.) offered an amendment to strike out the phrase "Secretary of War" wherever it occurred in the bill coupled with the "President." He thought the supreme command of the Army should rest where it was. He declared that he favored the bill, because it would do no little harm in time of peace. He said it would provide a few officers with harmless amusement, and not interfere with the conduct of the Army in the field when actual war came. The amendment was adopted, as were several other minor verbal amendments.

When the bill was placed upon its passage the division resulted: Ayes, 155; noes, 52. Whereupon Sims (Tenn.) made the point of no quorum. On roll-call the bill was passed, 155 to 52.

Cooper (Wla.), Merrill (Pa.), Lamb (Va.), Burk (Pa.), Cassell (Pa.), and Adams (Pa.), rising to questions of personal privilege, denied statements in certain papers that they had employed clerks jointly with other members.

Sullivan (N. H.) called for a bill to increase the pension for total deafness from \$30 to \$40 per month. Sullivan said there were but 925 such soldiers on the pension rolls. The additional charge entailed on the Treasury would be about \$25,000 per annum. After some discussion the bill was passed.

Bills were passed to fix the time for holding United States Court in Utah; to provide additional punishment for persons twice convicted of counterfeiting; and to change the boundaries of the southern and central judicial districts of Indian Territory. At 3:50 P. M. the House adjourned.

Kalamazoo Will Show You.
NEW YORK, Jan. 6.—Hudson River ice yachtsmen, according to the News, are preparing to enter their craft in the international races which are to be held from January 20 to 24 on Gull Lake, Kalamazoo, Mich., where pennants, cups and money prizes are to be competed for.

The Kalamazoo Club is having built a defender that is to be bigger in every way than the Jack Frost or the Hudson. The new yacht, which is called the Wolverine, will spread 300 feet of sail; backbone, 5 feet; mast, 30 feet. The Jack Frost spreads but 220 feet of sail, and is 25 feet broad at the runners. All races are to be at 20 miles, and with a time limit of one hour and 15 minutes.

INTEREST IN GRAND JURY

Rumors of Seattle's Corruption Are Developing Into Facts.

AFTER HOT FIRE OF CRITICISM

SEATTLE, Jan. 6.—Great interest is being taken in the proceedings of the grand jury, which are being carried on with vigor here, and which were instituted because of the alleged corruption of the police department and of the municipal administration. The jury began this morning by summoning several of the most prominent gamblers of this community, also a police captain, and city detective, George T. Piper, a well-known politician, was also examined. It is said that the jury has for its object the investigation of the police department and the municipal administration, and that it is by taking the gamblers first.

Although the sessions are strictly private and witnesses sworn to secrecy, enough has been learned by leakage to come to the conclusion that some rumors are developing into facts. The charges against the police are that the big gamblers were closed up because they would not submit to a levy by the Clancy brothers of 20 per cent of their profits for police protection, also that during the campaign last Spring a big contribution was made to elect the political administration and that even now, or until all places were closed, three weeks ago, owing to the scandal, a levy was laid on their profits in return for which the Clancy brothers were secured. Several indictments, it is believed, will be found by the jury before the end of the investigation.

LEFT UNPAID ACCOUNTS.

Constable Attaches Property of Oregon City Saloonkeeper.

OREGON CITY, Or., Jan. 6.—(Special.)—John Cooke, constable, attached a saloon on the corner of Main and Fourth streets for several months, left town suddenly Sunday night, leaving behind him a host of unpaid bills and accounts. Cooke formerly lived at Canby, where he ran a saloon. Five attachments and one execution are out against Cooke in the Justice Court, and this afternoon, Pickenstein, Mayer & Co., of Portland, filed an attachment against him for \$125.50. Constable Moody is taking an inventory of the stock, which will be sold in about 10 days.

His guardians want him sent to his native country for the benefit of his mental and physical health, and he will be taken there by his brother.

Labor Trouble Adjusted.

The trouble between the painters' union and Johnson & Andrews, who were declared unfair for subletting a painting contract to S. S. Mohler, a nonunion man, was adjusted at a meeting of Federal Labor Union last night. All sides of the question were presented and the contending parties have agreed to drop the matter. The difficulty will probably result in the establishment of a central labor body in this city.

VOTE TO ADMIT FAIRMOUNT.

Eugene Takes in Suburbs and Increases Number of Wards to Five.

EUGENE, Or., Jan. 6.—(Special.)—At the meeting of the City Council last night the question of ratification of the bill for the admission of Fairmount and College Hill additions to the city limits of Eugene was considered. The Council was not a unit in favor of the proposition, and the matter occasioned considerable debate, but finally resulted in ratification by a vote of 4 to 2.

It was decided to have the bill provide for the establishment of four city wards and that the Council should be authorized to propose additional wards. There is considerable opposition to the proposed new charter, which seems to grow no less with time.

New Rural Delivery Route.

Notice has been received from Washington to the effect that the new rural mail delivery route from Eugene eastward will begin operation the first of next month. The route from Eugene to Springfield, on the south side of the river, returning on the north side. At the same time two other routes will begin in the county, one from Springfield and one out from Irving.

At the Booth-Kelly Company's logging camp, on the McKenzie River, near Lewis and Clark, a fire broke out last night and caused considerable damage. The fire was caused by a logging engine and was struck by the cable, when it loosened from its struts. The fire spread to Eugene last night and placed in the hospital, where his injuries were found to be quite serious.

Receiver for Copper Mine.

LOS ANGELES, Jan. 6.—The Copper Belle Mining Company, of West Virginia, with headquarters in New York and capitalized at \$1,000,000, is in financial difficulties and has been appointed on petition of M. A. Newmark & Co., of Los Angeles, the Copper Belle owns valuable copper mines, a smelter, and a store in Gleason, Ariz.

Spaulding, of Cleveland, O., who is stopping at San Bernardino and came here to look after some property was held up and robbed by two men, who hit him with a club, breaking his shoulder and also bruising him severely. The highwaymen secured a diamond stud and \$50 in money.

IS MATCH FOR MUNROE

MAN WHO STOOD UP TO JEFFRIES IS NO WONDER.

Jack Sullivan, of Butte, Stars Four Rounds With Him, but Could Not Finish Him.

ANACONDA, Mont., Jan. 6.—Jack Sullivan, a local boxer, tonight stayed four rounds before Jack Munroe, the man who did the same thing with Jim Jeffries, Sullivan, much the lighter man, and has never been in a finish fight. Munroe did all the aggressive work, chasing Sullivan around the ring when they were not clinched.

In the first round Sullivan stood up pretty well, and made some returns for the stiff punching of Munroe. He also did some clever ducking. In the remaining three rounds, it was mostly clinching and short-arm blows, and Sullivan dropped to his knees after each exchange, remaining for nearly the count each time. In the last round he was on the floor most of the time, but he showed himself quick and a hard hitter. Sullivan is clever, but in a finish fight would hardly last. He gave very little punishment, but managed to avoid most of what was meant for him.

SHALL THERE BE PEACE?

Each Big League Magnate Says the Other Must Act.

CINCINNATI, Jan. 6.—Chairman Hermann of the peace committee of the National Baseball League, today received a letter from President Johnson, of the American League. Hermann refused to give out the contents of the letter, but said there is no reason to believe now that the peace committees of the National and American Leagues will meet this week and that it was up to President Johnson to call a meeting of the peace committee when he is ready to do so. In baseball circles here it seems to be the consensus of opinion that all negotiations between the two leagues are off.

GOVERNORS OF IDAHO AND MONTANA RECOMMEND EXHIBITS FOR LEWIS AND CLARK FAIR.

BOISE, IDAHO, Jan. 6.—(Special.)

At a joint session of the Legislature this afternoon, Governor Morrison read his first biennial message. The Legislative hall was crowded with a large and attentive audience, and a very favorable impression was created by the message. Touching on the St. Louis and Portland expositions, Governor Morrison has the following to say:

St. Louis Exposition.

"At this day we are not permitted to think and work for ourselves alone. Our sister states of the great and growing West look to us for recognition and encouragement. There are reciprocal obligations which if discharged will bring satisfactory rewards. The historic city of St. Louis, in the great State of Missouri, is making an eloquent appeal to her sister commonwealths of the West in behalf of the universal exposition, commemorating acquisition of the Louisiana territory, to be held in that city in the year 1904. There is not here to dilate upon the theme, which under the pen would expand beyond reasonable limits. Let it suffice to say here that had there been no Louisiana purchase they would, in all probability, have been no Idaho, no cluster of splendid intermountain states, no Northwest, Pacific Coast and the great American flag. No extortion should be required to secure from the Legislature whatever action may be necessary to the end that the State of Idaho may be represented in that exposition, and that liberal provision may be made for that purpose. It may well be doubted if any exposition ever held, or to be held, in the United States afforded, or will afford, the practical opportunities to display the products and resources of our great state as with the coming exposition at St. Louis. Its location is most happy for results in that particular. Its magnitude and popularity will attract a world-wide audience. An Idaho exhibit, operated in harmony with our bureau of immigration, ought to be of great and lasting benefit to the state.

Lewis and Clark Exposition.

"A little further in the future, in 1905, Portland, on the Willamette, will be celebrating the 100th anniversary of the advent of the Lewis and Clark expedition into the valley of the Columbia. President Jefferson's expedition to Louisiana from the French Government in 1803, followed that action by starting Lewis and Clark in 1804 for the purpose of examining and reporting what was to be found in the vast and then unvisited region to which the young American Republic had fallen heir. It would be interesting to accompany in spirit that expedition as it toiled up the turbid and rapid Missouri in its frail canoes and batteaux in contact with daily and constantly increasing difficulties and dangers."

Governor Toole in Sympathy With Project.

HELENA, Mont., Jan. 6.—(Special.)—Referring to the Lewis and Clark Exposition at Portland, Governor Toole in a message to the Legislature today said in part:

"When this matter was first called to my attention by a letter from Hon. H. W. Corbett, I appointed Hon. Samuel T. Hauser, of Lewis and Clark County, a commissioner to attend the preliminary meeting at Portland, November 5, 1901, at which steps were taken to inaugurate the celebration referred to. I am in entire sympathy with the object and purpose of the exposition, and would be pleased to see this state, through an exhibition of its resources and a liberal attendance of its citizens, contribute to the success of the enterprise, and for this purpose I recommend an appropriation to be expended in such manner as you may direct."

"It is believed that the exhibit which it is proposed to install at St. Louis in 1904 might be available for this purpose. That an appropriation will be made admits of practically no doubt. The large mining companies which will make individual exhibits at St. Louis will doubtless follow the example of the state and send them to Portland as well."

ALASKA AND ITS NEEDS

JAMES L. SHOUP ADVOCATES A TERRITORIAL GOVERNMENT.

United States Marshal Brings Down Prisoners From the North on His Way East.

"If Alaska is to make any marked advancement, she must have a territorial form of government," said James M. Shoup, United States Marshal of Alaska, when seen at the Portland Hotel last night. "Under the present system the people have no voice in the making of the laws and the information that members of Congress can have upon the conditions there is not sufficient to enable them to enact proper laws for the government of Alaska."

Mr. Shoup has held the office of United States Marshal to Alaska since 1897. He was appointed at that time Marshal of the entire territory. In 1900 a division was made and three districts were created. Mr. Shoup was appointed again, and will serve until 1904. He has become very interested in Alaska and Alaska people during his stay among them, and seems eager to promote their interests.

"Alaska is now sufficiently advanced to be able to support a territorial form of government," said he. "I believe that if the people would make petition to Congress they would be granted the right to make their own laws."

Asked why this was not done, he said: "The large corporations and heavy property-owners oppose the movement. I am sure that if it was left to a direct vote of the people such an action would be taken. If Alaska were a territory the taxes would be much larger than they are. The corporations are there for speculative interests, and do not care about the laws or the welfare of the country. What they want is large returns from their business, and extra taxes would not help them in this. Such an argument, however, is fallible, for their taxes would be expended immediately in building up the country. The large companies which are in the ground and fish out of the water, and should be willing to give something to help the advancement of the country."

"It is wrongly supposed," he continued, "that the settlement there is all transient. The population is fast becoming permanent. Many thousands of people in Alaska are there for life, and their children will grow up with the country. The climate is not so bad as is supposed. It is not so cold at Juneau, where I have my headquarters, as it is in Idaho. The coldest it has been this winter was 5 degrees above zero."

In speaking of the political chances of his brother, George L. Shoup, who is a candidate for re-election to the Senate from Idaho, Mr. Shoup expressed hope of his brother's success.

"I am sure there is not a candidate who would represent the state better than my brother," he said. "The other candidates are all friends of mine, and I have nothing to say against them. I have been in many political campaigns when all of them were with me, and they are all able men. My brother, however, has an acquaintance with the great men of the Nation, which makes him better fitted than any other man in the state for the position."

Mr. Shoup will leave this morning for the East. He will stop at Boise for a few days, and visit his family there before continuing his journey. His trip from Alaska was to bring five convicts and a crazy man to the United States for confinement. The convicts were left at McNeil's Island, and the crazy man at Salem.

Corbett Willing to Fight.

BUFFALO, N. Y., Jan. 6.—"I will accept the offer of the Hamilton Athletic Club, of San Francisco, to fight Jeffries for the championship of the world," said James J. Corbett tonight. Corbett believes Jeffries will also accept the offer.

Rule to Silence Critics.

CHICAGO, Jan. 6.—A ruling by stewards of the Western Jockey Club was given out today which is directed at the heads of critics who make themselves unpopular by adverse comments. "Any person seeking to injure, defame or bring into disrepute by threats, intimidation, menace or otherwise the association, or the rule runs, has an audience of meetings of association racing under the jurisdiction of the Western Jockey Club shall be disqualified."

Chaffee Ordered It.

Major Glenn Says That's Why He Adopted Water Cure.

MANILA, Jan. 6.—When the trial by court-martial of Major Edward J. Glenn, of the Fifth Infantry, was resumed here today, the defense renewed its request that General Chaffee, and Smith and other witnesses be summoned from the United States. The court refused this request for the present.

It was charged in the defense that the records of the Sixth Brigade, commanded by General Smith, had been tampered with and that important documents had been abstracted. The defense wished to examine General Smith as to certain documents and other written and verbal orders, for the purpose of showing the character of campaign General Smith desired to have waged.

General Chaffee was wanted as a witness for the purpose of obtaining certain documents which were not recorded at division headquarters. It was declared that General Chaffee had sent a telegram to the Department of Southern Luzon, where Cabelle's force was operating, clad in American uniforms. The text of this telegram is given as follows:

"The division commander directs that, no matter what methods be adopted, information as to the whereabouts of this force must be obtained. The officers are directed that this order was authorization for the water cure, and that officers in the field so interpreted it. If this interpretation was proper, the defense said General Chaffee was bound to the opportunity to show why he had failed to interfere to prevent the court-martialing of officers for executing the order."

Many Deaths From Cholera.

WASHINGTON, Jan. 6.—The report of the Philippine Commission for the last fiscal year says that from the time of cholera's first appearance in Manila to September 1, 1902, the total number of recorded cases was 52,525, of which 37,472 resulted fatally, the mortality being 71 per cent.

BUILD THEATER FOR DUSE

Morgan's Daughter Heads Movement for Italian Actress.

NEW YORK, Jan. 6.—Miss Anna Morgan, daughter of the late John Morgan, has subscribed \$100 to the fund with which Mme. Eleonor Duse, the Italian actress proposes to build an Italian National Theater on the shores of Lake Albano, near Rome. The ground for the theater, together with gardens, was recently donated by Count Frankenstein, a friend of the actress and a liberal patron of the arts.
