

AT PORTLAND, 1904

Oregon Likely to Secure Livestock Convention.

SUFFICIENT VOTES PLEDGED

Delegates at Kansas City Are Jubilant Over Prospects—Oregon Is Talked Everywhere and All Are Anxious to Come.

KANSAS CITY, Mo., Jan. 12.—(Special.)—The Oregon delegates to the National Livestock Convention here are in a happy mood tonight over their apparent success in capturing the 1904 convention for Portland.

The hopeful tone of the Oregonians is evidently warranted, judging by the talk heard in the hotel lobbies, where the campaigning goes on. The Oregon party arrived at 3:30 o'clock this morning, after a pleasant trip, and opened headquarters at the Coates Hotel, where apples and langes were given away.

The Star today says: "The Oregon delegates are persistent convention rooters. They want Portland selected as the meeting place for the convention of 1904, and are raising shirts, clams and liquors for votes."

The convention is the largest Kansas City has entertained since Bryan's second nomination for President in 1900. Probably 7000 visitors, outsmen and relatives, are here.

Most of the Oregon delegates will attend the stockman's ball tomorrow night, but some will go to a banquet at St. Joseph. The minstrel show at the Convention Hall Friday night will probably be attended by 20,000 people.

WORK OF CONVENTION.

President Springer Attacks So-Called Beef Trust—Memorial to Congress.

KANSAS CITY, Jan. 12.—President John W. Springer's attack upon the so-called beef trust, and the passage of memorials to Congress urging that laws for the betterment of livestock conditions be enacted, were the features of the program of the sixth annual convention of the National Livestock Association.

President Springer, after declaring that the "American stockman proposed to take care of his own interests, and that those interests must be protected by laws of the Congress of the United States just as long as the finished products made from our raw materials are heavily protected."

Another memorial was presented to Chairman Payne, of the ways and means committee of the House, and urged that the Grosvener anti-shoddy bill, now being held up in committee, be reported at once.

Several resolutions of importance were passed. One of them had reference to the lack of proper inspection of swine exhibited at county, state and National fairs, and the frequent exposure of healthy show stock to disease as a result.

The National Livestock Association began its fourth annual session at the Century Theater here today, evening in the grand auditorium was filled and many stood about the walls.

Governor A. W. Dockery was to have extended the city light save. The response on behalf of the association was made by Peter Jansen, of Nebraska, who spoke in glowing terms of the work before the convention and the future importance of the National Livestock Association.

Then John W. Springer, of Denver, president of the association, delivered his annual address. It was a forceful and original deal with directness upon the legislation, pending and future, necessary for the protection of the livestock industry.

President Springer said: "We have to pay a dear cost that, while we may differ on politics and religion we must stand together in a National organization if we would hold our own in the world."

Let it be understood here and now that the American stockman proposes to take care of himself, and that he is not a supplicant at the doors of the Federal Congress for any subsidy for any branch of his industry.

Our interests are fully and fully believe in a reciprocity with the world. We are not a five-and-dime policy such as the great McKinley outlined. Not only this, but we advocate that the Congress of the United States should be made to protect the American goods of products when the same is wholly unjustifiable as the proposed German tariff bill now under consideration.

We believe the world is continually progressing and we should not be content with a high-priced list of live interstate commerce. We are now urging upon Congress that a census of all livestock animals on ranch and farm be taken every five years and promptly published.

It was the unanimous opinion of the convention that the Denver convention should be reassembled and its resolutions still further urged on Congress and the Attorney-General's office as the most effective and only solution of the present problem.

WILL ACCEPT THE SWORD

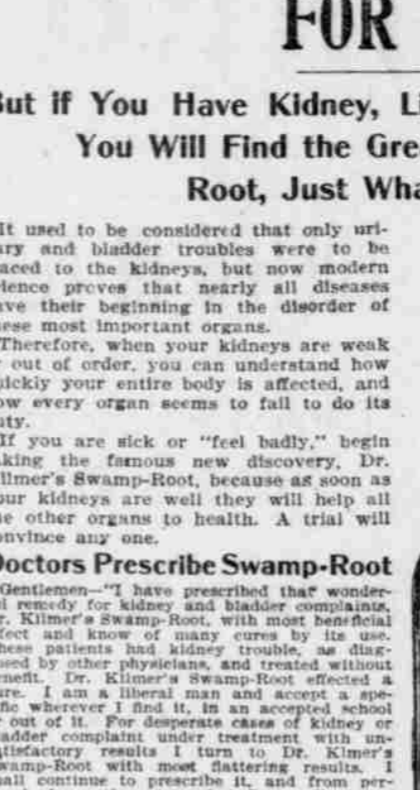
