

IT TAKES TEN MEN

Browns Unable to Overcome
Umpire McDonald.

HIS DECISIONS VERY YELLOW

Even Los Angeles Rooters Hiss Him—
Andrews Makes a Darling
Steal, and Ties the Score
in the Eighth.

LOS ANGELES, Cal., April 5.—(Staff correspondence.)—It took Umpire McDonald to defeat the Browns at Chutes Park this afternoon by the score of 2 to 1. The ex-pitcher, whose judgment of balls and strikes has been decidedly yellow during the series, made it his business to see that Portland did not win today's game. In the first inning he was within striking distance when Dummy Hoy ran fully six feet out of the base line making the journey between first and second. The decision was so far from correct that even the 300 people who will stand for almost any decision so long as it is not against the home team, suddenly became a hissing bedlam. Even the Browns, who were the game for Captain Dillon's crew, so the umpire with the deliberate intent called Cravath safe at first when he was fairly and squarely out. He called the Los Angeles right fielder safe just because the Browns had not only tied the score in their half of the eighth inning, but because Jay Andrews had made Joe Corbett hit like a sailing platter hit to a p.

Andrews' Darling Steal.
It was Andy Anderson's two-bagger that gave the Browns their third baseman the chance to pull off a trick that he as old as the game. Smith and Andrews both went out on short in field hits. Anderson, whose goodness had captured the fans, was a patient waiter. Joe Corbett, whose salary equals that of a bank cashier, after putting the two strikes on him thought he had the sick man as good as on the bench. The brother of the actor-pugilist lobbed over the plate, and Andy caught it at the seam. If he had not been injured the hit would have been good for three runs, but the best he could do was to take up his residence at second. He was to have to continue the journey, so Andrews took his home run. Just because Corbett of curves was afraid of Zinsner, who had connected with two of his in-shots, so he presented him with a free pass to first. Captain Vigneux, who was also presented with the same sort of transportation. Jay Andrews in the meantime stole third. The plifing habit was still with him strong and after Shields had twice fanned the atmosphere he made a dash for the rubber. Corbett had just started to wind himself for the delivery when Andrews came tearing towards the goal. The glaring fact was so surprising that the Los Angeles twirler lost his head and sent the sphere toward Spies with the speed of a cannon ball. Shields saw what was up and took a wide swipe at the ball. Spies in getting out of the way of Shields' swing dropped the ball and Andrews scored. The daring play brought the crowd to its feet and they almost howled themselves hoarse. Van Buren, whose batting eyes have been to the bad for several days, was given the fourth chance during the game to bring in a run. He failed, however, and flew out to law as he had done twice previously.

The game from start to finish was a splendid pitcher's battle, with a shade of the best of it in Shields' favor. The clever Brown southpaw struck out four of the crack Los Angeles ax-wielders and gave only two men bases on balls. He kept his hits well scattered, and he fielded his position in fine style. Out of the five hits made off his delivery only two were merited, while the Browns found Corbett for two doubleackers and seven singles, only one of which was of the scratch order. At that Corbett pitched a splendid game. All through the journey his curves were problems too difficult to solve by the head-stomach method of the Portland uniform. Van Buren and Shaffer, who head the batters' list, hit him, but Nadeau and Andrews were easy for the 1930 pitcher. To Anderson, Zinsner, and Shields he was not so puzzling. Their hitting, especially the two first mentioned, was well timed and well placed.

Trying to Shake the Hoodoo.
The Browns are trying all sorts of schemes to shake the hoodoo that has followed them since leaving San Jose. In an effort to change the bad luck into good Captain Vigneux today picked up a couple of colored boys and made them bat. Corbett, but even this charm could not overcome the handicap that Umpire McDonald handed out. Schmeery who has been out of the game for two days, hopes to be able to take part in the opening game at Sacramento Tuesday. Captain Vigneux also hopes by this time that Smith's case of "Charley horse" will have disappeared. The team left tonight for San Francisco. They will spend the day at the Bay City and go to Sacramento Tuesday morning.

MANY PRIZES FOR DOGS

FOURTH ANNUAL BENCH SHOW OF PORTLAND KENNEL CLUB.

Casinos of Aristocratic Pedigree Are Registered for Exhibition in Greater Numbers Than Ever.

The Fourth annual bench show of the Portland Kennel Club, to be held in the Exposition building April 15 to 18, promises to be the banner exhibition since the club's first attempt in 1929. All of the bench shows have been a success, but this year all the old prize winners will be back as well as many new dogs who have records to make. Secretary W. W. Pease has already registered a greater number of dogs than ever before, and a great number of entries will be received during the last few days prior to April 8, when the entries close, thus giving the show the greatest registration in the history of the club.

Among dogs that will be on exhibition will be Dr. D. Gareschi's Irish setter, Dachsund. A steel engraving will be given for the best great Dane, and a terra cotta figure for the best St. Bernard.

The Portland Cocker kennels have donated two solid silver cups to be awarded the best cocker dog and bitch sired by any of their stud dogs; donor not to compete. C. D. Nadin, of Ballston, Or., has offered silver medals for the following classes, purchased from his kennel: Best puppy dog under 12 months, best puppy bitch under 12 months, best dog over 12 months and best bitch over 12 months.

A silver medal has been donated by T. J. A. Tideman, of San Francisco, to be awarded the best Irish setter puppy. The California Cocker Club has given a silver medal to be awarded the best cocker, belonging to the cocker club, in the show.

E. C. Plume, of San Francisco, will give a silver medal for the best cocker spaniel puppy owned in Oregon. The California Collie Club has donated medals for which only the California club dogs may compete. The medals are as follows: Silver medal for the best collie bitch, bronze medal for the best collie puppy dog, best collie puppy bitch, best California bred collie bitch and best California bred collie dog.

These special prizes have all been donated by different friends of the local club.

The Seattle pennant aspirants took a fall out of Oakland in their opening game at San Francisco. Pitcher Herr, who is about as big as Jim Jeffries, left his curves at home in the second chapter. Sixteen men faced him and he let out 11 hits, which resulted in ten runs. Had not Moskman relieved him there would have been no telling how far Seattle would have gone. Both Oakland and Seattle will have to move faster and play better than they have during their San Francisco engagement, if they hope to do more than break even in the season.

The big pitcher's game, Charley Reilly, in no way kept the Browns in fact, his departure is more welcomed than he seemed. He was the one man on the team that President Marshall and Captain Vigneux expected to dispense with. When he joined Reilly on his journey to Riverside, it was with the approval of the Portland management. Unless he shows up better later in the season, he did during practice, the club is not a lower by his going.

It took Sacramento to put the first cramps in Hank Harris' stars. Terry McGovern and Charley Reilly, who pitched and lost, he would have given them a chance to break the hard-luck streak under which they have been laboring.

The opening game brought out the largest week-day crowd that ever graced a San Francisco grandstand. Exclusive of the ladies and the free list, there were paid admissions on Thursday afternoon. The war talk of course helped to swell the attendance. There will be some curiosity to see McCloskey's aggregation, the regulars are not over-excited or lying awake nights awaiting their coming. So far the players that McCloskey has signed are not in the same class as those on the Pacific Coast League. Fred Ely is the best on the list so far.

PACIFIC NATIONAL LEAGUE READY.

Will Play Opening Game of Schedule in Portland, April 14.
The members of Jack Grim's Portland National baseball team are all in the city, and are waiting patiently for the opening game with Spokane on April 14. This game will be played in Portland at the National Park on the East Side, and at the same time Tacoma will open in Seattle. Butte in San Francisco and Helena in Los Angeles.

Grim's team will be composed of a number of star players, and if they do not land the Pacific Northwest League pennant for Portland, it will not be their fault. They have all played ball in fast company, and promise to give Portland all she wants of the first-class article.

The grounds on the East Side have been held back from completion a few days by the recent inclement weather, but Grim promises to open on time. The grandstand and the fence are practically built, and the principal work remaining is the erection of the bleachers, and the finishing of the diamond. Ballast brought from England is being hauled out to the park by the wagon load, and this, mixed with the clay soil, promises to give the players a firm, fast track.

At the last meeting of the Council, the Oregon Water Power & Railway Company was granted permission to extend a spur north from Hawthorne avenue on East Eighth street, right to the entrance of the grounds. This spur will be built along the curb, and will be a great convenience to the fans, as they will not be obliged to walk any distance for cars.

At the top of the stand is a little cupola, high above the crowd, built especially for the scorers and the press representatives. The stand is also built back to the sun, and Old Sol will be unable to trouble the fans on the hot days.

The catching work of the Waboot will consist of Arthur Anderson, of the Los Angeles team, and Danny Shay, who did the backstop work for the 1927 Portland team. The three pitchers already signed are Quick, who played with Spokane last year; Wallace, from the Cleveland club; and Lundholm, from the same team. Grim also has several other men in mind, and will call them on. Grimdon will be traded to San Francisco for a good man, and with this prospective force, Portland will be hard to beat in the matter of curves.

"Glad" Davis will hold down the initial sofa. He played in Denver last season, and is credited with being the best first baseman in the Western League. Zeigler, who was signed for second, has jumped to the Seattle outlaw team, and a new man will have to be secured in his place. Grim will not say whom he will land yet.

Harry Deister, brother of the famous Jake, who played for Portland last year, will play third. He has been with New Orleans. Donohue, of Spokane, will play short, and the field will be composed of three of the following men: Hanley, of Illinois, N. Y.; Dairymple, of Seattle; Wilson, who batted .25 in the Western two years ago; and Tom Parrott. Warner, of the New York State League, will act as utility man.

Grim also has his eye on A. J. McCarthy, of the 1926 Detroit team. He has signed with both Portland and Concord, N. H., and Jack Deitrick will be awarded to the Waboots.

The first game the team will play will be with the Multnomah Club, on the Multnomah field, on Saturday. This will show the fans what sort of a nine they will have to back, and what sort of playing will have to be put up in order to win the 1933 Pacific Northwest League pennant.

Grim himself has just returned from the league meeting at Tacoma, which he states was the most harmonious baseball meeting ever attended. At the meeting a committee was appointed composed of John R. Coleman, D. E. Dugdale and W. E. Farrell, to arrange the schedule for 1933. This committee is at work now, and, according to Grim, it makes no sense to Portland what the final outcome is.

All I want is that the season shall open in this city," he declared last night, after his return from Tacoma. "I want to open my season before the opposition team returns from the South. I believe I am going to give Portland a good team, and an excellent quality of baseball, and I want to show this fact early. That the season will open here is sure for Spokane is to come to Portland. I do not care where we close, though, of course, I would prefer to end the season at home."

The demand of the California teams that they be allowed more games at home resulted in the appointment of a special committee to draft the playing schedule, and the appointment of a California member of the committee. There were two schedules presented at the Tacoma meeting, but neither of these gave the California teams the advantage they wanted. There were too many games shown on the eastern end of the circuit, and the schedule extended during a season when there was a great deal of danger of unfavorable weather.

The league magnates agreed with the California representatives that the California cities should be given all the baseball possible, and for the purpose of according to this request that the special committee was designated to take the matter out of President Lucas' hands.

The first games are scheduled for April 14, and there will be no change in the arrangement which sends Butte to San Francisco, Helena to Los Angeles, Tacoma to Seattle and Spokane to Portland.

An interesting legal fight has been precipitated by the serving of an injunction on the Seattle Electric Company to prevent it from interfering with D. E. Dugdale in his preparations for the coming baseball season. The company has apparently decided that it will not permit the rotund manager of the Seattle baseball team to use the old park, and in consequence of this determination commenced filing up logs at the entrance of the park in such a way that Dugdale could not pass through without bodily discomfort. After several days of sore throats, the pioneer baseball manager came to the conclusion that it was about as hard work as running bases, so he determined to have his rights determined by the court.

"All there is to it," said Dugdale, as he wiped the perspiration from his brow and puffed slightly, "is the question of being held in the ninth annual Sp. It was understood in the beginning that I was to play ball on the Y. M. C. A. or Athletic Park for three years. I intended that I am entitled to the grounds this year, and as long as the company has taken steps to interfere with me I am compelled to take steps to protect my rights."

DATES OF PACIFIC LEAGUE.
Arranged at Meeting of Magnates at Tacoma.
TACOMA, April 5.—The Pacific National League magnates met again this evening at the Hotel Tacoma, received the report of their schedule committee, and after the transaction of some minor business, formally adjourned. They will leave for home in the morning.

The schedule as adopted will be made public next Sunday. It provides for a playing season of 150 games, 15 games per week, each club playing 136 games. The holiday dates are very evenly distributed, and, in personal interviews, each club manager expressed complete satisfaction with the schedule. The season opens April 14 and closes on October 25. There will be 114 games in San Francisco, 98 in Los Angeles, 76 in Seattle, 76 in Portland, 50 in Tacoma, 78 in Spokane, 57 in Butte and 57 in Helena.

In an exhibition game this afternoon the Tigers defeated the Centrals team of the Southwest Washington League 4 to 1, nothing, in a fast game, the feature of which was Byers' stick work, three singles and a pair of two-baggers. Centrals was reinforced by Joe McCarthy and Pitcher Law of the Tacoma team.
