BOODLER TELLS ALL

Mental Strain Too Great for
Missouri Man.

WEEPS WHILE RELATING STORY

Attorney Folk Secures the Names of
More Principals in Legislative
Scandal, but Law of Limita-
tions Protects Them.

ST. LOUIS, May 15.—Unable to bear the strain of mental torture which he says he has suffered since the grand jury investigation into legislative boodling was instituted, ex-Senate Senator Fred L. Busche went before Circuit Attorney Folk this afternoon and made a complete and far-reaching confession of his connection with corrupt deals extending over a period of eight years. Busche's declarations involve several men of prominence and he named those who have been conspicuous at the State Capital as distributors of boodle.

Later Busche was taken before the grand jury where he remained an hour. When he emerged from the jury-room tears were rolling down his cheeks. With his face buried in his handkerchief he hurried down the steps to the Eleventh-street exit of the building.

"I will give you until Monday to tell all you know about boodling," was the ultimatum which Circuit Attorney Folk served on the ex-Senator the other day.

"All right, Mr. Folk," replied Busche. "I will think it all over. It has worried me a good deal."

"I am willing to tell everything," said ex-Senator Busche to Circuit Attorney Folk. "I have booded practically from the first week of the 1895 session. In 1897 I received money for voting for the text-book bill. In 1898 Schweichardt paid me \$250 for refusing to call up a resolution demanding that certain bills be released. I got \$500 for my vote on the St. Louis transit bill. I received a salary from the lobby to take care of a railroad bill and other legislation, usually amounting to about \$700 for the session. As near as I can figure, I made about \$15,000 out of my legislative experience. No one knows how much I suffered during the past few weeks. I am sincerely sorry."

This, in substance, is a part of Busche's written statement made to Circuit Attorney Folk. He has corroborated most of the confession by ex-Senator Schweichardt. Busche's confession exceeds that of Schweichardt in the extent to which he goes into revealing the workings of the corruptionists who have figured in legislation during the past five years. Busche was first elected to the State Senate in 1888 from the Thirty-third District of St. Louis, and served three terms.

Ex-Senator Charles Schweichardt was before the grand jury again today. Before entering the jury-room he told Circuit Attorney Folk of other corruption with which he was familiar during his term as Senator, which he had not previously mentioned.

from legislation at the 1899 session and included one or two who are members of the present assembly. He broke down twice while conferring with Mr. Folk and, weeping bitterly, said:

"I am telling these things only to ease my mind."

Going back to the 35th Assembly, when the bill to create a School Book Commission was one of the principal issues before the Legislature, Busche said that the School Book Trust put up a big fund.

"I got \$1000," he said, "and others got just as much, and some may have got more."

"On one occasion," he said, "there was a resolution presented to have all bills held in committee. I got \$250 for holding up that resolution."

"Killing bills by smothering them in committee was very common," he said.

Because of the statute of limitations, which prevents prosecution three years after the crime is committed, none of the men named, whom Busche has testified can be indicted.

Among the other witnesses examined today by the grand jury in connection with the investigation into boodling in the State Legislature, was Joseph Shannon, of Kansas City, who was a conspicuous figure at Jefferson City during the sessions of the 35th General Assembly. It is supposed that Mr. Shannon has some knowledge of school-book legislation. Joseph Tall, private secretary to United States Senator Stone, was another witness before the inquisitorial body.

CLOSING IN ON DYNAMITER.

Police Have Found a Brakeman Who

Identifies Rousseau's Picture.

NEW YORK, May 15.—R. B. Skinner, head brakeman on the West Shore train, which arrived from Buffalo at Weehawken at 8:45 on the night of April 25, has positively identified a picture of G. Rousseau, the dynamiter, as that of one of the passengers on his train. Rousseau, with a companion who looked very much like him, boarded the train at Buffalo, having been transferred from the Wabash road.

"I remember the two men distinctly," said Brakeman Skinner. "Rousseau asked me how long his trunk would be kept at the West Shore without storage charges. I told him the rules of the road in that matter. He explained that he and his companion were to sail on the French line the following Wednesday. He spoke excellent English, although impressing me as either an Italian or a Frenchman. I remember that they had considerable hand baggage, and that when the Westcott Express Messenger went through the train at Cornwall they decided to keep their baggage instead of having it checked."

"The men did not mingle with other passengers. They went out and took lunch at the railroad station in Syracuse, but made no display of money. They asked me for the nearest hotel to the ferry in New York City, and I gave them the address of one."

Only One Man in the Plot.

NEW YORK, May 15.—Police Inspector McCusker returned today from Chicago, where he had been investigating the mystery of the infernal machine left on the Cunard pier. He said his trip had established the fact that only one man was concerned in the whole affair, and that he was not, in the inspectors' opinion, the member of any secret society or band. He had not expected to find Rousseau, the suspect, in Chicago.

Clews are leading to other Western cities. A good description of the man wanted has been telegraphed to every town and city in the United States and Canada, he said. The inspector said that he is a long way from solving the mystery, but hoped that something tangible would soon be discovered.

The dynamite, the inspector asserted, was procured in this city—where, he declined to say. The inspector is also satisfied that there was no motive of revenge and that Rousseau was never connected in any way with the Cunard Line. He denied

The inspector replied, in response to questions, that there was no possibility of the matter turning out to be a joke. He asserted that there was a serious scheme behind it. As to the nature of this he was silent. McCusker would not say in what directions the search for Rousseau was being made.

PRISONER CHEATS GALLIOWS.

Wife Murderer Swallows Poison

Just Before Time for Execution.

LEXINGTON, Ky., May 15.—William McCarthy, wife-murderer, who was to be hanged at 8 o'clock this morning, took morphine some time during the night and died from its effects at 8:15. The death watch, Alexander McKeever, sat within three feet of McCarthy all night, but says he is absolutely at a loss to know how or when he took the drug.

After the body of the suicide had been taken to the cemetery County Judge Bullock ordered it brought back to the city and an autopsy performed on it. The court is desirous to ascertain absolutely the nature and ingredients of the poison used.

ARRESTED FOR SENDING POISON.
Woman Charged With Murder of

Two Men.

MEMPHIS, Tenn., May 15.—Detective J. A. Sweeney, of Cincinnati, arrived here today with a warrant charging Mrs. Lizzie McCormick with the murder of the express company employee, who died from the effects of drinking whiskey from a package addressed to Mrs. Kate Noble, of that city.

The detective had scarcely made his appearance in the office of Chief of Police Mason before Mrs. McCormick's attorneys arrived, and announced that Mrs. McCormick would not return to Cincinnati without requisition papers. The attorneys also announced that they had instituted habeas corpus proceedings. The police are making every effort to trace the fatal package.

Tonight the widow of John B. Flicker, who died from the effects of the poison,

swore out a warrant charging Mrs. McCormick with the murder.

MAN SLAYS WOMAN.

He Then Closes a Scandal by Ending His Own Life.

EL PASO, May 15.—George Peterson and Mrs. T. M. Fairchild were shot and killed this morning in the Ramona House here. The hotel-keeper, awakened by rapping on his door, found Peterson in the hall, who said that he had been shot by Mrs. Fairchild and that she had also shot herself. The proprietor went to call assistance and while he was gone three more shots were fired. When he came back both of the victims were dead. The woman lay on a bed in a pool of blood.

Mrs. Fairchild's husband, a traveling salesman, left recently for San Bernardino, Cal. Peterson came here a short time after. The cause of the shooting is unknown. The evidence indicates that Peterson did the shooting. His father is a wealthy commission merchant at Amherst, Wis. Mrs. Fairchild was registered from Denver, Colo.

Peterson a Railroad Man.

MILWAUKEE, May 15.—A Journal special from Amherst, says:

George M. Peterson, who figured in the El Paso tragedy today, was a single man 22 years of age. He left here about three years ago, going to Milwaukee, where he was employed in the freight department of the Wisconsin Central Railway. Peterson left Milwaukee last fall for Denver, from which place he left for Texas. Nothing is known here of Mrs. Fairchild.
