WILL COLLECT FOR PARK CONCERT FUND.—The City Park Board has raised nearly all of the \$500 in subscriptions necessary to insure the series of 30 Summer concerts to be given in the city parks beginning about the middle of this month, and today the work of collection will begin. Charles L. Brown has been authorized by the board to make the collection and asks that, in order to facilitate his work, subscribers will have their checks ready beforehand and kindly leave them with their clerks, so that he may get them on calling. Checks should be made payable to J. E. Weir, the City Treasurer. The amount subscribed is still a little short of the necessary total, and as there are doubtless many persons whom the solicitors have not been able to see who are interested in the project, they are requested to telephone their subscriptions to J. D. Meyer, of the Park Board, at 44 Third street. A complete list of the subscribers will be published in the daily papers at the end of the week. The series will consist of 30 concerts to be given by a band of 35 men on Wednesday afternoons in City Park, and on Wednesday and Friday evenings at the following points: The Park block, near Jefferson street; the North Park block, near the Federal building; Holladay Park, on the East Side, and the Plaza block in front of the Courthouse.

NO HOLIDAY DECLARED.—Chief of Police Hunt was at the Auditor's office yesterday morning to ascertain whether a special election day was a general holiday or not, and whether saloons would be closed during the day or not. He was informed by Auditor Devlin that there was no holiday on days of special elections, unless ordered by the Mayor, but that on all days when an election was being held saloons must be closed from 1 to 7 P. M. The Chief said the saloonmen would probably know this and act accordingly, but he had no policemen to notify them, as all his men would be needed at the polls. A little later the force came marching up to the City Hall to escort the ballot boxes to the polling places. A stranger who arrived in the city yesterday was astonished to see a tent pitched on the pavement on Fourth street, fastened to spikes driven in the ground blocks. When he had ascertained that it was a polling place for a city election, he said it appeared evident that vacant buildings were scarce in the city.

PEPPERS AT A HIGH PRICE.—A woman who had purchased enough "soup vegetables" at a market yesterday for 5 cents to make soup for a dozen Welshmen, said as she paid her nickel, "I will take one of those peppers for my bird." "That ten-pound box of peppers cost \$1.50," said the clerk, "and they sell at 5 cents each." "Who buys half-grown, half-ripened peppers at such a price?" asked a bystander. "Oh, the hotels and restaurants," was the reply. "These are the first of the season, and there is a great demand for them. After a while a whole box like that can be bought for 15 cents." Naturally, anything that is out of season is high-priced, but it is difficult to imagine that many people are hankering for such peppers at 45 cents per pound, which are only good to burn their mouths. The birds and many people will wait till peppers are cheaper.

DEATH OF A PROMINENT YOUNG ATTORNEY.



GEORGE C. STOUT.

George C. Stout, a prominent young attorney, died yesterday morning at 11:15 at St. Vincent's Hospital. Since December he had been suffering from cirrhosis of the liver, and a few weeks ago he underwent an operation, which afforded only temporary relief. Mr. Stout was born in Portland, December 24, 1893. His father was Lansing Stout, who was elected County Judge at the first election held in Oregon under the state constitution, and who was also the first Representative in Congress after the admission of Oregon into the Union. He fathered died when George Stout was but an infant. The boy was educated in Portland, and after completing the common school course, commenced the study of law in the office of St. Waldo, Smith, Stout & Bole, the senior member of which, the late Judge Raleigh Stout, was George Stout's stepfather. After taking the regular law course in the University of Oregon Law School, the young man was admitted to the bar in May, 1892. Since that time he was engaged in active practice, part of the time as a member of the firm of St. Bole & Stout. Since the death of his stepfather, a year ago, he had not been a member of a law firm, but was called in to serve in important cases. Before his death he had just recently returned from a case in the United States Supreme Court, winning for his clients and acquitting himself with great credit. He was a Democrat in politics, and although he took a great interest in public affairs never held a public office. He was a member of the Multnomah Amateur Athletic Club and a charter member of the local branch of the Knights of Columbus. In his profession and with everyone with whom he came in contact he was popular and respected, and a host of friends will mourn the loss of his genial presence. He is survived by his mother, Mrs. Raleigh Stout, his brothers, Lansing Stout and Plowden Stout, and his sisters, Mrs. James Laidlaw, Mrs. Charles Cheney and Miss Susan Stout. The funeral will take place tomorrow from the Cathedral and interment will be at Riverview cemetery.

HORSES IN A RUNAWAY.—A runaway accident came near depriving some of the readers of The Sunday Oregonian of their papers Sunday morning. He placed his bicycle on top of the load of papers and drove back to the office and turned the team over to the driver and his assistant, who fortunately had not been much injured. Then they saved the horses a chance to see how fast they could travel to the South End. The carriers received their papers and completed their routes on time, and none of the subscribers knew that anything had gone wrong.
