FIRES REACHING OUT

New England Forests Are a Great Mass of Flames.

SITUATION IS BECOMING GRAVE

New York and Baltimore Suffer From Smoke From Middle Atlantic Blazes—Thousands of Men Act as Fire-Fighters.

NEW YORK, June 5.—The forest fires in the Adirondacks and New England are spreading at an alarming rate and are destroying millions in timber and hundreds of thousands of dollars worth of summer cottages and camping resorts.

Fires are reported in Vermont, New Hampshire, Massachusetts, Connecticut and Maine. Long Island, to the east of here, has been swept for miles. Over this city and all the region around the smoke from the forest fires is so dense that the sun is obscured. The big ocean-going vessels felt their way in and out of the harbor or else remained at anchor to avoid collisions.

The situation is grave. In spite of the efforts of the hundreds of men the fires are spreading. The most serious are now in the vicinity of Long Lake, east towards Newcomb Lake and Mount Marcy. Further south fires are raging along the Cedar River and at Indian Lake.

Heat Drives Fire-Fighters Out. SARATOGA, N. Y., June 5.—The sun today is still obscured by dense smoke and ashes from Adirondack forest fires. Reports which reached here today from the Catskill Lake region are that the fire covered a territory 15 miles in width and 30 miles in length and are still spreading despite the efforts of hundreds of fire-fighters. The heat is so intense and the smoke so dense that the fire-fighters cannot approach within two miles of the fire.

Navigation on the Adirondack lakes is practically suspended. A steamer with a gang of fire-fighters has been missing on Long Lake for three days. The fires in the Cold River region cover 20 miles square.

Baltimore Enveloped in Smoke. BALTIMORE, June 5.—A smoky pall so thick that it obscured the sun and rendered navigation on the bay and river difficult, and so strong in odor as to be easily detected, hung over Baltimore today. Forest fires in New England and New York caused this heavy volume of smoke.

Fire-Fighters Are Burned. SAVYLLER, L. I., June 5.—The section of Long Island that has suffered most severely from the forest fires is that in the vicinity of Medford and Farmingville, and the individual losses will reach into the thousands. Many fire fighters have been injured or burned.

Flames Are Being Held Back. GLENS FALLS, N. Y., June 5.—Reports today from North Creek region state that the fire fighters are holding the flames back. Nearly 2000 men are at work fighting the fire in the Hudson River watershed.

Fire Destroys Half of Town. SALT LAKE, June 5.—A dispatch to the

Tribune says that fire tonight destroyed half the houses in the town of Terrace, Utah. Details are not given.

(Terrace is located on the Southern Pacific Railroad near the Utah-Nevada line.)

SOCIETY IN STRIERS' PLACE

Richly-Dressed Women Act as Dishwashers in Chicago Hotel.

CHICAGO, June 5.—A trace was declared between the hotel proprietors and their employes tonight. No active steps will be taken by either side for two days, while committees of the hotelmen and labor leaders will endeavor to arrange an amicable settlement of the difficulty.

A meeting between the officers of the employes' union with the restaurant proprietors has been called for tomorrow, with a similar agreement, it is expected, will be reached.

The strike has spread to the Chicago Beach and the Grand Pacific Hotels. At the Chicago Beach every man and woman employed in the hotel was ordered out, and every one, from chambermaid to bell-boy, obeyed the summons instantly.

Great indignation followed among the guests, who include many prominent and wealthy Chicagoans. They voted to stand by the hotel management, and richly dressed women, changing their dresses for more common ones, cleared tables and washed dishes. The strike at the Grand Pacific Hotel was not so general. The waiters, cooks, bartenders and porters only were ordered out, but it is expected that the rest of the employes will follow them today.

With two hotels and 12 restaurants and lunch-rooms already tied up as a result of labor troubles, cooks and waiters endeavored to spread the strike today by calling on the help in three leading hostilities of the city. Union delegates visited the Auditorium Hotel, the Auditorium Annex and the Palmer House restaurants, but walkouts at these places were temporarily averted at least by an agreement for a conference to talk over the situation.

Japanese Diet Closes. TOKIO, June 5.—The session of the Diet closes today. The House of Representatives passed all the financial measures as amended by the Lower House and the bill extending the Formosa camphor monopoly system to the whole of the Empire. The Peers, moreover, adopted a resolution condemning the policy of having recourse to loans for public work except in unavoidable cases.

SALISBURY IS ILL. Ex-Premier of England Has a Chill Which Occasions Alarm.

LONDON, June 5.—It was reported today that the Marquis of Salisbury was seriously ill at Hatfield House, his Hertfordshire home, but inquiry showed the report was exaggerated. According to Salisbury's private secretary, Lord Salisbury had a chill during the night, which occasioned some alarm, but he was better this morning.

His boldness yesterday held a conference with the cardinals regarding Manila, for which post there are three candidates—F. C. Rooker, formerly secretary of the delegation at Washington; J. J. Hayes, of St. Louis; and Rev. Thomas A. Hendrick, of Rochester. The last named was proposed by Cardinal Gibbons.

COAL BARONS YIELD POINT

DANGER OF STRIKE IN PENNSYLVANIA IS PASSING.

Conciliation Board Middle Is Practically Settled Before Convention Called to Consider It.

WILKESBARRE, Pa., June 5.—The danger of a strike seems to be already passing away, even before the decision of the convention of miners, which is to meet in Pottsville within ten days. This is due to the statements of coal companies' officials and superintendents that if the miners, at their convention, should reject the three district presidents as their representatives on the conciliation board by a majority vote, there would be no further objection to their eligibility to serve on the board. This action will probably be taken at the coming convention, as the leaders of the miners are not desirous of forcing the issue to a suspension of work, unless they can find no other alternative.

MINERS' SIDE OF THE CASE. Nichols Holds Recognition of Miners' Union Does Not Enter In.

SCRANTON, Pa., June 5.—The following statement concerning the conciliation board middle was given out today by T. D. Nichols, district president of the United Mineworkers: "The operators say it is a question of recognition of the United Mineworkers of America, but as the arbitration commission decided against this, I think it is out of the question altogether. I hold it is not a matter of recognition of the United Mineworkers, but simply a plan formed by the commission by which the differences between the miners and operators could be adjusted without direct contact of the miners' officers with the operators or superintendents."

"What I would call recognition is the existence of a contract with the United Mineworkers of America covering the conditions of employment, and by which the officers of the union would be fully authorized to take up the grievances presented by their members and discuss the same with the superintendents of the companies involved."

"At present we are not allowed the privilege of representing the men in this manner, although the men themselves authorize us and require us to act as their representatives."

The question of referring the trouble to Judge Gray, chairman of the strike commission, for adjudication, it is alleged by Mr. Nichols, first came from the miners' side, but was rejected by the operators.

Mitchell to Hold a Conference. INDIANAPOLIS, June 5.—John Mitchell, president of the United Mineworkers, started for Chicago this morning to confer with Herman Just, who represents mine operators of Illinois, and J. F. Reynolds, who represents the miners of the Illinois district, on local wage scales.

In regard to the statement of Pennsylvania coal operators that the three district presidents would be recognized on the board of conciliation if they were rejected at the convention of miners to be held at Pottsville, Secretary Wilson said today that such an arrangement would not be satisfactory to the miners if it would establish a precedent, as the convention would cost the miners \$15,000.

PEACE BY ARBITRATION. New York Building Trades Submit a General-Strike Plan to Labor.

NEW YORK, June 5.—The Building Trades Employers' Association has a scheme of arbitration for securing in-

dustrial peace. The plan has been sent out to all employers and to all unions of laborers in the building trades.

Briefly, the plan provides that when employers have a trade agreement with some other employer, they shall be organized a trade arbitration board, where all difficulties in trade can be discussed and adjusted. In addition, a labor court or general board for the settlement of all disputes. The former board is to consist of two arbitrators chosen by each association represented in the Building Trades Employers' Association, and two from each union whose employers are represented in the Employers' Association. From this body of general arbitrators, not less than four shall be chosen by the Building Trades Employers' Association, and two from each union whose employers are represented in the Employers' Association. Strikes and lockouts are prohibited before the matter in dispute has been submitted to the general arbitration board for settlement.

BOARD WILL HANDLE STRIKES. Federation of Miners Takes Labor Troubles Out of Unions' Hands.

DENVER, June 5.—Hereafter the executive board of the Western Federation of Miners will have full power to direct the movements of local unions in case of difficulty. An amendment to the constitution was adopted by the convention today empowering the convention to use its judgment, and binding local unions to abide by its decisions.

A resolution was adopted, at the request of the United Brotherhood of Railway Employees, declaring the Canadian Pacific Railway Company unfair.

The American Labor Union convention interpreted its constitution so that affiliated members are eligible to office. Hereafter the only ones eligible were direct members of the organization. Both conventions will probably extend into next week.

The new constitution will absorb the American Labor Union and amendments to the constitution will occupy the time of the miners for several days.

The miners will re-elect the present officers, with the exception of one member of the executive board, who will be re-elected on account of private business.

The miners this afternoon adopted a resolution for the consolidation of the Miners' Magazine, the official organ of the federation, and the American Labor Union Journal, the organ of the Labor Union. The consolidated paper will be sent to all members of both organizations.

Discusses Coal Situation With Baer. PHILADELPHIA, June 5.—R. C. Lather, general superintendent of the Reading Coal and Iron Company, today held a protracted conference with President Baer, of the Reading Company. Although neither Mr. Baer nor Mr. Lather would state the object of the conference, it is unofficially said that the situation on the lower coal field was discussed.

More Mills Give In to Strikers. PHILADELPHIA, June 5.—Eight textile mills in the Manayunk district refused operations today, the strikers getting their demands. Two mass meetings, attended by about 8000 strikers, were held today.

Laundry Strike Left to Arbitrators. CHICAGO, June 5.—The laundry strike, which was begun here May 1, was settled tonight, and the strikers will return to work Monday. All grievances are to be submitted to a board of arbitration.

Freighthandlers Get a Raise. CHICAGO, June 5.—Both the Illinois and Michigan Central railroads have granted their freighthandlers the same increase in wages as conceded by the Lake Shore and six other roads, recently.

Carpenters' Strike Compromised. PHILADELPHIA, June 5.—The strike of carpenters which has been in progress since May 1 has been settled by a compromise.

GOULD AIDS FLOOD FOLK

RAILROAD PRESIDENT SENDS \$5000 TO KANSAS CITY.

Other Liberal Contributions Are Being Made, and There Is Now a \$75,000 Fund for the Refugees.

KANSAS CITY, Mo., June 5.—George Gould today sent \$5000 to the Kansas City, Kan., relief committee, and President Burt, of the Union Pacific, sent \$500 to each Kansas City. There were other liberal contributions of money and supplies, and the total cash received in both cities is about \$75,000. Not all of the 30,000 people driven from their homes have received assistance from the public, but food and shelter and clothing were given to all who needed.

The military camp at Wyandotte opened with 1500 inhabitants, whites and negroes being separated. The military camp in this city opened with 500 inhabitants. The convention hall camp, which accommodates 3000 will be maintained. Sanitary conditions are excellent in all camps, and there is little sickness.

KANSAS CITY IS IN NEED OF AID. Missouri City of the Same Name Issues an Appeal in Its Behalf.

KANSAS CITY, Mo., June 5.—The Citizens' General Relief Association of Kansas City, Mo., have issued a statement to the public giving thanks for sympathy and kind offers of aid, and asking that assistance be sent to Kansas City, Kan. The statement follows: "As we decline at this time to accept assistance from without, it is because we believe it our duty to meet the situation which confronts us to the fullest extent of our ability. The calamity which has come to us is no doubt great, but it is not disaster."

"The bottom lands, known among us as West Kansas City, is the severest sufferer. The water has reached here a level of ten feet, and there is every reason to fear that there has been great injury to the property of the poor and to the goods and possibly buildings of wholesale merchants and manufacturers. But until these districts are accessible and they will not be until possibly next Monday, it is futile to estimate the damage and to make any intelligent statement of the relief necessary."

Whatever may be the loss of our merchants, they will bear it; we may find a greater destruction of the property of the working population than is now anticipated, and if so we will have to call for assistance from without, but until such a situation shall develop we see no cause for asking assistance.

"It is proper, however, to state that Kansas City, Kan., and the other neighboring towns in Kansas, have suffered severely, and while Kansas City, Mo., generously came to their assistance, we must not stand in the way of assistance to our neighbors from other sections of the country. To all those willing to assist these stricken towns we recommend that they address their offers to W. H. Craddock, Mayor of Kansas City, Kan."

MORE BODIES FOUND AT TOPEKA.

Generous Responses Are Being Made to the Appeal for Aid.

TOPEKA, Kan., June 5.—The dead in the Topeka flood now number 78. A hostman this afternoon reported that seven bodies had been found near the north end of Harrison street. The unfortunates were Mrs. Jessie Shaw and four children and

a man and woman named Shumweller. The body of a man named Edwards was picked up by a party near Soldier Creek. Other bodies found today were those of Mrs. Nellie Watson; Mrs. Minnie Prayers and George McDonald. They were caught in the wreckage.

The greater part of North Topeka is a waste of sand, burying the city from a mere coating to a depth of from two to four feet. The Union Pacific and Rock Island tracks are covered with sand in places to a depth of three feet. Generous responses are being made to the appeals for aid. From all over the country telegrams are being received authorizing the officers here to draw on organizations for funds.

Rations for Tornado Sufferers. WASHINGTON, June 5.—General Chaffee has sent to General Corbin a copy of the following dispatch from Lieutenant Kear, at Gainesville, Ga.: "Fifteen hundred people dependent upon charity, 200 seriously injured. Have requested 6000 rations and medical supplies from Fort McPherson. No further immediate relief necessary."
