Resents Boys' Jeers to Be Shot.

MOODY DENIES IT
Kaiser's Visit to Ship Not Criticized.

TAKEN AS HONOR INSTEAD
Inspection of Kearsarge No Breach of Etiquette.

AMERICANS WIN BOAT RACES
They Capture Two Firsts, One Second and a Third Against the Boats of the German Fleet in Unfamiliar Waters.

ENGLAND WILL PAY FLEET UNPRECEDENTED HONORS.
LONDON, June 29.—When the American squadron shall reach Portsmouth it will not be at Spithead, which is the usual place for foreign warships, but it will be brought into Portsmouth harbor itself. Never before has such an honor been paid to a squadron of a foreign power, for it will place the American warships actually within the gates of the empire's chief arsenal.

WASHINGTON, June 29.—Secretary Moody today received telegrams from newspaper editors and others inquiring as to published reports that Emperor William's inspection of the Kearsarge was sharply criticized in the Navy Department, and was considered a breach of naval etiquette. In reply, the Secretary sent the following telegram:

"No criticism of the Emperor's inspection of the Kearsarge has been uttered by any responsible person in this department, so far as I can ascertain. I am informed further by Rear-Admiral Taylor, Chief of the Bureau of Navigation, that the Emperor's inspection is in no way subject to criticism, and can be considered in no light other than courteous attention on the Emperor's part to us. It is a long established custom for foreign monarchs to inspect battleships of friendly nations, and is regarded as an honor. WILLIAM H. MOODY, Secretary of the Navy."

AMERICANS WIN BOAT RACES.

First in the Leading Events and That in Unfamiliar Waters.
KIEL, June 29.—The American men-of-war won two firsts, a second and a third in today's races against the boats of the German fleet. The Americans had five boats entered in four events, while the Germans had 37, and the American crews were not familiar with the course and not specially trained for the occasion. The cruiser Chicago's sailing cutter, entered by Midshipman Stephen C. Rowan, won Prince Henry's prize for warships' cutters in a competition with the cutters of the German ships Goeben, Hohenzollern, Frauenlob, Adriaens, Glitz and Haguen. The sailing launch of the United States cruiser San Francisco, entered by Ensign George W. Steele, Jr., won the prize in the race for launches. The launch of the German turret ship Kaiser Wilhelm der Grosse was second, and that of the flagship Kearsarge, entered by Lieutenant Henry C. Mustin, was third. More than 100 sailboats covered the lower bay this morning, for, besides the boats against which the American crews raced, 30 German boats took part in the regatta. The American boats, contest, and the one which attracted most attention from the Germans, was that between the large launches. Lieutenant Mustin led after the first quarter of a mile, but the German boat, which was a mile ahead of the San Francisco's launch.

Kearsarge Boat Is Fouled.
Then what was probably a civilian's yacht, which was running obliquely, fouled the Kearsarge's launch, and a few moments later the stranger's bowsprit ran through the sail of the Kearsarge's launch, tearing away part of it. Before the two boats could be disentangled, the San Francisco's launch passed and 100 yards behind her the launch of the Kaiser Wilhelm der Grosse.

Lieutenant Mustin and Ensign Steele both outlasted the German boats in turning the mark buoys, gaining several seconds on each turn. The German crews cheered the American winners heartily.

Kaiser Makes Gifts to Americans.
The Emperor presented the prizes to the winners at the yacht club tonight in the shape of personal gifts to the officers commanding the launches. Ensign Steele received a silver cup.

"I hope you will drink many a bumper out of it," said Emperor William, handing it to him. Lieutenant Mustin and Midshipman Rowan, who sailed the Chicago's small cutter, received silver cigarette boxes.

The protest entered yesterday by Herr Guillaume, owner of the Clara, against the race for her class, because she carried only one anchor, whereas under German rules two are necessary, has been overruled and the prize awarded to the Cicerly, which beat the Clara by three minutes. The British yachtsmen were angry over the protest, which they regarded as unsportsmanlike.

In bidding Emperor William farewell on board the Hohenzollern, Rear-Admiral Cotton, on behalf of the Captains and officers of his squadron, said the officers would carry away with them never-to-be-forgotten memories of the hospitality and courtesy that had been shown them during their stay here. The Emperor replied that the visit had been charming to him personally, and he hoped it would be enjoyed in its impression on the friendship between the two nations. Admiral Cotton and the Captains of the American warships attended a dinner tonight given by the yacht club in honor of the Emperor, and sat with His Majesty and United States Ambassador Tower in the garden for an hour witnessing a display of fireworks by the combined fleets and the playing of the vessel's searchlights.

The Emperor will leave on board the Meteor at 7 o'clock tomorrow morning for a long sail to Eckernforde. The Hohenzollern will sail at 8:30 in the morning, flying the Emperor's flag, which will be saluted as though the Emperor were aboard. The American squadron will leave at 7 o'clock tomorrow evening.

The jacks on the Kearsarge tonight gave a minstrel show and boxing exhibition. Twenty men and four officers from each of the German ships were present. It was the first time that many of the German sailors had seen boxing.

MORE NATIONS TO HONOR FLEET.

England and Portugal are making ready to receive the Squadron. WASHINGTON, June 29.—The State Department has been advised that the governments of England and Portugal are making ready to shower hospitality on the American fleet. King Edward has arranged to give a grand ball on July 5 in honor of President Loubet, and the American naval officers attached to the squadron will be invited to meet the President. On the following day the King will give the officers a banquet in Buckingham Palace. The naval end of the reception will make a magnificent marine spectacle. In reply, the Secretary sent the following telegram:

ROOSEVELT OUT IN RAIN
Storm Has No Terrors for President When He Wants to Go Riding.

OYSTER BAY, N. Y., June 29.—Undaunted by the drenching rain, President Roosevelt accompanied two of his sons and some members of the Westchester club today for a "long drive" on his estate. The President, who was soaked through and through, soaked his horses and his dogs, and soaked the country. Arrangements were completed by Secretary Loeb today for the President's trip to Huntington, L. I., on July 4. He will go to assist in the celebration of the 50th anniversary of the founding of the town. The trip will be made from Sagamore Hill to Huntington Bay in the Syph. He will return to Sagamore Hill immediately upon the conclusion of his trip. Early today Secretary Loeb went to the Roosevelt house and he and the President spent nearly three hours in the handling of mail and the transaction of executive business.

Dr. Lyman Abbott, editor of the Outlook, took luncheon with the President and Mrs. Roosevelt today. His call was purely social.

The executive offices in the Moor block were opened for business today, and Secretary Loeb and Secretary Barnes were busy in getting them in shape for their summer's work.

AMERICAN RABBIS MEET.
Resolution Introduced Thanking Roosevelt for Sympathy Shown.

DETROIT, June 29.—The annual meeting of the Central Conference of American Rabbis opened tonight in Temple Bethel with three score rabbis from all parts of the United States present. Rabbi Joseph Silverman, of New York, the president of the conference, in his message took up the recent Jewish massacres in Russia and reviewed the protest of the B'nai B'rith Society to President Roosevelt and the President's action in forwarding the society's protest to the Czar.

Rabbi Silverman said that in view of the President's action it was wise to cease further agitation for public meetings of protest and urged the adoption of resolutions thanking the President and informing the public that the exigencies of the situation at Kiel had been met as far as possible. Such resolutions will be presented and considered Wednesday.

Rabbi Jacob Netzer, of San Francisco, opened the conference tonight with prayer.

NEGROES ISSUE APPEAL.
Country Asked to Enforce the Laws in the Present Crisis of the Race.

LOUISVILLE, June 29.—At the annual session of the Afro-American Press Association held here today, a strong address dealing with the race question was unanimously adopted for issuance to the country at large. The address calls on the people to enforce the principles of good government in the present crisis in the history of the Afro-American people.

AN IMMENSE LANDSLIDE.
Melting Snow in Colorado Causes Top of Mountain to Break Off.

OURAY, Colo., June 29.—An immense landslide, 100 feet wide came down from the main range into Silver Creek basin, beyond and between the Revenue and Camp Bird mines. The whole top of the mountain broke off, and another section of the mountains looks as if it would break off. The slides are caused by the melting of deep snow. No damage has resulted.

On Trial for Killing Husband.
MOUNT HOLLY, N. Y., June 29.—Mrs. Phares, aged 30, who has been a prisoner in the County Jail since March, was today placed on trial, charged with causing the death by poison of Arthur A. Phares, her husband.

DES MOINES, June 29.—(Special.)—Ex-Representative George D. Perkins, of the Sioux City Journal, will be the temporary chairman of the Republican state convention, which meets Wednesday morning, and will sound the keynote of the campaign. The permanent chairman will probably be Representative Hepburn. The present state officers, Governor Cummins, Lieutenant-Governor Herriott and Railway Commissioner David J. Palmer, will be renominated by acclamation. Superintendent of Public Instruction Barrett, who has served three terms, is this year opposed by Mr. Adams from his own district, and the race between the two is likely to be close. This is the only office over which there is any contest.

publican party in giving protection to home industries, and point for its ample vindication to the extraordinary rapidity with which our National resources have been developed, and our industrial and financial independence secured.

We favor such changes in the tariff from time to time as become desirable, through the progress of our industries and their changing relations to the commerce of the world. We endorse the policy of reciprocity as the natural development of our progress, and urge its development as necessary to the realization of our highest commercial possibilities. We favor any modification of the tariff schedules that may be required to prevent their affording a shelter to monopoly.

The understanding is that two drafts of the new plank have been made, and a third will be devised tomorrow. Governor Cummins, it is said, insists upon more direct and vigorous expression as to revision than Senator Allison and the other compromisers desire to have incorporated. CHRISTIAN PARTY TO MEET.

Call issued for Convention to Name Presidential Candidates. DAVENPORT, Ia., June 29.—William R. Benkert, chairman of the National Executive Committee of the United Christian party, has issued a call for a National Convention of that party for May 1 to 4, 1904, at the World's Fair, in St. Louis. The call states that the convention will be held for the purpose of "economic discussion and peace on earth, in the name and spirit of Jesus Christ, and to further accomplish this great purpose by recommending or nominating candidates for President and Vice-President of the United States on a world-wide platform, on which all Christians and patriots can stand and finally unite to stand for the Union in His name."

The call suggests a woman for Vice-President.

FOES OF CANAL MAY REBEL
They Hold the Panama Treaty Payments Are Not Sufficient.

LONDON, June 29.—The Morning Advertiser publishes an authority this morning a statement by the Consul-General of Colombia, concerning the situation between the United States and Colombia in regard to the Panama Canal. The statement follows:

"The signing of the Hay-Herran treaty by the Colombian Minister in Washington has been the object of American pressure and intrigue for many months. Every effort has been made to prevent the opposition party, headed by General Reyes, from obtaining sufficient power to defeat the passage of the bill. General Reyes is in possession of sufficient arms and men to proclaim a revolution and unseat President Macraquin. He does not desire that Colombia control the minds of the people of Panama, and today the people are ready to rise when called to do so by the American agitators and proclaim their independence. This will be done if General Reyes, the Vice-President of the republic, is successful in inducing Colombia to refuse to sell. Panama will rise and claim its independence, with American guns and ammunition, purchased with American money. Once again America will step in and assert the independence of a downtrodden people, as she has done in the past, to her own increased and lasting benefit. Then, the American Government will build the canal, enforcing its own terms upon the helpless people."

KAISER PUZZLES CUBA.
He Says German Claims, of Which There Are None, Will Be Taken Up.

HAVANA, June 29.—Garcia Velaz, the Cuban Consul at Hamburg, reports that at a banquet at Hamburg at which Emperor William and Foreign Secretary Baron von Richthofen were present, the Emperor remarked that he was in a matter to be taken up by the German Minister to Cuba, would be the claims of German citizens. The officials here are puzzled to know what claims the Germans have since the war, which was disposed of, as far as Cuba is concerned by the treaty of Paris.

The Cuban officials incline to the belief that Baron von Richthofen intended to the Spanish bonds sold in Europe on account of the Cuban war debts.

TO FIGHT BEEF TRUST.
Colorado Company Will Put in a \$1,000,000 Plant in Kansas City.

KANSAS CITY, Mo., June 29.—Representatives of the United States Packing Company, of Colorado, are in Kansas City to consider the question, they say, of establishing a million-dollar packing plant here. The United States Packing Company was organized under the laws of Colorado in October, 1902, and its purpose is to endeavor to compete with the so-called "beef trust." James H. Peabody, Governor of Colorado, is the president of the independent concern, which already has commenced the construction of a packing-house at Pueblo. The plant of the promoters of the new enterprise contemplate the construction of three plants in the West.

DISASTER ON HONEYMOON
Lieutenant and Mrs. M. O. Roberts Are Thrown From Motor-Car.

PARIS, June 29.—Lieutenant Marshall O. Roberts, of the Scots Guards, son of Mrs. Ralph Vivian, formerly Mrs. Marshall O. Roberts, of New York, who was married to Miss Irene Helen Murray, daughter of Sir George Murray, in London, June 29, was making an automobile trip from Paris to Fontainebleau with his bride today, when they met with an accident, and both were thrown from the motor-car. They were badly though not fatally hurt.

Novelist's Condition Critical.
LONDON, June 29.—George Meredith, the novelist, who has been ill for some time, yesterday suffered a relapse, and his condition is announced to be critical.

MAY BE PUT OUT
Salt Lake City Is After Portland's Place.

LEAGUE MAGNATES MEET
Los Angeles and San Francisco Are to Stay.

GRIM'S NINE COSTS THEM MONEY
Schedule Will Be Rearranged to Suit Butte-Helena Will Not Be Dropped—Dr. Emmet Drake Opposes Transfer of His Team.

The Pacific National League will not drop Los Angeles and San Francisco. A new schedule will be arranged covering the balance of the season, whereby the Los Angeles and San Francisco clubs, which are now in the north, will make a second tour of the northern cities before going home. After making the tour of the northern cities the California clubs will return home and open next with Seattle and Spokane.

The Portland club was the subject of a great deal of discussion, but no action was taken concerning it. The other clubs do not favor retaining that city if Salt Lake is able to make a satisfactory showing. No discord was apparent at the meeting, all agreeing that they would fight it out in California. There is no indication of any inclination to drop the Helena club.

TACOMA, June 29.—(Special.)—The Pacific National League magnates began their session at 2 o'clock this afternoon, adjourning at 11 o'clock tonight, and they will meet again at 9 o'clock this morning, and expect to conclude their business tomorrow. No discord was apparent among the magnates, who unanimously decided to stand by the Los Angeles and San Francisco clubs, which, according to recent rumors, were to be dropped. A well-organized movement was on foot to form a new league in the north, to consist of Seattle, Tacoma, Spokane, Butte, Helena and Salt Lake City.

The entire morning today was spent by the magnates in discussion in the hotel corridors, and it speedily developed that the Tacoma and Seattle clubs insisted upon fulfilling their agreements with the California clubs. In this they were supported by Butte, whose chief contention was for more games in that city during July and August, which are said to be the two best months of the year there for baseball. It was then agreed that the California clubs which are now playing in the north should make one more trip around the circuit instead of going home, exactly what that club was willing to do in the old schedule. Completing this trip they will then go home and open with Spokane and Seattle. The showing made by the Helena club appears to have been satisfactory, and there is no indication tonight that Helena will be dropped.

Portland May Be Dropped.
Salt Lake City and Portland are the subjects of much discussion. The fate of Portland will be settled tomorrow. In their controversy, and in the magnates favor Salt Lake in preference to Portland. C. H. Griffin, who is in the city, was authorized to represent the Salt Lake Club, and he laid before the league just exactly what that club was willing to do in return for receiving the franchise. Tonight several hours were spent in discussion with Mr. Griffin by Harry Hart, of San Francisco, and by J. H. Griffin, of Tacoma, Perrell of Helena and Reynolds of Butte, representing the league.

The Salt Lake club stood willing to fulfill every condition imposed upon it by the league, but it saw no reason why it should deposit \$1000 forfeit money unless the other clubs did so. Salt Lake was prepared to make the deposit if the other clubs would. The question of transferring the Portland players to Salt Lake was discussed at length, and a general informal canvass given to the situation in both cities. It is admitted that Portland retained the other clubs of the league will have to go to the front with cash to support the team in that city, and this is likely to be an important factor in winning the franchise for Salt Lake.

Decision to Be Made Today.
Dr. Emmet Drake, president of the Portland club, is here, and is opposed to the transfer of his club to Salt Lake. Harry Hart stated tonight that tomorrow would decide the Portland-Salt Lake question. The auditing committee named today to go over the books of the treasurer will make its report in the morning, and the schedule for the rest of the season along the lines indicated will be made out tomorrow, which with the Portland question completes the business to come before the league. There is no sentiment shown by any of the clubs antagonistic to President Lucas.

NEGRO MEETING BROKEN UP
Wilmington Police Will Not Allow an Anti-Lynching Gathering.

WILMINGTON, Del., June 29.—The proposed mass meeting of colored residents of Wilmington, to protest against lynchings, and to take steps to protect the negro population of this vicinity, was not held tonight. Chief of Police Black made a request of influential colored men to use their influence against the holding of a meeting at this time, for the reason that such a gathering might incite further trouble between the whites and the blacks. A small crowd gathered in the vicinity of the place where the meeting was to have been held, but the police quickly dispersed it.

Holds Jett Did Not Kill Macrum.
