

HONOR TO FLEET

Britain Welcomes American Ships.

NATIONAL SALUTES FIRED

First Day Begins and Ends Brilliantly.

DINNER IS GIVEN FOR VISITORS

Vessels at Portsmouth Are All Handsomely Decorated and Illuminated by Night-Royal Yacht Makes a Great Display.

WELCOME OF THE KING. BUCKINGHAM PALACE, July 7.—Admiral Cotton, United States fleet, and his staff, and your squadron to England, and is looking forward to greeting you and your brother officers in London.

PORTSMOUTH, July 7.—The American squadron's first day in British waters ended as brilliantly as it began.

Scene is Most Picturesque.

At 10 o'clock all the vessels turned on their searchlights, the British warships flashing red and blue, and the Kearsarge and her consort red and green. The feature of the illumination was the display by the searchlights of the Victoria and Albert, which formed four different colors, the whole resembling a rainbow.

King's Message of Welcome.

Admiral Cotton, on receipt today of the King's message of welcome, immediately replied as follows: "Fingst Kearsarge, Portsmouth—Lord Knollys, Secretary to His Majesty, King Edward VII, Buckingham Palace, London: "Dear Admiral Cotton acknowledges with grateful appreciation His Majesty's cordial welcome to himself and officers of the squadron under his command to England, and anticipates with great pleasure the honor of meeting and paying his respects to His Majesty in London."

Entrance of the Fleet.

With the boom of cannon, the British fleet on behalf of King Edward welcomed the United States squadron to Great Britain's naval headquarters this morning. The gunboat Machias joined the flagship Kearsarge, the Chicago and the San Francisco, early in the morning, and shortly after 5 o'clock signals began to flutter from the mastsheads of the American and British ships. The latter, in obedience to a signal from Lord Charles Bessborough, commander of the Channel Squadron, formed two lines and down this lane of huge gray warships moved the Americans, their white sails gleaming in the sunshine.

National Salutes were fired by each squadron, which were followed by an exchange of salutes to Rear-Admiral Cotton and Vice-Admiral Bessborough. Subsequently the two Admirals exchanged calls on the flagships, according to the usual honors as each came over the side.

At high tide the American warships entered the harbor, led by the Kearsarge, which was moored south of the railway jetty, and within a stone's throw of Nelson's old flagship, the Victory; King Edward's yacht, the Victoria and Albert, and the battleship Collingwood, flagship of Admiral Hotham, the commander-in-chief of Portsmouth.

"Attention" is Sounded.

As the Kearsarge approached the jetty, "attention" was sounded on the Victoria and Albert, the Victory and the other ships in the harbor, a courtesy which was returned from the Kearsarge's deck, on which were drawn up an Admiral's guard of 10 marines, under the command of Lieutenant Colly.

As soon as the Kearsarge was berthed, Sir William Meade, the Mayor of Portsmouth, boarded her and greeted Admiral Cotton, saying: "The people of Portsmouth welcome the American squadron and extend to its officers and men all the courtesies they can offer."

Admiral Cotton replied, expressing his pleasure on behalf of the United States.

The departure of Admiral Milne, commander of the royal yacht, specially detailed by King Edward to welcome the Americans, arrived on board the Kearsarge, and was escorted by Admiral Cotton and Captain Hemphill. Admiral Milne expressed the gratification of King Edward at the arrival of the squadron, and, in behalf of the King, welcomed it to Great Britain. Subsequently, Admiral Cotton, Captain Hemphill and the staff officers visited the naval officials, escorted by an Admiral's guard and a band.

Admiral Cotton has designated the officers who are to attend the state ball at Buckingham Palace, London, Wednesday, in honor of President Loban. Besides Rear-Admiral Cotton and all the American commanders, the list includes a number

of Lieutenants and Ensigns, and representatives of the medical and pay staffs. During Admiral Cotton's visit to Admiral Hotham, the latter recalled the fact that they had previously met at Bournemouth, when Admiral Hotham commanded the British-Pacific Squadron and Admiral Cotton was in command of the United States squadron. The former reiterated personally the warm message of welcome which had previously transmitted to Admiral Cotton at Spithead. The Americans were presented to Lady Hotham and returned immediately after Admiral Cotton was on board the Kearsarge, Admiral Hotham and his staff returned Admiral Cotton's call.

Deputy Governor Cochrane, of the Isle of Wight, also called on Admiral Cotton. Subsequently the American officers ended their official visits by calling on the Mayor of Portsmouth.

Admiral Cotton and the other American officers, while in London, will be quartered at various hotels as the guests of the Nation.

Admiral Cotton vigorously denies the report which appeared in the German newspapers that over the United States ship Kearsarge, at Kiel. The Admiral declares that the discipline of the crews is excellent.

Only Two Men Have Deserted.

WASHINGTON, July 7.—The following cablegram, under date of today, was received at the Navy Department from Rear-Admiral Cotton at Portsmouth: "Only two stragglers at Kiel; both Americans by birth; still absent. Admiral Cotton has this information to the department in response to a cable inquiring as to the accuracy of the reports that a large number of sailors, chiefly of foreign birth, had deserted from the American ships during the visit of the squadron at Kiel."

MAINE WELCOMES BRITISH FLEET.

Texas Gives the Admiral's Salute to Visitors at Bar Harbor.

BAR HARBOR, Me., July 7.—The British fleet, commanded by Vice-Admiral Sir Archibald D. Douglas, K. C. B., and consisting of the flagship Ariadne and crosser Athene and Distribution, has arrived here. The Admiral's salute of 15 guns was fired by the United States battleship Texas, to which the Ariadne responded. Admiral Douglas, who is accompanied by the Adjutant-General Farnham and staff, representing Governor Hill, who welcomed Admiral Douglas as requested by Secretary of the State.

Admiral Douglas, with his officers, returned the calls immediately, and went ashore to the Mount Desert reading-room, where the local committee and residents. Following the round of official calls came a public reception. Later, Mr. and Mrs. B. Hall McCormick entertained the English and American Admirals.

MORE TIME FOR THE CANAL

Colombia Cannot Dispose of Panama Treaty at Regular Session.

WASHINGTON, July 7.—William Nelson Cromwell, counsel for the Panama Canal Company, had an hour's conference today with Acting Secretary Loomis respecting conditions in Bogota so far as they affect the Panama canal treaty. Mr. Cromwell has received a cablegram from Bogota stating that the treaty was presented to the Colombian Senate, July 2, and that it will be considered at the regular session beginning on the 20th that would displace the special order which gave the treaty the right of first consideration in that body. However, that difficulty in that case will be met by a renewal of the special order to govern the proceedings in regular session.

THINK UNCLE SAM STINGY.

Colombians Desire More Money for the Panama-Canal Note.

NEW YORK, July 7.—Senator Pedro Valez, a member of the Colombian Congress from Casanare, and ex-Governor of Bolivar, has arrived in this city by way of Cuba. He will return to Colombia next week to take his place on the committee that is expected probably will depend the fate of the treaty. He does not expect a decision before the end of August, as Congress must give the measure careful consideration. He is strongly opposed to the treaty. The people object to a permanent cession of a part of their territory to the United States. They do not think that this country has not been generous enough in the matter of indemnity and rental.

Discussion Will Be Public.

BOGOTA, Colombia, July 8.—The Senate yesterday resolved to discuss the Hay-Herran canal treaty in public session.

STUDENTS STEAL AN AUTO

Portland Youth One of Three Harvard Men in Disgrace.

BOSTON, Mass., July 7.—(Special.)—Infatuation for the society of pretty, vivacious butterflies in opera choruses has brought disgrace upon three proud scions of wealthy families who have been attending Harvard. They are charged with stealing a "Red Devil" automobile from Kansas Skinner, who conducts a public garage here.

The machine was valued at \$800 and was alleged to have been taken from the building by John Lankershim, of Los Angeles, son of a California banker; a Portland, Or., student, and a Brooklyn youth. Lankershim has been arrested, and the police are keeping the wires hot in an effort to head off the Portland, Or., youth, who is now speeding toward the Coast. They decline to give his name, fearing that he may escape them.

The automobile was taken all over New England and finally left a wreck at Providence.

Guy Hunt's Case Continued.

BOSTON, Mass., July 7.—(Special.)—Guy L. Hunt, of Portland, Or., appeared in court today and asked for a continuance until July 11, ball being fixed at \$100 as before.

MRS. J. G. BLAINE ILL.

Widow of Statesman Suffers From Breaking Down of System.

AUGUSTA, Me., July 7.—Mrs. Blaine, widow of the late James G. Blaine, is reported to be seriously ill at her home in this city. Mrs. Blaine has been ill for some time, and her condition is due to a general breakdown of the system.

TERRY IN ERUPTION

But Indian Commissioner Extinguishes Him.

INDIGNANT AT HIS REMOVAL

Puyallup Indian Superintendent Refuses to Go to Round Valley, but Is Told to Go or Resign—He Denounces His Chief.

OREGONIAN NEWS BUREAU, Washington, July 7.—Frank Terry, Superintendent of the Puyallup School, is in eruption. A hot blast from Puyallup was received by Indian Commissioner Jones this morning, in which Terry announces in bold, defiant terms, that he will not obey the recent order for his reduction in salary and transfer to Round Valley, Cal. He moreover denounces the Commissioner for circulating through the Northwest press reports that he is incompetent, and closes by demanding a thorough investigation of the Puyallup School.

But Mr. Terry will be as much surprised to receive Commissioner Jones' reply as he was to first read of his demotion, a consummation he very much doubted until the official order was received. In his customary calm manner, the Commissioner today wrote to Terry announcing that the affairs of the Puyallup School had been most thoroughly investigated, and no further investigation was needed or intended. As for the order to resign, the Commissioner says that matter rests with Terry alone. If he does not wish to accept the transfer to Round Valley, Cal., at \$300 less than he drew at Puyallup, there are plenty of men in the service willing to take the place. One thing is assured, Superintendent Linton will assume charge at Puyallup just as soon as his boss is approved, and the chief is chronicled to take place within a week or two at the outside. If Terry desires to remain in the Indian service, there is but one place open to him. If that place is not acceptable, he can resign.

It may be stated in this connection that the Indian office is not trifling with Terry or the other employees at Puyallup. Their status has been clearly defined, and they are to be dealt with in a precise manner.

Regarding Terry's complaint that the Commissioner has circulated damaging reports as to his fitness, Mr. Jones simply replied that he assumes no responsibility for correspondence of Northwest papers. Terry's reduction from \$400 to \$350 is left to testify to the Commissioner's judgment as to his competency. The Puyallup incident, so far as it relates to Terry, is regarded in Washington as closed.

TO REPRESENT ALASKA AT FAIR.

Hitchcock Makes His Assistant St. Louis Commissioner.

OREGONIAN NEWS BUREAU, Washington, D. C., July 7.—Assistant Secretary of the Interior Ryan has been designated by Secretary Hitchcock as Alaska Commissioner for the St. Louis Exposition, and charged with the collection of the Alaskan exhibit, showing the resources of the territory. Secretary Hitchcock construes the law to prohibit the employment of a salaried Commissioner, and all applications of residents of Alaska accordingly have been turned down. Judge Ryan has already communicated with representative citizens of Alaska and with Alaskan officials who assure him that the people are willing to assume all expense attending the collection and transportation of exhibits. It therefore has been determined to expend most of the \$25,000 appropriated in the erection of the Alaskan building, which by special favor, will contain the territorial exhibit. No state buildings are to be so used. Later in the summer, Judge Ryan will visit Seattle and confer with an Alaskan delegation with a view to learning how much space is required for the exhibit. Immediately thereafter plans for the building will be prepared.

RAILROAD RATES HELD UNJUST.

Utah Company Submits Western Schedule to Interstate Commissioner.

OREGONIAN NEWS BUREAU, Washington, D. C., July 7.—The H. I. Griffin Company, of Ogden, Utah, today filed with the Interstate Commerce Commission complaint against the Northern Pacific, Oregon Railway and Navigation Company, Oregon Short Line and Union Pacific railroad, alleging discrimination in rates on smoked fish, shipped from Seattle to Ogden. The company shows that the distance from Seattle to Ogden is but 400 miles, and the rate on smoked fish is \$1.50 per 100 pounds versus the rate of the same line on the same article shipped from Seattle to Omaha and other points in the Middle West, a distance of 2000, is only \$1. The railroads named will be advised of the charges, and will be called upon to make reply.

Northwest News Promoted.

OREGONIAN NEWS BUREAU, Washington, July 7.—Burlen L. Stephenson, of Oregon, clerk in the Treasury Department, today promoted from \$500 to \$600. William E. Shea, of Idaho, in the same department, received the same promotion.

FEWER TROOPS FOR PHILIPPINES.

Davis Cables His Plan to Root for Reducing the Force.

WASHINGTON, July 7.—Secretary Root has received from General Davis, commanding in the Philippines, a long cablegram over the new Pacific Commercial cable relating to the disposition of another reduction of troops in the islands for the next year.

In the opinion of General Davis, the conditions in the Philippines are such as to warrant quite a reduction of force, and he gives in detail his plan for making this reduction.

NEW CONSUL NAMED AT MILAN.

Harlan W. Brush Will Exchange Places With William Jarvis.

WASHINGTON, July 7.—Harlan W. Brush, of New York, has been appointed United States Consul at Milan, Italy, exchanging places with William Jarvis, of

New Hampshire, at present Consul at Milan, who has been appointed Consul at Niagara Falls.

China Makes Payment on Claims.

WASHINGTON, July 7.—The State Department has been notified that the Chinese government has paid the third installment on account of the Boxer indemnity, amounting to \$1,000,000. The settlement was made on the basis of the rate of exchange at the time the Peking treaty was signed, the United States reserving all rights to further compensation if it should appear that the indemnity payments are to be made on the basis of a lower rate of exchange, which is much higher.

Payne Ends His Vacation.

WASHINGTON, July 7.—Postmaster-General Payne today telegraphed that he will arrive here from the Catskills tomorrow evening, resuming his duties Thursday morning. There were no developments in the postoffice investigation today, although conditions are such that important developments may occur at any time.

Motion to Quash in Postal Fraud.

BALTIMORE, July 7.—In the United States District Court today a motion was made to quash the indictment against Ellsworth Upton, who, with Thomas W. McGregor, was recently indicted by the Federal grand jury, charged with complicity in mail pouch frauds. Judge Morris will hear arguments on the motion next Saturday.

He Seeks Minutes of Grand Jury.

NEW YORK, July 7.—Abram J. Rose, counsel for George F. Miller, who was indicted by the Federal grand jury in Brooklyn which investigated sales of automatic cashiers to the Postoffice Department, made a motion today for permission to inspect the grand jury minutes. The motion was denied.

Driggs in Postal-Fraud Case.

NEW YORK, July 7.—Counsel for Congressman Driggs, under indictment for alleged bribery in the investigation of charges of improper conduct preferred against Special Employee Barnes, ex-employee to General Leonard Wood, at Havana.

Held for Using Government Funds.

MANILA, July 7.—Customs Inspector Coates and Lieutenant Osborne, consular supply office, both stationed at San Fernando, have been arrested on the charge of misappropriation of Government funds.

President Refuses Him Clemency.

WASHINGTON, July 7.—The President has denied the application for executive clemency for the Japanese deserter, a Japanese, convicted in Hawaii of murder.

RUSSIA TO WARN BULGARIA

War With Turkey Is Not to Be Considered for a Moment.

VIENNA, July 7.—In well informed political circles, it is expected that Russia will shortly warn Bulgaria in an unmistakable manner on making war on Turkey.

War With Bulgaria Inevitable.

LONDON, July 8.—The Constantinople correspondent of the Daily Telegraph quotes an officer of high rank in the Turkish command as saying that a war with Bulgaria appears to be inevitable; that Turkey was never so well prepared for hostilities, and that the army on the frontier is in a state of readiness. Bulgaria's policy is to remain quiet until attacked.

ULTIMATUM NOT YET TO HAND.

Russia Has Heard Nothing of the Anglo-Japanese Note to China.

ST. PETERSBURG, July 7.—The Russian foreign office knows nothing of the alleged Anglo-Japanese ultimatum on the subject of Manchuria, which, according to the St. Petersburg press, is expected to be presented to the Chinese government recently, and which sets forth, among other matters, that if the departure of the Russians from Manchuria is indefinitely postponed, Great Britain and Japan must proceed to protect their interests, and added that China must demand from Russia the immediate evacuation of Manchuria.

Attitude of the Diplomats.

PEKING, July 7.—The representatives of the United States, Great Britain and Japan are preserving independent actions regarding Manchuria and are awaiting the attitude of the Russian government. The Japanese Minister is occasionally urging Prince Ching, President of the Foreign Office, to avoid making secret concessions to Russia.

CHINESE OFFICIALS CARRIED.

Officials in Two Provinces Are Giddy of Corruption.

PEKING, July 7.—On the recommendation of Tsen Chun Hsuan, the new Viceroy of the Provinces of Kwang Tung and Kwang Si, an edict was issued today cashiering all the high officials in Kwang Si, including the Governor, on account of corruption, incapacity and connivance with the rebellion which has been constant for the past year, provoking a threat on the part of the French to interfere. General Su and another General have been cashiered. The Chinese have been expelled from the Province with hard labor, because of having plundered the people.

China Finds Fault With Russia.

LONDON, July 8.—The Standard's correspondent at Tientsin says that the Chinese are complaining bitterly that the Russian troops encamped at Liangbenkwang have commandeered 80 carts to convey supplies of wheat to their forces on the Yalu.

King Oscar Is Not Ill.

STOCKHOLM, July 7.—There is no truth in the report published abroad that King Oscar is ill. He is to leave Stockholm July 11 for Norway, to be placed in the Norwegian Railway.

RIOTERS ARE COWED

Evansville Makes No More Moves Against Troops.

TROUBLE LIKELY TO COME YET

Threats of Violence Against Negroes on the Withdrawal of Soldiers Are Heard—Sheriff Afraid to Venture Out.

EVANSVILLE, Ind., July 7.—After the carnage of last night, Evansville tonight is obeying the orders of the Mayor and the people are keeping off the streets. There are nine dead, one dying, three others fatally hurt and 21 more or less injured. Four died today, Frank Lambie, aged 23, shot through the chin and breast; Fred Kappler, Jacob E. Cain, a barber, shot through the brain, and Charles Taylor, a wagonmaker, who was an on-looker and did not participate in the attack on the troops, and who was shot in the back.

John Barrett is dying from shot wounds received from the volley fired into the mob, and his physicians say he cannot live until morning. The unidentified dead man has been recognized as Robert W. Bock, who was shot in the head by the volley from the Courthouse defenders last night.

Force of Militia on Duty.

Eight companies of militia and one battery are in Evansville. The 400 soldiers are armed with rifles, and the night battery has a Gatling gun. The Terre Haute company arrived this afternoon and relieved the Vincennes and Evansville companies in guarding the jail. An hour later, Brigadier-General W. J. McKee, in command of the Indiana National Guard, arrived and assumed command of the troops. At 8:30 P. M. a special train arrived from Indianapolis, and the battery of artillery from Indianapolis; also a company from Martinsville. The troops were marched through a quiet, curious crowd of several thousand people. There was not a negro in sight. In the meantime the Evansville, Terre Haute and Vincennes companies had gone into camp around the Courthouse and jail, with their backs to the city. No one was allowed to approach within 300 yards of the jail.

General McKee ordered the Martinsville company to relieve the companies at the jail for the night, and the Indianapolis companies and the battery went into camp in Sunset Park, six squares from the jail.

Sheriff Afraid to Venture Out.

General McKee on his arrival this afternoon held in consultation with the Mayor and a committee of 15 prominent citizens designated by the Mayor as a committee of safety. At this meeting there were some expressions of severe criticism of the action of the Mayor. General McKee asked for the co-operation of Sheriff Kratz, but that official telephoned from the jail that it would be difficult for him to venture out. McKee was allowed to approach within 300 yards of the jail.

Reward for Capture of Rudolph.

JEFFERSON CITY, Mo., July 7.—Governor Dockery today offered a reward of \$500 for the capture of William Rudolph, the Union bank robber.

MOB SEEKS A SCHOOTEACHER.

Twelve-Year-Old Pupil Says He Attempted to Assault Her. SWEETZER, Ind., July 7.—U. S. Williams, a school teacher, last night attempted to assault one of his pupils, a girl named Beach, 12 years old. When the girl told her mother a crowd collected and early today went to the home of Williams, threatening violence, but the sheriff arrived today and rushed him off to Marion. He was removed from Marion today because trouble was feared if he remained there tonight. It is not known where Williams is concealed.

Butcher Is Mysteriously Shot.

HAZLETON, Pa., July 7.—Andrew Hudock, aged 25, of Freeport, treasurer of the Pennsylvania Stovak Catholic Union, was found today in his butcher shop, and shot in the head. The bullet had become so frightened that they were regarded as unfitted to perform their duties and were relieved from duty at their own request.

Pennsylvania Murderer Is Hanged.

LEBANON, Pa., July 7.—David Shaud, who shot and killed Mrs. Ida Becker and poisoned Cyrus Shaffer, was hanged here today. Shaud, who became angry at Mrs. Ida Becker for testifying against him in court, met his woman on the street and shot and killed her. When the policeman went to arrest him at his home, Shaud also shot and killed him.

Long Fight to Keep Out of Jail Fails.

LOUISVILLE, July 7.—The long fight made by J. M. McKnight, the ex-banker, to keep out of prison, ended in defeat today when in the United States Court Judge Evans ordered the prisoner to be taken to Atlanta to serve his sentence of six years.

Negro Hanged for Stabbing Man.

VICKSBURG, Miss., July 7.—Cato Garret, a negro, who stabbed Harry Stout to death last Saturday morning, was hanged by a mob near the scene of his crime this afternoon.

Electrocuted for Murder.

OSBURN, N. Y., July 7.—Wm. O'Connor, better known as George Smith, was electrocuted today for the murder of Watchman Matthew Wilson at Cobleskill, N. Y., in November, 1900.

NEGRO WHO CAUSED RIOT MOVED.

On Order of the Governor Brown Is Taken to Jeffersonville. VINCENNES, Ind., July 7.—Lee Brown, a negro who was in jail here for safety keeping after he killed Officer Massey at Evansville and precipitated the race riots there, today was taken to the jail at Jeffersonville by Sheriff Summitt on an order from Governor Durbin. At Jeffersonville Brown cannot be reached by a mob. The negro was barely alive, but was given stimulant and will be worked with for two hours by Dr. Decker.

NEGRO BISHOP ON SITUATION.

He Has Great Confidence in Final Solution of Race Problem. INDIANAPOLIS, Ind., July 7.—Bishop J. W. Hood, senior bishop of the A. M. E. Zion Church, in charge of the First Episcopal district, embracing New York, New England and Central North Carolina, is a guest here. In discussing the race troubles, Bishop Hood said: "I have great confidence in the ultimate solution of the race problem. This is a large, serious and important problem, but it necessarily moves slowly. It is necessary that the races get closer together. The negro must improve and the white man must be fair. The negro in the South is stubbornly pushing to the front. He is buying land, houses, plantations and stock, and is hoarding his earnings for the betterment of his condition."

JAILBREAKER STILL AT LARGE.

MOB SEEKS A SCHOOTEACHER.

Twelve-Year-Old Pupil Says He Attempted to Assault Her. SWEETZER, Ind., July 7.—U. S. Williams, a school teacher, last night attempted to assault one of his pupils, a girl named Beach, 12 years old. When the girl told her mother a crowd collected and early today went to the home of Williams, threatening violence, but the sheriff arrived today and rushed him off to Marion. He was removed from Marion today because trouble was feared if he remained there tonight. It is not known where Williams is concealed.

Butcher Is Mysteriously Shot.

HAZLETON, Pa., July 7.—Andrew Hudock, aged 25, of Freeport, treasurer of the Pennsylvania Stovak Catholic Union, was found today in his butcher shop, and shot in the head. The bullet had become so frightened that they were regarded as unfitted to perform their duties and were relieved from duty at their own request.

Pennsylvania Murderer Is Hanged.

LEBANON, Pa., July 7.—David Shaud, who shot and killed Mrs. Ida Becker and poisoned Cyrus Shaffer, was hanged here today. Shaud, who became angry at Mrs. Ida Becker for testifying against him in court, met his woman on the street and shot and killed her. When the policeman went to arrest him at his home, Shaud also shot and killed him.

Long Fight to Keep Out of Jail Fails.

LOUISVILLE, July 7.—The long fight made by J. M. McKnight, the ex-banker, to keep out of prison, ended in defeat today when in the United States Court Judge Evans ordered the prisoner to be taken to Atlanta to serve his sentence of six years.

Negro Hanged for Stabbing Man.

VICKSBURG, Miss., July 7.—Cato Garret, a negro, who stabbed Harry Stout to death last Saturday morning, was hanged by a mob near the scene of his crime this afternoon.

Electrocuted for Murder.

OSBURN, N. Y., July 7.—Wm. O'Connor, better known as George Smith, was electrocuted today for the murder of Watchman Matthew Wilson at Cobleskill, N. Y., in November, 1900.
