Washington Bankers Take Trip on Steamer.

SALMON CANNED BEFORE THEM

Whitcomb and Fairhaven People Have Done Everything to Make the Visit Enjoyable—Unfinished Business to Be Cleaned Up Today.

WHATCOMB, Wash., July 24.—(Staff Correspondence.)—The Washington bankers and their kindred today have been about the stringency of the money market, the necessity for an elastic currency or any of the other vexed questions which they talked about and listened to yesterday. The second day of the convention was given up to pleasure and in order to get all possible out of it an early start was made.

The party left Whitcomb at 8 o'clock this morning for Fairhaven, where they visited the cannery of the Pacific American Fisheries Company, the largest in the world. The catch was small and the big force of operatives put about 2500 cases of salmon cans right before the eyes of their visitors. The visiting bankers and their friends were joined at Fairhaven by the local reception committee and a number of other Whitcomb and Fairhaven people and the entire party embarked on the steamer George E. Starr for a trip to Blaine and Seattle.

On the trip they were afforded an opportunity to witness the lifting of a fish trap, an operation that was new and interesting to many of the visitors. There were about 250 on board the steamer and the party left the wharf in the midst of a shower which promised to dampen their ardor. It soon blew over, however, and the trip was most enjoyable. At Seattle the Alaska Packers Association had prepared an elaborate barbecue in which salmon, crabs and clams were the features.

The people of Whitcomb and Fairhaven have been untiring in their efforts to entertain the visitors and tonight gave a special vaudeville entertainment at Beck's Theater. Urgent business matters have called some of the members home, but nearly all of them will remain until tomorrow night.

BOLD THIEF OF SHEEP.

Lane County Rancher Fortunately Discovers His Property.

JUNCTION CITY, Or., July 24.—(Special.)—Numerous instances of larceny and

petty thieving are being reported of late in this locality, and it is only a matter of time when some of the miscreants will be brought to justice. One instance, in which just as a sheep was being taken to the market, has been reported to the authorities, wherein a band of sheep belonging to a certain rancher was sold to a stock-buyer. The owner and buyer proceeded to go to the market to look at some cattle, and in their ride passed the bunch of sheep just sold in the road. It was presumed by both that the animals had broken out of the pasture, and being in a hurry the men passed on, thinking the sheep would be all right if left there.

Upon the return of the erstwhile owner no sheep were passed, neither were they in the pasture. An investigation disclosed the painful fact that a neighbor had driven the sheep into his barn lot and had clipped their ears, placing on them his own mark. A peculiar fact was also disclosed when, upon strict search, the neighbor was not found, nor has he been seen since in the neighborhood. The proper owner took his property, and has not been molested. A warrant will meet the culprit upon his return.

Several instances of thefts of chickens, wood and grain have been reported, but these are rather common here.

BABB STOCK RANCH SOLD.

Umattila Property Brings \$50 Per Acre—Idaho Man Buys.

PENDLETON, Or., July 24.—(Special.)—M. H. Gillette has bought the W. H. Babb stock ranch, on the meadows near Echo, and will enter upon possession of the same in about ten days. This is the largest tract of property in this county for some time. The deal has been on the tapis for many months, but the papers which make this binding were not signed until Wednesday of this week. The consideration for both land and cattle is \$20,000, divided as follows: Five hundred and eight acres of land, \$10,000; or in round figures \$20 per acre; 220 head of cattle, \$8,000; or \$36 per head; the remainder for hay and implements. An irrigation ditch runs along the boundary of this property, which water right is included in the purchase.

Mr. Gillette recently sold out his landed possessions in Idaho for \$18,000, and left this morning for Moscow to gather up his traps and ship the same to Echo. These traps consist of 30 head of fresh milch cows, stock horses, wagons, farming implements and a carload of furniture. He expects it will take in the neighborhood of ten days to get everything cleaned up over there and on to his new possessions.

ALBANY MILLS TO START UP.

Oregon City People Will Use Them Temporarily.

ALBANY, Or., July 24.—(Special.)—The Albany woolen mills will begin operating again next Monday, after having been idle for several months. The Babb Manufacturing Company, of Portland, which purchased the plant, has put it in shape for work and has added machinery which will enable the mill to put out fine cloth. Heretofore the finer patterns have not been manufactured in Albany.

When the mill opens Monday it will be under the temporary management of the Oregon City Woolen Mills Company, which will operate the Albany mills until the Oregon City mills, which were recently disabled by fire, have been repaired and are ready to resume operations. Albany people are very much pleased over having this important industry again active.

HORSES SHIPPED BY THE CARLOAD.

Twelve Hundred Head Leave Eastern Oregon for Canada.

PENDLETON, Or., July 24.—(Special.)—W. H. Babb, the horseman of Echo, who on Tuesday sold to M. H. Gillette his large ranch on the meadows near Echo, shipped on Tuesday night about 1200 head of horses, with 40 carloads of horses, or 1200 head. About 600 of these are at Echo, 120 were delivered in this city yesterday, and he still lacks about 200 to complete the shipment. He expects to pick up about 60 head of the Fitzsimmons horses in Moscow, Idaho, and also has a pretty good idea where he will secure the remainder.

SEVEN CENTS FOR BIG FISH.

One Dealer at Astoria Raises the Purchase Price.

ASTORIA, July 24.—(Special.)—The run of fish last night and today, both up and down the river, has been very light, excepting in spots, and judging from reports received from the other side of the river there is little indication of another big run coming in in the immediate future.

The only change of note in the situation today was that J. Lindenberg, again raised the price for cold-storage fish, those weighing 25 pounds and over, to 7 cents per pound. None of the other dealers are paying more than 6 cents.

ROBBER STOPS CANEMAH GIRLS.

They Had No Valuables, and Were Not Harmed.

OREGON CITY, July 24.—(Special.)—Two young women residing at Canemah, were held up Wednesday night by a lone footpad, while they were returning to their homes from this city. Neither of the young ladies had any money or valuables and lost nothing. The bandit was not masked.

Blue River Mines Sold.

EUGENE, Or., July 24.—(Special.)—The Sunset, Yellow Rose and Tanaka Girl mines, in the Blue River district, which are looked upon as some of the most promising properties in the district, have just been purchased by Messrs. Dodge and Runyard, of Seattle. The purchasers have been making some time examining the properties and have just returned highly pleased with their prospects. They also speak highly regarding other properties in the district. The purchase price is not given to the public.

Grocers' Picnic at Canemah.

OREGON CITY, July 24.—(Special.)—The Retail Grocers' Protective Association will give a picnic at Canemah, near Park in this city Sunday, July 26. A number of excursion trains will be run from Portland, while a special train will bring several hundred other visitors to the city from Albany and other up-valley points. There will be two baseball games, a number of athletic contests and dancing both afternoon and evening.

Salem Boy Has Broken Bones.

SALEM, Or., July 24.—(Special.)—Little Raymond Stevens, son of George S. Stevens, fell or was thrown from a load of hay this afternoon and both bones of the left leg broke. The accident occurred while the team attached to the load ran away, which caused the accident. The boy was taken to the Salem Hospital, where the fractures were adjusted, and no serious complications are anticipated.

Collecting Mining Data.

BAKER CITY, Or., July 24.—George E. Book, of the United States Geological Survey, of Washington, D. C., arrived here today and will make a complete report of mining in Eastern Oregon, showing production, cost of operation, wages, etc. By act of Congress mine owners are compelled to furnish desired information under penalty.

Clackamas School Apportionment.

OREGON CITY, July 24.—(Special.)—County School Superintendent Zinner has made an apportionment of \$148,745 from the county fund among the various schools of the county. The apportionment amounted to \$1.85 per capita.

LAD IS HELD UP AT DRAIN

COTTAGE GROVE OFFICERS ARREST ROBBERS, WHO CONFESS.

Burglars Enter Drug Store and Take Gold Nuggets From the Show Window.

COTTAGE GROVE, Or., July 24.—(Special.)—While waiting for an early train at Drain, Or., this morning, on his way to Cottage Grove, a country lad was held up by two thugs at the point of a revolver and relieved of \$7.50 in silver. Upon arriving here this morning he reported the case to the authorities. Later on the men were arrested by Constable B. K. Lawson, and upon close questioning they confessed. They were taken to Drain this afternoon for hearing. No weapons were found upon them when arrested.

Burglars Entered the Modern Pharmacy

In this city last night and took from the front show window three gold nuggets valued at \$40. Nothing else in the store was disturbed. The cash register, containing \$1.50 in change, was opened, but the money was not taken. The thieves evidently were familiar with the place. They cut a glass from the rear door large enough for a hand to enter, turn the key and open the door. A cut hand left blood on the window curtains.

VAIN SEARCH FOR BODY.

Missing Eugene Man Was Thought to Have Drowned Himself.

EUGENE, Or., July 24.—(Special.)—Search was continued all day today in the hope of finding the body of C. W. Griffin, the young man who so mysteriously disappeared but without success. At the earnest request of Mrs. Griffin an expert

ment was tried to locate the body in the river with mercury. Several loaves of bread containing mercury were put in the water and it is claimed that if a corpse is in the water the loaf will float and stand directly over it.

One of the loaves took a very peculiar course and finally went to a hole about 20 feet deep, where it stood in one place for two hours. Men went out in a boat and tried to discover the body. There were stumps and snags at the bottom and nothing was found. A charge of dynamite in the water failed to raise anything. Further search at the same point will be made tomorrow.

A fact which gives some strength to the suicide theory is that he recently purchased a quantity of morphine and a hypodermic syringe. It is said he took a large dose of the drug at his home about two months ago with suicidal intent, but physicians were called and revived him. This time, it is argued, he went to a place where he would be not the danger of anyone interrupting him and thwarting his plans of self-destruction.

RIGHTS FOR SHIP RAILWAY.

Portage Engineer Believes Government Has Lost Its Interest.

SALEM, July 24.—(Special.)—Clerk W. N. Gaten, of the Board of Portage Railway Commissioners, has received a notice from the Oregon Railroad & Navigation Company, saying that representatives of that company will be pleased to meet the members of the board and their engineer on next Friday afternoon. The meeting will be held in Portland. All the members of the board will probably be present. The purpose of the meeting is to consider the question of a right of way over the property of the O. R. & N. Co. for the Portage road.

In the Oregonian's correspondence from Washington a few days ago it was stated that difficulty may be encountered in securing a right of way over the land secured by the General Government as a right of way for a ship railway. At the meeting of the board last Tuesday this matter was discussed, and Engineer Hammond was quite certain that the Government has lost its rights in the property. His understanding was that the Government secured the right of way for a ship railway, and that the Government has abandoned the project, it has lost the right. He thinks the right of way could be used for only one purpose, and before it can build a ship canal the Government must secure the right of way again. If this be true, the state will encounter no difficulty so far as the Government is concerned.

CONTROL OREGON COAL MINES.

Western Fuel Company Distributor of Beaver Hill Product.

SAN FRANCISCO, July 24.—Another step in the formation of a trust to control the coal supply on this coast, was taken yesterday when the Western Fuel Company was appointed wholesale distributor for the Beaver-Hill Coal Company. This means that the Western Fuel Company now controls the output of the Beaver-Hill mines in Oregon and that the retailer will henceforth be compelled to pay for the coal such prices as the Western Fuel Company may dictate.

The Western Fuel Company now is a merger of four different companies. It was formed six months ago, when three local coal companies pooled their interests and issued stock. The companies which combined were the John Rosenfeld & Sons Co., G. C. Wilson & Co. and John L. Howard, and the mines controlled by the company were the ones owned by the Rosenfelds at Nannaimo. The Beaver-Hill Coal Company owns mines near Coos Bay. Or. John D. Spreckels is the president of the company, and W. G. Stafford has been the distributing agent in this city. The company operates the steamer Carina, and the bunkers are located at Howard-street wharf No. 2.

PULLMAN WAREHOUSES BURNED.

Believed to Have Been Set on Fire—Destruction Rapid.

COLFAX, Wash., July 24.—At Pullman last night a fire started in the grain warehouses owned by the Puget Sound Warehouse Company, of Tacoma, and Nell Stewart, of Pullman. The first contained a carload of grain bags and tons of oats. The oats were insured for \$1000. The loss and insurance on the warehouse and grain bags was not learned. The other warehouse contained several carloads of farm machinery, including a combine, and other stock owned by the Stewart.

LOST MONEY IN POOLROOMS.

Captain Howard Is Believed to Have Committed Suicide.

OAKLAND, Cal., July 24.—Deputy Coroner Straight said today that the body of the man who was found dead at West Berkeley last Saturday morning with two bullets in his brain had been fully identified as that of Captain Thomas Howard, formerly a prominent citizen of Victoria, B. C. It is also believed that Howard committed suicide.

While in San Francisco he had been furnished with funds by J. P. Treanor, with whom he was interested in a mining scheme. A week ago last Saturday Treanor gave him \$250 and bade him good-bye. Howard having announced that he would leave for Victoria on the evening train. He was in great haste to leave the house where he had been staying, to the amount of about \$70, but to his friend and business associate he had represented the debt to be about \$100 and induced Treanor to furnish him with the larger sum.

Investigation shows that Howard afterward went to the poolrooms and lost what little money he had left. No date has been set for the inquest.

ONE CLOSE, ALL CLOSE.

Saloon-keepers of Vancouver Issue Ultimatum for Sundays.

VANCOUVER, Wash., July 24.—(Special.)—The saloon-keepers of Vancouver have held a meeting and decided that if they have to close their places of business on Sunday all places of business must close which are affected by the state law, and this includes all classes except hotels, livery stables, drug stores and undertakers. Restaurants are not exempt.

A committee has been notifying the business men this afternoon that next Sunday all places must close and not open upon penalty of arrest by the action of the saloonmen. The saloon-keepers are wroth at the action of the temperance league in forcing them to obey the law and they say that they will obey the law, but that the business men generally who come within the provisions of the law must also be compelled to close. The action is awaited with interest.

INDIAN LOUIS HANGED.

Murdered Squaw Because She Did Not Obey Him.

VANCOUVER, B. C., July 24.—Alex Loula, the Indian who murdered his squaw because she would not go home when he told her to, was hanged at Kamloops Jail this morning by Hangman Radcliff. Loula seemed glad to die, and he went to the scaffold with a smile.

His was a remarkable case and a remarkable end. He objected a few weeks ago to steps being taken to get a rap, saying that he preferred to die rather than be walled up from the sunshine and freedom.

The Indian's smiling demise was witnessed by a number of redskins in itself a unique circumstance, as the Indians generally abhor such a scene when one of their own tribe is the victim. The fact that the number of the tribe was allowed to witness the hanging had significance. It was intended to show them that life must be held sacred, and that squaws are not the mere beasts of burden and slaves, as the Indian bucks still believe them.

SEATTLE THUGS BEAT A MAN.

Senseless Body Is Then Thrown on the Railroad Track.

SEATTLE, Wash., July 24.—Thugs murderously beat and robbed Samuel Weidon and then threw his body across the railroad track, where it lay for several hours. Mr. Weidon found the injured man and sent him to a hospital. His head was smashed and his face was cut. He will recover, but will be marked for life.

Weidon was walking along a street in the tenderloin district, when he was pounced upon by the highwaymen, who knocked him into unconsciousness. Then they robbed him and afterward threw him on the track. That made the fifth job of a similar character done by footpads in Seattle in the last three days.

STEERS TRAMP TO DEATH.

Montana Stockman Is Smothered in Mire Under Horns.

GLASGOW, Mont., July 24.—Edward Enos, one of the wealthiest and best-known stockmen of Northern Montana, died today as a result of a fearful tramp into mire by his steers, smothered and drowned in soft mud and water of a slough of the Missouri River. Enos was on his way to a place where he was to sell some of his stock when the animal turned suddenly and knocked Enos off his feet. Then the herd pushed and tramped the prostrate man almost out of sight in the mire.

Show School Population Increase.

SALEM, July 24.—(Special.)—The annual school reports of Tillamook and Clatsop Counties were filed in the office of Superintendent of Public Instruction J. H. Ackerman today. Both show material increases in the school population during the year. Tillamook reports a school population of 173, as compared with 152 last year. The average daily attendance does not make so good a showing, however, for it has dropped from 54 to 73. The average salary of male teachers has advanced from \$40 to \$41, and of female teachers from \$33 to \$35.

Clatsop County reports a school population of 118, against 102 last year. The average daily attendance increased from 63 to 65. Clatsop also shows a good increase in the average amount of teachers' salaries. The salaries of male teachers has advanced from \$40 to \$41, and of female teachers from \$31 to \$32.

Angry, So He Broke a Window.

SALEM, Or., July 24.—(Special.)—Harry Dunn, a veteran of the Civil War, hopelessly addicted to drink, in a fit of rage today hurled a huge rock through the front window of the White House restaurant, completely demolishing the same. Considerable damage was done to interior fixtures. Dunn is now languishing in City Jail, and as this is not his first offense he will probably get the limit of the law.

Linn County Woman in Runaway.

ALBANY, Or., July 24.—(Special.)—Mrs. A. E. Lewis, who resides on a farm near Albany, was the victim of a runaway accident today, in which she sustained serious injuries. The horse became frightened while the lady was coming to town and ran away, throwing Mrs. Lewis out of the buggy. She struck on her head and her neck was nearly broken.
