

NEAR TO BARBS
Persians Butcher Reformers.

A GREAT RELIGIOUS RIOT
Massacre of Both Men and Women Lasts Two Days.

DEAD DRAGGED THROUGH TOWNS

One of the Male Victims Is Blown From the Mouth of a Cannon—Order Has Been Restored.

LONDON, July 29.—The Times this morning describes as follows the religious riots in the city and province of Yazd, Central Persia, which lasted more than a fortnight, and culminated at the end of June.

The outbreak was directed against religious reformers called Babists. In the city for two days every Bab found was butchered by the rabble, and the mutilated bodies were dragged through the streets followed by exultant crowds.

Houses were looted, women murdered and finally the priestly leaders of the rioters enjoined the populace to bring all the Babists before them for judgment. The Governor refused at first to listen to the threats of the crowd, but the residence was surrounded by menacing members of the mob and the following day he yielded. One Bab was blown from the mouth of a cannon. Order has been restored.

NEED FOR LABOR IS GREAT.

Lord Milner's Reasons for Wanting Coolies in South Africa are Given.

LONDON, July 29.—The Parliamentary correspondence on the South African labor question was issued today. Lord Milner, High Commissioner for South Africa, telegraphed Colonial Secretary Chamberlain on July 12, urging the employment of 100,000 Indian coolies for work on the railways, the coolies to be forcibly repatriated at the end of their service. Lord Milner reported the labor problem arising in the House of Commons last Monday afternoon in a short time, and now gradually, but inevitably, our tariff must be reduced.

QUOTES MCKINLEY ON TARIFF.

Englishman Uses President's Words as Argument for Free Trade.

LONDON, July 29.—Governor F. O. Schuster, at a meeting of the Union Bank of London directors today, made a reference to the British fiscal controversy. While he welcomed an inquiry into the fiscal policy of the government, the whole tenor of Mr. Schuster's argument was opposed to tampering with the tariff. He expressed the belief that the United States was free trade, and in support of this said in a private interview with the late President McKinley two years ago in which the latter said:

"My tariff bill has done its work. We have been able to build up many great industries in a short time, and now gradually, but inevitably, our tariff must be reduced."

MARCONI TAKEN TO TASK.

German Wireless Company Takes Exception to His Words.

BERLIN, July 29.—The German Wireless Telegraph Company, which was recently organized, through the amalgamation of the Siab and Braun systems, has issued a statement regarding Signor Marconi's utterances on the possibility of the German company intercepting Marconi messages in England. Marconi's opinion that such interception can only be effected by the German stations erected in England is, it is declared, erroneous. The German company says all that is necessary to erect a string of stations on the shores of the Baltic, or along the North Sea, attune its own wires to Marconi's station at Poldhu, Cornwall, and it would be impossible for Marconi to receive their messages. The statement concludes:

"Such procedure for controlling a world monopoly aimed at by Marconi could hardly be called 'chicanery,' but more properly self defense."

BRITISH SHIP MAY GO TO CHINA.

Grafton is Expected to Leave Equatorial in the Near Future.

VICTORIA, B. C., July 29.—There are rumors current at Esquimalt that H. M. S. Grafton may be sent to the China station when Rear-Admiral Blockford leaves for home shortly. The destination of this is obtainable. Already one of the vessels of this station has been sent to the China station from Esquimalt and never replaced. At the commencement of the campaign which resulted from the Boxer rising in China, H. M. S. Arctus was dispatched to China, and no vessel has relieved her.

Maritime conditions are being made to the land defenses at Esquimalt at Esquimalt Hill fort, where some 53 guns will be placed. Work is being carried on industriously, and this week the Admiralty has purchased a property between Esquimalt and Pardon's bridge, where large and modern powder magazines, plans for which are out, will be erected.

BRIDE IS OFFERED LAWMAKER.

Hungarian Deputy Shows Cash and Says Ex-Legislator Tendered It.

BUDA PEST, July 29.—Deputy Zelen Papp caused a sensation in the Lower House of the Diet today by spreading out

on the table 10,000 kroner in cash, which he declared, had been tendered him as a bribe to desert his fellow obstructionists and leave Buda Pest. Herr Papp, who is a member of the Diet, said he had added that it was an ex-Deputy Dienes who attempted to bribe him. Herr Dienes, he asserted, had 12,000 kroner, of which sum he retained 2000 as commission and handed 10,000 kroner to Herr Papp, while the latter accepted in order to be able to prove his allegations.

Deputy Lovassy said that the editor of the Magyar Orszag had been asked how much money would be required to buy off that newspaper's support of the obstructionists. A parliamentary committee was appointed to investigate the matter.

There was a stormy scene in the Diet this afternoon when the Premier, Count Hedervary, rose to commence the debate on the indemnity bill. The obstructionists stood up and the Chamber resounded with deafening shouts, the banging of desk lids and insults hurled at the Premier from the opposition benches. The session was suspended, but the scenes were repeated on its resumption, and ultimately being unable to obtain a hearing, the Premier handed the clerk of the house a written motion, moving the reading of the bill.

When the obstructionists became aware of this action a couple of members of the Kosuth party stormed the Presidential tribune, snatched the paper from the clerk's hands, and, shouting defiance, the tribune was soon filled with shouting Deputies and amidst the turmoil the session was again suspended.

After the session was suspended for the second time the obstructionists declared that orderly debate was impossible until the bribery question had been cleared up. The sitting was resumed for the third time and the greatest excitement prevailed in the lobby.

Deputies Olay and Polony accused Premier Hedervary of instigating bribery. The Diet was still in session at 10 o'clock tonight.

KING TO VISIT AMERICAN FLEET.

Rule of Portugal Will Be the Guest of Cotton Saturday.

LIBRION, July 29.—King Charles is expected to visit the United States European squadron on Saturday. The reception accorded to Rear-Admiral Cotton and the American officers by the King and Queen Amelia at the castle of Cintra, 14 miles from Lisbon, Monday, was most cordial. Admiral Cotton, while at Cintra, visited Queen Maria Pia, mother of the King, and the Duke of Oporto, brother of His Majesty.

There were 250 guests at the banquet given at the Ministry of Marine last night in honor of the King and Queen, and all of the Cabinet Ministers were present. Admiral Cotton was greeted with cheers, made a speech, during which he eulogized Portugal, and thanked the officials for the hearty reception accorded the American warships. He also referred to the exaggerated accounts of a petty squabble which occurred between the police and the American sailors, and declared that the relations between the two forces were most friendly.

The Minister of Foreign Affairs, the Minister of Marine and United States Minister Bryan also made speeches.

Admiral Cotton and his officers will entertain a large number of Portuguese ladies at a reception on the Brooklyn Avenue at 8 o'clock. Bryan will give a garden party August 5.

German Political Parties Will Unite.

BERLIN, July 29.—A proposal is on foot to amalgamate the National Socialist party of Germany with the National Socialist Congress, which will meet at Goettingen August 29 and 30, will undoubtedly agree to the amalgamation.

The three and a half rounds were lame, O'Neill avoiding the champion's rushes. In the fifth round O'Neill hit Corbett three glancing blows on the head, and then delivered a fourth one when Corbett dropped to his knees to avoid it.

This gave the local man confidence in the fifth round and proved fatal to him. He met Corbett's rush and in an unguarded moment received a terrific right-hand punch on the jaw, which sent him to the floor and he was counted out.

A CAUCUS ON POPE

Spanish Cardinals Will Vote Solidly for Rampolla.

THE KING'S INFLUENCE IS USED

Italian Papers Charge Gibbons With Intriguing Against a Head of the Church From Their Country.

ROME, July 29.—(Special by Cable.)—The Spanish cardinals held a caucus and will vote solidly for Rampolla. The King brought great pressure to bear.

The Italian papers accuse Cardinal Gibbons of intriguing against an Italian pope. Gibbons is far the most conspicuous foreigner present. An early election of a pope is looked for.

PREPARE FOR CONCLAVE.

Form of Ballot in Discussed and Cells Visited.

ROME, July 29.—During the meeting of the congregation today, the forms to be used during the conclave were discussed among the cardinals in order that each might be able to learn how to employ his ballot. After the meeting Cardinal Gregalia requested the cardinals to visit their cells and be prepared at tomorrow's meeting to present any complaints which they may have.

Cardinal Agliardi has relinquished his cell, near the Sixtine Chapel, to Cardinal Cremona, on account of the latter's illness. Over the door of each of the cells has been placed the coat of arms of the cardinal who is to occupy it.

Should all the cardinals now in Rome enter today, it will be the most numerous conclave in history. The conclave which elected Leo was attended by 61 cardinals. In the past popes have been elected by conclaves containing as low as nine.

The ecclesiastics who are to watch the sliding doors, which will be the only means of communication between the conclave and the outside world, have been requested to be present at the Vatican Friday afternoon to assume their duties. The sliding doors will only be opened between 9 and 11:30 in the morning, and between 5 and 7 in the evening. At all other times they will be locked.

The second requiem mass in the Sixtine chapel was termed the foreign mass. Cardinal Kopp, bishop of Bresl, celebrated the mass, assisted by the foreign cardinals, Gossens, Grunha and Ferraud, and one Italian cardinal, Di Pietro. The beautiful chapel overflowed as it did yesterday with the faithful.

The Vatican as a rule provides a carriage and horses for all the cardinals, and all the horses are alike, black with gold trim. But the authorities were not prepared for so many cardinals, and were obliged to give the last arrivals bay horses.

From the estimates made the cost to the Holy See of the various ornaments from the death of the pope to the election of his successor, if it takes place within a few days, will be \$400,000.

LOGUE DEFENDS GOTTLI.

Because He Is a Carmelite Does Not Follow He Is Narrow-Minded.

ROME, July 29.—Cardinal Logue, archbishop of Armagh, had an interview today with Cardinal Gibbons, and stated what he thought of the objections frequently mentioned against Cardinal Gottli being elected pope on the ground of his being a member of the Carmelite order. He would prevent him from dealing in a broad spirit with Catholic problems in America and Great Britain, Cardinal Logue said to a representative of the Associated Press.

"It is absurd. Cardinal Gottli was formerly an internuncio, and has mixed with the representatives of the various powers. He knows the various conditions as well as anybody. Just not follow that he is narrow minded."

"Moreover, it is unreasonable to attribute too much weight to the nationality of the new pope. International matters and internal policy are now almost invariably settled by committees of cardinals, who certainly understand the language of the departments just as well as the heads of departments of a civil government direct their department."

"But, who ever may be pope, it is not changes in policy without being careful to take the advice of those commissions which have heretofore directed the policy of the Vatican."

Two Cardinals Will Not Be Present.

ROME, July 29.—With the arrival here of Cardinal Prisci, archbishop of Naples, the number of cardinals who will participate in the conclave is complete and totals 62. Of the two remaining, Cardinal Alessi, archbishop of Palermo, cannot leave Palermo because of his health, and Cardinal Morano, archbishop of Sydney, N. S. Wales, although he has left Sydney, cannot, it is believed, arrive here before August 29, when it is supposed the conclave will be over.

SUGAR BILL TO SECOND READING.

Chamberlain Refers to Fiscal Policy, and Urges All to Keep Cool.

LONDON, July 29.—The House of Commons today passed the sugar convention bill to its second reading, by a vote of 144 to 14. In the course of the debate, Colonial Secretary Chamberlain, in referring to the possibility of losing the American market, said:

"If we had only treated the West Indies fairly, there is no reason why they should not be supplying us with the greater part of our demand. The government has had the choice between prohibition and rebating duties."

He believed prohibition the simplest plan, but if it should be necessary, he would take the opinion of Parliament on the question of countervailing duties. Mr. Chamberlain did not touch directly upon the fiscal question, but incidentally remarked, "we are on the eve of a great economic fight, and it behooves everybody to be ready, and the government has determined to suppress the freedom of speech which has prevailed since the upheaval of 1890. The names of 40 residents of Pekin who are accused of liberal tendencies were presented to the Dowager Empress today by the reactionary officials, who recommended that they be severely punished. Those accused are considered guilty of only what in enlightened countries would be the legitimate criticism of the government. This is said also to be true of the native journalists imprisoned at Shanghai, except in the case of two who suggested the assassination of the Manchur ruler as a remedy for China's troubles.

All foreigners and progressive Chinese

are deeply interested in the decision which the Ministers will make on the question of turning over the native editor arrested at Shanghai to Chinese jurisdiction, and they express the hope that technicalities concerning the jurisdiction of the court will be ignored, if necessary, and that the Ministers will refuse on the ground of humanity to deliver the prisoners to the Chinese for probable torture and execution, as happened in the case of the Chinese who were turned over to the Chinese officials at Shanghai during the Japanese War.

Chang Chi Tung, Viceroy of Nankin, is chief president of the local union, a reactionary party, advising such a course to the Empress Dowager, who will acquiesce. Prince Ching is reported to favor leniency.

HONORS MEMORY OF KING.

Rome Holds Mass and Marches to the Tomb of Humbert.

ROME, July 29.—Rome this morning was the scene of a religious procession, the contrasts which are now so characteristic of the Eternal City. While at the Vatican, in the Sixtine Chapel, a solemn service was being intoned with all the solemnity the Catholic church was capable of, for the repose of the soul of Pope Leo XIII, the spiritual monarch who claimed Rome as his capital, another and no less solemn service was being celebrated in the magnificent Pantheon for the repose of the soul of the late King Humbert, the temporal monarch, the captain of the Italian nation.

King Victor Emmanuel III and his mother, Dowager Queen Margaret, came here on purpose to attend the annual mass which is celebrated on the anniversary of the assassination of King Humbert, which occurred three years ago. The King drove to the Pantheon, the well-known red liveries of his coachmen and footmen aroused in a manner, and no royal word was in time to meet Queen Margaret, who was dressed in deepest black. After a tender embrace, mother and son entered the Pantheon, heard the mass and placed wreaths on the tombs of King Humbert and King Victor Emmanuel III.

The other members of the municipality of Rome, with the exception of a few of their number, who a few days ago went to the Vatican to condole with the camerlengo on Pope Leo's death, are very actively engaged in the duties of the city government, visited the Pantheon in a body and placed wreaths on the tombs of the two Kings.

The procession, which was mostly composed of local patriotic societies and bands, led by the members of the municipality, carried many banners, and Italian flags draped with crepe. Besides hundreds of wreaths, which they laid on the tombs of King Humbert and Victor Emmanuel at the Pantheon.

DRIVEN FROM CITY

Men Who Blew Up Mine Escorted Away by Citizens.

ALL PROMINENT IN THE UNION

Mass Meeting Attended by Hundreds Decides to Take Prisoners From Jail, but Everything is Done Quietly.

IDAHO SPRINGS, Colo., July 29.—After a businessmen's meeting tonight 500 citizens of Idaho Springs went to the City Jail and took 14 of the men arrested in connection with the blowing up of the Sun and Moon mine buildings last night, marched them to the city limits and told them to leave the place and never return. The men driven out include Howard Treadwell, president of the local union, A. D. Alcott, vice-president; George Becker, secretary; Peter Bender, treasurer, and two or three members of the executive committee. All the others are prominent members of the union.

Some of the men complained that they had no money, and a purse was made up for them. Everything was done in an orderly manner, and no rough word or act was indulged in toward the men. At the meeting, at which the action was determined upon, it is said fully 80 per cent of the city's business population was represented. It was presided over by City Attorney Colton and addressed by President Hauchet, of the First National Bank and other prominent men.

The other prisoners were taken to Georgetown, the county seat, this evening. The wrecked transformer house set fire to the oil in the transformers and threatened the destruction of the main shaft-house. The latest information from the scene is that the fire has been placed under control.

From the meager details of the affair it is learned that the watchman at the mine, aroused by the explosion, rushed out in time to observe two men running away from the transformer building. He fired at them several times, and a wounded man was found lying near by. He was taken in charge and the company physician sent for. Under-Sheriff Charles Peck, of Georgetown, and a posse have gone to the scene to make an investigation and protect the Sun and Moon property, if it is found necessary.

The Sun and Moon was the first mine affected by the strike, which was declared last February. After four months of idleness the mine resumed operations in June with nonunion men. Manager Sims, of the Sun and Moon, declares that no explosion of this kind has ever taken place near the transformer building. As near as can be learned the building was wrecked by a heavy charge of dynamite. The recently married man died this morning. He has been identified as Philip Fire, a member of the Miners' Union.

Twenty nonunion men were working on the eighth level of the mine at the time of the explosion, but the number of men damaged caused by the explosion amounts to several thousand dollars.

BUILDING MAY BE TIED UP.

Employers Stand Together to Make One Firm's Strikers Go In.

PITTSBURGH, July 29.—Indications point to an almost entire suspension of building in the Erie district within 48 hours, the result of a fight between the Building Trades Council and the Building Exchange members.

A week ago the Building Trades Council ordered a strike of all men affiliated with them who were employed by the contracting firm of A. & S. Wilson, because the firm employed a nonunion hoisting engineer on one of the contracts and refused to sign the scale. This order affected 10,000 men, and effectively tied up the majority of the firm's contracts.

Tonight the Builders' Exchange League, of which the Wilson firm is a member, took up the matter and after a full discussion of the subject, adopted a resolution which called for the appointment of a committee to notify the Building Trades Council that unless the employees of A. & S. Wilson, who are on strike, return to work within 48 hours that the employers of workmen connected with the Building Trades Council will suspend operations until the matter has been satisfactorily settled with the Builders' Exchange League.

STRIKE TIES UP STREET-CARS.

Detroit Men Walk Out When Morning Travel Has Just Begun.

DETROIT, Mich., July 29.—All the street-cars in the city were held up for more than two hours this morning at the time travel is usually heaviest by a strike of 35 firemen at the power-house. The men struck to enforce their demand for an eight-hour day, made some time ago. Outside help was rushed to the power-house, and the company had cars moving on most of the lines. At 8 o'clock three of the firemen had returned to work, while the others were endeavoring to induce the engineers to join them. Thousands of people were late in getting to work, owing to the tie-up.

An agreement was reached between the strikers and Superintendent Stanley, of the Detroit United Railway, a conference this afternoon and the men agreed to resume work under the old conditions. Negotiations, however, will be resumed where they were broken off by the strike this morning, and a conference seeking an adjustment of all differences will be held Monday.

Holds Unions Can Have Pickets.

NEW YORK, July 29.—Judge Cavanaugh in a decision today decided that labor unions have a right to place pickets about a plant where a strike is in progress, and he also declared that workmen have the right to persuade workmen to quit work. The jurist furthermore ruled that seven men to jail upon affidavits that they have violated an injunction. Judge Cavanaugh's decision is directly opposite to decisions rendered in the Superior Court.

Two Thousand Girls to Strike.

NEW YORK, July 29.—At a mass meeting, under the auspices of the Wrapper Makers, 200 girls employed in that trade here have been ordered to strike for a nine-hour day.

Barbers to Shave Dead Hereafter.
